113280 3. **Advisory Committee Appointment  
Gulf Coast Rail District**

Appoint one member to the Gulf Coast Rail District (MO)

*The Gulf Coast Rail District is governed by a board of directors, which is responsible for the management, operations and control of the District. State law provides that the commission may appoint one Ex Officio Nonvoting Director to the district's board of directors. This minute order approves the appointment of one Ex Officio Nonvoting Director to the board.*

113278 4. **Comprehensive Development Agreements**

- a. **Harris and Montgomery Counties** - Approve the selection of the proposer who submitted the best value proposal to develop, design, construct, and maintain Segments F1, F2, and G of the SH 99 (Grand Parkway) project, from south of US 290 in Harris County to west of US 59 North in Montgomery County, and authorize the executive director of the department to execute a comprehensive development agreement with the selected proposer (MO) (PRESENTATION)
- On May 3, 2012, the department issued a request for proposals to develop, design, construct, and potentially, maintain Segments F1, F2, and G of the Grand Parkway project, a toll project in Harris and Montgomery Counties consisting of improvements from south of US 290 in Harris County to west of US 59 North in Montgomery County. The department has completed its review and evaluation of proposals, and is presenting its best value recommendation to the commission.*

- 113279 4. **Comprehensive Development Agreements (continued)**  
b. **SH 99 (Grand Parkway) Toll Project**  
Various Counties - Consider the final approval of a request for financing from the Grand Parkway Transportation Corporation (GPTC) to pay for eligible costs associated with the development, design, construction, operation, and maintenance of Segments D, E, F1, F2, and G of the SH 99 (Grand Parkway) toll project, from north of Kingsland Blvd. in Harris County to west of US 59 North in Montgomery County, and pre-development costs of other portions of the Grand Parkway, and authorize the executive director to enter into a financial assistance agreement for the Grand Parkway toll project (MO)  
*The Department has negotiated a toll equity loan agreement with the GPTC for the Grand Parkway toll project. The loan would be limited to payment of mutually-approved projected facility costs, including the costs of design, construction, operation, and maintenance of the project. The amounts that could be borrowed each year will not exceed a maximum permitted amount defined in the loan agreement, not to exceed 100% of the projected toll revenue stream for that period in the mutually-approved investment grade traffic and revenue study. The borrowed funds could be used by GPTC for debt service payments and for certain budgeted operations and maintenance expenses and budgeted capital expenditures if toll revenue, money in certain reserve funds and accounts, and other revenue derived from the project are insufficient to make those payments.*
5. **Promulgation of Administrative Rules** Under Title 43, Texas Administrative Code, and the Administrative Procedure Act, Government Code, Chapter 2001:  
a. **Final Adoption**  
113281 (1) **Chapter 5 - Finance (MO)**  
Repeal of §§5.70 - 5.74 (Transportation Development Credit Program) and New §§5.101 - 5.111 (Transportation Development Credit Program)  
*Under federal law, a state may use certain toll revenue expenditures, known as transportation development credits (TDCs), as credit toward the non-federal share of certain projects. The new sections modify the policies and procedures related to the allocation, award and administration of TDCs.*  
113282 (2) **Chapter 7 – Rail Facilities and Chapter 25 – Traffic Operations (MO)**  
New §§7.101 – 7.106 (Railroad Crossings) and Repeal of §§25.70 – 25.76 (Railroad Crossings)  
*These rule changes address the recent transfer of the responsibilities for highway-rail grade crossing and grade separation access, safety, and project management from the Traffic Operations Division to the Rail Division. The rules under the current Chapter 25, Subchapter E, Railroad Grade Crossings, are being transferred to New Chapter 7, Subchapter F. The new subchapter has been reorganized and renumbered to reflect current rule formatting. Amendments to the transferred rules also provide for changes in current guidelines and standards of the department and the Manual on Uniform Traffic Control Devices.*

5. **Promulgation of Administrative Rules (continued)**
  - a. **Final Adoption (continued)**
    - (3) **Chapter 28 – Oversize and Overweight Vehicles and Loads (MO)**  
 New §28.40, Purpose, §28.41, Definition, and §28.42, Districts Powers and Duties, §28.43, Permit Eligibility, §28.44, Permit Issuance Requirements and Procedures, §28.45, Permit Weight Limits for Axles, §28.46, Movement Requirements and Restrictions, §28.47, Records (Victoria County Navigation District Permits)  
*These new sections provide the authority for the Victoria County Navigation District to issue permits for the operation of oversize and overweight vehicles on specific roads within Victoria County. The sections also establish the guidelines for the agreement between the county and the department and the requirements the county must follow in issuance of the permits.*
  - b. **Proposed Adoption**
    - (1) **Chapter 9 - Contract and Grant Management (MO)**  
 Amendments to §9.4, Civil Rights-Title VI Compliance (General)  
*These amendments clarify the department's Title VI responsibilities pursuant to Title 23, Code of Federal Regulations §200.9(b)(6)(7).*
6. **Office of Compliance and Ethics Report**  
*State law requires the commission to establish a compliance program, which must include a compliance office to oversee the program. The compliance office is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The compliance office is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.*
7. **Traffic Operations**  
**Hill County – Proposed lane use restrictions for trucks on I-35 in Hill County (MO)**  
*This minute order approves a restriction for trucks using designated sections of I-35 in Hill County. The department, working in conjunction with the local jurisdictions in Hill County, developed a proposed lane restriction for the I-35 corridor.*
8. **Contracts**  
**Award or reject contracts for maintenance, highway and building construction**  
*These proposed minute orders contain information concerning the receipt of bids for highway improvement contracts. The department may reschedule receipt of bids for those projects where the commission rejects all bids. Those bids accepted by the commission will result in conditional contract awards to the low bidders. Contract award conditions may involve securing funding from other sources, the contractor's ability to satisfy federal DBE subcontracting requirements, or other requirements as outlined in the project bid proposal.*
  - a. **Highway Maintenance and Department Building Construction**

  - b. **Highway and Transportation Enhancement Building Construction**

9. **Eminent Domain Proceedings**

**Various Counties** – Authorize the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached list) (MO)

*Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82<sup>nd</sup> Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.*

a. **Donations to the Department**

- (1) **Bridge Division** – Consider a donation from the Precast/Prestressed Concrete Institute (PCI) for a department employee's travel expenses to attend the 2012 PCI Annual Convention and National Bridge Meeting in Nashville, Tennessee on September 28 – 30, 2012 (MO)

*Attendance at this meeting allows the department to share ideas and state-of-the-art information and technology for concrete bridge design, fabrication and construction.*

- (2) **Travel Information Division** – Consider a donation from the Texas Travel Industry Association (TTIA) to provide food, beverage, lodging, admission and transportation to area attractions, from various sponsors, to the department during a study tour to educate the department's travel counselors on the Far West Texas Region from October 7-12, 2012 (MO)

*The donation allows the department to exchange information and ideas with those in attendance which will be a great benefit to the department.*

- (3) **Dallas District** – Consider a donation from QuikTrip Corporation for the design and construction of a right-turn deceleration lane for access to the donor's new facility located at the southbound frontage road (northwest corner) of Loop 12 and Davis Street in Dallas County (MO)

*The donation will ensure the safety of the traveling public to and from the donor's facility.*

- (4) **Dallas District** – Consider a donation from Lowe's Companies, Inc. for the design and construction of a deceleration lane on the eastbound frontage road of I-20 to the new Lowe's and commercial development in Dallas County (MO)

*The donation will ensure the safety of the traveling public to and from the donor's facility.*

- (5) **Houston District** – Consider a donation from NEC Northpark/59, L.C., for the design and construction of a left-turn lane and right-turn lane from SL 494 to the Northpark Place Reserve (Kroger Center) development in Montgomery County (MO)

*The donation will ensure the safety of the traveling public to and from the donor's facility.*

a. **Donations to the Department (continued)**

113294

- (6) **Houston District** – Consider a donation from Hearthstone HOA to provide a permanent irrigation system, plant material and maintenance of both in perpetuity as a landscape development project located within the right of way in the medians of FM 529 in Harris County (MO)  
*The donation will provide vegetative watering to trees within the right of way as part of the district wide landscape project in accordance with the Houston District's Green Ribbon Program.*

- (7) **Houston District** – Consider a donation from Sam's Real Estate Business Trust, for the design and construction of a right-turn lane from SH 288 at Discovery Bay Drive for the Sam's Club retail center in Brazoria County. (MO)  
*The donation will ensure the safety of the traveling public to and from the donor's facility.*

- (8) **San Antonio District** – Consider a donation from HEB Grocery Company, LP, for the installation of a new traffic signal on SH 97 at the intersection of S. Reed Street and the proposed location of the main entrance to the donor's facility (MO)  
*The donation will ensure the safety of the traveling public to and from the donor's facility.*

b. **Right of Way Dispositions and Donations**

*The commission must approve the sales, transfers and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept and acknowledge donations to the state of real property that is valued at \$500 or more.*

- (1) **Anderson County** - US 287 adjacent to Gus Engeling Wildlife Management Area - Consider the transfer of surplus right of way to the Texas Parks and Wildlife Department (TPWD) (MO)  
*The surplus land was used as a roadside park, which has been closed. The district has advised that the land is no longer needed for highway purposes. TPWD is a governmental entity with the authority to condemn the property and has requested that the surplus land be transferred to TPWD for use in conjunction with the adjacent wildlife management area. The estimated cost of future maintenance on the property exceeds the fair value of the property, and the surplus land may be transferred to TPWD.*

- (2) **Brazos County**- FM 158 in Bryan – Consider the quitclaim of surplus right of way to the abutting landowner (MO)  
*The surplus land is part of a city street that was used for highway purposes, there being no record title in the name of the state or city. The district has determined that the surplus land is no longer needed for highway purposes and recommends that it be quitclaimed to the abutting landowner to clear an encroachment on the land. The city has requested that the surplus land be quitclaimed to the abutting landowner.*

- (3) **Galveston County** - SL 197 in Texas City - Consider the removal of a highway segment from the system, redesignation of the remaining highway segment and transfer of surplus right of way to the city (MO)  
*The city has requested the removal and redesignation. The district has advised that the surplus land for the segment to be removed is no longer needed for highway purposes. The cost of future maintenance exceeds the value of the surplus land, and the surplus land may be transferred to the city.*

10. **Routine Minute Orders (continued)**

b. **Right of Way Dispositions and Donations (continued)**

- 113300** (4) **Hunt County** – SH 276 from 5.92 miles east of FM 751 to 0.17 miles east of FM 513 – Consider the acceptance of a donation of land for a highway improvement project (MO)  
*The property being donated to the department is necessary for the replacement of a bridge across Lake Tawakoni. The property being donated is in lieu of payment for the acquisition and is valued at more than \$500.*
- 113301** (5) **Tarrant County** - SH 183 at SH 199 in River Oaks - Consider the sale of surplus right of way to the abutting landowner (MO)  
*The district has determined that the surplus land is no longer needed for highway purposes. The abutting landowner has requested to purchase the surplus land, and it may be sold to the abutting landowner.*
- 113302** (6) **Tarrant County** - SH 360 at Harwood Road in Euless - Consider the quitclaim of surplus right of way to honor a reversionary clause (MO)  
*The district has determined that the surplus land is no longer needed for highway purposes. The instrument of conveyance to the state contains a clause to the effect that if the highway is abandoned, declared surplus or ceases to be used as a public highway, it will revert to the grantor.*
- 113303** (7) **Tarrant County** - I-820 at Cahoba Drive in Fort Worth - Consider the sale of surplus right of way to the successful bidder and retention of a drainage easement (MO)  
*The district has determined that the surplus land is no longer needed for highway purposes. An easement interest will be retained over a portion of the surplus land for highway drainage purposes. The city has no interest in acquiring the surplus land, and it was offered to the general public, subject to the drainage easement. As a result of advertising the sale, a successful bidder has been identified.*

c. **Highway Designations**

- 113304** (1) **Bowie County** - Authorize the submission of an application to the American Association of State Highway and Transportation Officials (AASHTO) to designate a segment of US 59 in Texarkana as an Interstate Highway (MO)  
*In accordance with the processes established by the Federal Highway Administration and AASHTO, this minute order authorizes the department to petition AASHTO to include a 3.5 mile segment of US 59 from I-30 to SL 151 in Texarkana as part of the Interstate Highway System as I-369. The proposed route will act as a spur within the developing Interstate Highway 69 System.*
- 113305** (2) **Cameron, Hidalgo and Starr Counties** - Authorize the submission of an application to the American Association of State Highway and Transportation Officials (AASHTO) to designate one or more segments of US 83 in the Rio Grande Valley as an Interstate Highway (MO)  
*In accordance with the processes established by the Federal Highway Administration (FHWA) and AASHTO, this minute order authorizes the department to petition AASHTO to include segments of US 83 in the Rio Grande Valley as part of the Interstate Highway System. FHWA's designation is contingent upon a finding that the segments meet current Interstate design standards and approval to add the segments to the Interstate System.*



10. **Routine Minute Orders (continued)**

d. **Release of Access Rights (continued)**

113306

- (1) **Harris County** – I-10, east of Westgreen Boulevard in Katy - Consider the designation of three locations on the highway at which access will be permitted to the abutting property (MO)

*The designation of two 30-foot breaks and one 130-foot break in the control-of-access line will allow the abutting landowner to open two proposed driveway locations and one proposed roadway location for access to and from the westbound frontage road. The district has determined that access may be permitted at these designated locations.*

- (2) **Waller County** - Authorize the re-designation of access control along the I-10 eastbound frontage road, immediately east of FM 1489, in the city of Brookshire in order to move the sole access point on the frontage road for the property owned by Brookshire Town Center, LLC, from its original location to a new location (MO)

*The I-10 eastbound frontage road in the city of Brookshire is a controlled access facility and Brookshire Town Center, LLC is requesting that its property's existing point of access to the frontage road be relocated approximately 110 feet west from the east end of the property. The original access point at the east end of this property will be removed and access will be denied at that location. In addition, the existing access point to this property from FM 1489 will be relinquished upon approval of the above requested access re-designation.*

*This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.*
