Minute order authorization

Summary of Commission actions:

- Authorize the conditional award to the best value proposer for the design-build contract (DBC) and capital maintenance contract (CMC) for the I-2/I-69C Interchange Project in the Pharr District.
- Authorize TxDOT to commence and complete negotiations with the best value proposer, and to modify the DBC and CMC as necessary as a result of such negotiations in preparation for the execution and delivery of the DBC and CMC.
- Authorize TxDOT, in the event that the negotiations with the selected proposer cannot be successfully completed, to commence negotiations with the next proposer in the order of the selection ranking.

Design-build scope

Project limits:

- Along I-2 from just west of 2nd
 Street to just east of FM 2557.
- Along I-69C from Nolana Loop to I-2, including interchange.

Project purpose:


- Decrease congestion
- Optimize ramp and interchange operations
- Reduce travel time
- Improve mobility




Overview

- Total project length: 7.8 miles
- I-2/I-69C Interchange Improvements:
 - Full reconstruction of all four direct connector structures with two lanes in each direction.
 - Increased mainlane capacity on a portion of I-2.
