However, the North Texas Tollway Authority (NTTA) has informed TxDOT that they will not object to any of their consultants joining a proposer team for the SH 360 Project if the consultant's current relationship as a consultant for NTTA services is terminated. Therefore, if a firm's or its consultant's contractual relationship with the NTTA is terminated for any reason, then TxDOT would not object to the firm joining a proposer team for the SH 360 Project. TxDOT requests a copy of the termination letter no later than May 2, 2014, in order for the firm to be eligible to participate on a proposer team. A final, modified list of conflicted firms will be included in an addendum to the RFQ issued after May 2, 2014.

25	Draft DBA Term Sheet	Payment Obligations & Progress Payment Limitations and Schedule		Suspension of progress payments based on the D-B Contractor being behind schedule is counter-productive. Unless the D-B Contractor is extremely far behind schedule and shows no willingness to prepare or follow a recovery schedule, the D-B Contractor will need to be able to rely on the progress payments to be able to accelerate work and catch up to the schedule. In addition, if the interim payments are "progress" payments, then they are based on activities completed and should not be suspended. The Owner has the option of Liquidated Damages to provide additional incentive for schedule recovery without putting the contractor in a position of needing to go cash negative in order to complete the project.
