FEDERAL DISCRETIONARY GRANT PROGRAM (TIGER II)

DESCRIPTION

This discussion item focuses on candidate transportation projects for submission to the U.S. Department of Transportation (USDOT) under the National Infrastructure Investment Program, referred to as TIGER II Discretionary Grants.

The USDOT is authorized to award \$600 million in TIGER II Discretionary Grants pursuant to the federal FY 2010 Appropriations Act. Funds will be awarded on a competitive basis for projects that will have a significant impact on the nation, a metropolitan area or a region. On June 8, 2010 the commission directed staff to work with other sponsoring entities to prepare applications for specific projects. This agenda item will allow staff to update the commission on the development of these applications.

ISSUES:

- TIGER II state applications will focus on rail, port and intermodal facilities
- Updated project list
 - o Seven out of the ten original projects remain on the list
 - Port of Brownsville and Sabine Pass Port Authority have withdrawn their proposals, others may fall out as the deadlines near for the commitment of local matching funds or as the cost/benefit ratios are further analyzed
 - The siding project on the South Orient Railroad has been withdrawn, since the timing of the monies, if awarded, does not coincide with needs. Local funds are being pursued instead.
- Pre-application requirements
 - o Qualifies applicant to submit TIGER II application
 - o Submitted electronically to USDOT by July 26, 2010
 - o Includes the following:
 - Applicant information
 - Project information and description
 - Funding information and assurances
 - NEPA assurance
 - O USDOT will inform project sponsors if eligibility, NEPA and funding assurances are not adequate and must be adjusted as part of the application
- Final applications due August 23, 2010
 - o Projects will be selected no sooner than September 15, 2010
