2	Is there a limit on the award amount per organization?	<p>Yes, see pages 33 and 34 of the RFP for maximum funding amounts for STEP Yearlong proposals and STEP Wave proposals.</p> <p>Maximum limits have not been established for General proposals.</p> <p>We encourage you to review the anticipated funding levels for all programs in each program area on page 26 of the RFP.</p>
3	We are planning to submit a Comprehensive Traffic Safety Campaign Proposal; however we are unsure about what <i>Advertising</i> entails under the <i>Unallowable Costs Section</i> on page 48 of the RFP. <u>Will Public Service Announcements (PSAs), traffic signage and bus adds fall under this category?</u> Is there a document we can have access to in reference to what type of advertisement is allowable?	<p>Yes.</p> <p>These costs are not allowable. Page 48 of the Traffic safety RFP states: "Only for very special circumstances can federal funds be used to purchase television and radio time for highway safety public service messages. Such expenditures must be approved in advance. <b>Projects to purchase television and radio time (or any other media) are not being accepted through this RFP.</b></p> <p>TxDOT will use a separate competitive bid process to solicit projects (paid and/or non-paid media) from vendors on the TxDOT-approved media vendor (ad agencies) list.</p>

Each proposal would address a different Program Area as defined in the RFP.	<p>For STEP grants, only one proposal can be submitted, with the exception of those requesting a Commercial Motor Vehicle (CMV) STEP. See page 38 of the RFP on how to request a CMV and an additional STEP proposal.</p> <p>For a General proposal, one proposal may be submitted for each area or separate proposals may be submitted to address each area. It is up to the proposing agency to decide. General proposers may submit as many proposals as it wishes.</p>

Therefore, all vehicles over the speed limit (regardless of the amount) should be listed on the survey as speeding.

23	<p>How many "media impressions" are considered sufficient?</p>	<p>This is up to the proposing agency to decide. This information should be presented in the performance measures and objectives to provide a solution to the proposed Traffic Safety problem identification in the proposal.</p>
24	<p>The scoring criteria include the demonstration of proven methods for measuring and evaluating project success.</p> <p>Can you please provide a definition or examples of such methods?</p> <p>Does this require a program evaluation by a certified independent evaluator</p>	<p>We are requesting how the proposing agency can measure and evaluate its own project (i.e., observational surveys, data analysis, surveys of participants in the program, general public surveys, measuring knowledge increase, impact evaluation, etc.).</p>

STEP agencies must only work the enforcement sites that are identified in the grant's Operational Plan. However, the Operational Plan can be amended throughout the grant year by submitting a Supplemental Request in eGrants. (Supplemental Requests can be accessed in eGrants once a grant is executed).
34	Do the warnings count for 2014?	No, warnings cannot be counted towards STEP performance in 2014.
35	Is the population based funding level solely based resident population, or can it be based on Traffic Counts/Transit Population?	The population must be based on resident population contained in the 2011 US census. This information is contained on page 33 of the RFP.
36	Can we apply/receive a step speed grant if we already pay officers overtime to work extra enforcement of traffic laws?	Yes, if your community has an identified problem (crashes, injuries and deaths) due to speed. Also, since overtime is already being worked, your agency needs to determine that there will be officers available to work the STEP grant.
37	When is the Traffic Safety Conference expected to take place?	We expect the Traffic Safety Conference to take place in early summer around the May-June time frame.
38	If you do not have a CMV yearlong but during your Comprehensive Yearlong Officers make CMV stops, can those be counted on your Monthly reports as CMV towards your STEP Element	It depends on the CMV stops. For example, if your agency has a speed element in your grant, and a CMV is pulled over for speeding, then the speed citation can be counted towards your

Prior approval must be obtained from TxDOT before out of state travel costs occur to be considered for reimbursement.
