

## Summary of Commission Action:




- Authorize the conditional award to the best value proposer for the Design-Build Contract (DBC) and Capital Maintenance Contract (CMC) for the Southeast Connector Project in Tarrant County.
- Authorize TxDOT to commence and complete negotiations with the best value proposer and to modify the DBC, as necessary, as a result of such negotiations in preparation of the execution and delivery of the DBC.
- Authorize TxDOT, in the event that the negotiations with the selected proposer cannot be successfully completed, to commence negotiations with the next proposer in the order of the selection ranking.






- Base Scope: I-20/I-820/US 287 11.1 miles
- Deferred Work Components (DWCs)
  - DWC 1: I-820 (Ramey Avenue to Brentwood Stair Road) 1.8 miles
  - DWC 2: US 287 (Bishop Street to Village Creek Road) 1.8 miles
  - DWC 3: I-20 (Little Road to Park Springs Boulevard) 1.9 miles
  - Project purposes
    - Safety and mobility improvements
    - Operational efficiency
    - Long-term congestion management

- Texas Clear Lanes project with an estimated design-build cost of up to \$2.2B
- Total length of 16.6 miles comprised of three roadways: I-20, I-820 and US 287
- Project scope for I-20 from Forest Hill Drive to Park Springs Boulevard
  - Construction of one additional general purpose lane (GPL), plus four-lane collector distributors, in each direction
  - Reconstruction and realignment of existing GPLs, frontage roads, on/off ramps and improvements to the I-20/US 287 interchange





- Project scope for I-820 from I-20 to Brentwood Stair Road
  - Construction of two additional general purpose lanes (GPL) in each direction
  - Construction of one additional frontage road lane in each direction
  - Reconstruction and realignment of existing GPLs, frontage roads, and on/off ramps;
    - along with improvements to the I-20/I-820 interchange and the I-820/US 287 interchange




Additional capacity shown with red arrows.
