**Various Counties** - Consider the award of federal Section 5311 funds and state funds to multiple entities for a variety of program-eligible purposes (MO)

The awards identified in this minute order reflect the allocation of federal Section 5311 program funds to Rural Economic Assistance League, Inc. for the construction of a maintenance facility and the allocation of discretionary federal Section 5311 funds and state funds to various entities due to changes in transit district boundaries.

#### 7. Aviation

**Various Counties** - Consider the award of federal non-primary entitlement grant funding, federal apportionment grant funding, Infrastructure and Investment Jobs Act grant funding, and state grant funding for airport improvement projects at various locations (MO)

Federal law authorizes the award of federal non-primary entitlement grant funding, federal apportionment grant funding, and Infrastructure and Investment Jobs Act grant funding to preserve and improve the state's general aviation system. State law authorizes the award of state grant funding for capital improvement projects.

#### 8. **Acquisition of Parcel**

**Galveston County** - Consider the approval of the acquisition of a parcel of land along the Gulf Intracoastal Waterway for dredge material placement (MO)

This minute order authorizes the Texas Department of Transportation (department) to purchase a 255.881-acre parcel of land for the placement of material dredged from the Gulf Intracoastal Waterway and future beneficial use projects, in accordance with the department's role as the non-federal sponsor as designated by the Texas Coastal Waterways Act.

**Various Counties** - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) (MO)

Texas Transportation Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82nd Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.

State statutes require the Texas Transportation Commission (commission) to acknowledge the acceptance of a gift to the Texas Department of Transportation that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.

#### b. Real Estate Dispositions

The Texas Transportation Commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.

#### c. **Reports**

#### **Compliance Division Report**

State law requires the Texas Transportation Commission (commission) to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of Texas Department of Transportation (department) policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.

#### d. **Highway Designation**

**Nueces County** - In the city of Driscoll, consider designating a segment of US 77 on a new location on the state highway system and redesignating a segment of US 77 as BU 77 on the state highway system (MO)

This minute order designates US 77 on a new location on the state highway system from a location south of County Road 28 southward to a location north of County Road 16, a distance of approximately 5.1 miles; and a segment of US 77 is redesignated as BU 77 on the state highway system from a location south of County Road 28 southward a location north of County Road 16, a distance of approximately 4.9 miles.

#### e. Land Acquisitions for Facilities

**Oldham County** - Consider the grant of authority to the department to acquire real property for facilities (MO)

The Texas Department of Transportation (department) is in the process of acquiring real property for the construction of new facilities and the expansion of existing facility sites. Funds for the purchase of these properties were appropriated by the 88th Legislature, General Appropriations Act for the 2024-2025 Biennium. The department requests the Texas Transportation Commission's authorization to enter into purchase contracts and related documents to complete the acquisition of the listed properties.

#### f. Speed Zones
