## **Rising To The Challenge**

With these unsettling times and unprecedented working conditions for most of us, TxDOT is rising to new challenges as we construct and maintain Texas roadways. Lufkin District crews are working under challenging conditions, including 'social distancing' on the job site. Many of our employees are working from home, but continue to deliver the same high-quality work and results you expect.

TxDOT.gov works to link you to excellent sources of information where you can find the latest facts on COVID-19, including the link for the Texas Department of State Health Services' coronavirus web page, the best source of COVID-19 health-related information in Texas.

TxDOT's Travel Information Center lobbies are closed until further notice, while the following services continue: Travel counselors are available from 8-5, M-F, to answer calls at (800) 452-9292. Road conditions are available 24/7, seven days a week, at (800) 452-9292 and at www.drivetexas.org. Safety rest areas remain open, although Texans should avoid gathering in groups larger than 10, per government requirements. In-person public meetings and hearings have been postponed and Texas Transportation Commission meetings will be conducted virtually. A list of meeting dates and information is available at txdot.gov.

#### What Is Stokesia laevis?



Lufkin District Environmental Specialist Matt Buckingham recently had his research published in the November edition of Phytoneuron, a digital publication in plant biology. The publication specializes in miscellaneous reports on taxonomy, floristics and geographical distribution of vascular plants.

Matt's research included information on *Stokesia laevis* (Asteraceae), a native flora of Texas, located in northern Jasper County. Matt co-authored the article with Pete M. Loos, Ecovirons, Inc.; Thomas C. Philipps, United States Forest Service; Eric L. Keith, Raven Environmental Services, Inc.; Jason R. Singhurst, Nongame and Rare Species/Texas Parks and Wildlife Department; and Walter C.

Holmes, Department of Biology, Baylor University. The group was notified by the Texas Parks and Wildlife Department in Austin that the article was approved for publication.

If not for the research, most of us would not know that the *Stokesia laevis* is reportedly new to the Texas flora. This species can be found near the slopes along the drainageways between sandhill ridges and on banks of small perennial side streams flowing into a spring-fed stream in the Angelina National Forest tucked beneath the long-leaf pines.

While new to Texas forests, the *Stokesia laevis* also makes its home in Alabama, Florida, Georgia, Louisiana, Mississippi and South Carolina. The article acknowledged the U.S. Forest Service for providing access to the plants, managing the landscape through its prescribed burn program and future potential opportunity to continue the study.

#### **Lufkin District Receives Award**

It was April 24, 2019, when skies grew dark and residents of San Augustine County knew it was not just another thunderstorm.

Two tornadoes touched down and left trails of debris across the county, leaving roads impassable, homes destroyed and residents injured or trapped. Lufkin District crews went to work and continued working through the night and the days to follow to clear roadways so emergency crews could reach those in need. Once the emergency had passed, crews began the task of helping clean and restore the area which took several weeks. Many residents were left with damaged or destroyed homes and downed trees and power lines littered throughout the county.



Lufkin District partnered with local law enforcement

and first responders to help residents of San Augustine and the surrounding area. For those efforts, the San Augustine County Chamber of Commerce awarded the Lufkin District the Excellence in Public Service Award January 21st at the Historic Museum Theatre in San Augustine. Nacogdoches Area Engineer Matt Brazil and San Augustine Maintenance Supervisor Kealon Hightower accepted the award on behalf of the district. TxDOT is proud to have been a part of the clean-up and restoration efforts in San Augustine County.


**Driven by Texans** 

- <u>US 59/SL 224 South Interchange</u> project involves upgrading existing US 59 by constructing new US 59 direct connectors at SL 224(S) and frontage roads along SL 224 between SH 7 and US 59. Utility relocations are currently underway. Construction began in September 2019 and is anticipated to be complete Summer 2023.
- <u>US 59 Diboll Relief Route</u> project involves constructing a new location controlled access roadway east of Diboll. Utility relocations are currently underway. Construction will begin in Spring 2020 and is anticipated to be complete Spring 2025.
- <u>US 59 Upgrade in Lufkin between Moffett Rd and SH 103</u> project involves upgrading existing US 59 to a controlled access roadway by adding frontage roads. Preparation of engineering plans, right-of-way (ROW) acquisition and demolition are underway. Once the ROW is clear, utility relocations will begin. Construction is currently scheduled to begin in 2020.
- <u>US 59 Upgrade in Redland between SL 287 and FM 2021</u> project involves upgrading existing US 59 to a controlled access roadway by adding frontage roads. ROW acquisitions are underway and TxDOT has started preparation of engineering plans. Construction is currently scheduled to begin in 2022.
- <u>US 59 Corrigan Relief Route</u> project involves the construction of a new location controlled access roadway west of Corrigan. ROW acquisitions have begun. TxDOT has started preparation of engineering plans. Construction is currently scheduled to begin in 2022.
- <u>US 59 Upgrade in San Jacinto and Liberty Counties between FM 2914 and North Cleveland</u> project involves upgrading existing US 59 to a controlled access roadway by adding frontage roads. ROW acquisitions have begun and TxDOT has started preparing engineering plans. Construction is currently scheduled to begin in 2023.
- <u>COMING SOON US 59/US 259 North Interchange</u> having received construction funding in the 2020 United Transportation Program (UTP), this project involves upgrading existing US 59/US 259 interchange to meet interstate standards. Schematic and environmental studies anticipated to begin Fall 2020. Construction is currently scheduled to begin in 2029.
- COMING SOON US 59 Upgrade in San Jacinto between FM 223 and Trinity River having received construction funding in the 2020 UTP, this project involves upgrading existing US 59 to a controlled access roadway by adding frontage roads to meet interstate standards. Schematic and environmental studies anticipated to begin early 2021. Construction is currently scheduled to begin in 2029. ■




