When It Rains, It Pours

It seemed like East Texas just recovered from a brutal winter storm when spring rains began causing extensive flooding in the Lufkin District.

On almost a daily basis, maintenance crews were monitoring high water, barricading roadways and repairing washouts and damage caused by extensive





No matter how well a roadway is built, when it is covered with rushing water, it could be damaged. In Houston County, crews repaired a washout that had traffic stopped and detoured. In Angelina County, problematic and low-lying areas were a constant concern through the month of May and into June. Trinity and San Jacinto counties also experienced many road closures. Farm Roads throughout the nine-county district were closed as water rose and even homes and businesses began to flood. Rivers were overflowing and area lake levels were such that reservoir dams had to be opened to allow flood waters to move downstream. This resulted in additional flooding near the floodgates.

Crews remained vigilant several nights and through weekends inspecting for washouts and damage to the roadways. In some areas, construction on major projects was all but at a standstill until water receded. Winter and spring of 2021 have been challenging for TxDOT construction and maintenance crews, but with the hope of warmer temperatures and the coming summer, the busiest season of the year will be in full swing.



The public is reminded to never drive through water over the roadway or around TxDOT barricades or cones set at flooded areas. You don't know the pavement conditions until it is too late. Wait until it is safe and barricades and cones are removed. You can always check for closures and road conditions

Public Outreach for ADA Self-Evaluation Summary of Findings

The Texas Department of Transportation (TxDOT) has a long history of being committed to providing for the safety, reliability, and accessibility of the public the agency serves. The people of Texas have come to expect the best highway system in the United States from this agency and should be able to now expect the best transportation system for everyone.

Therefore, following the passage of the American Disabilities Act (ADA) of 1990, TxDOT created an ADA Task Force in 1992 and completed a self-evaluation and guide in January 1993, which addressed all aspects of the ADA. The American Disabilities Act of 1990 is a civil rights statute that prohibits discrimination against people who have disabilities. Under the ADA, designing and constructing facilities for public use that are not usable by people who have disabilities constitutes discrimination. As TxDOT has gained an understanding of the requirements under the ADA, we make every effort to achieve compliance. This initiative still continues as TxDOT seeks to be proactive and accommodating in every aspect.

TxDOT is proud to be a part of changes and progress that can unite, serve and further the safe and efficient movement of goods, services and people that ensure everyone is included. With this in mind, TxDOT is finalizing a draft of a self-evaluation of ADA compliance Statewide for all facilities within the TxDOT umbrella, including physical access and program access. Physical access addresses barriers or obstacles in facility's, right of way, or TxDOT amenities. Program access can include physical access but primarily addresses policies, practices, communications, and procedures. TxDOT will be soliciting feedback through public outreach events that will be held virtually in the near future. These public outreach events, along with the draft "Summary of Findings Report" will be then posted on the TxDOT website for access after these events.

TxDOT Names New CEO

TxDOT Commissioners on May 26, 2021, named Marc Williams to lead TxDOT as the new executive director following the retirement of James Bass.

Marc took on his new role on June 1, 2021, after serving as deputy executive director. He began his service with TxDOT in 2012 as director of planning. In 2015, he was appointed as interim deputy director. Prior to joining TxDOT, Marc held leadership roles in public and private sector organizations involved in the planning and development of transportation infrastructure across the United States.

Driven by Texans


- <u>US 59/SL 224 South Interchange</u> project involves upgrading existing US 59 four-lane controlled access freeway from south of Spradley Street to the intersection of SH 7 west and State Loop 224. The project also involves the construction of new US 59 direct connectors at SL 224(S) and frontage roads along SL 224 between SH 7 and US 59. The \$86 million construction project was awarded to Longview Bridge and Road Ltd who began work in September 2019. The project is anticipated to be open to traffic in Summer 2023.
- <u>US 59 Diboll Relief Route</u> project involves constructing a new location four-lane controlled access freeway east of Diboll. Sacyr Construction USA LLC was awarded the \$140.1 million project and began construction in April 2020. The project is anticipated to be complete in Fall of 2024.
- <u>US 59 Upgrade in Lufkin between Moffett Rd and SH 103</u> project involves upgrading existing US 59 to a six-lane controlled access freeway with frontage roads. The \$19.3 million project was awarded to Longview Bridge and Road Ltd who began construction in February 2021. The project is anticipated to be complete in Spring 2023.
- <u>US 59 Upgrade in Redland between SL 287 and FM 2021</u> project involves upgrading existing US 59 to
 a four-lane controlled access freeway with frontage roads. TxDOT received environmental clearance and
 completed right-of-way (ROW) mapping. ROW acquisitions and demolition are underway. Upon completion of
 ROW acquisition and demolition, utility relocations will begin. Construction is currently scheduled to begin in
 2022.
- <u>US 59 Corrigan Relief Route</u> project involves the construction of a new location four-lane controlled access freeway west of Corrigan. TxDOT received approval of the schematic and environmental studies in March 2018. ROW acquisitions have begun. Upon completion of ROW acquisition and demolition, utility relocations will begin. Construction is currently scheduled to begin in 2022.
- <u>US 59 Upgrade in San Jacinto and Liberty Counties between FM 2914 and North Cleveland</u> project involves upgrading existing US 59 to a four-lane controlled access freeway with frontage roads. TxDOT received approval of schematic and environmental studies in August 2019. ROW acquisitions have begun. Upon completion of ROW acquisition and demolition, utility relocations will begin. Construction is currently scheduled to begin in 2023.
- COMING SOON US 59/US 259 NORTH NACOGDOCHES INTERCHANGE this project involves converting existing US 59 to a four-lane controlled access freeway from FM 343 to just north of the US 59/US 259 interchange. The proposed project would include reconstructing the US 59/US 259 interchange and constructing frontage roads. TxDOT has hired a consultant who began field surveying in late 2020. This survey data will be used to begin schematic and environmental studies. Construction is currently scheduled to begin in 2029.








