# **Volume 2 Activity Instructions**

This Volume 2 of TxDOT's Environmental Guide contains individual instructions for completing each of the Activities, Reviews, and Coordinations generated in TxDOT's Environmental Compliance Oversight System (ECOS) that may be required to environmentally approve a given transportation project.



This Volume contains instructions for each and every Activity that may be included in a project work plan for a given project. They are arranged in alphabetical order.

Below are some general principles to be applied in following the Activity Instructions in this Volume.

#### Date in footer of individual Activity Instructions

Whenever ENV revises any of the Activity Instructions in this Volume 2, ENV will update the month and year in the footers on the Volume 2 cover page and on the individual Activity Instructions that are being revised. ENV will <u>not</u> update the month and year in the footers of any individual Activity Instructions that are <u>not</u> being revised so that users will be able to tell from the footers if and when the instructions for a particular Activity have been revised.

#### References to "district environmental staff"

Throughout this Guide, references to "district environmental staff" may be read as referring to a district employee, a TxDOT consultant, local government representative, or local government consultant, depending on who is working in ECOS, performing the Activity, or producing the relevant documentation.

#### References to "core team"

For each EA and EIS, a core team is established prior to the project work plan development process to review the draft EA or EIS on behalf of TxDOT. The core team consists of a district employee and an ENV project delivery employee. These roles cannot be delegated to consultants or any other non-TxDOT employee.

#### References to "WPD I," "WPD II," "WPD III," and "WPD IV"

Throughout this Guide, "WPD I," "WPD II," "WPD III," and "WPD IV" are used to refer to the "WPD Section I – Project Definition," "WPD Section II – Tool," "WPD Section III – Project Work Plan," and "WPD Section IV – Findings" tabs of the "Work Plan Development" console.

#### Relationship of Environmental Guide to Previously Issued Guidance

ENV will be updating previously issued guidance as we move forward to reduce redundancy with this Guide, and remove any instructions that contradict this Guide. In the interim, the instructions in this Guide supersede any contradictory instructions in any previously issued ENV guidance.

#### Submitting drafts of documents to ENV for review

- Where ENV personnel are required to track their reviews of a document in ECOS, these Activity Instructions specifically call for the creation of a Review (i.e., a "Review \_\_\_\_\_\_" Activity) in which case the review activity must be created, and the comments on the document must be uploaded under that review activity according to the review activity instructions.
- In other instances, these Activity Instructions state only that the document is emailed to ENV for
  review without specifically calling for the creation of a review activity (e.g., "District environmental
  staff emails the draft form to the appropriate resource area ENV SME assigned to the respective
  district for review.") In these situations, it is appropriate for district environmental staff to simply
  submit the document to the ENV personnel by email, and for the ENV personnel to return any
  comments by email. <u>These emails and attachments (draft documents, comments, etc.) do not</u>



<u>need to be uploaded to ECOS</u>, unless the Activity Instructions for a particular Activity specifically instruct to upload an email (e.g., the General Counsel Division's email indicating a legal sufficiency determination).

#### Creation of any downstream Activities required prior to finalizing an Activity

Where the Activity Instructions in this Volume 2 call for the creation of one or more downstream Activities (e.g., the Activity Instructions for "Perform Noise Analysis" call for the creation of the "Perform Noise Workshop" Activity under certain conditions), the district environmental staff (or other specified individual) <u>must</u> create those downstream Activities <u>prior</u> to finalizing the original Activity. This will ensure that all needed Activities for the project are created at the appropriate stage of the project, and that the project will not be inadvertently environmentally cleared or LOA-cleared without all "Prior to Env Clearance\*" or "Prior to LOA" Activities having been recorded and completed.

Also, if it is known that a Review or Coordination will be required in connection with a newly created downstream Activity with a default milestone of "Prior to LOA," then it is advisable to go ahead and create that Review (as a placeholder) or Coordination when the downstream Activity is created instead of waiting until later. This will avoid the possibility of later needing to create a "Perform Reevaluation" Activity just to unlock the ability to create a Review or Coordination of that downstream Activity.

## These Activity Instructions do <u>not</u> establish "minimum" documentation requirements; they establish the <u>actual</u> documentation requirements

Throughout this volume, the Activity Instructions for the various Activities call for specific documentation to be created and uploaded (e.g., forms, checklists, tables, reports, etc). ENV SMEs have put a lot of work into determining the appropriate level of documentation for each specific Activity. Do <u>not</u> create or upload additional documentation under any Activity not called-for by the instructions for that Activity, unless dictated by some extenuating circumstances and agreed to by an ENV SME using the "\_\_\_\_\_\_ SME Consultation" Activity. Creation of excess and unnecessary documentation clutters the file, uses valuable storage space, and wastes state resources.

#### List of default milestones

As explained in Section 8.4.2 of Volume 1, each Activity has a default milestone based on when that particular Activity is normally completed in the project development process. There are five possible default milestones:

- Prior to Env Clearance\*
- Prior to LOA
- Prior to Construction
- During Construction
- Post-Construction



The list below specifies the default milestone for each Activity, Review, and Coordination. Note: any Review or Coordination must be finalized prior to finalizing the Activity.

### "Review \_\_\_\_\_ (generic)"

- **1.** The reviewer selects his or her name from the drop-down menu for the field labeled, "Reviewed By."
- 2. The reviewer fills-in the "Document Name" field with the <u>exact</u> file name of the documentation that is being reviewed (suggest using copy and paste). The document(s) that require review will have been identified by the individual who assigned the Review in the "Assignment Details" field of the Review, and uploaded under the same Activity for which the review was assigned. To see which documents have been uploaded under the relevant Activity, the reviewer may click on the "upload" icon next to the Activity on the "Activities" screen.

If the reviewer reviews multiple documents under a single Review, the reviewer fills-in the <u>exact</u> file name of the <u>primary</u> document reviewed, and identifies in the "Comments" field of the Review the exact file name of any additional documents reviewed.

If there is no documentation being reviewed, and the reviewer is only reviewing the information provided in the Activity (e.g., the "Comments" field), then the reviewer fills-in the "Document Name" field with a notation indicating the information being reviewed (e.g., "IIR data for 'LPST #3'").

**3.** The reviewer clicks on the calendar icon next to the "Upload Date" field and selects the date that the documentation that is being reviewed was uploaded to ECOS.

If the reviewer reviews multiple documents under a single Review, the reviewer selects the upload date for the <u>primary</u> document reviewed, and identifies in the "Comments" field of the Review the upload date of any additional documents reviewed.

If there is no documentation being reviewed, and the reviewer is only reviewing the information provided in the Activity (e.g., the "Comments" field), then the reviewer clicks on the calendar icon next to the "Upload Date" field and selects the date that the Activity being reviewed was created.

- **4.** The reviewer reviews the documentation or information provided in the Activity.
- 5. If he or she has comments on the documentation or information provided in the Activity, the reviewer records his or her comments using ENV's Technical Review Comment Response Matrix, and uploads the completed Technical Review Comment Response Matrix under the Review. Alternatively, if the reviewer would rather not use the matrix, the reviewer may record their comments as tracked changes or margin comments in the document that is being reviewed and upload it (however note that for EAs and EISs this approach is not available because a master comment/response matrix for multiple reviewers of the same document will be prepared).

If the reviewer has only very minimal comments on a document or an Activity (e.g., no more than a couple lines of text), he or she may record the comments in the "Comments" field of the Review instead of using **ENV's Technical Review Comment Response Matrix** (or recording their comments as tracked changes or margin comments in the document).



- **6.** The reviewer selects one of the following drop-down responses under the "Review Results" field in this Review:
  - "Approved no comments"
  - "Approved with comments"
  - "Not Approved"

Select "Approved with comments" in the following situations:

- The reviewer has some minor and/or straightforward comments that should be addressed in a revised version of the deliverable that should be uploaded to ECOS, but there is no need to assign an additional Review to back-check the revised version because the comments were so minor and/or straightforward.
- There are errors, inconsistencies, or other quality-related issues with the deliverable, but in the reviewer's opinion, there is no need to prepare a revised version of the deliverable and upload it to ECOS because, despite the errors, inconsistencies, or other quality-related issues, the deliverable adequately serves its purpose and so does not need to be re-done.

It is important that the reviewer explain in the "Comments" field of the Review which of these two scenarios applies.

- **7.** The reviewer finalizes this Review, and emails the individual who assigned the Review to let him or her know that the Review has been finalized.
- 8. Important note regarding due dates: Due dates are now required. Make sure that a due date is indicated in the "Assignment Details" for the Review. For many types of Reviews, the due date should be two weeks from the date the Review is assigned, although for some specific Reviews, the due date should be later see the estimated times for completing different kinds of Reviews in Chapter 9 of Environmental Guide, Volume 1. <u>Do not assign a Review with a due date that is less than the estimated time indicated in Chapter 9 without the ENV reviewer's prior approval.</u>

It is important that the reviewer completes their Review by the specified due date. If it will not be possible to complete the Review by the due date, reach out to the district environmental staff who assigned the Review to discuss changing the due date. District environmental staff must update the "Due Date" field in the "Assignment Details" section of the Review with any agreed upon new due date. It is important that these steps be followed as the due dates and ENV's completion of reviews in accordance with due dates will be reported to TP&Ds for informational purposes.





### "Coordinate \_\_\_\_\_ (generic)"

- **1.** "Associated Activity" This field is auto-filled with the associated Activity name (e.g., "Obtain Hot Spot Project of Air Quality Concern (POAQC) Determination").
- 2. "Agency Name" This field may be auto-filled with the name of the entity with which the Activity is being coordinated, (e.g., "Consultation Partners"), or the user may need to select the name of the entity with which the Activity is being coordinated from a drop-down menu.

If an Activity is being coordinated with multiple agencies, the user must create multiple Coordinations, as only one Agency Name may be entered per Coordination.

- **3.** "Coordination Status" This field is auto-filled with "Initiated" when this Coordination is created (district environmental staff or ENV SME will have to change this status prior to closing this Coordination as explained below).
- **4.** "Are Correspondence Details Included?" District environmental staff or ENV SME only selects "yes" if there is a desire to separately record each individual correspondence (including the status, method, date, and sender and recipient) as a separate line item in a table within the Coordination. Otherwise, district environmental staff or ENV SME selects "no."

If "yes" is selected, then for each individual correspondence, district environmental staff or ENV SME completes the following:

- "Correspondence Status" Select the appropriate status.
- "Correspondence Method" Select method.
- "Correspondence Date" For correspondence by TxDOT, fill-in the date the correspondence was sent. For correspondence received by TxDOT, fill-in the date the correspondence received by TxDOT.
- "Correspondence From" Fill-in the name of the entity.
- "Correspondence To" Fill-in the name of the entity, or for instances in which TxDOT sent the same correspondence to multiple entities on the same date, fill-in a notation indicating that the correspondence was sent to a group of entities.
- Click "Add."
- Click "Save."

The next correspondence cannot be added until the previous one has been added and the user has clicked "Save."

Note that for some Coordinations this field will be auto-filled with "yes," and tracking Correspondence Details is required.

5. District environmental staff or ENV SME uploads the correspondence under this Coordination.



- 6. Once the entire coordination is complete (which may include multiple rounds or correspondence), district environmental staff or ENV SME updates the "Coordination Status" to either "Completed" or, if the coordination has resulted in the need for conditions that need to be met such as monitoring or mitigation commitments, "Completed with conditions," and finalizes this Coordination.
- 7. If it is ever determined that this Coordination is not necessary or will not be completed for any reason, then district environmental staff or ENV SME changes the "Coordination Status" to "Rescinded," and finalizes this Coordination (DO NOT DELETE THIS COORDINATION).



### "Air SME Consultation" Activity

- **1.** District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of air quality.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding air quality, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding air quality.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.



### "Obtain Hot Spot Project of Air Quality Concern (POAQC) Determination" Activity

- District environmental staff completes ENV's Project of Local Air Quality Concern (POAQC) Decision Form and assembles the required attachments, and uploads the form and attachments under this Activity.
- 2. District environmental staff creates a Review of this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the Decision Form Project of Local Air Quality Concern (POAQC) that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 3. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff contacts the local MPO and requests that they schedule a conference call with the Consultation Partners: TxDOT, FHWA, EPA, TCEQ, the MPO, and for any area that borders another state, the state DOT from that other state (e.g., NMDOT in El Paso). The conference call is typically conducted via Microsoft Teams.

#### Coordination process

District environmental staff creates a Coordination under this Activity, and uploads all of the following documentation under the Coordination:

- Correspondence with the Consultation Partners
- Meeting minutes from the Consultation Partners conference call
- Determinations from EPA, FHWA, TCEQ, TxDOT, and any other state DOT from a bordering state (if applicable) as to whether the project is a POAQC (may be incorporated into the meeting minutes or submitted in follow-up email correspondence). Note that the MPO is not listed here as issuing a determination because technically the MPO is raising the question to the other Consultation Partners.

Follow the steps below to conduct the coordination.

**4.** After the conference call with the Consultation Partners has been scheduled, the district environmental staff provides the POAQC Decision Form and attachments to the Consultation Partners, and uploads the correspondence with the Consultation Partners under the <u>Coordination</u>.



- **5.** District environmental staff conducts the conference call and prepares meeting minutes for the Consultation Partners conference call, which must include a request for a Consultation Partner determination as to whether this is a project of air quality concern.
- 6. District environmental staff distributes the meeting minutes to each Consultation Partner for comments and corrections, and uploads the correspondence with the Consultation Partners and the final meeting minutes (with the word, "Approved," at the beginning of the file name) under the <u>Coordination</u>. If the determination was made on the call, the final meeting minutes must include a determination of whether this is a project of air quality concern. Otherwise email documentation from EPA, FHWA, TCEQ, TxDOT, and any other state DOT from a bordering state (if applicable) of their POAQC determination will need to be obtained and uploaded under the <u>Coordination</u>. Note that the MPO is not listed here as issuing a determination because technically the MPO is raising the question to the other Consultation Partners.
- **7.** If all the Consultation Partners' determination is that this <u>is not</u> a project of air quality concern, then proceed as follows.
  - District environmental staff must inform the public of the Consultation Partners' determination as part of the public involvement conducted for the environmental review of the project by including customizing the following statement and including it in any notice of public meeting, notice affording an opportunity for public hearing, or notice of public hearing for the project:

"The project is located within a <PM10 non-attainment area/CO maintenance area>; therefore, the conformity consultation process was conducted. On <insert date of hot-spot decision>, the conformity Consultation Partners made the determination that the proposed project is not a PM project of air quality concern and that a hot-spot analysis is not required."

- District environmental staff addresses, in writing, any conformity-related comments received from the public, shares the comments and responses with the Consultation Partners, and uploads the transmittals to and from the Consultation Partners under the <u>Coordination</u>.
- District environmental staff finalizes the Coordination and this Activity.
- If an EA or EIS is being prepared for the project, then district environmental staff prepares a statement indicating that this <u>is not</u> a project of air quality concern using ENV's Guidance for Preparing Air Quality Statements, and includes it in the appropriate section of the EA or EIS.
- 8. If the Consultation Partners' determination is that this <u>is</u> a project of air quality concern, then the district environmental staff finalizes the Coordination and this Activity, and creates the "Perform Hot Spot Analysis" Activity.

### "Obtain Project Level Conformity Determination" Activity

- **1.** If the project falls within the boundaries of an MPO, district environmental staff ensures the following:<sup>1</sup>
  - all of the project phases for the entire project as described in the "Environmental Clearance Project Description" on WPD I in ECOS are included in the fiscally constrained portion of the MTP;<sup>2</sup>
  - at least one project phase beyond the NEPA study is included in either the appropriate year of the conforming TIP or in Appendix D (if it will not be let within the timeframe of the TIP);
  - the current project limits are the same or fall within the project limits listed in (1) the MTP and (2) the FHWA-approved STIP or in Appendix D (if it will not be let within the timeframe of the TIP);
  - the activity being proposed is the same as that in the MTP and STIP (or Appendix D) project description in both: (1) type of facility<sup>3</sup> and (2) number of lanes;
  - unless the project is identified in the MTP as non-regionally significant, the project's ETC year falls between its identified conformity year in the MTP and the previous conformity year identified in the MTP;
  - that for projects with an estimated total project cost greater than \$1,500,000, the estimated total project cost does not exceed what is contained in the MTP by more than 50%; and
  - either 1) hot-spot conformity requirements do not apply (i.e., applicable to all areas outside of El Paso); 2) the consultation partners determined that a hot-spot analysis was not necessary; or 3) a hot-spot analysis demonstrates that the project will not cause, contribute to, or worsen a violation of the applicable NAAQS (including applicable written commitments to mitigation and SIP control measures, if any).
- 2. After district environmental staff confirms all of the above, then district environmental staff completes **ENV's Transportation Conformity Report form** with all required attachments.
- 3. Approximately 60 days prior to the anticipated environmental clearance, the district environmental staff uploads the Transportation Conformity Report form with all required attachments under this Activity, creates a Review of the Transportation Conformity Report form under this Activity, and assigns it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery

staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:

- prepares a new, revised version of the Transportation Conformity Report form that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **4.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, the ENV SME signs the Transportation Conformity Report form.

#### Finalization of Activity for a state project

- **5.** For a state project, the ENV SME uploads the signed Transportation Conformity Report form with the word, "Approved," at the beginning of the file name under this Activity, and finalizes this Activity.
- 6. If an EA or EIS is being prepared for the project, then district environmental staff prepares the appropriate customized statement regarding transportation conformity using ENV's Guidance for Preparing Air Quality Statements, and includes it in the appropriate section of any EA or EIS submittals.

#### Coordination process for an FHWA project

If the project is an FHWA project, the ENV SME creates a Coordination under this Activity, and uploads all of the following documentation under the Coordination:

- Correspondence with FHWA
- FHWA-signed Transportation Conformity Report form

Follow the steps below to conduct the coordination.

- **5.** ENV SME submits the Transportation Conformity Report form to FHWA for signature.
- **6.** After FHWA has signed the Transportation Conformity Report form, the ENV SME uploads the fully executed Transportation Conformity Report form and all attachments with the word, "Approved," at the beginning of the file name under the <u>Coordination</u>, and finalizes both the Coordination and this Activity.
- 7. If an EA or EIS is being prepared for the project, then district environmental staff prepares the appropriate customized statement regarding transportation conformity using ENV's Guidance for Preparing Air Quality Statements, and includes it in the appropriate section of any EA or EIS submittals.

### "Perform Air Monitoring Commitments" Activity

- **1.** District environmental staff fills-in the "Comments" field with an explanation of any air quality commitments for the project.
- **2.** District environmental staff uploads any documentation associated with air quality commitments for the project under this Activity.
- **3.** After all air quality commitments for the project have been completed, district environmental staff finalizes this Activity.



### "Perform Carbon Monoxide Traffic Air Quality Analysis (CO TAQA)" Activity

1. District environmental staff identifies applicable receptor locations for the TAQA.

- Use project-specific traffic data to identify the sections of each build alternative that contain the highest AADT.
- Use project schematics to identify the areas of these high AADT sections that contain the narrowest right-of-way (ROW). Place a receptor on the ROW line at these locations.
- Determine whether the project will contain major signalized intersections. If so, follow the EPA Guideline for Modeling Carbon Monoxide from Roadway Intersections to identify appropriate receptor locations.
- **2.** District environmental staff obtains the applicable CO emission rates.
  - Consult **ENV's Emission Rates Lookup Table (ERLT) for TAQA** and determine whether it contains CO emission rates for the TxDOT district in which this project resides. If so, use the emission rates provided in that table. If not, develop the applicable CO emission rates using the MOVES emission factor model.
- **3.** District environmental staff develops the TAQA results.
  - Calculate the design hour volume (DHV) traffic for each project segment by multiplying the segment's AADT by the K-factor. The AADT and K-factor can be obtained from project-specific traffic analyses.
  - Perform the dispersion modeling using EPA's CAL3QHC dispersion model for the ETC and design year for each alternative using:
    - the parameters for a worst-case scenario in Appendix A of this 1-pager, "CAL3QHC Parameters;"
    - the 1-hr CO background concentrations in Appendix B of this 1-pager, "Background CO Concentrations & CO NAAQS;"
    - the receptor locations identified in Step 1 above; and
    - the emission rates identified in Step 2 above.

The result will be the 1-hr CO concentrations.

- Develop the 8-hr CO concentrations for each receptor by using the formula in Appendix C of this 1-pager, "Converting the One-Hour CO Standard to the Eight-Hour CO Standard."
- **4.** District environmental staff analyzes the modeling results.
  - Determine whether the 1-hr CO concentrations at each receptor are less than the 1-hr CO NAAQS (Appendix B of this 1-pager), and the 8-hr CO concentrations at each receptor are less than the 8-hour CO NAAQS (Appendix B of this 1-pager).
  - If modeled results exceed the 1-hr or 8-hr CO NAAQS, consult with the ENV air specialist to determine whether there was a flaw in the analysis.

- If modeled results exceed either the 1-hr or 8-hr CO NAAQS, and there was no flaw in the analysis, consult with the ENV air specialist on how to proceed.<sup>1</sup>
- District environmental staff documents the CO TAQA in an individual document uploaded under this Activity. The documentation of the CO TAQA must include all information listed in ENV's Documentation Standard for a CO TAQA Technical Report.
- 6. District environmental staff creates a Review of this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the CO TAQA technical report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 7. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, the district environmental staff uploads the final CO TAQA technical report with the word, "Approved," at the beginning of the file name, and finalizes this Activity.
- 8. If an EA or EIS is being prepared for the project, then district environmental staff prepares a summary of the CO TAQA to be included in the appropriate section of the EA or EIS using the standardized language provided in ENV's Guidance for Preparing Air Quality Statements.

It is recommended that the same person or persons who prepared the CO TAQA technical report prepare the summary of the CO TAQA to be included in the EA or EIS.

#### **Appendix A: CAL3QHC Parameters**

A worst-case analysis is used to demonstrate that standards will not be exceeded under the worst possible conditions. To help create the worst-case scenario, the CAL3QHC model uses the following variables:

**Roadway:** The CAL3QHC model is limited to a maximum of 120 roadway links. A roadway link is defined as a straight segment of roadway having a constant height, width, traffic volume, and emission factor. The links are defined by the coordinates of their start and end points and should be established to reflect orientation to true north.

**Free-flow Receptor Siting:** Receptors should be located on the right-of-way line adjacent to the roadway segments with the highest traffic volume at the narrowest portion of the project right-of-way. Receptor should be located outside of the mixing zone (discussed below). If the receptor is located within a mixing zone, consider altering the mixing zone so that the receptor remains outside of the mixing zone. CAL3QHC can accommodate a maximum of 60 receptors.

**Averaging Time:** Averaging time can range from 30 minutes to 60 minutes. Since most predictions are performed for a one hour period, use 60 minutes in the CAL3QHC models.

**Surface Roughness:** Surface roughness coefficients range between 3 to 400 centimeters. Table 1 of the CAL3QHC User's Guide provides surface roughness coefficients for a variety of surface types and land uses. If land use is mixed, use the smaller roughness coefficient for the worst-case analysis.

**Settling and Deposition Velocities:** Both settling and deposition velocities should be entered as 0 cm/sec.

**Scale Factor:** The scale conversion factor entered in the CAL3QHC models should be 0.3048 if the model units are in feet, or 1.0 if the units are in meters.

**Receptor Height:** Receptor height should be set at an assumed breathing height of 5.9 if coordinates are in feet, or 1.8 if coordinates are input in meters.

**Traffic Volume:** Use Design Hour Volume (DHV), or peak hour traffic volumes, for a given segment of roadway. The DHV is calculated by multiplying the AADT of the segment by the project-specific K Factors. The AADT and K Factor can be obtained from project-specific traffic analyses. The DHV is then divided by the number of travel lanes used in the CAL3QHC model. The DHV can be developed by using Transportation Research Board Special Report 209 (Highway Capacity Manual).

**CO Emission Factors:** A CO ERLT is included in the Air Quality toolkit. The look-up tables provide estimated CO emissions by area, year, speed, and roadway type. Use of the CO look-up tables could prevent the need for performing MOVES modeling; however, if MOVES CO results and the CO emissions tables are both available, use the higher value of the two emission factors in the dispersion model for the worst-case analysis. The emission factor is expressed in grams/mile.

**Source Height:** Source height refers to the elevation of the roadway relative to the receptors. For atgrade roadways, the source height will be zero (at grade). For elevated and depressed roadway links, the elevation should reflect the elevation relative to the receptors. In CAL3QHC, the source height should not be greater than +10 meters (+32 feet) for an elevated roadway section, or lower than -10 meters (-32 feet) for a depressed roadway section. If the receptors are higher or lower than these limits, use +10 or - 10 meters (+32 or -32 feet).

**Mixing Zone Width:** The mixing zone width represents the width of the CO plume that has been generated by the vehicles and dispersed by their wake, and is considered to be uniform in regard to emissions and turbulence. The mixing zone width should equal the width of the travel lanes (without shoulders) plus 3 meters (or 10 feet) on each of the outside travel lanes.

Wind Speed: A wind speed of one meter per second should be used for a worst-case analysis.

Wind Angle: Evaluate wind at 10 degree increments as recommended by the CAL3QHC User's Guide. Wind angle is represented in degrees from north (i.e., 00 is equivalent to a wind from the north).

**Atmospheric Stability Class:** Values of one to six, representing atmospheric stability classes A-F, respectively, can be used in the CAL3QHC model. For worst-case analysis, use Stability Class 4 for urban areas or Stability Class 5 for rural areas.

Mixing Height: A mixing height of 1000 meters should be used.

Background CO Concentration: Refer to Appendix B.

#### Additional CAL3QHC Intersection Modeling Parameters

Additional parameters and considerations required for CAL3QHC intersection modeling are discussed below.

**Roadway and Intersection:** A roadway link is defined as a straight segment of roadway having a constant height, width, traffic volume, and emission factor. The links are defined by the coordinates of their start and end points and should be established to reflect orientation to true north. Roadway links in the CAL3QHC model are defined as either (1) Free-flow links or (2) Queue links.

**Mixing Zone Width:** In CAL3QHC, the mixing zone width should equal the width of the free-flow travel lanes (without shoulders) plus 3 meters (or 10 feet) on each of the outside travel lanes. For roadway links defined as queue links, the mixing zone is equal to the width of the travel lane.

**Intersection Receptor Siting:** Receptors should be located 3 meters from the outside edge of the roadway at distances of 3 meters, 25 meters, 50 meters, and mid-block from the outside edge of the intersection cross-street. CAL3QHC can accommodate up to 60 receptors.

**Queue Link Information:** CAL3QHC requires the following information for each roadway modeled as a Queue Link:

Average Signal Cycle Length (in seconds);

Average Red Time Length (in seconds);

Clearance Time Lost (Yellow Light), use 2 seconds if the clearance time is unknown;

Saturation Flow Rate, the saturation flow rate is the hourly capacity for each roadway queue link expressed in vehicles per hour. Use 1,600 veh/hr if rate is not specified.

Signal Type, the signal type can be specified as (1) Pretimed, (2) Actuated, or (3) Semiactuated. If the signal type is not specified, CAL3QHC will assume the signal type is (1) Pretimed; and

Arrival Rate, CAL3QHC has five options for arrival type, (1) Worst, (2) Below Average, (3) Average, (4) Above Average, or (5) Best Progression. Enter an arrival rate of (3) Average for a default value.

**Intersection Emission Factors:** A *CO ERLT* is included in the Air Quality toolkit, which in conjunction with the associated document, *Useful Information: CO TAQA ERLT*, can be used to identify idling emission factors. In addition, when looking up applicable emission factors for free-flow traffic through intersections use the default speeds identified in Table 4-2 of the EPA's 1992 guidance document titled, *Guideline for Modeling Carbon Monoxide from Roadway Intersections*.

Estimates of CO Background Concentrations for Texas Cities and Rural Areas

#### Appendix C: Converting the One-Hour CO Standard to the Eight-Hour CO Standard

Modeling results from the CAL3QHC model are in one-hour CO concentrations and are compared to the one-hour NAAQS standard for CO. The eight-hour CO concentration is calculated using the one-hour CO concentration and a persistence factor, and then adding in the appropriate background CO concentration provided in Appendix B. The following formula can be used to convert the one hour results to eight-hour results:

CO8 = (CO1 - BG1) 0.7 + BG8

where:

CO8 = Eight-hour CO concentration

CO1 = One-hour CO concentration

BG1 = One-hour background CO concentration (Appendix B)

0.7 = Persistence factor (meteorology and traffic)

BG8 = Eight-hour background CO concentration (Appendix B)



### "Perform Congestion Management Process (CMP) Analysis" Activity

- **1.** District environmental staff identifies the Metropolitan Planning Organization (MPO) where the project is located.
- **2.** District environmental staff identifies date of adoption and latest amendment date of the MPO's Congestion Management Process (CMP).
- **3.** District environmental staff determines whether the project is included in the MPO's CMP.

If so, proceed to step 4.

If not, district environmental staff requests that the MPO determine whether the project should be incorporated into the MPO's CMP. If the project should be incorporated into the MPO's CMP, district environmental staff follows the MPO procedures for evaluating congestion within the corridor. If the project need not be incorporated into the MPO's CMP, district environmental staff requests that the MPO provide a waiver for the project indicating why it is not appropriate for this project to be included in the CMP.

District environmental staff cannot complete this Activity unless the project is included in the MPO's CMP, or the MPO has provided a waiver. If a waiver has been obtained from the MPO, proceed to step 7. Otherwise, proceed to step 4.

- **4.** District environmental staff follows the established process of the local MPO or collaborates with the MPO to identify other operational improvements, if any, within the project corridor.
- **5.** District environmental staff follows the established process of the local MPO or collaborates with the MPO to identify any reasonable travel demand reduction and operational management strategies that should be committed to for the project.
- **6.** District environmental staff identifies the committed congestion reduction strategies for this project (e.g., signal timing, intersection improvements, pedestrian facilities, etc.).
- District environmental staff either documents a waiver of CMP requirements or provides results of the CMP analysis by customizing the appropriate statement(s) from ENV's Guidance for Preparing Air Quality Statements.
- **8.** District environmental staff uploads the waiver of CMP requirements or the customized statement(s) (with any attachments) under this Activity.
- 9. District environmental staff may, at its discretion, create a Review of the customized statement(s) (with any attachments) under this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district. If district environmental staff elects to create an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV



SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:

- prepares a new, revised version of the customized statement(s) (with any attachments) that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **10.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if a Review was created), district environmental staff uploads the final customized statement(s) (with any attachments) with the word, "Approved," at the beginning of the file name, and finalizes this Activity.
- **11.** If an EA or EIS is being prepared for the project, then district environmental staff includes the customized statement(s) in the appropriate section of the EA or EIS.

### "Perform Hot Spot Analysis" Activity

- **1.** District environmental staff prepares a draft methodology for performing a hot spot analysis in compliance with the latest available versions of the following EPA guidance documents, as applicable:
  - Transportation Conformity Guidance for Quantitative Hot-Spot Analyses in PM2.5 and PM10 Nonattainment and Maintenance Areas
  - Using MOVES in Project-Level Carbon Monoxide Analyses
- 2. District environmental staff completes ENV's Hot Spot Pre-Analysis Consensus form and uploads the form under this Activity.
- 3. District environmental staff creates a Review of this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of **ENV's Hot Spot Pre-Analysis Consensus form** that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **4.** Once the ENV SME has no further comments (and ENV Project Delivery staff, if applicable) and has finalized his or her Review, the district environmental staff contacts the local MPO and requests that they schedule a conference call with the Consultation Partners (TxDOT District, ENV, FHWA, EPA, TCEQ, and MPO).

#### Coordination process for hot spot pre-analysis consensus form

District environmental staff creates a Coordination under this Activity, and uploads all of the following documentation under the Coordination:

- Correspondence with the Consultation Partners
- Meeting minutes from the Consultation Partners conference call

Follow the steps below to conduct the coordination.

- **5.** After the conference call with the Consultation Partners has been scheduled, the district environmental staff provides the Hot Spot Pre-Analysis Consensus form to the Consultation Partners, and uploads the correspondence with the Consultation Partners under the <u>Coordination</u>.
- **6.** District environmental staff conducts the conference call and prepares meeting minutes for the Consultation Partners conference call, which must include getting approval for the following items:



- the overall methodology for the hot spot analysis,
- the future years to be analyzed,
- the methodology for identifying applicable background concentrations,
- the models to be used,
- additional point-sources that should be included in the analysis,
- applicable receptor locations,
- sources for the input data to be used in the modeling, and
- identification of any State Implementation Plan (SIP) mitigation measures that this project is required to incorporate.
- 7. District environmental staff distributes the meeting minutes to each Consultation Partner for comments and corrections, and uploads the correspondence with the Consultation Partners and the final meeting minutes (with the word, "Approved," at the beginning of the file name) under the <u>Coordination</u>.

#### Conducting hot spot modeling

- **8.** In accordance with the methodology approved by the Consultation Partners, the district environmental staff models the future year emissions associated with the build alternative,<sup>1</sup> and determines if the modeled emissions exceed the NAAQS for the applicable pollutant.
  - If modeled emissions for the build alternative do not exceed the NAAQS, then the analysis is complete.
  - If modeled emissions for the build alternative exceed the NAAQS, the district environmental staff models the future year emissions associated with the no-build alternative, and determines whether the modeled emissions for the build alternative exceed the modeled emissions for the no-build alternative in the future years modeled. If the modeled emissions for the build alternative are less than the modeled emissions for the no-build alternative, then the analysis is complete.
  - If modeled emissions for the build alternative exceed both the NAAQS and the modeled emissions for the no-build alternative, then the district environmental staff identifies mitigation measures or project design changes that can reduce the applicable pollutant emissions and quantifies and re-models until modeled emissions for the build alternative are lower than either the NAAQS or the no-build alternative, in which case the analysis is complete.
- 9. After the analysis is complete, district environmental staff prepares a technical report in accordance with ENV's Documentation Standard for a Hot Spot Analysis Technical Report, and uploads it under this Activity. Ensure that any mitigation measures or project design changes accounted for in the modeling are identified in the mitigation commitments in the technical report.
- 10. District environmental staff creates a new Review of the hot spot analysis technical report under this Activity and assigns it to the ENV SME. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:

- prepares a new, revised version of the hot spot analysis technical report that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).

#### Coordination process for hot spot analysis technical report

Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, the district environmental staff creates a Coordination under this Activity, and uploads all of the following documentation under the Coordination:

- Correspondence with the Consultation Partners
- Correspondence with FHWA

Follow the steps below to conduct the coordination.

- **11.** District environmental staff provides the hot spot analysis technical report to the Consultation Partners for review, and uploads the correspondence with the Consultation Partners under the <u>Coordination</u>.
- **12.** After any comments made by the Consultation Partners have been addressed, at least 60 days prior to the public involvement conducted for the environmental review of the project, the district environmental staff provides the hot spot analysis technical report to FHWA for final approval, and uploads the correspondence with FHWA under the <u>Coordination</u>.
- **13.** After FHWA has approved the hot spot analysis technical report, the district environmental staff uploads the final report under this <u>Activity</u> with the word, "Approved," at the beginning of the file name, and, if there any related mitigation commitments, creates the "Perform Air Quality Commitments" Activity.
- 14. If an EA or EIS is being prepared for the project, then district environmental staff prepares a summary of the hot spot analysis to be included in the appropriate section of the EA or EIS using the standardized language provided in ENV's Guidance for Preparing Air Quality Statements.

It is recommended that the same person or persons who prepared the hot spot analysis technical report prepare the summary of the hot spot analysis to be included in the EA or EIS.

**15.** District environmental staff must inform the public of the hot spot analysis as part of the public involvement conducted for the environmental review of the project by customizing the following statement and including it in any notice of public meeting, notice affording an opportunity for public hearing, or notice of public hearing for the project.

"The project is located within a <PM10 non-attainment area/CO maintenance area>; therefore, the conformity consultation process was conducted. On <insert date of hot-spot decision>, the conformity Consultation Partners made the determination that a hot-spot analysis is required. The hot-spot analysis is available for public review."



- **16.** District environmental staff addresses, in writing, any conformity-related comments received from the public, shares the comments and responses with the Consultation Partners, and uploads the transmittals to and from the Consultation Partners under the <u>Coordination</u>.
- **17.** District environmental staff finalizes the Coordination and this Activity.

### "Perform Mobile Source Air Toxics (MSAT) Analysis" Activity

- **1.** District environmental staff determines if <u>any</u> of the following conditions apply:
  - the project affects a major intermodal facility or port which may be a large generator of diesel traffic;
  - public concern has been raised regarding MSAT emissions associated with the project; or
  - the project adds capacity<sup>1</sup> and is an FHWA/FTA project, and has an AADT<sup>2</sup> of greater than 140,000 vpd.

If <u>any</u> of the above conditions apply, and if the project is located in proximity to populated areas, then district environmental staff must obtain the base<sup>3</sup> and design year<sup>4</sup> NEPA traffic data<sup>5</sup> for both the build and the no-build alternatives. Then conduct an MSAT conference call to determine whether a qualitative or quantitative MSAT analysis will be required.

If <u>none</u> of the above conditions above apply, then there is no need for an MSAT conference call, and the district environmental staff performs a qualitative MSAT analysis.

#### MSAT conference call

- **2.** District environmental staff obtains the following:
  - project description
  - document type
  - aerial map identifying the project
  - any available schematics
  - build and no-build base and design year traffic data
- **3.** District environmental staff arranges the MSAT conference call with the following participants, and provides them with the information listed above:
  - ENV air specialist
  - TxDOT district traffic expert TxDOT
  - TxDOT district environmental coordinator
  - TxDOT district project manager

- contractor responsible for preparing the MSAT analysis
- **4.** District environmental staff leads and takes minutes for the MSAT conference call, covering the following topics:
  - reason for initiating the MSAT conference call (i.e., which of the conditions listed above applies to the project)
  - brief project description
  - determination about whether project will require a quantitative or qualitative MSAT analysis

If it is determined that the project will require a quantitative MSAT analysis, also cover the following topics:

- What NEPA traffic data is available
- Whether the traffic data includes both build and no-build alternatives
- Whether the traffic data includes a study area or corridor that is larger than just the links of the project
- Obtaining vehicle miles travelled (VMT) breakdowns for various timeframes (peak and off-peak hours at a minimum)
- Obtaining congested speeds for each timeframe (peak and off-peak hours at a minimum)
- anticipated environmental approval date
- estimated time of completion ("ETC") year
- appropriate base year and design year to analyze in the MSAT analysis
- whether an interim year<sup>6</sup> is recommended for this project
- methodology for determining the affected network<sup>7</sup>
- emissions model that will be used
- identification of whether MSAT emission rate tables are available or, if not, identification of appropriate methodology for the environmental consultant to use in developing the emission rates
- **5.** District environmental staff distributes draft meeting minutes to participants for comments and corrections.
- **6.** District environmental staff uploads the final meeting minutes under this Activity with the word, "Approved," at the beginning of the file name.
- **7.** District environmental staff performs either a quantitative or qualitative MSAT analysis, depending on the outcome of the MSAT conference call.

#### Quantitative MSAT Analysis

- 8. District environmental staff consults ENV's Emission Rates Lookup Table (ERLT) for MSAT. If it contains MSAT emission rates for the relevant TxDOT district, use those rates.<sup>8</sup> If not, develop applicable emission rates for each priority MSAT using the MOVES emission factor model.
- **9.** District environmental staff conducts quantitative MSAT analysis by completing the following:
  - Develop an affected network for the base, interim,<sup>9</sup> and design years using the methodology established in the MSAT conference call minutes.<sup>10</sup>
  - For each of the affected networks, multiply the applicable emission rates for each priority MSAT by the VMT for each time period for each network link. Aggregate the results to determine the total emissions for each priority MSAT for each network link.
  - For each of the affected networks, aggregate the VMT for each of the affected network links to determine the total VMT.
  - For each of the affected networks, aggregate the VMT for each of the affected network links to determine the total MSAT emissions.
- **10.** District environmental staff analyzes the modeling results by completing the following:
  - Determine whether the total MSAT emissions in the future years analyzed are less than the total MSAT emissions in the base year.
  - If the total MSAT emissions in the future years analyzed are more than the total MSAT emissions in the base year, consult with the ENV air specialist to determine if there was a flaw in the analysis.
  - If the total MSAT emissions in the future years analyzed are more than the total MSAT emissions in the base year, and there was no flaw in the analysis, consult with the ENV air specialist on how to proceed.
- **11.** District environmental staff documents the quantitative MSAT analysis in an individual document uploaded under this Activity. The documentation of the quantitative MSAT analysis must include all information listed in **ENV's Documentation Standard for a Quantitative MSAT Technical Report**.
- 12. District environmental staff creates a Review of the quantitative MSAT technical report under this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the quantitative MSAT technical report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and

- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **13.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff uploads the final quantitative MSAT technical report with the word, "Approved," at the beginning of the file name, and finalizes this Activity.
- 14. If an EA or EIS is being prepared for the project, then district environmental staff prepares a summary of the quantitative MSAT analysis to be included in the appropriate section of the EA or EIS. The summary must contain the required elements set forth in ENV's Guidance for Preparing Air Quality Statements.

It is recommended that the same person or persons who prepared the quantitative MSAT technical report prepare the summary of the quantitative MSAT analysis to be included in the EA or EIS.

#### Qualitative MSAT Analysis

- 8. District environmental staff prepares a customized qualitative MSAT analysis statement using ENV's Guidance for Preparing Air Quality Statements.
- **9.** District environmental staff uploads the customized qualitative MSAT analysis statement under this Activity.
- 10. District environmental staff may, at its discretion, create a Review of the customized qualitative MSAT analysis statement under this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the customized qualitative MSAT analysis statement that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **11.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff uploads the final qualitative MSAT analysis statement with the word, "Approved," at the beginning of the file name, and finalizes this Activity.
- **12.** If an EA or EIS is being prepared for the project, district environmental staff includes the customized qualitative MSAT analysis statement in the appropriate section of the EA or EIS.

# "Archeology SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of archeology. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding archeology, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding archeology.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.



# "Develop or Manage Work Authorization" Activity

This Activity may be used by an ENV SME to track the development of a work authorization for a complicated project.

- **1.** The ENV SME self-assigns the Activity.
- 2. The ENV SME describes the WA in the "Comments" field.
- **3.** The ENV SME completes the associated work authorization and finalizes the Activity.



# "Obtain Archeology Section 106/Antiquities Code of Texas (ACT) Approval" Activity

- 1. For (1) projects where TxDOT is the official project sponsor and (2) FHWA projects where a local government is the <u>official</u> project sponsor, the ENV SME confirms:
  - that the "Perform Archeology Background Study" Activity has been finalized,
  - that any necessary downstream Activities that can be finalized prior to environmental clearance have been created and finalized, and
  - that any downstream Activities that cannot be finalized until after environmental clearance have been created.

For non-FHWA projects where a local government is the <u>official</u> project sponsor, the local government sponsor instead proceeds as follows:

- If the project will <u>not</u> involve five or more acres of ground disturbance; will <u>not</u> involve more than 5,000 cubic yards of earth moving; will <u>not</u> occur in historic district or other designated historic site; and will <u>not</u> affect a recorded archeological site, then the local government project sponsor provides an explanation to that effect in the "Comments" field of this Activity, and finalizes this Activity (see Texas Antiquities Code 191.0525(d)).
- If the project <u>will</u> involve five or more acres of ground disturbance; <u>will</u> involve more than 5,000 cubic yards of earth moving; <u>will</u> occur in historic district or other designated historic site; or <u>will</u> affect a recorded archeological site, then the local government project sponsor uploads under this Activity any documentation demonstrating Antiquities Code compliance (and if the project requires a federal permit, Section 106 compliance), and notifies the ENV SME that this documentation has been uploaded.
- 2. If any commitments apply to the project, then the ENV SME confirms that the appropriate Activities have been created using the applicable milestones. This step is not required for non-FHWA projects with a local government sponsor.
- **3.** The ENV SME makes the overall effect determination for the entire project based on the outcomes of all the finalized archeology Activities, or for a non-FHWA project with a local government project sponsor, the documentation uploaded by the local government project sponsor.

The overall determination must be one of the following:

- "No historic properties affected" This means the project will not affect <u>any</u> archeological historic property. Typically, we reach this finding when no archeological historic properties occur within the project's area of potential effects.
- "PA/MOU compliant need access" This means the project is covered by Stipulation XI.E of the Programmatic Agreement among the Federal Highway Administration, the Texas Department of Transportation, the Texas State Historic Preservation Officer, and the Advisory Council on Historic Preservation Regarding the Implementation of Transportation Undertakings. This stipulation allows TxDOT to proceed with project approval in cases where access to



private property was denied, preventing the completion of necessary studies and associated consultation. If this finding has been selected, then the ENV SME must create the Activities to be completed, using the milestone "Prior to Construction."

"No adverse effect"
 This means there will be <u>no</u> adverse effect to <u>any</u> archeological historic property. In rare cases, the ENV SME must create any additional Activities to be completed to ensure the "no adverse effect" finding, using the appropriate milestones (this is not required for a non-FHWA project with a local government project sponsor).

- "Adverse effect"
   This means there <u>will</u> be an adverse effect to <u>at least one</u> archeological historic property.
   If this finding has been selected, then the ENV SME must create the Activities to be completed to resolve the adverse effects, using the appropriate milestones (this is not required for a non-FHWA project with a local government project sponsor).
- **4.** In the field labeled "Determination of Effect," the ENV SME selects the appropriate choice from the drop-down menu. The four choices for this field are:
  - "No historic properties affected"
  - "PA/MOU compliant need access"
  - "No adverse effect"
  - "Adverse effect"

5. The ENV SME finalizes this Activity.

# "Obtain Project Information or Access" Activity

- **1.** The ENV SME assigns the Activity to district environmental staff.
- 2. The ENV SME describes the needed information or rights of entry in the "Comments" field.
- **3.** District environmental staff uploads the requested information under this Activity, using the following naming conventions:
  - Project information: CSJ\_Project\_info\_DD-MMM-YYYY (e.g., "090238128\_Project\_Info\_12-Apr-2019")
  - Right of entries: CSJ\_ROE\_DD-MMM\_YYYY (e.g., "142501012\_ROE\_04-Feb-2018").
- 4. District environmental staff notifies the ENV SME that the information is available.
- **5.** The ENV SME finalizes the activity.



# "Perform Archeological Background Study" Activity

- 1. If district environmental staff believes that the project does not warrant a background study even though the project is not on the List of Projects that Do Not Require Review or Coordination for Archeological Compliance, then district environmental staff must contact the ENV SME assigned to the respective district to discuss the project. If the ENV SME agrees that a background study is not warranted, then district environmental staff:
  - selects, "No," from the drop-down menu for the field labeled, "Was an Archeology Background Study performed?"
  - inserts the following statement in the "Comments" field of this Activity: "This project does not require a background study per [insert name], ENV SME" and
  - finalizes this Activity.
- District environmental staff prepares an archeological background study according to ENV's Template for Archeological Background Studies. Alternatively, district environmental staff may request that the appropriate ENV SME prepare the archeological background study.

Regardless of whether the archeological background study is prepared by district environmental staff or an ENV SME, it must be prepared by a professional archeologist (see 13 TAC 26.4(2)), and district environmental staff must provide the professional archeologist with the project's area of potential effects as defined in **ENV's Template for Archeological Background Studies**.

Important note: **ENV's Template for Archeological Background Studies** calls for a screen capture of the WPD I screen in ECOS to be attached to the background study. By attaching a screen capture of the WPD I screen in ECOS to the background study, the preparer is confirming that the WPD I screen contains a project description and that the WPD I project description is the description of the project upon which the background study is based. If there is any discrepancy between the description, such discrepancy must be resolved before the WPD I screen is attached to the background study and the background study is submitted to TxDOT for review.

Note that it is not necessary to attach a screen capture of the WPD I screen to the background study when the background study is being prepared in connection with a reevaluation. The partially completed reevaluation form uploaded to ECOS will have a description of any design changes (see instructions for "Perform Reevaluation").

# Preparation of archeological background study by district environmental staff

**3.** If the archeological background study is prepared by district environmental staff, then for the field labeled, "Finding," in this Activity, district environmental staff selects, "In Progress" if the district environmental staff has all project information needed to prepare the archeological background study, or "Need project information," if district environmental staff is waiting for project information before preparing the archeological background study.



- **4.** District environmental staff uploads the archeological background study under this Activity using this file naming convention: CSJ\_Background\_Study\_DD-MMM-YYY (e.g., "222215027\_Background\_Study\_04-Jan-2016").
- 5. District environmental staff creates a Review of the archeological background study under this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district. Based on workload and other factors, this assignment will likely be re-assigned to another ENV SME. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the archeological background study that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 6. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff uploads the archeological background study with the word, "Approved," at the beginning of the file name.

#### Preparation of archeological background study by ENV SME

- **3.** If the district environmental staff requests that an ENV SME prepare the archeological background study, then the district environmental staff uploads any available maps, schematics, or typical sections under the "Other Project-Related Information" Activity.
- 4. District environmental staff assigns this Activity to the appropriate resource area ENV SME assigned to the respective district. Based on workload and other factors, this assignment will likely be re-assigned to another ENV SME.
- 5. For the field labeled, "Finding," in this Activity, the ENV SME selects, "In Progress" if the ENV SME has all project information needed to prepare the archeological background study, or "Need project information," if the ENV SME is waiting for project information before preparing the archeological background study.
- 6. The ENV SME uploads the archeological background study under this Activity using this file naming convention: CSJ\_Background\_Study\_DD-MMM-YYY (e.g., "222215027\_Background\_Study\_04-Jan-2016").
- 7. If the project is anticipated to be cleared with an EA or EIS, the ENV SME creates a Review of the archeological background study under this Activity and assigns it to ENV Project Delivery staff. Once the ENV Project Delivery staff has finalized his or her Review, if there are pending comments, the ENV SME:



- prepares a new, revised version of the archeological background study that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.

Once the ENV Project Delivery staff has no further comments and has finalized his or her Review, the ENV SME uploads the archeological background study with the word, "Approved," at the beginning of the file name.

#### Next steps after uploading approved archeological background study

- **7.** Regardless of how the archeological background study has been produced (i.e., whether it was produced by district environmental staff or an ENV SME), the ENV SME completes the following steps, using the available technical documents and coordination results.
- 8. The ENV SME selects "Yes" from the drop-down menu for the field labeled, "Was an Archeology Background Study performed?"
- 9. The ENV SME selects "Adverse effect," "No effect/no further work," "No adverse effect/no further work," or "Survey/additional work required" from the drop-down menu for the "Finding" field. For projects with no potential to cause effects, with minimal potential to cause effects, or with no known historic properties in the APE, the typical response is "No effect/no further work." The ENV SME proceeds as instructed below, depending on the Finding.
  - <u>"Adverse effect"</u> If the ENV SME ultimately selected, "Adverse effect" for the "Finding" field, then the ENV SME creates three Coordinations under this Activity (one for THC-A Coordination, one for PA Tribe Coordination, and one for ACHP Coordination). In addition, the ENV SME may create an OTH Coordination, if consultation included other consulting parties. The ENV SME proceeds according to the Coordination instructions below. The ENV SME also creates the "Perform Archeology Data Recovery" Activity, the "Perform Archeology Mitigation" Activity, or the "Perform Archeology Monitoring Commitments" Activity.

Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeological Background Study" Activity once all associated Coordinations have been finalized.

<u>"No adverse effect/no further work"</u> - If the ENV SME ultimately selected "No adverse effect/no further work," then the ENV SME creates two Coordinations under this Activity (one for THC-A Coordination and one for PA Tribe Coordination). In addition, the ENV SME may create an OTH Coordination, if consultation included other consulting parties. The ENV SME proceeds according to the Coordination instructions below. The ENV SME may also create the "Perform Archeology Mitigation" Activity, if this Activity was necessary to achieve the "No adverse effect/no further work" finding.



Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeological Background Study" Activity once all associated Coordinations have been finalized.

<u>"No effect/no further work"</u> - If the ENV SME ultimately selected, "No effect/no further work," then the ENV SME creates two Coordinations under this Activity (one for either ENV-A In-House Coordination or THC-A Coordination, and one for Native American Tribal Coordination, PA Tribe or Non-PA Tribe as applicable). In addition, the ENV SME may create an OTH Coordination, if consultation included other consulting parties. The ENV SME proceeds according the Coordination instructions below.

Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeological Background Study" Activity once all associated Coordinations have been finalized.

<u>"Survey/additional work required"</u> - If the ENV SME ultimately selected,
 "Survey/additional work required," then the ENV SME creates the "Perform Archeology Survey" Activity, and finalizes the "Perform Archeological Background Study" Activity.

Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

# ENV-A In-House Coordination Process

If the ENV SME determines that the project can be coordinated internally because it meets the criteria for internal coordination under ENV's Memorandum of Understanding between the Texas Historical Commission and the Texas Department of Transportation and/or the Programmatic Agreement among the Federal Highway Administration, Texas State Historic Preservation Office, Advisory Council on Historic Preservation, and the Texas Department of Transportation, then the ENV SME follows the steps below to begin the coordination (there is no need to upload anything to this coordination).

- 1. In the Coordination, the ENV SME selects the drop-down response "ENV-A" for the "Agency Name" field.
- 2. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details as follows:
  - For the "Correspondence Status" field, the ENV SME selects, "Sent Information," using the drop-down menu.
  - For the "Correspondence Method" field, the ENV SME selects, "Other," using the dropdown menu.



- For the "Correspondence Date" field, the ENV SME enters the current date.
- For the "Correspondence From" field, the ENV SME enters, "TxDOT."
- For the "Correspondence To" field, the ENV SME enters "TxDOT."
- For the "Comments" field, the ENV SME enters, "Request for internal review and approval of a finding of no archeological historic properties affected and no further work required, as permitted under the PA and MOU."
- **3.** The ENV SME assigns the ENV-A Coordination to the ENV SME team lead or ENV SME manager.
- 4. Once a week, the ENV SME team lead or ENV SME manager reviews the archeological background study for each assigned project and requests clarifications from the authoring ENV SME as necessary. Once the review has been completed, resulting in a satisfactory archeological background study and confirmation of "no effect/no further work," the ENV SME team lead or ENV SME manger follows the steps below to complete the coordination.
- 5. The ENV SME team lead or ENV SME manager fills-in the correspondence details as follows:
  - For the "Correspondence Status" field, the ENV SME team lead or ENV SME manager selects, "Response received no further action", using the drop-down menu.
  - For the "Correspondence Method" field, the ENV SME team lead or ENV SME manager selects, "Other," using the drop-down menu.
  - For the "Correspondence Date" field, the ENV SME team lead or ENV SME manager enters the current date.
  - For the "Correspondence From" field, the ENV SME team lead or ENV SME manager enters "TxDOT."
  - For the "Correspondence To" field, the ENV SME team lead or ENV SME manager enters "TxDOT."
  - For the "Comments" field, the ENV SME team lead or ENV SME manager enters, "Internal review and approval of a finding of no archeological historic properties affected and no further work required, as permitted under the PA and MOU."
- 6. In the Coordination, the ENV SME team lead or ENV SME manager selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 7. The ENV SME team lead or ENV SME manager finalizes the Coordination.

# THC-A Coordination process

If the ENV SME determines that the project does <u>not</u> meet the criteria for internal coordination under ENV's **Memorandum of Understanding between the Texas Historical Commission and the Texas Department of Transportation** and/or the **Programmatic Agreement among the Federal Highway Administration, Texas State Historic Preservation Office, Advisory Council on Historic Preservation, and the Texas Department of Transportation** and must instead be coordinated with the Texas Historical Commission/Texas State Historic Preservation Officer (THC/TSHPO) (for example because important sites might be impacted by the project or other unusual circumstances), then the ENV SME uploads the following documentation under the Coordination:



- Consultation letter to the THC/TSHPO: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016")
- The emailed response from the THC/TSHPO: CSJ\_THC\_response\_DD-MMM-YYYY (e.g., "222213005\_THC\_response\_07-Sep-2016")
- Any other correspondence to or from TxDOT or the THC/TSHPO, using the following naming convention for correspondence to TSHPO: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016").

- The ENV SME drafts the consultation letter, using ENV's Template for TSHPO/THC Consultation Regarding Archeological Historic Properties. The ENV SME transmits the draft letter and associated archeological background study to the ENV SME manager.
- 2. The ENV SME manager reviews the archeology background study and requests clarifications from the authoring ENV SME as necessary. Once the review has been completed, resulting in a satisfactory consultation letter and report and confirmation of proposed findings, the ENV SME manager sends the letter and archeology background study to the THC/TSHPO via THC's eTRAC system.
- **3.** The THC/TSHPO reviews the letter and archeology background study and emails any requests for clarifications from the authoring ENV SME as necessary.
- **4.** The ENV SME transmits to THC/TSHPO any requested responses or clarifications via THC's eTRAC system.
- 5. The THC/TSHPO emails their final response to the ENV SME from the THC's eTRAC system.
- 6. In the Coordination, the ENV SME selects the drop-down response "THC-A" for the "Agency Name" field.
- 7. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the THC/TSHPO, using "TxDOT" to refer to TxDOT and "THC" to refer to the THC/TSHPO in the "Correspondence From" and "Correspondence To" fields.
- The ENV SME uploads each email or letter to or from TxDOT and the THC/TSHPO under the Coordination, using this file naming convention for the consultation letter sent by TxDOT to the THC via the THC's eTRAC system: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016"); this file naming convention for any additional correspondence from TxDOT to THC: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016"); and this file naming convention for the emailed responses from THC to TxDOT: CSJ\_THC\_response\_DD-MMM-YYYY (e.g., "222213005\_THC\_response\_07-Sep-2016").
- **9.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."



**10.** The ENV SME finalizes the Coordination.

#### Native American Tribal Coordination (i.e., early tribal coordination) process

If the ENV SME determined that the project is a minor project (for definition of "minor project" see **ENV's Staff Archeologist Consultation Procedures**), and lacks known sites within the APE, and was coordinated with federally recognized tribes through ENV's early tribal coordination process (for list of coordinated projects, see **ENV's Early\_Coordination\_CSJ\_List.xIs**), then the ENV SME uploads the following documentation under the Coordination:

- Signed consultation request letter sent for the first time the project appeared on the Early Tribal Coordination list, using this file naming convention: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "091818132\_Consultation\_Request\_10-Mar-2017")
- Any responses from tribes, using this file naming convention: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222215017\_Consultation\_Response\_ Comanche\_14-Oct-2015")
- Any other correspondence to or from TxDOT or tribes

- 1. The ENV SME must have already transmitted lists of upcoming projects and basic project information to tribal consulting parties. This consultation occurs well in advance of project development. For projects that can be coordinated through the Early Tribal Coordination program, tribal consultation must already have been completed prior to creation of this Activity.
- ENV SME checks the "WPD Section I Project Definition" page in ECOS to verify that the project can be classified as a minor type. The ENV SME also checks the Texas Archeological Sites Atlas to verify that no recorded sites occur within the project's APE.
- 3. ENV SME checks the current ENV's Early\_Coordination\_CSJ\_List.xls on the Archeology Sharepoint site to verify that the project has been coordinated through the Early Tribal Coordination program.
- **4.** In the Coordination, the ENV SME selects the drop-down response "Native American Tribal Coordination (NA)" for the "Agency Name" field.
- **5.** In the "Comments" field of the Coordination, the ENV SME lists all of the tribes with whom the project was coordinated.
- 6. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the tribes.
- 7. The ENV SME uploads the signed consultation request letter sent for the first time the project appeared on the Early Tribal Coordination list. This letter can be found on the Archeology Sharepoint site. The ENV SME also uploads each additional email or letter to or from TxDOT and the tribes regarding the project under the Coordination. This correspondence uses the following file naming conventions:



- The signed consultation request letter: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "091818132\_Consultation\_Request\_10-Mar-2017")
- Any responses from the tribes: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222215017\_Consultation\_Response\_ Comanche\_14-Oct-2015")
- 1. Once either all comments from tribes have been satisfactorily addressed or no response has been received within the review period (31 days from the day that the letter was transmitted), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **2.** The ENV SME finalizes the Coordination.

### PA and Non-PA Tribal Coordination (i.e., formal, project-specific coordination) process

ENV's formal, project-specific tribal coordination process is required under either of the following two conditions:

- The ENV SME determined that the project is a major project (for definition of "major project" see ENV's Staff Archeologist Consultation Procedures) or has one or more known sites within the APE.
- The project is a minor project (for definition of "minor project" see **ENV's Staff Archeologist Consultation Procedures**) that lacks known sites within the APE, but the project was not included on a list of upcoming projects sent to tribes under the Native American Tribal Coordination (i.e., early tribal coordination) process described above.

For either of these conditions, the ENV SME uploads the following documentation under the Coordination:

- Consultation email: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- Any other correspondence to or from TxDOT or tribes

Follow the steps below to conduct the coordination.

- 1. The ENV SME drafts the consultation email, using **ENV's Template for Tribal Consultation**. The ENV SME transmits the draft and the archeology background study to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- 2. In the Coordination, the ENV SME selects the drop-down response "PA Tribe (PA)" for the "Agency Name" field if the project is a major project or has one or more known sites within the APE.

If the project is a minor project that lacks known sites within the APE but was not included on a list of upcoming projects sent to tribes under the Native American Tribal Coordination (i.e., early tribal coordination) process described above, then the ENV SME selects the drop-down response "Non PA Tribe (NPA)" for the "Agency Name" field.



- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the tribes with whom the project was coordinated.
- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the tribes.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the tribes under the Coordination using the following file naming conventions:
  - Consultation email: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- 6. Once either all comments from tribes have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 7. The ENV SME finalizes the Coordination.

#### Other Consulting Party Coordination process

For some large, complex projects with potential for controversy and/or adverse effects to archeological historic properties, the ENV SME will identify and invite consultation with other consulting parties. These consulting parties could include County Historical Commissions, local archeological societies (e.g., the Houston Archeological Society (HAS)), and other knowledgeable parties. When the ENV SME consults with other consulting parties, the ENV SME uploads the following documentation under the Coordination:

- Consultation email: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007 Consultation Request Other Parties 08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_HAS\_20-Jun-2018")
- Any other correspondence to or from TxDOT and the other consulting parties.

- 1. The ENV SME drafts the consultation email, using ENV's Template for Other Consulting Party Consultation. The ENV SME transmits the draft email and the archeological background study to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- 2. In the Coordination, the ENV SME selects the drop-down response "Other Consulting Parties (OTH)" for the "Agency Name" field.
- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the other consulting parties with whom the project was coordinated.



- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the other consulting parties.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the other consulting parties under the Coordination using the following file naming conventions:
  - Consultation email: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_Other\_Parties\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_HAS\_20-Jun-2018")
- Once either all comments from other consulting parties have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **9.** The ENV SME finalizes the Coordination.

#### Advisory Council on Historic Preservation Coordination process

For projects with adverse effects, the ENV SME will notify the Advisory Council on Historic Preservation (ACHP). When the ENV SME coordinates with ACHP, the ENV SME uploads the following documentation under the Coordination:

- Advisory Council on Historic Preservation Electronic Section 106 Documentation Submittal System (e106) Form: CSJ\_ACHP\_DD-MMM-YYYY (e.g., "363201001\_Submittal\_ACHP\_08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Response\_ACHP\_DD-MMM-YYYY (e.g., "363201001\_ Response\_ACHP\_03-Mar-2019")

- The ENV SME completes the Advisory Council on Historic Preservation Electronic Section 106 Documentation Submittal System (e106) Form. The ENV SME also compiles documentation of completed consultation and any maps, report excerpts, and photographs that describe the affected property. The ENV SME then submits the form and associated documentation by email to ACHP.
- **2.** In the Coordination, the ENV SME selects the drop-down response "Advisory Council on Historic Preservation (ACHP)" for the "Agency Name" field.
- **3.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the ACHP.
- **4.** The ENV SME uploads all correspondence to or from TxDOT or the ACHP under the Coordination using the following file naming conventions:

- 5. Once either all comments from ACHP have been satisfactorily addressed or no response has been received within the notification period (15 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 6. The ENV SME finalizes the Coordination.

# "Perform Archeology Data Recovery" Activity

- 1. If, after creating this Activity, the district environmental staff or the ENV SME determined that archeological data recovery would not, in fact, be required, then the district environmental staff or the ENV SME selects, "No," from the drop-down menu for the field labeled, "Was Archeology Data Recovery performed?," explains in the "Comments" field why no archeological data recovery was required and finalizes this Activity.
- 2. The archeological data recovery report may be prepared by a local government's consultant or by an ENV SME. Regardless of whether the archeological data recovery report is prepared by a local government's consultant or an ENV SME, it must be prepared by a professional archeologist (see 13 TAC 26.4(2)). This Activity must be created separately for each site that will be excavated, if multiple sites will be excavated for the same project.

Projects that would occur on TxDOT right of way or other state or local public land have an additional requirement. The professional archeologist must apply for and acquire a Texas Antiquities permit from the Texas Historic Commission prior to beginning the data recovery excavation. The professional archeologist prepares the permit application in accordance with **ENV's Review Standard for Antiquities Permit Applications**.

Also, note that sometimes a cemetery is identified and/or removed as part of this "Perform Archeology Data Recovery" Activity. In these instances, the ENV SME still creates the "Perform Cemetery Investigation" and/or "Perform Cemetery Removal" Activities and follows the instructions in those Activities. The identification and/or removal of the cemetery, however, will be included as part of the data recovery report for the project. Note that the pre-removal coordination required by the Activity Instructions for the "Perform Cemetery Removal" Activity must be conducted prior to removing any cemetery, regardless of whether it is removed as part of this "Perform Archeology Data Recovery" Activity or the "Perform Cemetery Removal" Activity.

Acquire Texas Antiquities Permit by local government's consultant (if needed)

- 1. If a Texas Antiquities permit is required specifically for the data recovery excavation, the local government project sponsor uploads the Texas Antiquities Permit application (if applicable), using the file naming convention: CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "222215024\_Permit\_App\_10-Apr-2016").
- 2. The local government project sponsor creates a Review of the Texas Antiquities permit application under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, the local government project sponsor also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the local government project sponsor:
  - prepares a new, revised version of the Texas Antiquities Permit application that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and



- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 3. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, the ENV SME transmits a copy of the completed comment response matrix showing how all the ENV SME's comments were addressed to the local government sponsor. The local government project sponsor uploads the Texas Antiquities Permit application with the word, "Approved," at the beginning of the file name.
- **4.** The local government project sponsor transmits the approved Texas Antiquities Permit application to the Texas Historical Commission and a copy of the completed comment response matrix showing how all the ENV SME's comments were addressed for their review, approval, and assignation of the Texas Antiquities Permit number for the project.
- **5.** The THC reviews the permit application and requests clarifications or revisions from the local government project sponsor as necessary.
  - The local government project sponsor prepares a revised Texas Antiquities Permit application and uploads the revised Texas Antiquities Permit application with the word "Revised" at the beginning of the file name.
  - The local government project sponsor transmits the revised Texas Antiquities Permit application to the THC.
- 6. Once the THC has no further comments, the THC will email the ENV SME and professional archeologist performing the investigation the permit and the assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit application email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved\_222215024\_Permit\_App\_10-Apr-2016").
- 7. The professional archeologist can begin the investigation at that point.

# Preparation of archeological data recovery report by local government's consultant

- 8. For the field labeled, "Work Status," in this Activity, the local government project sponsor selects, "In Progress," if the local government project sponsor has all project information and access to real property needed to prepare the archeological data recovery report. Alternatively, if the local government project sponsor lacks project information or access to real property needed to prepare the archeological data recovery report, then the local government project sponsor selects one of the following drop-down options for this field:
  - Select, "Need Additional ROE/ROW Acquisition," if the local government project sponsor is waiting for both right-of-entry and right-of-way acquisition.
  - Select, "Need Project Information," if the local government project sponsor is waiting for project information.
  - Select, "Need ROE," if the local government project sponsor is waiting for right-of-entry.
  - Select, "Need ROW Acquisition," if the local government project sponsor is waiting for right-of-way acquisition.



- 9. Once the data recovery excavation has been completed, the local government project sponsor prepares an archeological data recovery report and uploads the archeological data recovery report using the file naming convention CSJ\_Data\_recovery\_DD-MMM-YYY (e.g., "222215024\_Data\_recovery\_10-Apr-2016").
- **10.** The local government project sponsor creates a Review of the archeological data recovery report under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, the local government project sponsor also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the local government project sponsor:
  - prepares a new, revised version of the archeological data recovery report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **11.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, the local government project sponsor uploads the archeological data recovery report with the word, "Approved," at the beginning of the file name.

#### Acquire Texas Antiquities Permit by ENV SME

- 1. The ENV SME requests a Texas Antiquities Permit number from the THC through the THC's eTRAC system for their review, approval, and assignation of the Texas Antiquities Permit number for the project.
  - The THC reviews the permit application and requests clarifications or revisions from the ENV SME as necessary.
  - The ENV SME prepares a revised Texas Antiquities Permit application.
  - The ENV SME transmits the revised Texas Antiquities Permit application to the THC.
- 2. Once the THC permit review process has been successfully completed, the THC will email the ENV SME and the professional archeologist performing the investigation the permit and assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit application email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved\_222215024\_Permit\_App\_10-Apr-2016").
- 3. The professional archeologist can begin the investigation at that point.

#### Preparation of archeological data recovery report by the ENV SME

4. If the district environmental staff requests that an ENV SME prepare the archeological data recovery report, and if the ENV SME needs any project information or right of entry, then the ENV SME creates the "Obtain Project Information or Access" Activity, and the district environmental staff uploads any available right of entries or other project information requested by the SME under the "Obtain Project Information or Access" Activity.



- 5. Once the data recovery excavation has been completed, the ENV SME prepares an archeological data recovery report and uploads the archeological data recovery report using the file naming convention CSJ\_Data\_recovery\_DD-MMM-YYY (e.g., "222215024\_Data\_recovery\_10-Apr-2016").
- 6. If the project is anticipated to be cleared with an EA or EIS, the ENV SME creates a Review of the archeological data recovery report under this Activity and assigns it to ENV Project Delivery staff. Once ENV Project Delivery Staff has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the archeological data recovery report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.

Once ENV Project Delivery has no further comments and has finalized his or her Review, the ENV SME uploads the archeological data recovery report with the word, "Approved," at the beginning of the file name.

#### Next steps after uploading the approved archeological data recovery report

- 1. Regardless of how the archeological data recovery report was produced (i.e., whether it was produced by a local government's consultant or an ENV SME), the ENV SME completes the following steps, using the available technical documents and coordination results.
- 2. The ENV SME selects "Yes" from the drop-down menu for the field labeled, "Was Archeology Data Recovery performed?"
- **3.** In the "Right of Entry (ROE) Required" field, the ENV SME enters "Yes" or "No" to designate whether ROE must be obtained prior to starting fieldwork.
- 4. In the "Volume Excavated" field, the ENV SME enters the cubic meters of hand excavation at the site as documented in the corresponding archeological data recovery report. The volume is reported as a numeric value without any further qualifiers or descriptors.
- **5.** In the "NEPA Approval Date" field, the ENV SME enters the date indicated for the "Environmental Clearance" field on WPD I.
- **6.** In the "Permit Number" field, the ENV SME enters the Permit Number (if any) assigned by the THC to the investigation. If there is no THC permit, enter "0."
- 7. The ENV SME may, at his or her discretion, use the "Parcels" table to track parcels for which access has been granted, access has been denied, and data recovery has been completed. This table is most useful for large projects where data recovery will be conducted in more than one stage due to partial access to private property.
  - The ENV SME enters a descriptor or parcel identification number in the "Parcel ID" field. This field may be used to encompass multiple parcels, when appropriate.



- The ENV SME enters the date at which granted ROE expires in the "ROE Expiration Date" field.
- The ENV SME enters "Yes" or "No" in the "Data Recovery Completed" field to track at which parcels the investigations have been completed.
- The ENV SME enters the date at which ROE received in the "ROE Received Date" field.
- The ENV SME enters the date at which ROE requested in the "ROE Requested Date" field.
- The ENV SME clicks "Add." This allows the parcel to move from below the shaded line and into the table.
- 8. The ENV SME enters the County and trinomial number in the "Site Number" field.
- **9.** The ENV SME enters information to characterize the site in the "Site Description" field.
- **10.** The ENV SME finalizes the "Perform Archeology Data Recovery" Activity once the ENV SME completes, if applicable, THC-A Coordination, PA Tribal Coordination, and OTH Coordination as explained below.
- **11.** If cemetery removal is completed as part of this Activity, and if any of the burials are identified as being Native American, then the ENV SME creates the "Perform Native American Graves Protection and Repatriation Act (NAGPRA) Analysis" Activity.

#### THC-A Coordination process

Coordination with the THC will occur when the data recovery requires a Texas Antiquities Permit from the THC. The ENV SME uploads the following documentation under the Coordination:

- Consultation letter to the THC/TSHPO: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016")
- The emailed response from the THC/TSHPO: CSJ\_THC\_response\_DD-MMM-YYYY (e.g., "222213005\_THC\_response\_07-Sep-2016")

- 1. The ENV SME drafts the consultation letter, using ENV's Template for TSHPO/THC Consultation Regarding Archeological Historic Properties. The ENV SME transmits the draft letter and associated archeological data recovery report to the ENV SME manager.
- 2. The ENV SME manager reviews the archeological data recovery report and requests clarifications from the authoring ENV SME as necessary. Once the review has been completed, resulting in a satisfactory consultation letter and report and confirmation of proposed findings, the ENV SME manager sends the letter and archeological data recovery report to the THC/TSHPO via THC's eTRAC system.
- **3.** The THC/TSHPO reviews the letter and archeological data recovery report and emails any requests for clarifications from the authoring ENV SME as necessary.



- **4.** The ENV SME transmits to THC/TSHPO any requested responses or clarifications via THC's eTRAC system.
- **5.** The THC/TSHPO emails their final response to the ENV SME from the THC's eTRAC system.
- 6. In the Coordination, the ENV SME selects the drop-down response "THC-A" for the "Agency Name" field.
- 7. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the THC/TSHPO, using "TxDOT" to refer to TxDOT and "THC" to refer to the THC/TSHPO in the "Correspondence From" and "Correspondence To" fields.
- 8. The ENV SME uploads each email or letter to or from TxDOT and the THC/TSHPO under the Coordination, using this file naming convention for the consultation letter sent by TxDOT to the THC via the THC's eTRAC system: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016"); this file naming convention for any additional correspondence from TxDOT to THC: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016"); and this file naming convention for the emailed responses from THC to TxDOT: CSJ\_THC\_response\_DD-MMM-YYYY (e.g., "222213005\_THC\_response\_07-Sep-2016").
- **9.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **10.** The ENV SME finalizes the Coordination.

#### PA Coordination (i.e., formal, project-specific coordination) process

Typically, tribal consultation regarding data recovery excavation should be completed prior to the "Perform Archeology Data Recovery" Activity. In rare cases, the outcome of the prior consultation might require the ENV SME to continue consultation during the Activity. Under these conditions, the ENV SME uploads the following documentation under the Coordination:

- Consultation emails: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- Any other correspondence to or from TxDOT or tribes

Follow the steps below to conduct the coordination.

1. The ENV SME drafts an email, using **ENV's Template for Tribal Consultation**. The ENV SME transmits the draft email and the archeological data recovery report to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.



- 2. In the Coordination, the ENV SME selects the drop-down response "PA Tribe (PA)" for the "Agency Name" field.
- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the tribes with whom the project was coordinated.
- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the tribes.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the tribes under the Coordination using the following file naming conventions:
  - Consultation emails: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- 6. Once either all comments from tribes have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 7. The ENV SME finalizes the Coordination.

#### Other Consulting Party Coordination process

Typically, other consulting party consultation regarding the data recovery excavation should be completed prior to the "Perform Archeology Data Recovery" Activity. In rare cases, the outcome of the prior consultation might require the ENV SME to continue consultation during the Activity. Under these conditions, the ENV SME uploads the following documentation under the Coordination:

- Consultation emails: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_Other\_Parties\_08-Jun-2017")

- 1. The ENV SME drafts the consultation email using ENV's Template for Other Consulting Party Consultation. The ENV SME transmits the draft email and the archeological data recovery report to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- 2. In the Coordination, the ENV SME selects the drop-down response "Other Consulting Parties (OTH)" for the "Agency Name" field.
- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the other consulting parties with whom the project was coordinated.



- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the other consulting parties.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the other consulting parties under the Coordination using the following file naming conventions:
  - Consultation emails: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_Other\_Parties\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_HAS\_20-Jun-2018")
- 6. Once either all comments from other consulting parties have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 7. The ENV SME finalizes the Coordination.

# "Perform Archeology Mitigation" Activity

1. This Activity is used to document the resolution of adverse effects to an archeological historic property through alternative mitigation (mitigation other than data recovery excavations). The alternative mitigation report may be prepared by district environmental staff, or district environmental staff may request that the appropriate ENV SME prepare the alternative mitigation report.

Alternative mitigation that would occur on TxDOT right of way or other state or local public land has an additional requirement. A professional archeologist (see 13 TAC 26.4(2)) must apply for and acquire a Texas Antiquities permit from the Texas Historic Commission. The professional archeologist prepares the permit application in accordance with **ENV's Review Standard for Antiquities Permit Applications**.

Acquire Texas Antiquities Permit by district environmental staff (if needed)

- 1. If a Texas Antiquities permit is required, district environmental staff uploads the Texas Antiquities Permit application (if applicable), using the file naming convention: CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "222215024\_Permit\_App\_10-Apr-2016").
- 2. District environmental staff creates a Review of the Texas Antiquities permit application under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the Texas Antiquities Permit application that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 3. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments, has finalized his or her Review, and has transmitted a copy of the completed comment response matrix showing how all the ENV SME's comments were addressed to district environmental staff, district environmental staff uploads the Texas Antiquities Permit application with the word, "Approved," at the beginning of the file name.
- 4. The district transmits the approved Texas Antiquities Permit application to the professional archeologist along with a copy of the completed comment response matrix showing how all the ENV SME's comments were addressed. The professional archeologist submits the approved Texas Antiquities Permit application and a copy of the completed comment response matrix showing how all the ENV SME's comments were addressed to the Texas Historical Commission via the THC's eTRAC system for their review, approval, and assignation of the Texas Antiquities Permit number for the project.



- **5.** The THC reviews the permit application and requests clarifications or revisions from the ENV SME as necessary.
  - The ENV SME emails any such requests for revision or clarification to the district environmental staff.
  - The district environmental staff prepares a revised Texas Antiquities Permit application and uploads the revised Texas Antiquities Permit application with the word "Revised" at the beginning of the file name.
  - The professional archeologist transmits the revised Texas Antiquities Permit application to the THC via the THC's eTRAC system.
- 6. Once the THC has no further comments, the THC will email the ENV SME and the professional archeologist performing the investigation the permit and the assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit application email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved\_222215024\_Permit\_App\_10-Apr-2016").
- 7. The professional archeologist can begin the alternative mitigation at that point.

#### Preparation of alternative mitigation report by district environmental staff

- Once the requirements of the mitigation have been completed, district environmental staff prepares an alternative mitigation report, and uploads the alternative mitigation report using the file naming convention CSJ\_Alternative\_mitigation\_DD-MMM-YYY (e.g., "222215024\_Alternative\_mitigation\_10-Apr-2016").
- 9. District environmental staff creates a Review under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the alternative mitigation report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).

#### Acquire Texas Antiquities Permit by ENV SME (if needed)

- **4.** The ENV SME transmits to THC/TSHPO any requested responses or clarifications via THC's eTRAC system.
- 5. The THC/TSHPO emails their final response to the ENV SME from the THC's eTRAC system.
- 6. # "Perform Archeology Monitoring Commitments" Activity

1. This Activity is used to document the completion of archeological monitoring commitments according to the Texas Historical Commission's standards for monitoring and associated reporting (13 TAC 26). The archeological monitoring report may be prepared by district environmental staff, or district environmental staff may request that the appropriate ENV SME prepare the archeological monitoring report. Regardless of whether the archeological monitoring report is completed by district environmental staff or an ENV SME, it must be prepared by a professional archeologist (see 13 TAC 26.4(2)).

Archeological monitoring that would occur on TxDOT right of way or other state or local public land has an additional requirement. The professional archeologist must apply for and obtain a Texas Antiquities permit from the Texas Historic Commission prior to beginning monitoring. The professional archeologist prepares the permit application in accordance with **ENV's Review Standard for Antiquities Permit Applications**.

Acquire Texas Antiquities Permit by district environmental staff (if needed)

The professional archeologist submits the approved Texas Antiquities Permit application and a copy of the comment response matrix showing how all the ENV SME's comments were addressed to the Texas Historical Commission via the THC's



eTRAC system for their review, approval, and assignation of the Texas Antiquities Permit number for the project.

- **5.** The THC reviews the permit application and requests clarifications or revisions from the ENV SME as necessary.
  - The ENV SME emails any such requests for revision or clarification to the district environmental staff.
  - The district environmental staff prepares a revised Texas Antiquities Permit application and uploads the revised Texas Antiquities Permit application with the word "Revised" at the beginning of the file name.
  - The professional archeologist transmits the revised Texas Antiquities Permit application to the THC via the THC's eTRAC system.
- 6. Once the THC has no further comments, the THC will email the ENV SME and the professional archeologist performing the investigation the permit and the assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit application email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved\_222215024\_Permit\_App\_10-Apr-2016").
- 7. The professional archeologist can begin the archeological monitoring at that point.

#### Preparation of archeological monitoring report by district environmental staff

Once the THC permit notification/review process has been successfully completed, the THC will email the ENV SME and the professional archeologist performing the investigation the permit and the assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved\_222215024\_Permit\_App\_10-Apr-2016").

# "Perform Archeology Survey" Activity

- 1. If, after creating this Activity, the district environmental staff or the ENV SME determined that an archeological survey would not, in fact, be required, then the district environmental staff or the ENV SME selects, "No," from the drop-down menu for the field labeled, "Was an Archeology Survey performed?;" explains in the "Comments" field why no archeological survey was required, and finalizes this Activity.
- 2. The archeological survey report may be prepared by district environmental staff, or district environmental staff may request that the appropriate ENV SME prepare the archeological survey. Regardless of whether the archeological survey report is prepared by district environmental staff or an ENV SME, it must be prepared by a professional archeologist (see 13 TAC 26.4(2)).

Projects that would occur on TxDOT right of way or other state or local public land have an additional requirement. The professional archeologist must apply for and acquire a Texas Antiquities permit from the Texas Historic Commission. The professional archeologist prepares the permit application in accordance with ENV's Review Standard for Antiquities Permit Applications.

  - The district environmental staff prepares a revised Texas Antiquities Permit application and uploads the revised Texas Antiquities Permit application with the word "Revised" at the beginning of the file name.
  - The professional archeologist transmits the revised Texas Antiquities Permit application to the THC via the THC's eTRAC system.
- 6. Once the THC has no further comments, the THC will email the ENV SME and the professional archeologist performing the investigation the permit and the assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit application email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved\_222215024\_Permit\_App\_10-Apr-2016").
- 7. The professional archeologist can begin the investigation at that point.

#### Preparation of archeological survey report by district environmental staff

- 8. For the field labeled, "Work Status," in this Activity, district environmental staff selects, "In Progress," if the district environmental staff has all project information and access to real property needed to prepare the archeological survey report. Alternatively, if the district environmental staff lacks project information or access to real property needed to prepare the archeological survey report, then district environmental staff selects one of the following drop-down options for this field:
  - Select, "Need Additional ROE/ROW Acquisition," if the district environmental staff is waiting for both right-of-entry and right-of-way acquisition.
  - Select, "Need Project Information," if the district environmental staff is waiting for project information.
  - Select, "Need ROE," if the district environmental staff is waiting for right-of-entry.
  - Select, "Need ROW Acquisition," if the district environmental staff is waiting for right-ofway acquisition.
- 9. Once the investigation has been completed, district environmental staff prepares an archeological survey report according to ENV's Template for Archeological Survey Report, and uploads the archeological survey report using the file naming convention CSJ\_Survey\_DD-MMM-YYY (e.g., "222215024\_Survey\_10-Apr-2016").
- **10.** District environmental staff creates a Review of the archeological survey report under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:



- prepares a new, revised version of the archeological survey report that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **11.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff uploads the archeological survey report with the word, "Approved," at the beginning of the file name.

# Acquire Texas Antiquities Permit by ENV SME (if needed)

- 1. Under ENV's Memorandum of Understanding between the Texas Historical Commission and the Texas Department of Transportation, the ENV SME may not need to submit a formal permit application for a Texas Antiquities Permit. This permit may instead be obtained by notifying the Texas Historical Commission of the upcoming fieldwork.
- 2. The ENV SME requests a Texas Antiquities Permit number from the THC through the THC's eTRAC system for their review, approval, and assignation of the Texas Antiquities Permit number for the project.
  - The THC reviews the permit notification/application and requests clarifications or revisions from the ENV SME as necessary.
  - The ENV SME prepares a revised Texas Antiquities Permit notification/application.
  - The ENV SME transmits the revised Texas Antiquities Permit notification/application to the THC.
- 3. Once the THC permit notification/review process has been successfully completed, the THC will notify the ENV SME and the professional archeologist performing the investigation of the assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved\_222215024\_Permit\_App\_10-Apr-2016").
- **4.** The professional archeologist can begin the investigation at that point.

#### Preparation of archeological survey report by ENV SME

- 5. If the district environmental staff requests that an ENV SME prepare the archeological survey report, and if the ENV SME needs any project information or right of entry, then the ENV SME creates the "Obtain Project Information or Access" Activity, and the district environmental staff uploads any available right of entries or other project information requested by the SME under the "Obtain Project Information or Access" Activity.
- 6. For the field labeled, "Work Status," in this Activity, the ENV SME selects, "In Progress," if the ENV SME has all project information and access to real property needed to prepare the archeological survey report. Alternatively, if the ENV SME lacks project information or access to real property needed to prepare the archeological survey report, then the ENV SME selects one of the following drop-down options for this field:



- Select, "Need Additional ROE/ROW Acquisition," if the ENV SME is waiting for both right-ofentry and right-of-way acquisition.
- Select, "Need Project Information," if the ENV SME is waiting for project information.
- Select, "Need ROE," if the ENV SME is waiting for right-of-entry.
- Select, "Need ROW Acquisition," if the ENV SME is waiting for right-of-way acquisition.
- 7. Once the investigation has been completed, the ENV SME prepares an archeological survey report according to ENV's Template for Archeological Survey Report and uploads the archeological survey report using the file naming convention CSJ\_Survey\_DD-MMM-YYY (e.g., "222215024\_Survey\_10-Apr-2016").
- 8. If the project is anticipated to be cleared with an EA or EIS, the ENV SME creates a Review of the archeological survey report under this Activity and assigns it to ENV Project Delivery staff. Once ENV Project Delivery Staff has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the archeological survey report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.

Once ENV Project Delivery has no further comments and has finalized his or her Review, the ENV SME uploads the archeological survey report with the word, "Approved," at the beginning of the file name.

#### Next steps after uploading the approved archeological survey report

- 1. Regardless of how the archeological survey report has been produced (i.e., whether it was produced by district environmental staff or an ENV SME), the ENV SME completes the following steps, using the available technical documents and coordination results.
- 2. The ENV SME selects "Yes" from the drop-down menu for the field labeled, "Was an Archeology Survey performed?"
- **3.** In the "Right of Entry (ROE) Required" field, the ENV SME selects "Yes" or "No" to designate whether ROE must be obtained prior to starting fieldwork.
- 4. In the "Acreage Surveyed" field, the ENV SME enters the acreage of the Area of Potential Effects (not just the area subject to physical inspection or survey) as documented in the corresponding archeological survey report. The acreage is reported as a numeric value without any further qualifiers or descriptors.
- **5.** In the "Permit Number" field, the ENV SME enters the Permit Number (if any) assigned by the THC to the investigation. If there is no THC permit, enter "0."
- **6.** The ENV SME may, at his or her discretion, use the "Parcels" table to track parcels for which access has been granted, access has been denied, and survey has been completed. This table is



most useful for large projects where survey will be conducted in more than one stage due to partial access to private property.

- The ENV SME enters a descriptor or parcel identification number in the "Parcel ID" field. This field may be used to encompass multiple parcels, when appropriate.
- The ENV SME enters the date at which granted ROE expires in the "ROE Expiration Date" field.
- The ENV SME enters "Yes" or "No" in the "Survey Required" field to track which parcels of the evaluated APE require survey.
- The ENV SME enters "Yes" or "No" in the "Collection" field to track whether the ROE allows collection of artifacts. ROE allows collection when the signed ROE form includes permission to collect and included a signed Deed of Gift form.
- The ENV SME enters the date at which ROE received in the "ROE Received Date" field.
- The ENV SME enters the date at which ROE requested in the "ROE Requested Date" field.
- The ENV SME enters "Yes" or "No" in the "Survey Completed" field to track on which parcels survey has been completed.
- The ENV SME clicks "Add." This allows the parcel to move below the shaded line and into the table.
- 7. The ENV SME uses the "Sites" table to summarize the investigation results; do not add any data to this table if the survey found no sites. These results must be finalized following the completion of consultation. Each individual site gets its own row in the table. This information will be used for an annual report from FHWA to the National Park Service, to identify the status of work, and to provide data for NEPA analysis.
  - The ENV SME enters the County and trinomial number in the "Site Number" field.
  - The ENV SME selects the correct response from the drop-down menu for the "4(f) Property" field. The options are "Yes," "No," and "Undetermined." In the vast majority of cases, the appropriate response is "No," since most archeological sites are not listed or eligible for listing in the National Register of Historic Places. In the unusual circumstance in which the site is listed or eligible for listing in the National Register of Historic Places, the ENV SME answers, "Yes," and also creates the "Obtain Section 4(f) Approval" Activity (if it has not already been created).
  - The ENV SME selects the correct response from the drop-down menu for the "Site Eligibility" field. The options are "Eligible Alternative Mitigation", "Eligible –Avoidance", and "Eligible Data Recovery", "Ineligible", and "Undetermined".
  - The ENV SME selects the correct response from the drop-down menu for the "Project Effect" field. The options are "Adverse Effect," "No Adverse Effect Avoidance," "No Adverse Effect Outside APE," "No Effect", and "Undetermined". The answer to this question must correspond with the answer to the "Site Eligibility" field; for example, a site labeled as "Ineligible" would never suffer an "Adverse Effect".
  - The ENV SME enters information to characterize the site in the "Site Description" field.
  - The ENV SME clicks "Add." This allows the site to move below the shaded line and into the table.
- 8. The ENV SME selects "Adverse effect," "No Effect/No Further Work," "No Adverse Effect/No Further Work," or "Potential Adverse Effect/Further Work Required" from the drop-down menu for the "Work Status" field. For projects with no archeological historic properties in the APE, the



typical response is "No Effect/No Further Work." The ENV SME proceeds as instructed below, depending on the Finding.

"Adverse effect" - If the ENV SME ultimately selected "Adverse effect" for the "Finding" field, then the ENV SME creates three Coordinations under this Activity (one for THC-A Coordination, one for PA Tribe Coordination, and one for ACHP Coordination). In addition, the ENV SME may create an OTH Coordination, if consultation included other consulting parties. The ENV SME proceeds according to the Coordination instructions below. The ENV SME also creates the "Perform Archeology Data Recovery" Activity, the "Perform Archeology Mitigation" Activity, or the "Perform Archeology Monitoring Commitments" Activity.

Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeology Survey" once all associated Coordinations have been finalized.

"No adverse effect/no further work" - If the ENV SME ultimately selected "No adverse effect/no further work," then the ENV SME creates two Coordinations under this Activity (one for THC-A Coordination and one for PA Tribe Coordination). In addition, the ENV SME may create an OTH Coordination, if consultation included other consulting parties. The ENV SME proceeds according to the Coordination instructions below. The ENV SME may also create the "Perform Archeology Mitigation" Activity, if this Activity was necessary to achieve the "No adverse effect/no further work" finding.
 Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeology Survey" once all associated Coordinations have been finalized.

- "No effect/no further work" If the ENV SME ultimately selected, "No effect/no further work," then the ENV SME creates either ENV-A In-House Coordination or THC-A Coordination. Additional Coordinations may be appropriate under the following circumstances:
  - if the ENV SME previously undertook PA Tribe Coordination or the Activity resulted in the discovery of archeological sites or Native American cemeteries, then the ENV SME must conduct additional PA Tribe Coordination; and
  - if consultation included other consulting parties, then the ENV SME may create an OTH Coordination.

The ENV SME proceeds according to the Coordination instructions below. Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeology Survey" once all associated Coordinations have been finalized.



 "Potential Adverse Effect/Further Work Required" - If the ENV SME ultimately selected, "Potential Adverse Effect/Further Work Required," then the ENV SME creates two Coordinations under this Activity (one for THC-A Coordination and one for PA Tribe Coordination). In addition, the ENV SME may create an OTH Coordination, if consultation included other consulting parties. The ENV SME proceeds according to the Coordination instructions below. The ENV SME also creates the "Perform Archeology Testing" Activity and/or "Cemetery Investigation" Activity, as applicable.

Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeology Survey" once all associated Coordinations have been finalized.

#### ENV-A In-House Coordination Process

If the ENV SME determines that the project can be coordinated internally for expediency and it meets the criteria for internal coordination under ENV's Memorandum of Understanding between the Texas Historical Commission and the Texas Department of Transportation and/or the Programmatic Agreement among the Federal Highway Administration, Texas State Historic Preservation Office, Advisory Council on Historic Preservation, and the Texas Department of Transportation, then the ENV SME follows the steps below to begin the coordination (there is no need to upload anything to this coordination).

- 1. In the Coordination, the ENV SME selects the drop-down response "ENV-A" for the "Agency Name" field.
- In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details as follows:
  - For the "Correspondence Status" field, the ENV SME selects, "Sent Information," using the drop-down menu.
  - For the "Correspondence Method" field, the ENV SME selects, "Other," using the dropdown menu.
  - For the "Correspondence Date" field, the ENV SME enters the current date.
  - For the "Correspondence From" field, the ENV SME enters, "TxDOT."
  - For the "Correspondence To" field, the ENV SME enters "TxDOT."
  - For the "Comments" field, the ENV SME enters, "Request for internal review and approval of a finding of no archeological historic properties affected and no further work required, as permitted under the PA and MOU."
- **3.** The ENV SME assigns the ENV-A Coordination to the ENV SME team lead or ENV SME manager.
- 4. Once a week, the ENV SME team lead or ENV SME manager reviews the archeological survey report for each assigned project and requests clarifications from the authoring ENV SME as necessary. Once the review has been completed, resulting in a satisfactory archeological survey



and confirmation of "no effect/no further work," the ENV SME team lead or ENV SME manger follows the steps below to complete the coordination.

- 5. The ENV SME team lead or ENV SME manager fills-in the correspondence details as follows:
  - For the "Correspondence Status" field, the ENV SME team lead or ENV SME manager selects, "Response received no further action", using the drop-down menu.
  - For the "Correspondence Method" field, the ENV SME team lead or ENV SME manager selects, "Other," using the drop-down menu.
  - For the "Correspondence Date" field, the ENV SME team lead or ENV SME manager enters the current date.
  - For the "Correspondence From" field, the ENV SME team lead or ENV SME manager enters "TxDOT."
  - For the "Correspondence To" field, the ENV SME team lead or ENV SME manager enters "TxDOT."
  - For the "Comments" field, the ENV SME team lead or ENV SME manager enters, "Internal review and approval of a finding of no archeological historic properties affected and no further work required, as permitted under the PA and MOU."
- 6. In the Coordination, the ENV SME team lead or ENV SME manager selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 7. The ENV SME team lead or ENV SME manager finalizes the Coordination.

#### THC-A Coordination process

If the ENV SME does not require expedited review or determines that the project does <u>not</u> meet the criteria for internal coordination under ENV's **Memorandum of Understanding between the Texas Historical Commission and the Texas Department of Transportation** and/or the **Programmatic Agreement among the Federal Highway Administration, Texas State Historic Preservation Office, Advisory Council on Historic Preservation, and the Texas Department of Transportation** and must instead be coordinated with the Texas Historical Commission/Texas State Historic Preservation Officer (THC/TSHPO) (for example because important sites might be impacted by the project or other circumstances), then the ENV SME uploads the following documentation under the Coordination:

- Consultation letter to the THC/TSHPO: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016")
- The emailed response from the THC/TSHPO: CSJ\_THC\_response\_DD-MMM-YYYY (e.g., "222213005\_THC\_response\_07-Sep-2016")
- Any other correspondence to or from TxDOT or the THC/TSHPO, using the following naming convention for correspondence to TSHPO: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016").

Follow the steps below to conduct the coordination.

 The ENV SME drafts the consultation letter, using ENV's Template for TSHPO/THC Consultation Regarding Archeological Historic Properties. The ENV SME emails the draft letter and associated archeological survey report to the ENV SME manager.



- 2. The ENV SME manager reviews the archeological survey report and requests clarifications from the authoring ENV SME as necessary. Once the review has been completed, resulting in a satisfactory consultation letter and report and confirmation of proposed findings, the ENV SME manager sends the letter and archeological survey report to the THC/TSHPO via THC's eTRAC system.
- **3.** The THC/TSHPO reviews the letter and archeological survey report and emails any requests for clarifications from the authoring ENV SME as necessary.
- **4.** The ENV SME transmits to THC/TSHPO any requested responses or clarifications via THC's eTRAC system.
- **5.** The THC/TSHPO emails their final response to the ENV SME from the THC's eTRAC system.
- 6. In the Coordination, the ENV SME selects the drop-down response "THC-A" for the "Agency Name" field.
- 7. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the THC/TSHPO, using "TxDOT" to refer to TxDOT and "THC" to refer to the THC/TSHPO in the "Correspondence From" and "Correspondence To" fields.
- 8. The ENV SME uploads each email or letter to or from TxDOT and the THC/TSHPO under the Coordination, using this file naming convention for the consultation letter sent to the THC/TSHPO via the THC's eTRAC system: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016"); this file naming convention for any additional correspondence from TxDOT to THC: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016"); and this file naming convention for the emailed responses from THC to TxDOT: CSJ\_THC\_response\_DD-MMM-YYYY (e.g., "222213005\_THC\_response\_07-Sep-2016").
- **9.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **10.** The ENV SME finalizes the Coordination.

#### PA Tribal Coordination (i.e., formal, project-specific coordination) process

ENV's formal, project-specific tribal coordination process is required under either of the following two conditions:

- the ENV SME previously conducted PA tribal coordination during earlier phases of investigation for the project, or
- the Activity resulted in the discovery of new archeological sites or Native American cemeteries on an FHWA undertaking.

For either of these conditions, the ENV SME uploads the following documentation under the Coordination:



- Consultation email: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- Any other correspondence to or from TxDOT or tribes

Follow the steps below to conduct the coordination.

- 1. The ENV SME drafts the consultation email using **ENV's Template for Tribal Consultation**. The ENV SME emails the draft email and the archeological survey report to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- 2. In the Coordination, the ENV SME selects the drop-down response "PA Tribe (PA)".
- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the tribes with whom the project was coordinated.
- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the tribes.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the tribes under the Coordination using the following file naming conventions:
  - Consultation email: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- 6. Once either all comments from tribes have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 7. The ENV SME finalizes the Coordination.

#### Other Consulting Party Coordination process

For some large, complex projects with potential for controversy and/or adverse effects to archeological historic properties, the ENV SME will identify and invite consultation with other consulting parties. These consulting parties could include County Historical Commissions, local archeological societies (e.g., the Houston Archeological Society (HAS)), and other knowledgeable parties. When the ENV SME consults with other consulting parties, the ENV SME uploads the following documentation under the Coordination:

- Consultation email: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007 Consultation Request Other Parties 08-Jun-2017")

- Any other correspondence to or from TxDOT and the other consulting parties.



Follow the steps below to conduct the coordination.

- 1. The ENV SME drafts the consultation email using ENV's Template for Other Consulting Party Consultation. The ENV SME emails the draft email and the archeological survey report to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- 2. In the Coordination, the ENV SME selects the drop-down response "Other Consulting Parties (OTH)" for the "Agency Name" field.
- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the other consulting parties with whom the project was coordinated.
- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the other consulting parties.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the other consulting parties under the Coordination using the following file naming conventions:
  - Consultation emails: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_Other\_Parties\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_HAS\_20-Jun-2018")
- Once either all comments from other consulting parties have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **9.** The ENV SME finalizes the Coordination.

#### Advisory Council on Historic Preservation Coordination process

For projects with adverse effects, the ENV SME will notify the Advisory Council on Historic Preservation (ACHP). When the ENV SME coordinates with ACHP, the ENV SME uploads the following documentation under the Coordination:

Follow the steps below to conduct the coordination.

 The ENV SME completes the Advisory Council on Historic Preservation Electronic Section 106 Documentation Submittal System (e106) Form. The ENV SME also compiles documentation of completed consultation and any maps, report excerpts, and photographs that



describe the affected property. The ENV SME then submits the form and associated documentation by email to ACHP.

- 2. In the Coordination, the ENV SME selects the drop-down response "Advisory Council on Historic Preservation (ACHP)" for the "Agency Name" field.
- **3.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the ACHP.
- **4.** The ENV SME uploads all correspondence to or from TxDOT or the ACHP under the Coordination using the following file naming conventions:
  - Advisory Council on Historic Preservation Electronic Section 106 Documentation Submittal System (e106) Form: CSJ\_ACHP\_DD-MMM-YYYY (e.g., "363201001\_Submittal\_ACHP\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Response\_ACHP\_DD-MMM-YYYY (e.g., "363201001\_Response\_ACHP\_03-Mar-2019")
- 5. Once either all comments from ACHP have been satisfactorily addressed or no response has been received within the notification period (15 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 6. The ENV SME finalizes the Coordination.

# "Perform Archeology Testing" Activity

- 1. If, after creating this Activity, the district environmental staff or the ENV SME determined that archeological testing would not, in fact, be required, then the district environmental staff or the ENV SME selects, "No," from the drop-down menu for the field labeled, "Was Archeology Testing performed?," explains in the "Comments" field why not archeological testing was required, and finalizes this Activity.
- 2. The archeological testing report may be prepared by a local government's consultant or by an ENV SME. Regardless of whether the archeological testing report is prepared by a local government's consultant or an ENV SME, it must be prepared by a professional archeologist (see 13 TAC 26.4(2)). This Activity must be created separately for each site that will be evaluated, if multiple sites will be tested for the same project.

Projects that would occur on TxDOT right of way or other state or local public land have an additional requirement. The professional archeologist must apply for and acquire a Texas Antiquities permit from the Texas Historic Commission prior to beginning excavation. The professional archeologist prepares the permit application in accordance with **ENV's Review Standard for Antiquities Permit Applications**.

#### Acquire Texas Antiquities Permit by local government's consultant (if needed)

- 1. If a Texas Antiquities permit is required, the local government project sponsor uploads the Texas Antiquities Permit application (if applicable), using the file naming convention: CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "222215024\_Permit\_App\_10-Apr-2016").
- 2. The local government project sponsor creates a Review of the Texas Antiquities permit application under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, the local government project sponsor also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the local government project sponsor:
  - prepares a new, revised version of the Texas Antiquities Permit application that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 3. Once the ENV SME has no further comments, has finalized his or her Review (and ENV Project Delivery staff, if applicable), and has transmitted a copy of the completed comment response matrix showing how all the ENV SME's comments were addressed to the local government project sponsor, the local government project sponsor uploads the Texas Antiquities Permit application with the word, "Approved," at the beginning of the file name.
- **4.** The local government project sponsor transmits the approved Texas Antiquities Permit application along with a copy of the completed comment response matrix showing how all the



ENV SME's comments were addressed to the Texas Historical Commission via the THC's eTRAC system for their review, approval, and assignation of the Texas Antiquities Permit number for the project.

- **5.** The THC reviews the permit application and requests clarifications or revisions from the local government project sponsor as necessary.
  - The local government project sponsor prepares a revised Texas Antiquities Permit application uploads the revised Texas Antiquities Permit application with the word "Revised" at the beginning of the file name.
  - The local government project sponsor transmits the revised Texas Antiquities Permit application to the THC via the THC's eTRAC system.
- 6. Once the THC has no further comments, the THC will email the ENV SME and the professional archeologist performing the investigation the permit and the assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit application email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved 222215024 Permit App 10-Apr-2016").
- 7. The professional archeologist can begin the investigation at that point.

#### Preparation of archeological testing report by local government's consultant

- 8. For the field labeled, "Work Status," in this Activity, the local government project sponsor selects, "In Progress," if the local government project sponsor has all project information and access to real property needed to prepare the archeological testing report. Alternatively, if the local government project sponsor lacks project information or access to real property needed to prepare the archeological testing report, then the local government project sponsor selects one of the following drop-down options for this field:
  - Select, "Need Additional ROE/ROW Acquisition," if the local government project sponsor is waiting for both right-of-entry and right-of-way acquisition.
  - Select, "Need Project Information," if the local government project sponsor is waiting for project information.
  - Select, "Need ROE," if the local government project sponsor is waiting for right-of-entry.
  - Select, "Need ROW Acquisition," if the local government project sponsor is waiting for rightof-way acquisition.
- **9.** Once the investigation has been completed, the local government project sponsor prepares an archeological testing report according to **ENV's Template for Interim Testing Reports** and uploads the archeological testing report using the file naming convention CSJ\_Testing\_DD-MMM-YYY (e.g., "222215024\_Testing\_10-Apr-2016").
- 10. The local government project sponsor creates a Review of the archeological testing report under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, the local government project sponsor also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the local government project sponsor:



- prepares a new, revised version of the archeological testing report that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **11.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, the local government project sponsor uploads the archeological testing report with the word, "Approved," at the beginning of the file name.

#### Acquire Texas Antiquities Permit by ENV SME (if needed)

- 1. Under ENV's Memorandum of Understanding between the Texas Historical Commission and the Texas Department of Transportation, the ENV SME may not need to submit a formal permit application for a Texas Antiquities Permit. This permit may instead be obtained by notifying the Texas Historical Commission of the upcoming fieldwork.
- 2. The ENV SME requests a Texas Antiquities Permit number from the THC through the THC's eTRAC system for their review, approval, and assignation of the Texas Antiquities Permit number for the project.
  - The THC reviews the permit notification/application and requests clarifications or revisions from the ENV SME as necessary.
  - The ENV SME prepares a revised Texas Antiquities Permit notification/application.
  - The ENV SME transmits the revised Texas Antiquities Permit notification/application to the THC.
- 3. Once the THC permit notification/review process has been successfully completed, the THC will notify the ENV SME and the professional archeologist performing the investigation of the assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved\_222215024\_Permit\_App\_10-Apr-2016").
- **4.** The professional archeologist can begin the testing at that point.

#### Preparation of archeological testing report by the ENV SME

- 5. If the district environmental staff requests that an ENV SME prepare the archeological testing report, and if the ENV SME needs any project information or right of entry, then the ENV SME creates the "Obtain Project Information or Access" Activity, and the district environmental staff uploads any available right of entries or other project information requested by the SME under the "Obtain Project Information or Access" Activity.
- 6. For the field labeled, "Work Status," in this Activity, the ENV SME selects, "In Progress," if the ENV SME has all project information and access to real property needed to prepare the archeological testing report. Alternatively, if the ENV SME lacks project information or access to real property needed to prepare the archeological testing report, then the ENV SME selects one of the following drop-down options for this field:



- Select, "Need Additional ROE/ROW Acquisition," if the ENV SME is waiting for both rightof-entry and right-of-way acquisition.
- Select, "Need Project Information," if the ENV SME is waiting for project information.
- Select, "Need ROE," if the ENV SME is waiting for right-of-entry.
- Select, "Need ROW Acquisition," if the ENV SME is waiting for right-of-way acquisition.
- 7. Once the testing has been completed, the ENV SME prepares an archeological testing report according to ENV's Template for Interim Testing Reports and uploads the archeological testing report using the file naming convention CSJ\_Testing\_DD-MMM-YYY (e.g., "222215024\_Testing\_10-Apr-2016")
- 6. If the project is anticipated to be cleared with an EA or EIS, the ENV SME creates a Review of the archeological testing report under this Activity and assigns it to ENV Project Delivery staff. Once ENV Project Delivery Staff has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the archeological testing report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.

Once ENV Project Delivery has no further comments and has finalized his or her Review, the ENV SME uploads the archeological testing report with the word, "Approved," at the beginning of the file name.

#### Next steps after uploading the approved archeological testing report

- 1. Regardless of how the archeological testing report was produced (i.e., whether it was produced by a local government's consultant or an ENV SME), the ENV SME completes the following steps, using the available technical documents and coordination results.
- **2.** The ENV SME selects "Yes" from the drop-down menu for the field labeled, "Was Archeology Testing performed?
- **3.** In the "Right of Entry (ROE) Required" field, the ENV SME selects "Yes" or "No" to designate whether ROE must be obtained prior to starting fieldwork.
- **4.** In the "Volume Excavated" field, the ENV SME enters the cubic meters of hand excavation at the site as documented in the corresponding archeological testing report. The volume is reported as a numeric value without any further qualifiers or descriptors.
- **5.** In the "Permit Number" field, the ENV SME enters the Permit Number (if any) assigned by the THC to the investigation. If there is no THC permit, enter "0."
- 6. The ENV SME may, at his or her discretion, use the "Parcels" table to track parcels for which access has been granted, access has been denied, and testing has been completed. This table is most useful for large projects where testing will be conducted in more than one stage due to partial access to private property.



- The ENV SME enters a descriptor or parcel identification number in the "Parcel ID" field. This field may be used to encompass multiple parcels, when appropriate.
- The ENV SME enters the date at which granted ROE expires in the "ROE Expiration Date" field.
- The ENV SME enters "Yes" or "No" in the "Testing Completed" field to track at which parcels the investigations have been completed.
- The ENV SME enters the date at which ROE received in the "ROE Received Date" field.
- The ENV SME enters the date at which ROE requested in the "ROE Requested Date" field.
- The ENV SME enters "Yes" or "No" in the "Collection" field to track whether the ROE allows collection of artifacts. ROE allows collection when the signed ROE form includes permission to collect and included a signed Deed of Gift form.
- The ENV SME clicks "Add." This allows the parcel to move from below the shaded line and into the table.
- 7. The ENV SME uses the "Sites" section of this Activity to summarize the investigation results. These results must be finalized following the completion of consultation. This information will be used for an annual report from FHWA to the National Park Service, to identify the status of work, and to provide data for NEPA analysis.
  - The ENV SME enters the County and trinomial number in the "Site Number" field.
  - The ENV SME selects the correct response from the drop-down menu for the "4(f) Property" field. The options are "Yes," "No," and "Undetermined." In the vast majority of cases, the appropriate response is "No," since most archeological sites are not listed or eligible for listing in the National Register of Historic Places. In the unusual circumstance in which the site is listed or eligible for listing in the National Register of Historic Places, the ENV SME answers, "Yes," and also creates the "Obtain Section 4(f) Approval" Activity (if it has not already been created).
  - The ENV SME selects the correct response from the drop-down menu for the "Site Eligibility" field. The options are "Eligible Alternative Mitigation", "Eligible –Avoidance", and "Eligible Data Recovery", "Ineligible", and "Undetermined".
  - The ENV SME selects the correct response from the drop-down menu for the "Project Effect" field. The options are "Adverse Effect," "No Adverse Effect Avoidance," "No Adverse Effect Outside APE," "No Effect", and "Undetermined". The answer to this question must correspond with the answer to the "Site Eligibility" field; for example, a site labeled as "Ineligible" would never suffer an "Adverse Effect".
  - The ENV SME enters information to characterize the site in the "Site Description" field.
- 8. The ENV SME selects "Adverse effect," "No Effect/No Further Work," "No Adverse Effect/No Further Work," or "Potential Adverse Effect/Further Work Required" from the drop-down menu for the "Finding" field. For projects with no archeological historic properties in the APE, the typical response is "No Effect/No Further Work." The ENV SME proceeds as instructed below, depending on the Finding.
  - "Adverse effect" If the ENV SME ultimately selected "Adverse effect", then the ENV SME creates three Coordinations under this Activity (one for THC-A Coordination, one for PA Tribe Coordination, and one for ACHP Coordination). In addition, the ENV SME may create an OTH Coordination, if consultation included other consulting parties. The ENV SME proceeds according to the Coordination instructions below. The ENV SME also



creates the "Perform Archeology Data Recovery" Activity, the "Perform Archeology Mitigation" Activity, or the "Perform Archeology Monitoring Commitments" Activity.

Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeology Testing" Activity once all associated Coordinations have been finalized.

"No adverse effect/no further work" - If the ENV SME ultimately selected "No adverse effect/no further work," then the ENV SME creates two Coordinations under this Activity (one for THC-A Coordination and one for PA Tribe Coordination). In addition, the ENV SME may create an OTH Coordination, if consultation included other consulting parties. The ENV SME proceeds according to the Coordination instructions below. The ENV SME may also create the "Perform Archeology Mitigation" Activity, if this Activity was necessary to achieve the "No adverse effect/no further work" finding.

Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeology Testing" Activity once all associated Coordinations have been finalized.

- "No effect/no further work" If the ENV SME ultimately selected, "No effect/no further work," then the ENV SME creates either ENV-A In-House Coordination or THC-A Coordination. Additional Coordinations may be appropriate under the following circumstances:
  - if the ENV SME previously undertook PA Tribe Coordination or the Activity resulted in the discovery of archeological sites or Native American cemeteries, then the ENV SME must conduct additional PA Tribe Coordination; and
  - if consultation included other consulting parties, then the ENV SME may create an OTH Coordination.

The ENV SME proceeds according to the Coordination instructions below. Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeology Testing" Activity once all associated Coordinations have been finalized.

 "Potential Adverse Effect/Further Work Required" - If the ENV SME ultimately selected, "Potential Adverse Effect/Further Work Required," then the ENV SME creates two Coordinations under this Activity (one for THC-A Coordination and one for PA Tribe Coordination). In addition, the ENV SME may create an OTH Coordination, if consultation included other consulting parties. The ENV SME proceeds according to the Coordination instructions below. The ENV SME also creates the "Cemetery Investigation" Activity, as applicable.



Also, if further work is needed to identify the presence of burials, the ENV SME creates the "Perform Cemetery Investigation" Activity, and/or if burials have already been identified and require removal, the ENV creates the "Perform Cemetery Removal" Activity.

The ENV SME only finalizes the "Perform Archeology Testing" Activity once all associated Coordinations have been finalized.

#### ENV-A In-House Coordination Process

If the ENV SME determines that the project can be coordinated internally for expediency and it meets the criteria for internal coordination under ENV's Memorandum of Understanding between the Texas Historical Commission and the Texas Department of Transportation and/or the Programmatic Agreement among the Federal Highway Administration, Texas State Historic Preservation Office, Advisory Council on Historic Preservation, and the Texas Department of Transportation, then the ENV SME follows the steps below to begin the coordination (there is no need to upload anything to this coordination).

- 1. In the Coordination, the ENV SME selects the drop-down response "ENV-A" for the "Agency Name" field.
- 2. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details as follows:
  - For the "Correspondence Status" field, the ENV SME selects, "Sent Information," using the drop-down menu.
  - For the "Correspondence Method" field, the ENV SME selects, "Other," using the dropdown menu.
  - For the "Correspondence Date" field, the ENV SME enters the current date.
  - For the "Correspondence From" field, the ENV SME enters, "TxDOT."
  - For the "Correspondence To" field, the ENV SME enters "TxDOT."
  - For the "Comments" field, the ENV SME enters, "Request for internal review and approval of a finding of no archeological historic properties affected and no further work required, as permitted under the PA and MOU."
- **3.** The ENV SME assigns the ENV-A Coordination to the ENV SME team lead or ENV SME manager.
- 4. Once a week, the ENV SME team lead or ENV SME manager reviews the archeological testing report for each assigned project and requests clarifications from the authoring ENV SME as necessary. Once the review has been completed, resulting in a satisfactory archeological testing report and confirmation of "no effect/no further work," the ENV SME team lead or ENV SME manger follows the steps below to complete the coordination.
- 5. The ENV SME team lead or ENV SME manager fills-in the correspondence details as follows:
  - For the "Correspondence Status" field, the ENV SME team lead or ENV SME manager selects, "Response received no further action", using the drop-down menu.
  - For the "Correspondence Method" field, the ENV SME team lead or ENV SME manager selects, "Other," using the drop-down menu.



- For the "Correspondence Date" field, the ENV SME team lead or ENV SME manager enters the current date.
- For the "Correspondence From" field, the ENV SME team lead or ENV SME manager enters "TxDOT."
- For the "Correspondence To" field, the ENV SME team lead or ENV SME manager enters "TxDOT."
- For the "Comments" field, the ENV SME team lead or ENV SME manager enters, "Internal review and approval of a finding of no archeological historic properties affected and no further work required, as permitted under the PA and MOU."
- 6. In the Coordination, the ENV SME team lead or ENV SME manager selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 7. The ENV SME team lead or ENV SME manager finalizes the Coordination.

# THC-A Coordination process

If the ENV SME does not require expedited review or determines that the project does <u>not</u> meet the criteria for internal coordination under ENV's **Memorandum of Understanding between the Texas Historical Commission and the Texas Department of Transportation** and/or the **Programmatic Agreement among the Federal Highway Administration, Texas State Historic Preservation Office, Advisory Council on Historic Preservation, and the Texas Department of Transportation** and must instead be coordinated with the Texas Historical Commission/Texas State Historic Preservation Officer (THC/TSHPO) (for example because important sites might be impacted by the project or other circumstances), then the ENV SME uploads the following documentation under the Coordination:

- Consultation letter to the THC/TSHPO: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016")
- The emailed response from the THC/TSHPO: CSJ\_THC\_response\_DD-MMM-YYYY (e.g., "222213005\_THC\_response\_07-Sep-2016")
- Any other correspondence to or from TxDOT or the THC/TSHPO, using the following naming convention for correspondence to TSHPO: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016").

- 1. The ENV SME drafts the consultation letter, using ENV's Template for TSHPO/THC Consultation Regarding Archeological Historic Properties. The ENV SME emails the draft letter and associated archeological testing report to the ENV SME manager.
- 2. The ENV SME manager reviews the archeological testing report and requests clarifications from the authoring ENV SME as necessary. Once the review has been completed, resulting in a satisfactory consultation letter and report and confirmation of proposed findings, the ENV SME manager sends the letter and archeological testing report to the THC/TSHPO via THC's eTRAC system.
- **3.** The THC/TSHPO reviews the letter and archeological testing report and emails any requests for clarifications from the authoring ENV SME as necessary.



- **4.** The ENV SME transmits to THC/TSHPO any requested responses or clarifications via THC's eTRAC system.
- 5. The THC/TSHPO emails their final response to the ENV SME from the THC's eTRAC system.
- **6.** In the Coordination, the ENV SME selects the drop-down response "THC-A" for the "Agency Name" field.
- 7. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the THC/TSHPO, using "TxDOT" to refer to TxDOT and "THC" to refer to the THC/TSHPO in the "Correspondence From" and "Correspondence To" fields.
- 8. The ENV SME uploads each email or letter to or from TxDOT and the THC/TSHPO under the Coordination, using this file naming convention for the consultation letter signed by the THC/TSHPO via the THC's eTRAC system: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016"); and this file naming convention for any additional correspondence from TxDOT to THC: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016"); and this file naming convention for the emailed responses from THC to TxDOT: CSJ\_THC\_response\_DD-MMM-YYYY (e.g., "222213005\_THC\_response\_07-Sep-2016").
- **9.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **10.** The ENV SME finalizes the Coordination.

PA Tribal Coordination (i.e., formal, project-specific coordination) process

ENV's formal, project-specific tribal coordination process is required in order to consult on the eligibility and effects determinations made in compliance with the National Historic Preservation Act.

The ENV SME uploads the following documentation under the Coordination:

- Consultation emails: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- Any other correspondence to or from TxDOT or tribes

- To continue consultation, the ENV SME drafts text for an email, using ENV's Template for Tribal Consultation. The ENV SME emails the draft email and the archeological testing report to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- 2. In the Coordination, the ENV SME selects the drop-down response "PA Tribe (PA)".



- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the tribes with whom the project was coordinated.
- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the tribes.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the tribes under the Coordination using the following file naming conventions:
  - Consultation emails: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- 6. Once either all comments from tribes have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 7. The ENV SME finalizes the Coordination.

#### Other Consulting Party Coordination process

For some large, complex projects with potential for controversy and/or adverse effects to archeological historic properties, the ENV SME will identify and invite consultation with other consulting parties. These consulting parties could include County Historical Commissions, local archeological societies (e.g., the Houston Archeological Society (HAS)), and other knowledgeable parties. When the ENV SME consults with other consulting parties, the ENV SME uploads the following documentation under the Coordination:

- Consultation emails: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007 Consultation Request Other Parties 08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007 Consultation Response HAS 20-Jun-2018")
- Any other correspondence to or from TxDOT and the other consulting parties.

- The ENV SME drafts the consultation email using ENV's Template for Other Consulting Party Consultation. The ENV SME emails the draft email and the archeological testing report to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- 2. In the Coordination, the ENV SME selects the drop-down response "Other Consulting Parties (OTH)" for the "Agency Name" field.
- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the other consulting parties with whom the project was coordinated.



- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the other consulting parties.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the other consulting parties under the Coordination using the following file naming conventions:
  - Consultation emails: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_Other\_Parties\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_HAS\_20-Jun-2018")
- Once either all comments from other consulting parties have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **9.** The ENV SME finalizes the Coordination.

#### Advisory Council on Historic Preservation Coordination process

For projects with adverse effects, the ENV SME will notify the Advisory Council on Historic Preservation (ACHP). When the ENV SME coordinates with ACHP, the ENV SME uploads the following documentation under the Coordination:

- Advisory Council on Historic Preservation Electronic Section 106 Documentation Submittal System (e106) Form: CSJ\_ACHP\_DD-MMM-YYYY (e.g., "363201001\_Submittal\_ACHP\_08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Response\_ACHP\_DD-MMM-YYYY (e.g., "363201001\_ Response\_ACHP\_03-Mar-2019")

- 1. The ENV SME completes the form Advisory Council on Historic Preservation Electronic Section 106 Documentation Submittal System (e106) Form. The ENV SME also compiles documentation of completed consultation and any maps, report excerpts, and photographs that describe the affected property. The ENV SME then submits the form and associated documentation by email to ACHP.
- **2.** In the Coordination, the ENV SME selects the drop-down response "Advisory Council on Historic Preservation (ACHP)" for the "Agency Name" field.
- **3.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the ACHP.
- **4.** The ENV SME uploads all correspondence to or from TxDOT or the ACHP under the Coordination using the following file naming conventions:



- Advisory Council on Historic Preservation Electronic Section 106 Documentation Submittal System (e106) Form: CSJ\_ACHP\_DD-MMM-YYYY (e.g., "363201001\_Submittal\_ACHP\_08-Jun-2017")

- 5. Once either all comments from ACHP have been satisfactorily addressed or no response has been received within the notification period (15 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 6. The ENV SME finalizes the Coordination.

# "Perform Cemetery Investigation" Activity

- 1. If, after creating this Activity, the district environmental staff or the ENV SME determined that a cemetery investigation would not, in fact, be required, then the district environmental staff or the ENV SME selects, "No," from the drop-down menu for the field labeled, "Was a Cemetery Investigation performed?;" explains in the "Comments" field why no cemetery investigation was required, and finalizes this Activity.
- 2. The research and (possibly) fieldwork needed to identify the presence of burials is typically completed as part of the "Perform Archeological Background Study" Activity or the "Perform Archeology Survey" Activity, in which case the information needed to complete this "Perform Cemetery Investigation" Activity will be found in the documentation associated with those Activities.

This Activity must be created separately for each cemetery that has been identified, if multiple cemeteries have been identified for the same project, regardless of whether the research and (possibly) fieldwork needed to identify the presence of burials was completed as part of the Perform Archeological Background Study" Activity, the "Perform Archeology Survey" Activity, or as a separate investigation.

If the research and (possibly) fieldwork needed to identify the presence of burials is <u>not</u> completed as part of the "Perform Archeological Background Study" Activity or the "Perform Archeology Survey" Activity, then such work may be conducted by district environmental staff, or district environmental staff may request that the appropriate ENV SME conduct that work.

Also, if the research and (possibly) fieldwork needed to identify the presence of burials is <u>not</u> completed as part of the "Perform Archeological Background Study" Activity or the "Perform Archeology Survey" Activity, <u>and</u> fieldwork is required, <u>and</u> the fieldwork would occur on TxDOT right of way or other state or local public land, then there is an additional requirement. A professional archeologist must apply for and acquire a Texas Antiquities permit from the Texas Historic Commission. The professional archeologist prepares the permit application in accordance with **ENV's Review Standard for Antiquities Permit Applications**.

#### Acquire Texas Antiquities Permit by district environmental staff (if needed)

- 1. If a Texas Antiquities permit is required, district environmental staff uploads the Texas Antiquities Permit application (if applicable), using the file naming convention: CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "222215024\_Permit\_App\_10-Apr-2016").
- 2. District environmental staff creates a Review of the Texas Antiquities permit application under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the Texas Antiquities Permit application that is responsive to the comments made and uploads it under this Activity;



- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **3.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff uploads the Texas Antiquities Permit application with the word, "Approved," at the beginning of the file name.
- **4.** The ENV SME transmits the approved Texas Antiquities Permit application to the Texas Historical Commission for their review, approval, and assignation of the Texas Antiquities Permit number for the project.
- **5.** The THC reviews the permit application and requests clarifications or revisions from the ENV SME as necessary.
  - The ENV SME emails any such requests for revision or clarification to the district environmental staff.
  - The district environmental staff prepares a revised Texas Antiquities Permit application and uploads the revised Texas Antiquities Permit application with the word "Revised" at the beginning of the file name.
  - The ENV SME transmits the revised Texas Antiquities Permit application to the THC.
- **6.** Once the THC has no further comments, the THC will notify the ENV SME and the professional archeologist performing the investigation of the assigned permit number.
- 7. The professional archeologist can begin the fieldwork at that point.
- **8.** The THC will also mail a hard copy of the Texas Antiquities Permit to the ENV SME and the professional archeologist.
- **9.** The ENV SME will upload a copy of the Texas Antiquities Permit using the file naming convention CSJ\_TAP\_DD-MMM-YYYY (e.g., "222219005\_TAP\_02-May-2018").

# Performance of research and (possibly) fieldwork needed to identify the presence of burials by district environmental staff (if needed)

- **10.** As stated earlier, research and (possibly) fieldwork is needed in connection with this Activity only if such work was not completed as part of the "Perform Archeological Background Study" Activity or the "Perform Archeology Survey" Activity.
- **11.** For the field labeled, "Work Status," in this Activity, district environmental staff selects, "In Progress," if the district environmental staff has all project information and access to real property needed to conduct any required fieldwork. Alternatively, if the district environmental staff lacks project information or access to real property needed to conduct any required fieldwork, then district environmental staff selects one of the following drop-down options for this field:
  - Select, "Need Additional ROE/ROW Acquisition," if the district environmental staff is waiting for both right-of-entry and right-of-way acquisition.



- Select, "Need Project Information," if the district environmental staff is waiting for project information.
- Select, "Need ROE," if the district environmental staff is waiting for right-of-entry.
- Select, "Need ROW Acquisition," if the district environmental staff is waiting for right-ofway acquisition.
- 12. Once the research and (possibly) fieldwork has been completed, <u>if fieldwork was done for this Activity</u>, district environmental staff prepares a cemetery investigation report according to ENV's Template for Archeological Survey. When using the template to prepare a cemetery investigation report, make appropriate edits to the title and other parts of the template to reflect that the report is for a cemetery investigation (not a background study or survey). District environmental staff uploads the cemetery investigation report using the file naming convention CSJ\_Cemetery\_Investigation\_DD-MMM-YYY (e.g., "222215024\_Cemetery\_Investigation\_10-Apr-2016").
- **13.** District environmental staff creates a Review of the report under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **14.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff uploads the cemetery investigation report with the word, "Approved," at the beginning of the file name.

#### Acquire Texas Antiquities Permit by ENV SME (if needed)

- 1. Under ENV's Memorandum of Understanding between the Texas Historical Commission and the Texas Department of Transportation, the ENV SME may not need to submit a formal permit application for a Texas Antiquities Permit. This permit may instead be obtained by notifying the Texas Historical Commission of the upcoming fieldwork.
- 2. The ENV SME either submits a permit notification email to the THC or transmits a hard copy of the Texas Antiquities Permit application to the THC for their review, approval, and assignation of the Texas Antiquities Permit number for the project.
  - The THC reviews the permit notification/application and requests clarifications or revisions from the ENV SME as necessary.
  - The ENV SME prepares a revised Texas Antiquities Permit notification/application.
  - The ENV SME transmits the revised Texas Antiquities Permit notification/application to the THC.



- 3. Once the THC permit notification/review process has been successfully completed, the THC will notify the ENV SME and the professional archeologist performing the investigation of the assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit application or notification email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved\_222215024\_Permit\_App\_10-Apr-2016").
- 4. The professional archeologist can begin the fieldwork at that point.
- **5.** The THC will also mail a hard copy of the Texas Antiquities Permit to the ENV SME and the professional archeologist (if a consultant will perform the investigation).
- **6.** The ENV SME will upload a copy of the Texas Antiquities Permit using the file naming convention CSJ\_TAP\_DD-MMM-YYYY (e.g., "222219005\_TAP\_02-May-2018").

# Performance of research and (possibly) fieldwork needed to identify the presence of burials by ENV SME (if needed)

- 7. As stated earlier, research and (possibly) fieldwork is needed in connection with this Activity only if such work was not completed as part of the "Perform Archeological Background Study" Activity or the "Perform Archeology Survey" Activity.
- 8. If the district environmental staff requests that an ENV SME perform the research and (possibly) fieldwork needed to identify the presence of burials, and if the ENV SME needs any project information or right of entry, then the ENV SME creates the "Obtain Project Information or Access" Activity, and the district environmental staff uploads any available right of entries or other project information requested by the SME under the "Obtain Project Information or Access" Activity.
- 9. For the field labeled, "Work Status," in this Activity, the ENV SME selects, "In Progress," if the ENV SME has all project information and access to real property needed to conduct any required fieldwork. Alternatively, if the ENV SME lacks project information or access to real property needed to conduct any required fieldwork, then the ENV SME selects one of the following drop-down options for this field:
  - Select, "Need Additional ROE/ROW Acquisition," if the ENV SME is waiting for both rightof-entry and right-of-way acquisition.
  - Select, "Need Project Information," if the ENV SME is waiting for project information.
  - Select, "Need ROE," if the ENV SME is waiting for right-of-entry.
  - Select, "Need ROW Acquisition," if the ENV SME is waiting for right-of-way acquisition.
- 15. Once the research and (possibly) fieldwork has been completed, <u>if fieldwork was done for this Activity</u>, the ENV SME prepares a cemetery investigation report according to ENV's Template for Archeological Survey. When using the template to prepare a cemetery investigation report, make appropriate edits to the title and other parts of the template to reflect that the report is for a cemetery investigation (not a background study or survey). The ENV SME uploads the cemetery investigation report using the file naming convention CSJ\_Cemetery\_Investigation\_DD-MMM-YYY (e.g., "222215024\_Cemetery\_Investigation\_10-Apr-2016").



- 16. If the project is anticipated to be cleared with an EA or EIS, the ENV SME creates a Review of the cemetery investigation report under this Activity and assigns it to ENV Project Delivery staff. Once ENV Project Delivery Staff has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the cemetery investigation report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.

Once ENV Project Delivery has no further comments and has finalized his or her Review, the ENV SME uploads the cemetery investigation report with the word, "Approved," at the beginning of the file name.

Next steps after completing research and (possibly) fieldwork needed to identify the presence of burials

- 1. Regardless of how the research and (possibly) fieldwork was performed and regardless of who was responsible for performing that work, the ENV SME completes the following steps, using the available technical documents and coordination results.
- **2.** The ENV SME selects "Yes" from the drop-down menu for the field labeled, "Was a Cemetery Investigation performed?"
- **3.** If the research and (possibly) fieldwork needed to identify the presence of burials was completed as part of the "Perform Archeological Background Study" Activity or the "Perform Archeology Survey" Activity, then in the "Comments" field for this Activity, the ENV SME indicates which Activity included this work.
- **4.** In the "Right of Entry (ROE) Required" field, the ENV SME enters "Yes" or "No" to designate whether ROE must be obtained prior to starting fieldwork.
- **5.** In the "Permit Number" field, the ENV SME enters the Permit Number (if any) assigned by the THC to the investigation. If there is no THC permit, enter "0."
- 6. The ENV SME may, at his or her discretion, use the "Parcels" table to track parcels for which access has been granted, access has been denied, and investigation has been completed. This table is most useful for large projects where the investigation will be conducted in more than one stage due to partial access to private property.
  - The ENV SME enters a descriptor or parcel identification number in the "Parcel ID" field. This field may be used to encompass multiple parcels, when appropriate.
  - The ENV SME enters the date at which granted ROE expires in the "ROE Expiration Date" field.
  - The ENV SME enters "Yes" or "No" in the "Investigated Completed" field to track which parcels of the evaluated APE still require investigation.
  - The ENV SME enters the date at which ROE received in the "ROE Received Date" field.
  - The ENV SME enters the date at which ROE requested in the "ROE Requested Date" field.
  - The ENV SME clicks "Add." This allows the parcel to move below the shaded line and into the table.



- 7. The ENV SME uses the "Sites" section of this Activity to summarize the investigation results. These results must be finalized following the completion of consultation. This information will be used for an annual report from FHWA to the National Park Service, to identify the status of work, and to provide data for NEPA analysis.
  - The ENV SME enters the THC's Cemetery ID Number, site trinomial, or cemetery name in the "Cemetery ID" field.
  - The ENV SME selects the correct response from the drop-down menu for the "4(f) Property" field. The options are "Yes," "No," and "Undetermined." In the vast majority of cases, the appropriate response is "No," since most cemeteries are not eligible for inclusion in the National Register of Historic Places.
  - The ENV SME selects the correct response from the drop-down menu for the "Burials in APE" field. The options are "Yes," "No," and "Undetermined."
  - The ENV SME selects the correct response from the drop-down menu for the "Is Cemetery 50 years or older" field. The options are "Yes," "No," and "Undetermined."
  - The ENV SME selects the correct response from the drop-down menu for the "Site Eligibility" field. The options are "Eligible Alternative Mitigation", "Eligible –Avoidance", and "Eligible Data Recovery", "Ineligible", and "Undetermined".
  - The ENV SME selects the correct response from the drop-down menu for the "Project Effect" field. The options are "Adverse Effect," "No Adverse Effect Avoidance," "No Adverse Effect Outside APE," "No Effect", and "Undetermined". The answer to this question must correspond with the answer to the "Site Eligibility" field; for example, a site labeled as "Ineligible" would never suffer an "Adverse Effect".
  - The ENV SME selects the correct response from the drop-down menu for the "Cemetery Type" field. The options are "Perpetual Care," "Unknown," "Abandoned", and "Other". Refer to the Health and Safety Code, Chapter 711 for definitions of these cemetery types.
  - The ENV SME enters information to characterize the site in the "Site Description" field.
- 8. The ENV SME may, at his or discretion, use the "Burials" table to summarize the investigation results. Each burial gets its own row in this table. Do not add any data to this table if the investigation did not identify individual burials. This table is most useful when individual burials may require removal to address project effects.
  - The ENV SME enters an identifier in the "Burial ID" field.
  - The ENV SME selects the correct response from the drop-down menu for the "Next of Kin Known" field. The options are "Yes," and "No".
  - The ENV SME enters the date on which permission was received from the appropriate parties to relocate the burial in the "Permission to Relocate Date" field.
  - The ENV SME selects the correct response from the drop-down menu for the "NAGPRA-Related" field. The options are "Yes," and "No".
  - The ENV SME enters an identifier for the next-of-kin, if known, in the "Next of Kin" field.
  - The ENV SME enters any additional information relevant for identifying the burial in the "Burial Description" field.
  - The ENV SME clicks "Add." This allows the burial to move below the shaded line and into the table.
- **9.** The ENV SME selects "Adverse effect," "No Effect/No Further Work," or "No Adverse Effect/No Further Work," from the drop-down menu for the "Work Status" field. For suspected cemeteries



that are later confirmed as having no burials, the typical response is "No Effect/No Further Work." (Note that "Potential Adverse Effect/Further Work Required" is listed as a drop-down option, but for this particular Activity, the ENV SME must never select it. Any work needed to identify the presence of burials must be completed as part of this Activity, not any other downstream Activity).

- 10. The ENV SME proceeds as instructed below, depending on the Finding.
  - "Adverse effect" If the ENV SME ultimately selected "Adverse effect" for the "Work Status" field, then the ENV SME creates the "Perform Cemetery Removal" Activity, the "Perform Archeology Mitigation" Activity, or the "Perform Archeology Monitoring Commitments" Activity. In addition, the ENV SME creates a THC-A Coordination, PA Tribe Coordination, OTH Coordination, and/or County Clerk Coordination (which is also tracked as an "Other Consulting Parties (OTH)" in ECOS) as appropriate according to the below instructions for each type of coordination. The ENV SME proceeds according to the Coordination instructions below if any Coordinations were created. The ENV SME only finalizes the "Perform Cemetery Investigation" Activity once all associated Coordinations have been finalized.
  - "No adverse effect/no further work" If the ENV SME ultimately selected "No adverse effect/no further work," then the ENV SME may create the "Perform Archeology Mitigation" Activity, if this Activity was necessary to achieve the "No adverse effect/no further work" finding. In addition, the ENV SME creates a THC-A Coordination, PA Tribe Coordination, OTH Coordination, and/or County Clerk Coordination (which is also tracked as an "Other Consulting Parties (OTH)" in ECOS) as appropriate according to the below instructions for each type of coordination. The ENV SME proceeds according to the Coordination instructions below if any Coordinations were created. The ENV SME only finalizes the "Perform Cemetery Investigation" Activity once all associated Coordinations have been finalized.
  - "No effect/no further work" If the ENV SME ultimately selected "No effect/no further work," then no additional Activities are necessary to evaluate or address potential effects to cemeteries. In addition, the ENV SME creates a THC-A Coordination, PA Tribe Coordination, OTH Coordination, and/or County Clerk Coordination (which is also tracked as an "Other Consulting Parties (OTH)" in ECOS) as appropriate according to the below instructions for each type of coordination. The ENV SME proceeds according to the Coordination instructions below if any Coordinations were created. The ENV SME only finalizes the "Perform Cemetery Investigation" Activity once all associated Coordinations have been finalized.

# THC-A Coordination process

Coordination with the THC on a standalone cemetery investigation may occur in rare cases. A project will merit consultation on a standalone cemetery investigation when:

- district environmental staff determined that the project meets the "No Review" criteria on ENV's "List of Projects that Do Not Require Review or Coordination for Archeological Compliance," a known cemetery occurs within or adjacent to the project's area of potential effects, and the cemetery requires a field investigation and a Texas Antiquities Permit for that field investigation; or
- the archeological background study and associated coordination resulted in a determination that the project would have no effect on archeological historic properties; a cemetery occurs within or



adjacent to the project's area of potential effects; and the cemetery requires a field investigation and a Texas Antiquities Permit for that field investigation.

The ENV SME uploads the following documentation under the Coordination:

- Consultation letter signed by the THC/TSHPO: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016")
- Any other correspondence to or from TxDOT or the THC/TSHPO, using the following naming convention for correspondence to TSHPO: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016").

- The ENV SME drafts the consultation letter, using ENV's Template for TSHPO/THC Consultation Regarding Archeological Historic Properties. The ENV SME emails the draft letter and associated cemetery investigation report to the ENV SME manager.
- 2. The ENV SME manager reviews the technical report and requests clarifications from the authoring ENV SME as necessary. Once the review has been completed, resulting in a satisfactory consultation letter and report and confirmation of proposed findings, the ENV SME manager sends the letter and cemetery investigation report to the THC/TSHPO.
- **3.** The THC/TSHPO reviews the letter and technical report and requests clarifications from the authoring ENV SME as necessary.
- 4. The ENV SME transmits to THC/TSHPO any requested responses or clarifications.
- **5.** The THC/TSHPO signs the consultation letter and returns the original, signed consultation letter to the ENV SME.
- 6. In the Coordination, the ENV SME selects the drop-down response "THC-A" for the "Agency Name" field.
- 7. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the THC/TSHPO, using "TxDOT" to refer to TxDOT and "THC" to refer to the THC/TSHPO in the "Correspondence From" and "Correspondence To" fields.
- 8. The ENV SME uploads each email or letter to or from TxDOT and the THC/TSHPO under the Coordination, using this file naming convention for the consultation letter signed by the THC/TSHPO: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016"); and this file naming convention for any additional correspondence from TxDOT to THC: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016").
- **9.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."



**10.** The ENV SME finalizes the Coordination.

#### PA Coordination (i.e., formal, project-specific coordination) process

Consultation with federally recognized tribes on a standalone cemetery investigation may occur in rare cases. A project will merit consultation on a standalone cemetery investigation when:

- district environmental staff determined that the project meets the "No Review" criteria on ENV's "List of Projects that Do Not Require Review or Coordination for Archeological Compliance," and a known Native American cemetery occurs within or adjacent to the project's area of potential effects of an FHWA undertaking; or
- the archeological background study and associated coordination resulted in a determination that the project would have no effect on archeological historic properties; a Native American cemetery occurs within or adjacent to the project's area of potential effects of an FHWA undertaking; and the cemetery requires a field investigation.

Under these conditions, the ENV SME uploads the following documentation under the Coordination:

- Consultation emails: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007 Consultation Request 08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- Any other correspondence to or from TxDOT or tribes

- 1. The ENV SME drafts the consultation email using **ENV's Template for Tribal Consultation**. The ENV SME emails the draft email and the cemetery investigation report to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- **2.** In the Coordination, the ENV SME selects the drop-down response "PA Tribe (PA)" for the "Agency Name" field.
- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the tribes with whom the project was coordinated.
- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the tribes.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the tribes under the Coordination using the following file naming conventions:
  - Consultation emails: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- 6. Once either all comments from tribes have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or



"Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."

7. The ENV SME finalizes the Coordination.

#### Other Consulting Party Coordination process

Often, county historic commissions, cemetery organizations, and cemetery caretakers will have special insight to the history of local cemeteries. The ENV SME will identify and invite consultation with these consulting parties in order to evaluate the potential for burials, both marked and unmarked, in the area of potential effects. When the ENV SME consults with other consulting parties, the ENV SME uploads the following documentation under the Coordination:

- Consultation emails: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_Other\_Parties\_08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_HAS\_20-Jun-2018")
- Any other correspondence to or from TxDOT and the other consulting parties.

- 1. The ENV SME drafts the email using ENV's Template for Other Consulting Party Consultation. The ENV SME emails the draft email and the cemetery investigation report (if one was prepared) to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- 2. In the Coordination, the ENV SME selects the drop-down response "Other Consulting Parties (OTH)" for the "Agency Name" field.
- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the other consulting parties with whom the project was coordinated.
- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the other consulting parties.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the other consulting parties under the Coordination using the following file naming conventions:
  - Consultation emails: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_Other\_Parties\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_HAS\_20-Jun-2018")
- 6. Once either all comments from other consulting parties have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 7. The ENV SME finalizes the Coordination.



#### County Clerk Coordination Process

If the investigation results in the finding of a previously unknown or abandoned cemetery, a Notice of Existence must be filed with the County Clerk within ten days of completing identification efforts. When the ENV SME must file a Notice of Existence, the ENV SME uploads the following documentation under the Coordination:

- Transmittal letter to landowner: CSJ\_Letter\_LandownerLastName\_DD-MMM-YYYY (e.g., "222217007\_Letter\_Anderson\_12-Jun-2017").
- Notarized Notice to County Clerk: CSJ\_Notice\_County\_Clerk\_DD-MMM-YYYY (e.g., "222217007\_Notice\_Frio Co\_Clerk\_12-Jun-2017")

- 1. The ENV SME works with the district environmental staff to write a legal description of the land on which the cemetery was found. In cases where the site location information is protected from public disclosure under the Antiquities Code of Texas, the legal description comprises the survey and abstract numbers for the parcel on which the cemetery occurs as recorded in the local appraisal district records.
- 2. The ENV SME drafts a Notice of Existence, using either the Notice of Existence of Archeological Cemetery form from the THC or the Notice of Existence of Unknown or Abandoned Cemetery form from the THC. Use the former form in cases where the site location information is protected from public disclosure under the Antiquities Code of Texas. Use the latter form in cases where the site location information is not protected from public disclosure under the Antiquities Code of Texas.
- 3. The ENV SME has the form notarized.
- **4.** The ENV SME makes a copy of the notarized Notice, creates a transmittal letter, makes a copy of the transmittal letter, and mails the letter and Notice copy to the landowner on record in the local appraisal district. In cases where TxDOT owns the property on which the cemetery occurs, the SME addresses the letter to the appropriate District Engineer.
- 5. The ENV SME files the Notice with County Clerk for the County in which the cemetery occurs. The ENV SME should bring a copy of the transmittal letter to the landowner. The ENV SME should also bring a copy of Texas Health and Safety Code, Chapter 711.011 when filing, as many County Clerks are unfamiliar with this part of the Code.
- 6. In the Coordination, the ENV SME selects the drop-down response "Other Consulting Parties (OTH)" for the "Agency Name" field.
- 7. In the "Comments" field of the Coordination, the ENV SME identifies the County Clerk office with which the notice is filed and identifies the landowner of record in the local appraisal district.
- 8. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence detail for the Notice.



- 9. The ENV SME uploads the notarized Notice of Existence under the Coordination using the following file naming convention: CSJ\_Notice\_County\_Clerk\_DD-MMM-YYYY (e.g., "222217007\_Notice\_Frio Co\_Clerk\_12-Jun-2017").
- **10.** The ENV SME uploads the transmittal letter under the Coordination using the following file naming convention: CSJ\_Letter\_LandownerLastName\_DD-MMM-YYYY (e.g., "222217007\_Letter\_Anderson\_12-Jun-2017").
- **11.** The ENV SME finalizes the Coordination.

# "Perform Cemetery Removal" Activity

- 1. If, after creating this Activity, the district environmental staff or the ENV SME determined that cemetery removal would not, in fact, be required, then the district environmental staff or the ENV SME selects, "No," from the drop-down menu for the field labeled, "Was a Cemetery Removal performed?," explains in the "Comments" field why no cemetery removal was required and finalizes this Activity.
- 2. The fieldwork and reporting required for the removal of a cemetery is sometimes completed as part of the "Perform Data Recovery" Activity, in which case some of the information needed to complete this "Perform Cemetery Removal" Activity will be found in the documentation associated with that Activity.

This Activity must be created separately for each cemetery requiring the removal, if multiple such cemeteries have been identified for the same project. This Activity must be created regardless of whether the removal of the cemeteries was completed as part of the "Perform Data Recovery" Activity or as a separate effort.

If the fieldwork and reporting required for the removal of a cemetery is <u>not</u> completed as part of the "Perform Archeology Data Recovery" Activity, then such work may be completed by a local government's consultant or an ENV SME. Regardless of whether the cemetery removal is performed by a local government's consultant or an ENV SME, it must be performed by a professional archeologist (see HSC 711.0105(a) and 13 TAC 26.4(2)).

Prior to removal of burials, the professional archeologist may need permission from one or more parties. The particular parties depend on the nature of the cemetery and other circumstances. Projects that would occur on TxDOT right of way or other state or local property have an additional requirement. The professional archeologist must apply for and obtain a Texas Antiquities permit from the Texas Historic Commission prior to beginning the cemetery removal. The professional archeologist prepares the permit application in accordance with **ENV's Review Standard for Antiquities Permit Applications**.

# Required Coordination prior to cemetery removal (if needed)

As stated earlier, the fieldwork and reporting associated with removing a cemetery may be completed as part of the "Perform Archeology Data Recovery" Activity. Regardless of whether the fieldwork and reporting required for the cemetery removal is performed as part of the "Perform Archeology Data Recovery" Activity or as part of the "Perform Cemetery Removal" Activity, the coordination described below will be completed and tracked as part of the "Perform Cemetery Removal" Activity.

Coordination related to the "Perform Cemetery Removal" Activity may have to be completed prior to performing the Activity. The nature of the required permissions depends on the type of cemetery and other circumstances as explained below. If any permissions are required, then the local government project sponsor or ENV SME creates a single "Coordinate Cemetery Removal" Coordination for all permissions, and uploads the following *documentation* under this Coordination:



- Requests for removal: CSJ\_Removal\_request\_party\_DD-MMM-YYYY (e.g., "222217007\_Removal\_Notification\_Woodlawn\_Cemetery\_08-Jun-2017").
- Notification letters or follow-up emails: CSJ\_Removal\_notification\_party\_DD-MMM-YYYY (e.g., "222217007\_Removal\_Notification\_THC\_08-Jun-2017").
- Email transmittal (if applicable) that accompanies formal letters: CSJ\_Removal\_Transmittal\_THC\_DD-MMM-YYYY (e.g., "222217007\_Removal\_Transmittal\_Other\_Parties\_08-Jun-2018").
- Electronic file copy of any responses: CSJ\_Removal\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Removal\_Response\_TravisCHC\_20-Jun-2018").
- Any other correspondence to or from TxDOT and the other consulting parties.
- The district court order, if one was obtained: CSJ\_Removal\_order\_DD-MMM\_YYYY (e.g., 222217007\_Removal\_order\_03-Mar-2019)
- State registrar permits (one per removed burial), if disinterment permits were obtained: CSJ\_Disinter\_Permit\_##\_DD-MMM-YYYY (e.g., 222217007\_Disinter\_Permit\_01\_04-Apr-2019)

Follow the steps below to conduct the required coordination. The applicable steps depend on the type of cemetery.

- 1. For an actively maintained cemetery where burials will be removed from the cemetery, the local government project sponsor or ENV SME obtains the following two sets of required permissions (for other types of cemeteries, skip to the next step):
  - The local government project sponsor or the ENV SME requests permission from the cemetery organization, the plot owner(s), and a representative from the decedent's family (see HSC 711.004(a) for the exact order of priority for the family representative). Since the permissions are required, no standard time frame exists for the acquisition of the permissions.
  - Once those permissions have been received, the local government project sponsor or the ENV SME obtains a permit or permits from the state registrar (HSC 711.004(f)). The state registrar requires up to eight weeks to process applications.
- 2. For an actively maintained cemetery where burials will be removed from the cemetery and the aforementioned consent cannot be obtained, the local government project sponsor or ENV SME does the following (HSC 711.004(c)) (for other types of cemeteries skip to the next step):
  - The local government project sponsor or the ENV SME gives notice to the cemetery
    organization or, if the cemetery organization cannot be found, the Texas Historical
    Commission;
  - The local government project sponsor or the ENV SME gives notice to the plot owner(s) and family representative(s) as detailed in HSC 711.004(a);
  - The local government project sponsor or the ENV SME, through the Office of the Attorney General, then requests a court order from the district court. No standard time frame exists for the acquisition of the court order, as it depends on when the proposed order can get scheduled on the district court docket. In prior cases, the court order has required four to six months to obtain.
  - After the court order has been obtained, the local government project sponsor or the ENV SME obtains a permit or permits from the state registrar (HSC 711.004(f)). The state registrar requires up to eight weeks to process applications.



- **3.** For unmarked graves from an unknown or abandoned cemetery where burials will be removed from the cemetery, the local government project sponsor or ENV SME obtains the following required permissions:
  - The local government project sponsor or the ENV SME gives notice to the Texas Historical Commission and the county historical commission (HSC 711.010(c))
  - The local government project sponsor or the ENV SME, through the Office of the Attorney General, then requests a court order from the district court HSC 711.010(a)). No standard time frame exists for the acquisition of the court order, as it depends on when the proposed order can get scheduled on the district court docket. In prior cases, the court order has required four to six months to obtain.
  - Permission from the state registrar is not required (HSC 711.004(f-1) and HSC 711.0105)
- **4.** The relocation of a burial within a family, fraternal, or community cemetery not larger than ten acres in size does not require any of the previously-described permissions (HSC 711(e)(1)(A)). A Texas Antiquities Permit may still be required for removals on state or local public lands.
- **5.** In the Coordination, the local government project sponsor or ENV SME selects the drop-down response "Other Consulting Parties (OTH)" for the "Agency Name" field.
- **6.** In the "Comments" field of the Coordination, the local government project sponsor or ENV SME lists all of the parties to whom notice was given or permission was requested.
- 7. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The local government project sponsor or ENV SME fills-in the correspondence details for each letter request, letter notification, email, request for court order, or disinterment permit request sent and each response received.
- **8.** The local government project sponsor or ENV SME uploads all correspondence to or from TxDOT or the other parties under the Coordination using the following file naming conventions:
  - Requests for removal: CSJ\_Removal\_request\_party\_DD-MMM-YYYY (e.g., "222217007\_Removal\_Notification\_Woodlawn\_Cemetery\_08-Jun-2017").
  - Notification letters or follow-up emails: CSJ\_Removal\_notification\_party\_DD-MMM-YYYY (e.g., "222217007\_Removal\_Notification\_THC\_08-Jun-2017").
  - Email transmittal (if applicable) that accompanies formal letters: CSJ\_Removal\_Transmittal\_THC\_DD-MMM-YYYY (e.g., "222217007\_Removal\_Transmittal\_Other\_Parties\_08-Jun-2018").
  - Electronic file copy of any responses: CSJ\_Removal\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Removal\_Response\_TravisCHC\_20-Jun-2018").
  - Any other correspondence to or from TxDOT and the other consulting parties.
  - The district court order, if one was obtained: CSJ\_Removal\_order\_DD-MMM\_YYYY (e.g., 222217007\_Removal\_order\_03-Mar-2019)
  - State registrar permits (one per removed burial), if disinterment permits were obtained: CSJ\_Disinter\_Permit\_##\_DD-MMM-YYYY (e.g., 222217007\_Disinter\_Permit\_01\_04-Apr-2019)



- **9.** In the Coordination, the local government project sponsor or ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **10.** The local government project sponsor or ENV SME finalizes the Coordination.

# Acquire Texas Antiquities Permit by local government's consultant (if needed)

- 1. As stated earlier, the fieldwork and reporting required for cemetery removal may be completed as part of the "Perform Archeology Data Recovery" Activity, in which case there is no need to obtain a separate Texas Antiquities Permit as described below.
- 2. If a Texas Antiquities permit is required specifically for the cemetery removal, the local government project sponsor uploads the Texas Antiquities Permit application (if applicable), using the file naming convention: CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "222215024\_Permit\_App\_10-Apr-2016").
- 3. The local government project sponsor creates a Review of the Texas Antiquities permit application under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, the local government project sponsor also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the local government project sponsor:
  - prepares a new, revised version of the Texas Antiquities Permit application that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **4.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, the local government project sponsor uploads the Texas Antiquities Permit application with the word, "Approved," at the beginning of the file name.
- **5.** The local government project sponsor transmits the approved Texas Antiquities Permit application to the Texas Historical Commission for their review, approval, and assignation of the Texas Antiquities Permit number for the project.
- **6.** The THC reviews the permit application and requests clarifications or revisions from the local government project sponsor as necessary.
  - The local government project sponsor prepares a revised Texas Antiquities Permit application uploads the revised Texas Antiquities Permit application with the word "Revised" at the beginning of the file name.
  - The local government project sponsor transmits the revised Texas Antiquities Permit application to the THC.
- **7.** Once the THC has no further comments, the THC will notify the professional archeologist performing the cemetery removal of the assigned permit number.



- **8.** The professional archeologist can begin the cemetery removal at that point (provided that all other required permissions described above have been obtained).
- **9.** The THC will also mail a hard copy of the Texas Antiquities Permit to the professional archeologist.
- **10.** The local government project sponsor will upload a copy of the Texas Antiquities Permit using the file naming convention CSJ\_TAP\_DD-MMM-YYYY (e.g., "222219005\_TAP\_02-May-2018").

# Preparation of cemetery removal report by local government's consultant (if needed)

- **11.** As stated earlier, the fieldwork and reporting required for cemetery removal may be completed as part of the "Perform Archeology Data Recovery" Activity, in which case there is no need to prepare a separate cemetery removal report as described below.
- **12.** Once the cemetery removal has been completed, the local government project sponsor prepares a cemetery removal report and uploads the cemetery removal report using the file naming convention CSJ\_Cemetery\_Removal\_DD-MMM-YYY (e.g., "222215024\_Cemetery\_Removal\_10-Apr-2016").
- **13.** The local government project sponsor creates a Review of the cemetery removal report under this Activity and assigns it to the ENV SME assigned to the project. If the project is anticipated to be cleared with an EA or EIS, the local government project sponsor also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the local government project sponsor:
  - prepares a new, revised version of the cemetery removal report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **14.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, the local government project sponsor uploads the cemetery removal report with the word, "Approved," at the beginning of the file name.

# Acquire Texas Antiquities Permit by ENV SME (if needed)

- 1. As stated earlier, the fieldwork and reporting required for cemetery removal may be completed as part of the "Perform Archeology Data Recovery" Activity, in which case there is no need to obtain a separate Texas Antiquities Permit as described below.
- 2. Under ENV's Memorandum of Understanding between the Texas Historical Commission and the Texas Department of Transportation, the ENV SME may not need to submit a formal permit application for a Texas Antiquities Permit. This permit may instead be obtained by notifying the Texas Historical Commission of the upcoming fieldwork.



- **3.** The ENV SME either submits a permit notification email to the THC or transmits a hard copy of the Texas Antiquities Permit application to the THC for their review, approval, and assignation of the Texas Antiquities Permit number for the project.
  - The THC reviews the permit notification/application and requests clarifications or revisions from the ENV SME as necessary.
  - The ENV SME prepares a revised Texas Antiquities Permit notification/application.
  - The ENV SME transmits the revised Texas Antiquities Permit notification/application to the THC.
- 4. Once the THC permit notification/review process has been successfully completed, the THC will notify the ENV SME and the professional archeologist performing the cemetery removal of the assigned permit number. The ENV SME uploads the approved Texas Antiquities Permit application or notification email, using the file naming convention: Approved\_CSJ\_Permit\_App\_DD-MMM-YYY (e.g., "Approved\_222215024\_Permit\_App\_10-Apr-2016").
- **5.** The professional archeologist can begin the cemetery removal at that point (provided that all other required permissions described above have been obtained).
- **6.** The THC will also mail a hard copy of the Texas Antiquities Permit to the ENV SME and the professional archeologist (if a consultant will perform the investigation).
- **7.** The ENV SME will upload a copy of the Texas Antiquities Permit using the file naming convention CSJ\_TAP\_DD-MMM-YYYY (e.g., "222219005\_TAP\_02-May-2018").

# Preparation of archeological cemetery removal report by the ENV SME (if needed)

- 8. As stated earlier, the fieldwork and reporting required for cemetery removal may be completed as part of the "Perform Archeology Data Recovery" Activity, in which case there is no need to prepare a separate cemetery removal report as described below.
- **9.** If the district environmental staff requests that an ENV SME prepare the cemetery removal report, and if the ENV SME needs any project information or right of entry, then the ENV SME creates the "Obtain Project Information or Access" Activity, and the district environmental staff uploads any available right of entries or other project information requested by the SME under the "Obtain Project Information or Access" Activity.
- **10.** Once the cemetery removal has been completed, the ENV SME prepares a cemetery removal report and uploads the cemetery removal report using the file naming convention CSJ\_Cemetery\_Removal\_DD-MMM-YYY (e.g., "222215024\_Cemetery\_Removal\_10-Apr-2016").
- 11. If the project is anticipated to be cleared with an EA or EIS, the ENV SME creates a Review of the cemetery removal report under this Activity and assigns it to ENV Project Delivery staff. Once ENV Project Delivery Staff has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the cemetery removal report that is responsive to the comments made and uploads it under this Activity;



- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.

Once ENV Project Delivery has no further comments and has finalized his or her Review, the ENV SME uploads the cemetery removal report with the word, "Approved," at the beginning of the file name.

# Next steps after uploading the approved cemetery removal report

- 1. Regardless of how the cemetery removal was performed and regardless of who was responsible for performing that work, the ENV SME completes the following steps, using the available technical documents and coordination results.
- 2. In the "Cemetery ID" field, the ENV SME enters the THC's Cemetery ID Number, site trinomial, or cemetery name.
- **3.** In the "De-Dedication Date" field, the ENV SME enters the date of the court order (if applicable) de-dedicating the parcel(s) on which cemetery occurred.
- **4.** In the "TX Antiquities Permit Number" field, the ENV SME enters the Permit Number (if any) assigned by the THC to the investigation. If there is no THC permit, enter "0."
- **5.** In the "Construction Clearance Date" field, the ENV SME enters the date on which all required permissions, removals, and other agreed-upon measures related to removal of the cemetery have been completed, allowing construction to occur at the site of the cemetery.
- **6.** In the "NEPA Approval Date" field, the ENV SME enters the date indicated for the "Environmental Clearance" field on WPD I.
- 7. The ENV SME uses the "Burials" table to summarize the removal results.
  - The ENV SME enters an identifier in the "Burial ID" field.
  - The ENV SME selects the correct response from the drop-down menu for the "Permit Obtained" field. The options are "Yes," and "No". If no permit is required from the state registrar, leave this field blank.
  - The ENV SME enters the date on which permission was received from the appropriate parties to relocate the burial in the "Permission to Relocate Date" field.
  - The ENV SME selects the correct response from the drop-down menu for the "Burial Status" field, detailing the intended final disposition of the burial. The options are "Reinterred w/i cemetery," "Perpetual care cemetery," "Trans to curation facility," and "Transferred to tribe".
  - The ENV SME enters the "Full Name of the Deceased" from the Disinterment Permit in the "Permit Number" field.
  - The ENV SME selects the correct response from the drop-down menu for the "NAGPRA Cultural Affiliation Determination" field. The options are "Yes," and "No". If NAGPRA does not apply to the burial, leave this field blank.



- The ENV SME enters the date on which the burial was removed in the "Burial Removal Date" field.
- The ENV SME clicks "Add." This allows the burial to move from below the shaded line and into the table.
- 8. The ENV SME finalizes the "Perform Cemetery Removal" Activity once all burials listed for removal have a "Burial Removal Date;" and the ENV SME completes, if applicable, THC-A Coordination, PA Tribal Coordination, and OTH Coordination as explained below.
- **9.** If any of the burials are identified as being Native American, then the ENV SME creates the "Perform Native American Graves Protection and Repatriation Act (NAGPRA) Analysis" Activity.

# THC-A Coordination process

Coordination with the THC will occur when the removal requires a Texas Antiquities permit from the THC. The ENV SME uploads the following documentation under the Coordination:

- Consultation letter signed by the THC/TSHPO: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016")
- Any other correspondence to or from TxDOT or the THC/TSHPO, using the following naming convention for correspondence to TSHPO: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016").

Follow the steps below to conduct the coordination.

- The ENV SME drafts the consultation letter, using ENV's Template for TSHPO/THC Consultation Regarding Archeological Historic Properties. The ENV SME emails the draft letter and associated cemetery removal report to the ENV SME manager.
- 2. The ENV SME manager reviews the cemetery removal report and requests clarifications from the authoring ENV SME as necessary. Once the review has been completed, resulting in a satisfactory consultation letter and cemetery removal report and confirmation of proposed findings, the ENV SME manager sends the letter and cemetery removal report to the THC/TSHPO.
- **3.** The THC/TSHPO reviews the letter and cemetery removal report and requests clarifications from the authoring ENV SME as necessary.
- 4. The ENV SME transmits to THC/TSHPO any requested responses or clarifications.
- **5.** The THC/TSHPO signs the consultation letter and returns the original, signed consultation letter to the ENV SME.
- 6. In the Coordination, the ENV SME selects the drop-down response "THC-A" for the "Agency Name" field.
- 7. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the THC/TSHPO,



using "TxDOT" to refer to TxDOT and "THC" to refer to the THC/TSHPO in the "Correspondence From" and "Correspondence To" fields.

- 8. The ENV SME uploads each email or letter to or from TxDOT and the THC/TSHPO under the Coordination, using this file naming convention for the consultation letter signed by the THC/TSHPO: CSJ\_THC\_DD-MMM-YYYY (e.g., "222213005\_THC\_20-Aug-2016"); and this file naming convention for any additional correspondence from TxDOT to THC: CSJ\_Consultation\_Request\_THC\_DD-MMM-YYYY (e.g., "222213005\_Consultation\_Request\_THC\_19-Aug-2016").
- **9.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **10.** The ENV SME finalizes the Coordination.

# PA Coordination (i.e., formal, project-specific coordination) process

Typically, tribal consultation regarding the removal of burials in the area of potential effects should be completed prior to the "Perform Cemetery Removal" Activity. In rare cases, the outcome of the prior consultation might require the ENV SME to continue consultation during the removal process. Under these conditions, the ENV SME uploads the following documentation under the Coordination:

- Consultation emails: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- Any other correspondence to or from TxDOT or tribes

Follow the steps below to conduct the coordination.

- 1. The ENV SME drafts an email, using **ENV's Template for Tribal Consultation**. The ENV SME emails the draft email and the cemetery removal report to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- **2.** In the Coordination, the ENV SME selects the drop-down response "PA Tribe (PA)" for the "Agency Name" field.
- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the tribes with whom the project was coordinated.
- **4.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the tribes.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the tribes under the Coordination using the following file naming conventions:
  - Consultation emails: CSJ\_Consultation\_Request\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_08-Jun-2017")



- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Tribe\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_Kiowa\_20-Jun-2018")
- 6. Once either all comments from tribes have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 7. The ENV SME finalizes the Coordination.

# Other Consulting Party Coordination process

Typically, other consulting party consultation regarding the removal of burials in the area of potential effects should be completed prior to the "Perform Cemetery Removal" Activity. In rare cases, the outcome of the prior consultation might require the ENV SME to continue consultation during the removal process. Under these conditions, the ENV SME uploads the following documentation under the Coordination:

- Consultation emails: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_Other\_Parties\_08-Jun-2017")
- Electronic file copy of any responses: CSJ\_Consultation\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_HAS\_20-Jun-2018")
- Any other correspondence to or from TxDOT and the other consulting parties.

Follow the steps below to conduct the coordination.

- The ENV SME drafts an email, using ENV's Template for Other Consulting Party Consultation. The ENV SME emails the draft email and cemetery removal report to the ENV SME responsible for consultation. The ENV SME responsible for consultation finalizes the documentation and transmits it to all appropriate consulting parties.
- 2. In the Coordination, the ENV SME selects the drop-down response "Other Consulting Parties (OTH)" for the "Agency Name" field.
- **3.** In the "Comments" field of the Coordination, the ENV SME lists all of the other consulting parties with whom the project was coordinated.
- 4. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each email sent to or from the other consulting parties.
- **5.** The ENV SME uploads all correspondence to or from TxDOT or the other consulting parties under the Coordination using the following file naming conventions:
  - Consultation emails: CSJ\_Consultation\_Request\_Other\_Parties\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Request\_Other\_Parties\_08-Jun-2017")
  - Electronic file copy of any responses: CSJ\_Consultation\_Response\_Party\_Name\_DD-MMM-YYYY (e.g., "222217007\_Consultation\_Response\_HAS\_20-Jun-2018")
- 6. Once either all comments from other consulting parties have been satisfactorily addressed or no response has been received within the review period (31 days), the ENV SME selects



"Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."

7. The ENV SME finalizes the Coordination.

# "Perform Consultation Documentation" Activity

This Activity may be used by an ENV SME to track the development of archeology-related consultation documentation for a complicated project.

- **1.** The ENV SME self-assigns the Activity.
- 2. The ENV SME describes the consultation in the "Comments" field.
- **3.** The ENV SME completes the associated documentation and finalizes the Activity.



# "Perform Native American Graves Protection and Repatriation Act (NAGPRA) Analysis" Activity

This Activity is used by an ENV SME to track compliance with the Perform Native American Graves Protection and Repatriation Act (NAGPRA), when NAGPRA is triggered for a project.

- **1.** The ENV SME self-assigns the Activity.
- 2. The ENV SME describes the NAGPRA issue in the "Comments" field.
- **3.** The ENV SME completes the associated work and consultation in accordance with 43 CFR 10.9-11, uploads all associated documentation under this Activity, and finalizes the Activity.

Citation(s): Native American Graves Protection and Repatriation Act, 25 U.S.C. 3001 et seq.; 43 CFR 10



# "Biology SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of biology. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding biology, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding biology.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.



# "Obtain Coastal Barrier Resources Act (CBRA) Opinion" Activity

**1.** District environmental staff determines if the project qualifies for the exception at 16 USC 3505(3), which is referred to as the "essential link exception:"

"The maintenance, replacement, reconstruction, or repair, <u>but not the expansion</u>, of publicly owned or publicly operated roads, structures, or facilities <u>that are essential links in a larger</u> <u>network or system</u>." 16 USC 3505(3).

2. If the project does <u>not</u> meet the "essential link exception" described above, then district environmental staff determines if the project qualifies for the exception at 16 USC 3505(6)(F), which is referred to as the "CBRA consistent exception."

To qualify for the CBRA consistent exception, the project must consist of the following:

"Maintenance, replacement, reconstruction, or repair, <u>but not the expansion</u> (except with respect to United States route 1 in the Florida Keys), of publicly owned or publicly operated roads, structures, and facilities." 16 USC 3505(6)(F).

<u>Additionally</u>, to qualify for the CBRA consistent exception, the project must be determined to be consistent with the following three purposes of the CBRA, which are to:

- minimize the loss of human life,
- minimize the wasteful expenditure of Federal revenues, and
- minimize the damage to fish, wildlife, and other natural resources associated with the coastal barriers along the Atlantic and Gulf coasts and along the shore areas of the Great Lakes. 16 USC 3501(b).
- **3.** If the project does <u>not</u> meet <u>either</u> of the exceptions listed above, then the project cannot proceed as a federally funded project.
- 4. If the project <u>does</u> meet one of the exceptions listed above, then district environmental staff prepares a draft consultation letter using the United States Fish and Wildlife Service's (USFWS) Inter-agency CBRA Consultation Template, which is available on USFWS's Coastal Barrier Resources System website (https://www.fws.gov/cbra/Consultations.html), and uploads the draft consultation letter under this Activity.
- 5. District environmental staff creates a Review of the draft consultation letter and assigns it to the appropriate ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the draft consultation letter that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and



- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 5. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if one was created), the ENV SME creates a Coordination and follows the steps below to conduct the coordination with the USFWS.

# Coordination process

- 6. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the USFWS.
- **7.** The ENV SME submits the consultation letter to the appropriate USFWS Ecological Services Field Office.
- 8. The ENV SME uploads the submitted consultation letter under the Coordination.
- **9.** The ENV SME uploads all correspondence between TxDOT and the USFWS under the Coordination.
- **10.** The ENV SME uploads the signed approval letter issued by the USFWS under the Coordination.
- **11.** After the USFWS issues the signed approval letter, the ENV SME finalizes the Coordination.

# Finalizing this Activity

**12.** After the ENV SME finalizes the Coordination, the ENV SME finalizes this Activity.

# "Obtain Endangered Species Act (ESA) Consultation" Activity

The instructions provided below are for conducting programmatic, informal project-specific, or formal project-specific consultation with the U.S. Fish and Wildlife Service (USFWS) (or the National Marine Fisheries Service) under section 7 of the Endangered Species Act. For instructions regarding which agency to consult with (USFWS versus NMFS), see **ENV's Environmental Handbook: Endangered Species Act.** If a project instead requires a section 10 authorization from the USFWS or NMFS, district environmental staff must contact the appropriate ENV SME assigned to the respective district to discuss how to proceed.

- 1. District environmental staff discusses the project with the ENV SME assigned to the respective district as soon as possible so that district environmental staff and the ENV EME are in alignment on the proposed course of action for completing ESA consultation.
- 2. The ENV SME may initiate "early coordination" with USFWS/NMFS, which is an informal exchange of information to discuss and vet avoidance, minimization, and voluntary conservation measures. This early coordination takes place prior to the consultation process discussed below, and does not need to be tracked in ECOS.
- **3.** For each species potentially affected by the project, district environmental staff determines whether the potential effects to that species are covered by a programmatic consultation that TxDOT has already completed with USFWS, by reviewing the programmatic consultation agreements listed below:
  - For the Red-cockaded Woodpecker, district environmental staff reviews ENV's Endangered Species Act Programmatic Consultation Agreement for Red-cockaded Woodpecker.
  - For the Golden-cheeked Warbler, district environmental staff reviews ENV's Endangered Species Act Programmatic Consultation Agreement for the Blackcapped Vireo and Golden-cheeked Warbler.
  - For the Houston toad, district environmental staff reviews ENV's Endangered Species Act Programmatic Consultation Agreement for the Houston toad.
  - For effects on *Eurycea* salamanders or karst invertebrate species related to geotechnical boreholes, traffic signals, and ITS projects, district environmental staff reviews ENV's Endangered Species Act Programmatic Consultation Agreement Covering Minor Projects for Eurycea Salamanders and Karst Invertebrates (WAC, AUS, SAT).

(Note that the four programmatic consultation agreements are the ones that are in effect as of the date of this version of the Environmental Guide Volume 2; however, ENV-NRM intends to develop additional programmatic consultation agreements in the future, so district environmental staff should check **ENV's Natural Resources Toolkit** for any additional programmatic consultation agreements beyond the four listed above that may be applicable to the project.)

**4.** For potential effects to species that <u>are</u> covered by one or more programmatic consultations, district environmental staff proceeds under the "Programmatic consultation" heading below.



- **5.** For potential effects to species that are <u>not</u> covered by a programmatic consultation, district environmental staff proceeds under the "Project-specific consultation" heading below.
- 6. If the same project has <u>both</u> potential effects that <u>are</u> covered by one or more programmatic consultations, <u>and</u> potential effects to species that are <u>not</u> covered by a programmatic consultation, then district environmental staff creates <u>another</u> "Obtain Endangered Species Act (ESA) Consultation" Activity.

In this situation, district environmental staff will address <u>all</u> potential effects that <u>are</u> covered by one or more programmatic consultations under <u>one</u> of the "Obtain Endangered Species Act (ESA) Consultation" Activities, and will address <u>all</u> potential effects that are <u>not</u> covered by a programmatic consultation under another "Obtain Endangered Species Act (ESA) Consultation" Activity.

# **Programmatic consultation**

- 7. District environmental staff indicates in the "Comments" field of this "Obtain Endangered Species Act (ESA) Consultation" Activity that this is a programmatic consultation, and for which species the programmatic consultation applies.
- **8.** District environmental staff conducts applicable field reconnaissance and identifies habitat in the vicinity of the project area for the covered species per the requirements of the applicable programmatic consultation(s).
- **9.** District environmental staff completes **ENV's Form for Documenting Applicability of Programmatic Consultation with USFWS**, and uploads it under this Activity. District environmental staff also uploads a map and photos of potential habitat, and any further documentation of field reconnaissance (if any was prepared) under this Activity.
- **10.** District environmental staff creates the "Perform Endangered Species Act (ESA) Consultation Commitments" Activity, and indicates the following in the "Comments" field of that Activity:
  - that the project is subject to a programmatic consultation,
  - the covered species and project actions, and
  - that the voluntary conservation methods listed in the Documenting Applicability of Programmatic Consultation with USFWS form uploaded under the "Obtain Endangered Species Act (ESA) Consultation" will be implemented.

Note that if different commitments will be completed at different milestones (e.g., some "Prior to LOA" and others "Prior to Construction"), then it will be necessary to create multiple "Perform Endangered Species Act (ESA) Consultation Commitments" Activities, and group the commitments that will be done at the same milestone under the same Activity.

**11.** District environmental staff notifies the appropriate ENV SME assigned to the respective district and the ENV programmatic species lead(s) identified in **ENV's Form for Documenting** 



**Applicability of Programmatic Consultation with USFWS** that the project is covered by one or more programmatic consultations and that the above-listed steps have been completed.

12. The ENV SME programmatic species lead(s) confirms that the project is covered by the programmatic consultation(s) and that the commitments from the programmatic consultation(s) have been noted in the "Comments" field of the "Perform Endangered Species Act (ESA) Consultation Commitments" Activity and finalizes this "Obtain Endangered Species Act (ESA) Consultation" Activity.

# **Project-specific consultation**

- 7. District environmental staff confers with the appropriate ENV SME assigned to the respective district to determine whether consultation will be formal or informal, and whether the biological assessment (BA)/biological evaluation (BE) will be prepared by district environmental staff or ENV.
- 8. District environmental staff or the ENV SME indicates in the "Comments" field whether this is a formal or informal consultation, or whether both kinds of consultations (formal and informal) are being conducted concurrently with a single consultation document.
- 9. If preparation of the draft BE or BA has not begun within 90 days of completion of the "Perform Species Analysis" Activity, then district environmental staff obtains a new IPaC species list and uploads it under this Activity. Use the following file naming convention for the IPaC list: "CSJ\_Project or Road Name\_USFWS Species List\_YYYYMMDD" (e.g., CSJ 1234-56- 789\_SH 151\_USFWS Species List\_20220331.pdf). If the list shows additional species that need to be considered, create a new "Perform Species Analysis" Activity and follow the instructions in Step 11 of that Activity.
- 10. District environmental staff or the ENV SME prepares a draft BE (informal consultation) or BA (formal consultation) according to ENV's Documentation Standard for a Biological Assessment or a Biological Evaluation and ENV's Template for a BE or BA, and uploads the draft BE or BA under this Activity. For a formal consultation, in addition to the BA prepared by TxDOT, ENV and USFWS may agree that TxDOT will also prepare a draft of the USFWS/NMFS Biological Opinion (BO), in which case the district environmental staff or the ENV SME will also prepare the draft BO and upload the draft BO under this Activity.
- 11. District environmental staff or the ENV SME creates individual Reviews of this Activity and assigns them to the district environmental staff and the ENV SME. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the district environmental staff and ENV SME (and ENV Project Delivery staff, if appliable) have finalized their Reviews, if there are pending comments, the district environmental staff or ENV SME:
  - prepares a new, revised version of the draft BE/BA (and, possibly, the draft BO) that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - create a new Review under this Activity, and assigns it to the ENV SME and district environmental staff (and ENV Project Delivery staff, if appliable).



**12.** Once the district environmental staff and the ENV SME (and ENV Project Delivery staff, if appliable) have no further comments and have finalized their Reviews, the ENV SME creates a Coordination under this Activity.

#### Coordination Process

ENV SME uploads all of the following documentation under the Coordination:

a. Written exchanges with USFWS/NMFS

Follow the steps below to conduct the coordination.

- **13.** ENV SME prepares a cover letter for the ENV NRM Section Director's (or a delegate's) signature.
- 14. If the BE/BA had not been submitted to the USFWS/NMFS within 90 days of when the IPaC species list was obtained, then the ENV SME obtains a new IPaC species list and uploads it under this Activity. Use the following file naming convention for the IPaC list: "CSJ\_Project or Road Name\_USFWS Species List\_YYYYMMDD" (e.g., CSJ 1234-56- 789\_SH 151\_USFWS Species List\_20220331.pdf). If the list shows additional species that need to be considered, create a new "Perform Species Analysis" Activity and follow the instructions in Step 11 of that Activity. Once the ENV NRM Section Director (or his/her delegate) has signed the cover letter, the ENV SME emails the signed cover letter and the BE/BA to the USFWS's designated TxDOT Transportation Liaison or appropriate NMFS representative.
- **15.** ENV SME fills-in the "Correspondence Details" for this transmittal and uploads the email to USFWS/NMFS and the attachments to the email under the Coordination.
- **16.** ENV SME submits the signed cover letter and the draft BE/BA via www.box.com to the appropriate USFWS/NMFS staff members.
- **17.** ENV SME fills-in the "Correspondence Details" for this transmittal and ENV SME uploads the signed cover letter and the BE/BA that was submitted to USFWS/NMFS under the Coordination.
- **18.** For any written responses from USFWS/NMFS or further written communications by TxDOT, the ENV SME fills-in the "Correspondence Details" and uploads the correspondence and attachments for each transmittal.
- **19.** Once the USFWS/NMFS has issued a written concurrence (informal consultation), or has issued a final BO (formal consultation), the ENV SME fills-in the "Correspondence Details" for this transmittal, uploads the written concurrence or final BO under the Coordination with the word, "Approved," at the beginning of the file name, and finalizes the Coordination.

#### Completion of "Obtain ESA Consultation" Activity

20. If any commitments resulted from the consultation with USFWS/NMFS (including any "voluntary conservation measures," and any "reasonable and prudent measures"), district environmental staff creates the "Perform Endangered Species Act (ESA) Consultation Commitments" Activity (if it has not already been created to document commitments from one or more programmatic consultations), and either lists the commitments from the consultation in the "Comments" field of



the "Perform Endangered Species Act (ESA) Consultation Commitments" Activity, or uploads a list of the commitments from the consultation under that Activity.

Note that if different commitments will be completed at different milestones (e.g., some "Prior to LOA" and others "Prior to Construction"), then it will be necessary to create multiple "Perform Endangered Species Act (ESA) Consultation Commitments" Activities, and group the commitments that will be done at the same milestone under the same Activity.

- **21.** The ENV SME confirms that the type of consultation indicated in the "Comments" field is correct.
- **22.** The ENV SME confirms that any commitments from the consultation are recorded as part of the "Perform Endangered Species Act (ESA) Consultation Commitments" Activity, then finalizes this "Obtain Endangered Species Act (ESA) Consultation" Activity.

# "Perform Endangered Species Act (ESA) Consultation Commitments" Activity

- **1.** District environmental staff uses this Activity to document any commitments that result from a consultation with the USFWS or NMFS under the Endangered Species Act, including:
  - commitments made by TxDOT in its written communications to USFWS/NMFS (e.g., voluntary conservation or reporting measures);
  - conditions listed by USFWS/NMFS in a concurrence letter (informal consultation); and/or
  - reasonable and prudent measures listed by USFWS in a final biological opinion (formal consultation).

Note that if different commitments will be completed at different milestones (e.g., some "Prior to LOA" and others "Prior to Construction"), then it will be necessary to create multiple "Perform Endangered Species Act (ESA) Consultation Commitments" Activities, and group the commitments that will be done at the same milestone under the same Activity.

2. District environmental staff also uses this Activity to document the need for consultation/authorization from the USFWS or NMFS if a currently proposed species becomes listed within the lifecycle of the project.

Separate instructions are provided below for these two different scenarios.

# Documentation of commitments resulting from consultation with USFWS or NMFS

- **1.** District environmental staff identifies in the "Comments" field whether the commitments resulting from a consultation with the USFWS/NMFS under the Endangered Species Act include any compensatory mitigation (e.g., acquisition and preservation of habitat).
- 2. District environmental staff either lists the commitments from the consultation in the "Comments" field of this Activity, or uploads a list of the commitments from the consultation under this Activity. Regardless of which method is chosen, the commitments must be stated exactly as written in the source document (i.e., TxDOT or USFWS/NMFS correspondence, or USFWS/NMFS biological opinion).
- **3.** District environmental staff notifies the appropriate ENV SME assigned to the respective district <u>after</u> the following conditions are satisfied:
  - For consultation commitments that <u>will</u> be incorporated into the design or construction contract, such commitments have been communicated in writing to design or contracting staff, as appropriate, and district environmental staff has explained in the "Comments" field how and when such commitments were communicated to design or contracting staff.
  - For consultation commitments that will <u>not</u> be incorporated into the design or construction contract (i.e., commitments that TxDOT staff or a separate environmental contractor will undertake), such commitments have been completed, and all documentation regarding compliance with consultation commitments (e.g., reports, surveys, etc.), including any



correspondence with USFWS regarding such consultation commitments, have been uploaded under this Activity.

**4.** The appropriate ENV SME assigned to the respective district confirms completion of the consultation commitments, and finalizes this Activity.

# Documentation of need for consultation/authorization from the USFWS or NMFS if a currently proposed species becomes listed within the lifecycle of the project

- 1. District environmental staff creates this Activity when it becomes evident that consultation with or authorization from the USFWS or NMFS may be required <u>if</u> a currently proposed species becomes listed within the lifecycle of the project.
- 2. District environmental staff explains in the "Comments" field the potential need for consultation with or authorization from the USFWS or NMFS if a currently proposed species becomes listed. Include details such as the species, proposed listing date, and basis for potential effect call.
- **3.** District environmental staff also explains in the "Comments" field that if the species becomes listed, no construction work will occur that could have an effect on the species until the effects on the species have been evaluated and, if necessary, consultation is completed.
- 4. If the species becomes listed, update the explanation in the "Comments" field and evaluate if the current and future project activities affect the species. If there are no effects expected from the project, document the determination and finalize this Activity. If the project may still affect the species, then create a "Perform Reevaluation" Activity and "Obtain Endangered Species Act (ESA) Consultation" Activity to track the consultation. Do not finalize this Activity until the consultation is complete.
- **5.** If the proposed listing is withdrawn by the USFWS or NMFS, then update the explanation in the "Comments" field and finalize this Activity.

# "Perform Essential Fish Habitat (EFH) Analysis" Activity

**1.** District environmental staff determines whether the project may have an adverse effect on essential fish habitat (EFH).

"Adverse effect" means "any impact that reduces quality and/or quantity of EFH. Adverse effects may include direct or indirect physical, chemical, or biological alterations of the waters or substrate and loss of, or injury to, benthic organisms, prey species and their habitat, and other ecosystem components, if such modifications reduce the quality and/or quantity of EFH. Adverse effects to EFH may result from actions occurring within EFH or outside of EFH and may include site-specific or habitat-wide impacts, including individual, cumulative, or synergistic consequences of actions." 50 CFR § 600.10.

- 2. If district environmental staff determines that the project <u>will not have an adverse effect on EFH</u>, then district environmental staff:
  - indicates in the "Comments" field of this Activity that the project will not have an adverse effect on EFH,
  - provides an explanation in the "Comments" field for concluding that the project will not have an adverse effect on EFH, and
  - finalizes this Activity.
- **3.** If the project <u>may have an adverse effect on EFH</u>, then consultation with the NMFS is required. Follow the instructions for the Coordination below.

# Coordination with NMFS

- **1.** District environmental staff creates a "Coordinate Essential Fish Habitat (EFH)" Activity.
- 2. District environmental staff prepares an EFH assessment. The EFH assessment may be prepared as a relatively short email to NMFS, or a more detailed report, depending on the extent of impacts to EFH. The EFH assessment must include the following components (see 50 CFR 600.920(e)(3)):
  - A description of the action.
  - An analysis of the potential adverse effects of the action on EFH and the managed species.
  - TxDOT's conclusions regarding the effects of the action on EFH.
  - Proposed mitigation, if applicable.

Additionally, if appropriate, the EFH assessment must also include:

- The results of an on-site inspection to evaluate the habitat and the site-specific effects of the project.
- The views of recognized experts on the habitat or species that may be affected.
- A review of pertinent literature and related information.
- An analysis of alternatives to the action. Such analysis must include alternatives that could avoid or minimize adverse effects on EFH.
- Other relevant information.



- 3. District environmental staff may, at its discretion, upload the EFH assessment and create a Review of the EFH assessment and assign it to the appropriate ENV SME assigned to the respective district. If district environmental staff elects to create an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review (if one was created), if there are pending comments, the district environmental staff may:
  - prepare a new, revised version of the EFH assessment that is responsive to the comments made and uploads it under this Activity;
  - complete a comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 4. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if one was created) district environmental staff transmits the EFH assessment to NMFS at least 60 days prior to the anticipated environmental clearance date (i.e., CE determination, FONSI, or FEIS/ROD).
- 5. NMFS must respond within 30 days of receipt of the EFH assessment.
- **6.** If NMFS provides written conservation recommendations, district environmental staff must respond to the NMFS's conservation recommendations in writing within 30 days. The written response to NMFS's conservation recommendations must contain the following information:
  - a description of measures proposed by the agency for avoiding, mitigating, or offsetting the impact of the activity on EFH; and
  - if TxDOT's response is inconsistent with NMFS's conservation recommendations, the response must explain TxDOT's reasons for not following the recommendations, including the scientific justification for any disagreements with NMFS over the anticipated effects of the action and the measures needed to avoid, minimize, mitigate, or offset such effects. 50 CFR 600.920(k).
- 7. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for each letter or email sent to or from NMFS.
- **8.** District staff uploads the transmitted EFH assessment and any additional correspondence with NMFS under this Coordination.
- **9.** In the Coordination, the district environmental staff selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

# Finalizing this Activity

1. If applicable, district environmental staff creates a "Perform Non-Endangered Species Act (ESA) Biology Commitments" Activity to track any resulting commitment that will be carried-out by

"Perform Essential Fish Habitat (EFH) Analysis" Activity



district environmental staff related to EFH. This Activity is not used to record and track BMPs and other commitments that will be the responsibility of design, construction, or maintenance personnel. Those commitments must be included in project plans, general notes, and specifications as appropriate.

**2.** District environmental staff finalizes this Activity.

# "Perform Farmland Protection Policy Act (FPPA) Analysis" Activity

1. If the project will <u>not</u> convert any prime, unique, statewide important, or locally important farmland as mapped by the Natural Resources Conservation Service (NRCS) Web Soil Survey to non-agricultural uses, then district environmental staff provides an explanation to that effect in the "Comments" field of this Activity, and finalizes this Activity. The only time this should occur is when the project is in a non-urbanized area and there is prime, unique, statewide important, or locally important farmland within the project limits (and so the answer to the WPD FPPA question is "No"); however, the project will not actually convert any of those farmlands due to the location of the construction work in relation to the location of the farmlands.

If the project <u>will</u> convert any prime, unique, statewide important, or locally important farmland as mapped by the Natural Resources Conservation Service (NRCS) Web Soil Survey to non-agricultural uses, then district environmental staff proceeds as instructed below.

2. District environmental staff determines whether the project is a corridor or non-corridor project, which determines the type of Farmland Conversion Impact Rating Form to be used (AD-1006 or NRCS CPA-106). Projects that have a linear or corridor-type site configuration connecting two distant points, and crossing several different tracts of land (i.e., typical widening or new location highway projects) are considered "corridor" projects and must use the corridor form NRCS CPA-106. Projects that will take place in a discrete location and do not have a linear or corridor-type site configuration (e.g., bridge replacement projects with no or little associated highway work) are considered "non-corridor" projects and must use form AD-1006. Complete Parts I, III, and VI of the appropriate NRCS form.

If district environmental staff has questions about how to fill-out the Farmland Conversion Impact Rating Form, then they may contact NRCS via email to Alan Stahnke, NRCS State Soil Scientist at alan.stahnke@usda.gov.

- 3. District environmental staff may, at his or her discretion, upload the draft Farmland Conversion Impact Rating Form, and create a Review of the draft Form and assign it to the appropriate ENV SME assigned to the respective district. If district environmental staff elects to create an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff may:
  - prepare a new, revised version of the draft Farmland Conversion Impact Rating Form that is responsive to the comments made and uploads it under this Activity;
  - complete a comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assign it to the ENV SME (and ENV Project Delivery staff, if applicable).



Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if one was created), district environmental staff proceeds as instructed below.

4. <u>If the site assessment score in Part VI is 59 points or less</u>, no further consideration under FPPA is needed and the project does not require coordination with the NRCS. District environmental staff documents that the "project activities meet the FPPA exemption criteria" in the "Comments" field, uploads the completed Farmland Conversion Impact Rating Form under this Activity, and finalizes this Activity.

<u>If the site assessment score in Part VI is 60 points or greater</u>, then coordination with the NRCS is required. See Coordination steps below. District environmental staff finalizes this Activity only after the Coordination has been completed.

# **Coordination**

- **1.** District environmental staff creates a "Coordinate Farmland Policy Protection Act (FPPA)" Coordination.
- 2. District environmental staff submits the completed Farmland Conversion Impact Rating Form and a map of the project area to the NRCS via email to Alan Stahnke, NRCS State Soil Scientist at alan.stahnke@usda.gov.
- **3.** The NRCS soil science staff will complete Parts II, IV, and V of the form. The results of their analysis will be recorded in Part V of the form, and the form will be returned to TxDOT.

If the NRCS determination of effect of the conversion has a total score of 159 or less, then district environmental staff documents that "this project received a total score of less than 160 on the NRCS form and therefore need not be given further consideration for protection and no additional sites need to be evaluated" in the "Comments" field of this Activity.

If the NRCS determination of effect of the conversion has a total score of 160 or greater, then district environmental staff completes Section VII of the form including the explanation of the alternative selected, and returns the form to NRCS.

Additionally, district environmental staff must consider any NRCS recommendations for minimizing the adverse effects and alternative actions to lessen the conversion's adverse effects to protected farmland. Document what was considered and why or why not measures to minimize the effects were or were not implemented in the "Comments" field of this Activity, <u>or</u> indicate in the "Comments" field of this Activity that documentation of consideration of NRCS recommendations is included in the EA or EIS, if applicable.

If the NCRS does not return the form to TxDOT within 30 days of when it was provided to NRCS, then district environmental staff records the expiration of the review period by adding a correspondence entry under the Correspondence Details and selecting, "No Response received – review time expired," from the drop-down for the field labeled, "Correspondence Status."



- **4.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for each letter or email sent to or from the NRCS.
- **5.** The district environmental staff uploads each email or letter to or from TxDOT and the NRCS under the Coordination.
- 6. In the Coordination, the district environmental staff selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

# "Perform Marine Mammal Protection Act (MMPA) Analysis" Activity

**1.** District environmental staff determines whether the project has the potential to cause an incidental take of marine mammals.

"Take" means "to harass, hunt, capture, collect, or kill, or attempt to harass, hunt, capture, collect, or kill any marine mammal, including, without limitation, any of the following: The collection of dead animals or parts thereof; the restraint or detention of a marine mammal, no matter how temporary; tagging a marine mammal; or the negligent or intentional operation of an aircraft or vessel, or the doing of any other negligent or intentional act which results in the disturbing or molesting of a marine mammal." 50 CFR 18.3, 216.3.

Activities such as removing or driving pilings or any other activities in the water that may create noise or vibration may be considered as causing harassment of marine mammals.

The only marine mammals living in waters off the Texas coast are the following:

- Manatees\*
- Whales
- Dolphins
- Porpoises

\* The United States Fish and Wildlife Service has regulatory jurisdiction over manatees under the Marine Mammal Protection Act. The rest of the marine mammals listed above are under the regulatory jurisdiction of the National Marine Fisheries Service (NMFS) (also known as "National Oceanic and Atmospheric Administration (NOAA) Fisheries").

- 2. If district environmental staff is <u>uncertain as to whether the project has the potential to cause an incidental take of marine mammals</u>, then district environmental staff may informally reach out to NMFS (for any marine mammals listed above with the exception of manatees) or a TxDOT transportation liaison at USFWS (for manatees) to discuss the project and request technical assistance; however, district environmental staff should not ask NMFS or USFWS to make the incidental take determination as that determination is made solely by TxDOT. If there are any emails or other documentation of this informal request for technical assistance and the input provided by NMFS/USFWS, district environmental staff may upload such documentation under this Activity.
- **3.** If any marine mammals were included in the species analysis spreadsheet prepared under the "Perform Species Analysis" Activity, then district environmental staff ensures that its determination regarding whether the project has the potential to cause an incidental take of marine mammals is consistent with the effect determination (for federally listed species) or impact determination (for state-listed species) recorded on the species analysis spreadsheet.



- 4. If district environmental staff determines that the project <u>does not have the potential to cause an</u> <u>incidental take</u> of marine mammals, then district environmental staff:
  - indicates in the "Comments" field of this Activity that the project will not have the potential to cause an incidental take of marine mammals,
  - provides an explanation in the "Comments" field for concluding that the project will not have the potential to cause an incidental take of marine mammals, and
  - finalizes this Activity.
- 5. If district environmental staff determines that the project <u>does have the potential to cause an</u> incidental take of marine mammals, then an incidental take permit from USFWS and/or NMFS is required, depending on whether the project has the potential to cause an incidental take of manatees, and/or one or more of the other marine mammals listed above.

District environmental staff indicates in the "Comments" field of this Activity that the project does have the potential to cause an incidental take of marine mammals and that an incidental take permit is required. Identify the specific marine mammal(s) that <u>will</u> require an incidental take permit, <u>and</u> the specific marine mammal(s) for which the project does <u>not</u> have the potential to cause an incidental take, including an explanation of why the project will not have the potential to cause an incidental take of that or those marine mammal(s).

To obtain the incidental take permit, follow the instructions for the Coordination below, depending on whether an incidental take permit is required from USFWS for manatees, and/or whether an incidental take permit is required from NMFS for other marine mammals.

Note that district environmental staff must proceed as indicated below even if federally listed marine mammals were included in a consultation with USFWS under the Endangered Species Act.

# Coordination with USFWS to obtain incidental take permit for manatees

- 1. District environmental staff creates a "Coordinate Marine Mammal Protection Act (MMPA)" Activity, and selects "U.S. Fish and Wildlife Service (USFWS)" as the agency with whom coordination is being conducted.
- 2. District environmental staff confers with the appropriate ENV SME assigned to the respective district to determine whether the request for an incidental take permit will be prepared by district environmental staff or ENV.
- **3.** District environmental staff or the ENV SME prepares a request for an incidental take permit including the 8 pieces of information listed at 50 CFR §18.27(d).
- 4. District environmental staff or the ENV SME creates individual Reviews of the request for an incidental take permit and assigns them to the district environmental staff and the ENV SME. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the district environmental staff and the ENV SME (and ENV Project Delivery staff, if applicable) have finalized their Reviews, if there are pending comments, the district environmental staff or the ENV SME:



- prepares a new, revised version of the request for an incidental take permit that is responsive to the comments made and uploads it under this Activity;
- completes a comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the district environmental staff and the ENV SME (and ENV Project Delivery staff, if applicable).
- 5. Once the district environmental staff and the ENV SME (and ENV Project Delivery staff, if applicable) have no further comments and has finalized his or her Review, the ENV SME mails the request and supporting documentation to both the TxDOT transportation liaison at USFWS and the USFWS Jacksonville, FL, Field Office at jaxregs@fws.gov. Emails with attachments are limited to a maximum size of 20 megabytes (20MB). If you chose or need to submit via multiple emails please use same subject line for each email and note numerical sequence in the subject line such as 1 of 3, 2 of 3, etc.
- 6. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from USFWS in connection with the request for an incidental take permit.
- **7.** The ENV SME staff uploads the transmitted request, any additional correspondence with USFWS, and the incidental take permit issued by USFWS under this Coordination.
- 8. In the Coordination, the district environmental staff selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

# Coordination with NMFS to obtain incidental take permit for other marine mammals

- 1. District environmental staff creates a "Coordinate Marine Mammal Protection Act (MMPA)" Activity, and selects "National Marine Fisheries Service (NMFS)" as the agency with whom coordination is being conducted.
- **2.** District environmental staff confers with the appropriate ENV SME assigned to the respective district to determine whether the application for an incidental take permit will be prepared by district environmental staff or ENV.
- 3. District environmental staff or the ENV SME prepares an application for an incidental take permit using NMFS's template cover letter and including the 14 pieces of information listed at 50 CFR § 216.104(a)). Further instructions regarding the preparation and submittal of an application for an incidental take permit are provided on NMFS's website (which is under the name "NOAA Fisheries").
- 4. District environmental staff or the ENV SME creates individual Reviews of the application for an incidental take permit and assigns them to the district environmental staff and the ENV SME. Once the district environmental staff and the ENV SME has finalized his or her Review, if there are pending comments, the district environmental staff or ENV SME:



- prepares a new, revised version of the application for an incidental take permit that is responsive to the comments made and uploads it under this Activity;
- completes a comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME.
- **5.** Once the district environmental staff and ENV SME have no further comments and have finalized their Reviews, the ENV SME transmits the application to NMFS (both electronically and in hard copy see the instructions provided on the NOAA Fisheries website).
- 6. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from NMFS in connection with the application for an incidental take permit.
- **7.** The ENV SME uploads the transmitted application, any additional correspondence with NMFS, and the incidental take permit issued by NMFS under this Coordination.
- **8.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

#### Finalizing this Activity

- 1. After TxDOT has obtained any required incidental take permit from USFWS and/or NMFS, district environmental staff indicates in the "Comments" field of this Activity the date on which the incidental take permit(s) was issued.
- 2. If applicable, district environmental staff creates a "Perform Non-Endangered Species Act (ESA) Biology Commitments" Activity to track any resulting commitment that will be carried-out by district environmental staff related to marine mammals. This Activity is not used to record and track BMPs and other commitments that will be the responsibility of design, construction, or maintenance personnel. Those commitments must be included in project plans, general notes, and specifications as appropriate.
- **3.** District environmental staff finalizes this Activity.

# "Perform Non-Endangered Species Act (ESA) Biology Commitments" Activity

1. District environmental staff uses this Activity to document any commitments related to protecting plant or animal species that do <u>not</u> result from a consultation with USFWS under the Endangered Species Act, but that will be carried-out by district environmental staff or ENV. This Activity is not used to record and track commitments that will be the responsibility of design, construction, or maintenance personnel. Those commitments must be included in project plans, general notes, and specifications as appropriate.

If there are multiple commitments, district environmental staff may either document them all under one Activity (but see below), or, if the district environmental staff intends to track each commitment separately, they may document them under separate, individually created "Perform Non-Endangered Species Act (ESA) Biology Commitments" Activities.

Note that if different commitments will be completed at different milestones (e.g., some "Prior to LOA" and others "Prior to Construction"), then it will be necessary to create multiple "Perform Non-Endangered Species Act (ESA) Biology Commitments" Activities, and group the commitments that will be done at the same milestone under the same Activity.

District environmental staff either lists the commitments in the "Comments" field of this Activity or uploads a list of the commitments under this Activity. Examples of documentation that may be uploaded under this Activity include:

- Non-ESA species surveys including non-federally listed mussel surveys
- Monitoring reports for non-ESA species
- Documentation related to relocation of non-ESA species
- 2. Once the commitment(s) are complete, district environmental staff finalizes this Activity.



# "Perform Species Analysis" Activity

If the project meets the requirements of the categorical exclusion criterion listed at 23 CFR 771.117(c)(1) regarding activities that do not involve or lead directly to construction such as planning and research activities, or the categorical exclusion criterion listed at 23 CFR 771.117(c)(29) regarding the purchase, construction, replacement or rehabilitation of ferry vessels, then district environmental staff inserts the following statement in the "Comments" field of this Activity: "This project does not require a species analysis," and finalizes this Activity.

If neither of the above-listed categorical exclusion criteria apply, but district environmental staff nevertheless believes that the project does not warrant a species analysis, then district environmental staff must contact the ENV SME assigned to the respective district to discuss the project. If the ENV SME agrees that a species analysis is not warranted, then district environmental staff inserts the following statement in the "Comments" field of this Activity: "This project does not require a species analysis per [insert name], ENV SME, because, given the nature and location of the project, there is no potential to affect any state-listed species or federally listed, proposed, or candidate species" and finalizes this Activity.

If none of the above-described scenarios apply, then proceed as indicated below.

There are two parts to this Activity: (1) preparation of the project-specific species analysis spreadsheet, and (2) completion of **ENV's Species Analysis form**.

# Preparation of project-specific species analysis spreadsheet

- District environmental staff downloads ENV's Species Analysis Spreadsheet from ENV's online toolkit, and follows the instructions in ENV's Instructions: Preparing a Species Analysis Spreadsheet. The spreadsheet should be populated using information gathered in the field during a habitat assessment and, if applicable, species-specific presence/absence surveys. See ENV's Guidance: Technical Requirements for Conducting Habitat Assessments and/or Presence/Absence Surveys for more information on completing these assessments and surveys.
- 2. District environmental staff uploads the list of federally listed species and critical habitat for the project from the IPaC system ("USFWS Species List") and the TPWD RTEST county list ("TPWD Species List") under this Activity per the instructions in ENV's Instructions: Preparing a Species Analysis Spreadsheet. Use the following file naming convention for the IPaC list: "CSJ\_Project or Road Name\_USFWS Species List\_YYYYMMDD" (e.g., CSJ 1234-56- 789\_SH 151\_USFWS Species List\_20220331.pdf). If a species-specific habitat assessment and/or presence/absence survey was done, district environmental staff also uploads documentation of the species-specific habitat assessment and/or presence/absence survey under this Activity.

IMPORTANT NOTE: As explained below, at the time this Activity is finalized, and at the time of the project's environmental clearance (a CE determination, FONSI, or FEIS/ROD), the list of federally listed species and critical habitat for the project from the IPaC system, and the TPWD



RTEST county list, that were downloaded and used for this species analysis must not be more than six months old.

**3.** If there will be a Review of the species analysis spreadsheet and form by the ENV SME assigned to the respective district (see Step 5 below), then district environmental staff uploads the completed species analysis spreadsheet in its native Excel format under this Activity with the word "Draft" in the file name.

If there will not be a Review of the species analysis spreadsheet and form by the ENV SME assigned to the respective district (see Step 5 below), then district environmental staff uploads a single combined pdf of the applicable tabs in the species analysis spreadsheet under this Activity with the word "Approved" in the file name (for instructions on how to prepare the single pdf see **ENV's Instructions: Preparing a Species Analysis Spreadsheet**).

#### Completion of ENV's Species Analysis form

- 4. District environmental staff completes ENV's Species Analysis form and uploads it under this Activity. If there will be a Review of the form (see below), then district environmental staff uploads the form with the word "Draft" in the file name. If there will not be a Review of the form (see below), then district environmental staff uploads the completed form under this Activity with the word "Approved" in the file name.
- 5. If the second, third, or fourth checkbox on the form is checked, or if the project is an EA or EIS project, then district environmental staff must create a Review of the project-specific species analysis spreadsheet and completed Species Analysis form under this Activity (including the IPaC and RTEST county list) and assign it to the appropriate resource area ENV SME assigned to the respective district (if the first checkbox is checked and the project is a CE, then the Review is optional). If the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the project-specific species analysis spreadsheet and completed Species Analysis form that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 6. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if a Review was created), district environmental staff uploads the final project-specific species analysis spreadsheet and final Species Analysis form, each with the word, "Approved," at the beginning of the respective file name. For the species analysis spreadsheet, district environmental staff uploads a single combined pdf of the applicable tabs in the species analysis spreadsheet under this Activity with the word "Approved" in the file name (for instructions on how to prepare the single pdf see ENV's Instructions: Preparing a Species Analysis Spreadsheet).



#### Potential next steps

- **7.** Regarding Section I. of the completed Species Analysis form ("Endangered Species Act"), district environmental staff proceeds as instructed below depending on which box(es) are checked:
  - First box is checked No consultation/authorization required

If the first box is checked, then no consultation with or authorization from the USFWS or NMFS is required for a listed or proposed species.

There is no need to create any further Activities for ESA compliance.

# • Second box checked – Consultation/authorization is required for listed species prior to environmental clearance

If the second box is checked, then consultation with or authorization from the USFWS or NMFS is required for a listed species (including either use of a programmatic consultation or project-specific consultation) prior to environmental clearance.

As part of the Review that will have been assigned to the ENV SME (see Step 5 above), the ENV SME will determine the correct path forward based on the district's assessment. If it is agreed that consultation with or authorization from the USFWS or NMFS is required, then the ENV SME will direct the district to create the "Obtain Endangered Species Act (ESA) Consultation" Activity.

• Third box is checked – Consultation/authorization <u>may</u> be required for a <u>proposed</u> species or <u>proposed</u> critical habitat after environmental clearance, depending on whether the species eventually becomes listed

If the third box is checked, then consultation with or authorization from the USFWS or NMFS may be required <u>if</u> a currently proposed species becomes listed within the lifecycle of the project.

As part of the Review that will have been assigned to the ENV SME (see Step 5 above), the ENV SME will determine the correct path forward based on the district's assessment. If it is agreed that consultation with or authorization from the USFWS or NMFS may be required after environmental clearance if a currently proposed species becomes listed within the lifecycle of the project, then the ENV SME will direct the district to create the "Perform Endangered Species Act (ESA) Consultation Commitments" Activity.

# • Fourth box is checked – Voluntary conference for a proposed species or proposed critical habitat prior to environmental clearance

If the fourth box is checked, then TxDOT is choosing to conference with USFWS or NMFS regarding a species currently proposed for listing prior to environmental clearance.

As part of the Review that will have been assigned to the ENV SME (see Step 5 above), the ENV SME will determine the correct path forward based on the district's assessment.



If it is agreed that a conference for the proposed species is appropriate, then the ENV SME will direct the district to create the "Obtain Endangered Species Act (ESA) Consultation" Activity (if it has not already been created for the second checkbox).

- 8. If Section II of the completed Species Analysis form ("TPWD Coordination") indicates that coordination with TPWD is required because the project is an EA- or EIS-level project, or that the project is a CE-level project but will be coordinated with TPWD at the district's discretion, then district environmental staff completes ENV's Documentation of Texas Parks and Wildlife Department Best Management Practices Form and uploads it under this activity (Review by an ENV SME is optional); and creates the "Coordinate Species Analysis (TPWD or BGEPA)" Activity. Additional information about the TPWD coordination process is provided below.
- 9. If Section III of the completed Species Analysis form ("Bald and Golden Eagle Protection Act (BGEPA)") indicates that construction activities will not occur within 660 feet of a nest during the nesting season and the project will adhere to the National Bald Eagle Management Guidelines of 2007, then the district environmental staff must ensure that this restriction is communicated to the appropriate contractor.

If Section III of the completed Species Analysis form indicates that coordination with USFWS to obtain a Non-Purposeful Take Permit is required, then the district environmental staff creates the "Coordinate Species Analysis (TPWD or BGEPA)" Activity and assigns it to the appropriate ENV SME assigned to the respective district. Additional information about the BGEPA coordination process is provided below.

- **10.** If, in accordance with Section IV of the completed Species Analysis form, any field investigations will be conducted for the presence or absence of migratory birds, then district environmental staff creates the "Perform Non-Endangered Species Act (ESA) Biology Commitments" Activity to record the results of any field investigations.
- **11.** If more than six months have passed since district environmental staff first downloaded the list of federally listed species and critical habitat for the project from the USFWS IPaC system or the TPWD RTEST county list (and this Activity is still open), then prior to finalizing this Activity, district environmental staff must check both of those on-line resources for any changes.

If <u>no listed species</u> have been added to the USFWS IPaC system and/or the TPWD RTEST county list, then district environmental staff uploads the new list of federally listed species and critical habitat for the project from the USFWS IPaC system and the TPWD RTEST county list under this Activity, and indicates in the "Comments" field of this Activity the date(s) on which the USFWS IPaC system and/or the TPWD RTEST county list were updated and that no species were added. Use the following file naming convention for the IPaC list: "CSJ\_Project or Road Name\_USFWS Species List\_YYYYMMDD" (e.g., CSJ 1234-56- 789\_SH 151\_USFWS Species List\_20220331.pdf).

If <u>one or more listed species</u> have been added to the USFWS IPaC system and/or the TPWD RTEST county list, then district environmental staff must do the following:

• District environmental staff uploads the new list of federally listed species and critical habitat for the project from the USFWS IPaC system and the TPWD RTEST county list under this Activity. Use the following file naming convention for the IPaC list:



"CSJ\_Project or Road Name\_USFWS Species List\_YYYYMMDD" (e.g., CSJ 1234-56-789\_SH 151\_USFWS Species List\_20220331.pdf).

- District environmental staff creates a new version of the project-specific species analysis spreadsheet by manually adding just the new species to the "addendum" tab of the project-specific species analysis spreadsheet.
- District environmental staff uploads the new version of the project-specific species analysis spreadsheet.
- If the new version of the project-specific species analysis spreadsheet affects the conclusions on the Species Analysis form, district environmental staff must update the Species Analysis form and upload the revised version under this Activity.
- District environmental staff may, at its discretion, create a Review of the new version of the project-specific species analysis spreadsheet (and the updated Species Analysis form if there is one) under this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district. Once the ENV SME has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the new version of the project-specific species analysis spreadsheet (and the updated Species Analysis form if there is one) that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - $\circ$  creates a new Review under this Activity, and assigns it to the ENV SME.
- Once the ENV SME has no further comments and has finalized his or her Review (if a Review was created), district environmental staff uploads the final new version of the project-specific species analysis spreadsheet (and the updated Species Analysis form if there is one) with the word, "Approved," at the beginning of the respective file name.
- If the Species Analysis form was updated to indicate that consultation with or authorization from the USFWS or NMFS is required, whereas the previous version of the form indicated that no consultation with or authorization from the USFWS or NMFS is required, then the district environmental staff creates the "Obtain Endangered Species Act (ESA) Consultation" Activity.
- For any federally listed species included in the new version of the project-specific species analysis spreadsheets, if the effect call is "may affect," then district environmental staff ensures that the species is addressed in consultation with the USFWS or NMFS (which may have already been initiated and/or completed, in which case consultation will need to be updated or re-initiated).
- **12.** After all steps listed above have been completed, and after TPWD or BGEPA coordination has been completed (if applicable), district environmental staff finalizes this Activity.

After this Activity is finalized, the project must be environmentally cleared (i.e., a CE determination, FONSI, or FEIS/ROD) within six months of when the list of federally listed species and critical habitat for the project from the USFWS IPaC system and the TPWD RTEST county list that were used for this species analysis were downloaded. In other words, at the time of environmental clearance, the downloaded lists that were used for this species analysis must not be more than six months old. If they are more than six months old at the time of environmental clearance, then prior to environmentally clearing the project, district environmental staff must



create this Activity again, and check the IPaC and TPWD RTEST county lists for any changes and follow the instructions in the immediately preceding step.

#### TPWD Coordination Process

The Memorandum of Understanding (MOU) with the Texas Parks and Wildlife Department (TPWD) is codified at 43 Texas Administrative Code §§2.201-2.207.

District environmental staff uploads all of the following documentation under the Coordination:

• Written exchanges with TPWD

The basic TPWD coordination steps are outlined below. For further information about how to conduct TPWD coordination, see **ENV's Guidance: TPWD Coordination Under the 2021 Memorandum of Understanding**.

- 1. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for each letter or email sent to or from TPWD.
- 2. If more than six months have passed since district environmental staff first downloaded the list of federally listed species and critical habitat for the project from the USFWS IPaC system and the TPWD RTEST county list, then prior to proceeding as instructed below, district environmental staff must check both of those on-line resources for any changes (see above instructions for updating documentation to reflect changes to the IPaC or TPWD RTEST lists).
- 3. Once ENV's Species Analysis Spreadsheet, ENV's Species Analysis Form, ENV's Surface Water Analysis Form (if applicable), and ENV's Documentation of Texas Parks and Wildlife Department Best Management Practices Form have been completed and uploaded (and reviewed by the ENV SME if any Reviews were assigned), district environmental staff initiates coordination with TPWD as instructed by ENV's Guidance: TPWD Coordination Under the 2021 Memorandum of Understanding.
- **4.** District environmental staff uploads the initiation email to TPWD, and any further email correspondence between TxDOT and TPWD to the Coordination.

For CE projects that are coordinated with TPWD at the district's discretion, there are no further coordination steps after the initial collaborative review and district environmental staff finalizes the coordination after this step.

For EA or EIS projects, proceed as instructed below once this step is completed.

5. For a project requiring an EA or EIS, at or around the same time that the draft EA or draft EIS is made available for public review, but no less than 45 days before the issuance of the environmental decision, district environmental staff will email the notice of availability of the draft EA or draft EIS to TPWD as instructed by ENV's Guidance: TPWD Coordination Under the 2021 Memorandum of Understanding.



- **6.** District environmental staff uploads the email to TPWD under the Coordination.
- **7.** If TPWD provides written comments, district environmental staff uploads the written comments under the Coordination.
- 8. If TPWD provides written comments, district environmental staff prepares a written response to TPWD's comments and emails them to the TPWD staff who provided the comments as instructed by ENV's Guidance: TPWD Coordination Under the 2021 Memorandum of Understanding.
- **9.** District environmental staff uploads the email responding to TPWD's comments, and finalizes the Coordination.

#### TPWD Coordination Process for a Reevaluation

- 1. For guidance on when a reevaluation must be coordinated with TPWD, see ENV's Guidance: TPWD Coordination Under the 2021 MOU.
- 2. Once Sections I., II., and III. of ENV's Reevaluation Form have been filled-out, and the partially completed form has been uploaded, and any new "Perform Species Analysis" and "Perform Surface Water Analysis" Activity has been completed (if applicable), district environmental staff follows the instructions for coordinating the reevaluation with TPWD set forth in ENV's Guidance: TPWD Coordination Under the 2021 MOU.
- **3.** District environmental staff uploads all written exchanges between TxDOT and TPWD under a Coordination created off of the new "Perform Species Analysis" Activity.
- **4.** Once the coordination is complete and all correspondence has been uploaded, district environmental staff finalizes the Coordination.

#### **BGEPA Coordination Process**

ENV SME uploads all of the following documentation under the Coordination:

- Written exchanges with USFWS
- Non-Purposeful Take Permit issued by USFWS

- **1.** The appropriate ENV SME assigned to the respective district contacts the USFWS transportation liaison to discuss the process for obtaining a Non-Purposeful Take Permit.
- **2.** District environmental staff prepares any materials needed to obtain a Non-Purposeful Take Permit.
- **3.** ENV SME conducts the coordination with USFWS, fills-out the "Correspondence Details" for any transmittals and uploads any exchanges with USFWS and the Non-Purposeful Take Permit issued by USFWS, under the Coordination.



**4.** Once USFWS has issued a Non-Purposeful Take Permit, the ENV SME finalizes the Coordination.

# "Community Impacts SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of community impacts. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding community impacts, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding community impacts.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.



# "Perform Community Impacts Assessment (CIA)" Activity

1. District environmental staff contacts the ENV SME assigned to the respective district to discuss project details and determine the appropriate level of analysis. This discussion is typically an informal Teams call and does not need to be documented in ECOS. The ENV SME may request that certain information be informally provided by the district environmental staff to make an informed decision about the appropriate level of analysis.

There are three levels of analysis. They are:

- Summary Analysis with no ENV SME Review Required
- Summary Analysis with ENV SME Required
- Full Report

The ENV SME will determine which of these three levels of analysis should be conducted based on the discussion with and information provided by district environmental staff. Separate instructions for each of these three levels of analysis are provided below.

#### Instructions for completing a "Summary Analysis with no ENV SME Review Required"

- **1.** District environmental staff explains the following in the "Comments" field of this Activity:
  - First, insert the following statement: "It has been determined through consultation with [insert name], ENV SME, that this project does not require a full Community Impacts Assessment Technical Report."
  - Second, describe which condition(s) requiring a community impacts analysis apply.
  - Lastly, provide information that supports why a full Community Impacts Assessment Technical Report is not warranted for the project.
- **2.** District environmental staff finalizes this Activity.

#### Instructions for completing a "Summary Analysis with ENV SME Review Required"

- District environmental staff completes <u>ONLY SECTION A</u> ("Summary Analysis") of <u>ENV's</u> Community Impacts Assessment Technical Report form, and uploads the form under this Activity.
- 2. District environmental staff creates a Review of the Community Impacts Assessment Technical Report form (with only Section A completed) under this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:



- prepares a new, revised version of the Community Impacts Assessment Technical Report form (with only Section A completed) that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).

Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff uploads the final Community Impacts Assessment Technical Report form with the word, "Approved," at the beginning of the file name, and finalizes this Activity.

# Instructions for completing a "Full Report"

1. District environmental staff completes ENV's Community Impacts Assessment Technical Report form in accordance with ENV's Instructions – How to Conduct Community Impacts Assessments and uploads the form under this Activity.

As explained in **ENV's Instructions – How to Conduct Community Impacts Assessments**, for a complex EA or EIS with substantial community impacts, district environmental staff may, alternatively, prepare a narrative-style report using **ENV's Community Impacts Assessment Technical Report** form as an outline. In this case, district environmental staff uploads the narrative-style report under this Activity.

- 2. District environmental staff creates a Review of the Community Impacts Assessment Technical Report form under this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the Community Impacts Assessment Technical Report form that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **3.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff uploads the final Community Impacts Assessment Technical Report form with the word, "Approved," at the beginning of the file name, and finalizes this Activity.
- **4.** If the Community Impacts Assessment Technical Report form indicates that there <u>are</u> mitigation measures proposed, then district environmental staff creates the "Perform Community Impacts Mitigation" Activity.



**5.** If an EA or EIS is being prepared for the project, then district environmental staff uses the summary of the community impacts assessment included in the Community Impacts Assessment Technical Report form to complete the appropriate section of the EA or EIS.

# "Perform Community Impacts Mitigation" Activity

- **1.** District environmental staff fills-in the "Comments" field with an explanation of any community impacts mitigation commitments for the project.
- **2.** District environmental staff uploads any documentation associated with community impacts mitigation commitments for the project under this Activity.
- **3.** After all community impacts mitigation commitments for the project have been completed, district environmental staff finalizes this Activity.



# "Haz Mat SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of hazardous materials. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding hazardous materials, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding hazardous materials.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.





# "Perform Haz Mat Initial Site Assessment (ISA)" Activity

- 1. District environmental staff completes ENV's Hazardous Materials Initial Site Assessment form and uploads the form under this Activity.
- 2. District environmental staff may, at its discretion, create a Review of the Hazardous Materials Initial Site Assessment form under this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district. If district environmental staff elects to create an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the Hazardous Materials Initial Site Assessment form that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **3.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if a Review was created), district environmental staff uploads the final Hazardous Materials Initial Site Assessment form with the word, "Approved," at the beginning of the file name, and finalizes this Activity.
- **4.** If Section 8.2 of the Hazardous Materials Initial Site Assessment form indicates that there <u>are</u> one or more unresolved hazardous materials concerns requiring additional investigations or assessments, then district environmental staff creates the "Perform Haz Mat Issue Identification and Resolution (IIR)" Activity.
- 5. If an EA or EIS is being prepared for the project, <u>and</u> if Section 8.2 of the Hazardous Materials Initial Site Assessment form indicates that there are <u>not</u> one or more unresolved hazardous materials concerns requiring additional investigations or assessments, then district environmental staff prepares a summary of the hazardous materials investigation and conclusions to be included in the appropriate section of the EA or EIS using ENV's Hazardous Materials in Project Development – Environmental Documentation.



# "Perform Haz Mat Issue Identification and Resolution (IIR)" Activity

District environmental staff uses this Activity to track the status of each unresolved issue identified in Section 8.1 of the Hazardous Materials Initial Site Assessment form. District environmental staff may, with an ENV SME's permission, assign this Activity to an ENV SME, in which case the ENV SME will complete the process set forth below instead of district environmental staff.

#### Initial IIR Activity Creation

**1.** For each unresolved issue identified in Section 8.1 of the Hazardous Materials Initial Site Assessment form, district environmental staff or the ENV SME completes the following steps.

Note that the purpose of the IIR Activity is to track the resolution of haz mat issues identified in the initial site assessment (ISA). District environmental staff or the ENV SME completing the steps below may either treat each individual site identified in the ISA as its own "Issue," or group similarly situated sites into a single "Issue," depending on whether they will be resolved on an individual or grouped basis.

- 2. District environmental staff or the ENV SME selects the drop-down response for the "Issue Type" field that corresponds to the Type of Concern for the issue as indicated in Section 8.1 of the Hazardous Materials Initial Site Assessment form. The drop-down options are:
  - "Oil and Gas Activity Concerns"
  - "Petroleum Storage Tanks (PST)"
  - "Leaking Petroleum Storage Tanks (LPST)"
  - "Landfills/Waste Pits/Dump Site Concerns"
  - "Non-LPST Source of Contamination Concerns"
  - "Other"
- **3.** District environmental staff or the ENV SME selects "Under Investigation" from the drop-down options for the "Issue Status" field.
- **4.** District environmental staff or the ENV SME specialist fills-in a unique name for the issue for the "Issue Name" field.
- 5. District environmental staff or the ENV SME fills-in a description of the issue in the "Issue Description" field. The information placed in this field may be cut and paste from the "Explain Unresolved or Resolved Issues" field from Section 8.1 of the Hazardous Materials Initial Site Assessment form.
- **6.** District environmental staff or the ENV SME clicks the "Add" button. This allows the issue to move into the table of issues below the shaded line.
- **7.** District environmental staff or the ENV SME performs steps 2-6 above for each unresolved issue identified in Section 8.1 of the Hazardous Materials Initial Site Assessment form.



8. District environmental staff may, at its discretion, ask the appropriate resource area ENV SME assigned to the respective district to look at this Activity to ensure that it has been filled-out correctly. This would be done outside of ECOS either by email or telephone conversation.

#### Updating individual issues within the IIR Activity table

- 1. When new information is obtained about an issue in the IIR table, but the issue has not yet been fully resolved, district environmental staff or the ENV SME selects the edit icon under the "Actions" column for the issue requiring an update.
- 2. District environmental staff or the ENV SME specialist updates the IIR Activity by adding additional information in the "Issue Description" field, which should show progression toward resolution. There are no required inputs for this field and notes entered are at the discretion of the district environmental staff or ENV SME.

#### Resolving individual issues within the IIR Activity table

- 1. If, and only if, the issue listed on an individual row in the IIR table has been fully and completely resolved, then district environmental staff or the ENV SME proceeds as instructed below to record resolution of the issue.
- **2.** District environmental staff or the ENV SME selects the edit icon under the "Actions" column for the issue requiring an update.
- **3.** District environmental staff or the ENV SME selects "Resolved" from the drop-down responses for the "Issue Status" field.
- 4. District environmental staff or the ENV SME updates the "Issue Description" field by providing a reason for resolving the issue. The reason provided shall be descriptive enough to justify no additional investigations into the issue. If the resolution of the issue is based on some documentation (e.g., TCEQ record, testing report, or remediation report), then upload the documentation under this Activity.
- 5. District environmental staff may, at its discretion, create a Review under this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district in order to have the ENV SME review the explanation and/or documentation supporting the resolution of the issue. Once the ENV SME has finalized his or her Review, if there are pending comments, the district environmental staff:
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME.
- **6.** Changing the "Issue Status" to "Resolved" will automatically change the value in the "Validation" column of the table from "N" to "Y."

### Preparation of summary for EA or EIS

1. If an EA or EIS is being prepared for the project, district environmental staff prepares a summary of the hazardous materials investigation and conclusions to be included in the appropriate section of the EA or EIS using ENV's Hazardous Materials in Project Development – Environmental Documentation.



Finalizing the IIR Activity

1. Once all issues in the table have been resolved and their respective "Issue Status" has been updated to "Resolved," and the value for each issue in the table under the "Validation" column has been changed to "Y," district environmental staff or the ENV SME finalizes this Activity.



# "Historical Studies SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of historical studies. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding historical studies, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding historical studies.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.



# "Obtain Historical Studies Section 106/Antiquities Code of Texas (ACT) Approval" Activity

- 1. For (1) projects where TxDOT is the official project sponsor and (2) FHWA projects where a local government is the <u>official</u> project sponsor, the ENV SME confirms:
  - all other historical studies Activities have been finalized (except for "Perform Historical Studies Mitigation" and "Perform Historical Studies Monitoring Commitments"), and
  - that any downstream Activities that cannot be finalized until after environmental clearance have been created.

For non-FHWA projects where a local government is the <u>official</u> project sponsor, the local government sponsor instead proceeds as follows:

- If the project will <u>not</u> involve five or more acres of ground disturbance; will <u>not</u> involve more than 5,000 cubic yards of earth moving; will <u>not</u> occur in historic district or other designated historic site; and will <u>not</u> affect a recorded archeological site, then the local government project sponsor provides an explanation to that effect in the "Comments" field of this Activity, and finalizes this Activity (see Texas Antiquities Code 191.0525(d)).
- If the project <u>will</u> involve five or more acres of ground disturbance; <u>will</u> involve more than 5,000 cubic yards of earth moving; <u>will</u> occur in historic district or other designated historic site; or <u>will</u> affect a recorded archeological site, then the local government project sponsor uploads under this Activity any documentation demonstrating Antiquities Code compliance (and if the project requires a federal permit, Section 106 compliance), and notifies the ENV SME that this documentation has been uploaded.
- 2. If any mitigation or monitoring commitments apply to the project, then the ENV SME confirms that the "Perform Historical Studies Mitigation" and/or "Perform Historical Studies Monitoring Commitments" Activities have been created and that all mitigation and/or monitoring commitments have been identified in the "Comments" field(s) of the appropriate Activity(ies). This step is not required for non-FHWA projects with a local government sponsor.
- **3.** The ENV SME makes the overall effect determination for the entire project based on the outcomes of all other historical studies Activities that have been completed, or for a non-FHWA project with a local government project sponsor, the documentation uploaded by the local government project sponsor.

The overall determination must be one of the following:

- "No historic properties affected" This means the project will not affect <u>any</u> historic property.
- "Minimal potential to affect historic properties" This means the project is covered by Appendix 4 of the Programmatic Agreement Among the Federal Highway Administration, the Texas Department of Transportation, the Texas State Historic Preservation Officer, and the Advisory Council on Historic Preservation Regarding the Implementation of Transportation Undertakings.
- "No adverse effect" This means there will be <u>no</u> adverse effect to <u>any</u> historic property.



•

- "Adverse effect" This means there <u>will</u> be an adverse effect to <u>at least one</u> historic property.
- **4.** In the field labeled "Project Determination of Effect," the ENV SME selects the appropriate choice from the drop-down menu. The four choices for this field are:
  - "No historic properties affected"
  - "Minimal potential to affect historic properties"
  - "No adverse effect"
  - "Adverse effect"
- **5.** In the field labeled "Comments," the ENV SME summarizes the project finding with language that may be used in any environmental documentation. The comments will include the project determination of effect, any further justifications of the ENV SME finding, and may refer to certain uploaded documents for more information.
- 6. The ENV SME finalizes this Activity.

# "Perform Historical Studies Desktop Survey" Activity

 District environmental staff prepares an historical studies desktop survey according to ENV's Documentation Standard and Report Template for Preparing an Historic Resources Survey Report. Alternatively, district environmental staff may request that the appropriate ENV SME prepare the historical studies desktop survey.

Regardless of whether the historical studies desktop survey is prepared by district environmental staff or an ENV SME, it must be prepared by a professional that meets the Secretary of the Interior's Professional Qualification Standards.

- 2. District environmental staff or the ENV SME (depending on who prepared the document) uploads the historical studies desktop survey under this Activity using this file naming convention: HIST DT CSJ MM-YY (e.g., HIST DT 2222-15-027 02-19).
- 3. District environmental staff or the ENV SME (depending on who prepared the document) creates a Review of the historical studies desktop survey under this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff or the ENV SME also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff or ENV SME (depending on who prepared the document):
  - prepares a new, revised version of the historical studies desktop survey that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 4. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, the district environmental staff or the ENV SME (depending on who prepared the document) uploads the approved historical studies desktop survey with the word, "Approved," at the beginning of the file name.
- 5. If, based on the results of the historical studies desktop survey, the ENV SME determines that a windshield survey, reconnaissance survey and/or an intensive survey is required, then the ENV SME does the following:
  - finalizes this Activity;
  - creates the "Perform Historical Studies Windshield Survey," "Perform Historical Studies Reconnaissance Survey" and/or "Perform Historical Studies Intensive Survey" Activity;
  - creates the "Obtain Section 4(f) Approval" Activity (if appropriate);
  - creates the "Perform Chapter 26 Analysis" Activity (if appropriate); and
  - notifies the district environmental staff of the newly created Activity(ies).



- 5. If, based on the results of the historical studies desktop survey, the ENV SME determines that no windshield survey, reconnaissance survey, or intensive survey is required, then the ENV SME does the following:
  - creates one or more of the following Coordinations based on ENV's Historical Studies Analysis Tool:
    - Environmental Historical (ENV-H)
    - Texas Historical Commission Historical (THC-H)
    - Texas Historical Commission Architecture (THC-R)
    - Advisory Council on Historic Preservation (ACHP)
    - County Historical Commission (CHC)
    - Certified Local Government (CLG)
    - Historical Consulting Parties (CPL-H)
  - proceeds according to the Coordination instructions below;
  - creates the "Perform Historical Studies Mitigation" Activity (for any adverse effects);
  - creates the "Perform Historical Studies Monitoring Commitment" Activity (for non-adverse effects, if appropriate);
  - creates the "Obtain Section 4(f) Approval" Activity (if appropriate);
  - creates the "Perform Chapter 26 Analysis" Activity (if appropriate);
  - notifies the district environmental staff of any newly created Activity(ies)); and
  - after all Coordinations are finalized, finalizes this Activity.

#### ENV-H In-House Coordination Process

If the ENV SME determines that the project can be coordinated internally based on **ENV's Historical Studies Analysis Tool**, then the ENV SME uploads the following documentation under the Coordination:

• Signed memo from ENV SME

- 1. The ENV SME prepares a memo according to ENV's Template for Stipulation IX Memo.
- 2. The ENV SME emails the memo to the ENV SME team lead for review and signature.
- **3.** Once the ENV SME team lead has signed the memo, the ENV SME team lead returns the memo to the ENV SME.
- **4.** In the Coordination, the ENV SME selects the drop-down response "Environmental Historical (ENV-H)" for the "Agency Name" field.
- 5. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details as follows:
  - For the "Correspondence Status" field, the ENV SME selects, "Response received no further action", using the drop-down menu.
  - For the "Correspondence Method" field, the ENV SME selects, "Letter", using the dropdown menu.



- For the "Correspondence Date" field, the ENV SME enters the date the memo was signed by the ENV CRM Section Director.
- For the "Correspondence From" field, the ENV SME enters "TxDOT."
- For the "Correspondence To" field, the ENV SME enters "TxDOT."
- 6. The ENV SME uploads a copy of the signed memo under the Coordination using the following naming convention: "Approved\_HIST IM CSJ MM-YY" (e.g. Approved\_HIST IM 2222-15-027 02-19).
- **7.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **8.** The ENV SME finalizes the Coordination.

#### THC/TSHPO Coordination process

If the ENV SME determines that the project must be coordinated with the Texas Historical Commission/Texas State Historic Preservation Officer (THC/TSHPO) based on **ENV's Historical Studies Analysis Tool**, then the ENV SME uploads the following documentation under the Coordination:

- Consultation letter signed by the THC/TSHPO
- Any other correspondence documenting decision-making to or from TxDOT or the THC/TSHPO

- **1.** The ENV SME prepares a consultation letter as appropriate using one of the following templates:
  - ENV's Template for Section 106 Projects Letter
  - ENV's Template for 4f Exception Letter (Joint 106 and 4f)
  - ENV's Template for 4f De Minimis Letter (Joint 106 and 4f)
  - ENV's Template for Programmatic Bridge 4f Letter (Joint 106 and 4f)
- 2. The ENV SME emails the consultation letter to the ENV SME team lead for review and approval.
- **3.** Once the ENV SME team lead has approved the consultation letter by initialing it, the ENV SME team lead returns the consultation letter to the ENV SME.
- **4.** The ENV SME signs the consultation letter and transmits the consultation letter and historical studies desktop survey to the THC/TSHPO via the THC eTRAC System.
- **5.** The THC/TSHPO reviews the letter and historical studies desktop survey and requests clarifications from the authoring ENV SME as necessary.
- **6.** The ENV SME transmits to THC/TSHPO any requested responses or clarifications.
- **7.** The THC/TSHPO signs the consultation letter and returns the original, signed consultation letter to the ENV SME.



- In the Coordination, the ENV SME selects the drop-down response "Texas Historical Commission

   Historical (THC-H)" or "Texas Historical Commission Architecture (THC-R)" for the "Agency Name" field, depending on ENV's Historical Studies Analysis Tool.
- 9. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the THC/TSHPO, using "TxDOT" to refer to TxDOT and "THC" to refer to the THC/TSHPO in the "Correspondence From" and "Correspondence To" fields.
- **10.** The ENV SME uploads the consultation letter signed by the THC under the Coordination using the following file naming convention: "Approved\_HIST THC CSJ MM-YY" (e.g., Approved\_HIST THC 2222-15-027 02-19).
- **11.** The ENV SME uploads each email or letter to or from TxDOT and the THC/TSHPO under the Coordination.
- **12.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **13.** The ENV SME finalizes the Coordination.

# Advisory Council on Historic Preservation (ACHP) Coordination process

If the ENV SME determines that the project must be coordinated with the Advisory Council on Historic Preservation (ACHP) based on **ENV's Historical Studies Analysis Tool**, then the ENV SME uploads the following documentation under the Coordination:

- Completed ACHP consultation form
- Consultation letter signed by the ACHP
- Any other correspondence documenting decision-making to or from TxDOT or the ACHP

- 1. The ENV SME completes the ACHP's consultation form.
- 2. The ENV SME emails the completed ACHP consultation form to the ENV SME team lead for review and approval.
- **3.** Once the ENV SME team lead has approved the completed ACHP consultation form, the ENV SME team lead returns the completed ACHP consultation form to the ENV SME.
- **4.** The ENV SME emails the completed ACHP consultation form to the ENV CRM Section Director for review and approval.
- **5.** Once the ENV CRM Section Director has approved the completed ACHP consultation form, the ENV CRM Section Director returns the completed ACHP consultation form to the ENV SME.



- 6. The ENV SME transmits the completed ACHP consultation form to the ACHP at the following address: e106@achp.gov and uploads the completed ACHP consultation form under the Coordination.
- **7.** The ACHP reviews the completed ACHP consultation form and requests clarifications from the ENV SME as necessary.
- 8. The ENV SME transmits to the ACHP any requested responses or clarifications.
- **9.** The ACHP issues a signed letter concluding the consultation.
- **10.** In the Coordination, the ENV SME selects the drop-down response "Advisory Council on Historic Preservation (ACHP)" for the "Agency Name" field,
- **11.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the ACHP.
- **12.** The ENV SME uploads the ACHP's signed letter concluding the consultation using the following file naming convention: "Approved\_HIST ACHP CSJ MM-YY" (e.g., Approved\_HIST ACHP 2222-15-027 02-19).
- **13.** The ENV SME uploads each email or letter to or from TxDOT and the ACHP under the Coordination.
- **14.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **15.** The ENV SME finalizes the Coordination.

### County Historical Commission (CHC) Coordination process

If the ENV SME determines that the project must be coordinated with the County Historical Commission (CHC) based on **ENV's Historical Resources Studies Tool**, then the ENV SME or district environmental staff uploads the following documentation under the Coordination:

• Any correspondence documenting decision-making to or from TxDOT or the CHC

- 1. The ENV SME or the district environmental staff provides information regarding the project to the CHC by email, telephone conversation, or letter. Depending on the project, the ENV SME or district environmental staff could, but is not required to use the one following templates:
  - ENV's Template for CHC General Correspondence 106
  - ENV's Template for CHC Letter Non-Truss Bridges 106
  - ENV's Template for CHC Letter Truss Bridges 106
- 2. In the Coordination, the ENV SME or the district environmental staff selects the drop-down response "County Historical Commission (CHC)" for the "Agency Name" field.



- **3.** In the Coordination, the field labeled, "Are Correspondence Detailed Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME or district environmental staff fills-in the correspondence details.
- **4.** The ENV SME or district environmental staff uploads any correspondence to or from TxDOT and the CHC under the Coordination using the following file naming convention: "HIST CHC CSJ MM-YY" (e.g., HIST CHC 2222-15-027 02-19).
- 5. Once either all comments from the CHC have been addressed or no response has been received within the review period (30 days), the ENV SME or district environmental staff selects "Completed" from the drop-down menu for the field labeled, "Coordination Status."
- 6. The ENV SME or district environmental staff finalizes the Coordination.

### Certified Local Government (CLG) Coordination process

If the ENV SME determines that the project must be coordinated with the Certified Local Government (CLG) based on **ENV's Historical Studies Analysis Tool**, then the ENV SME or district environmental staff uploads the following documentation under the Coordination:

• Any correspondence documenting decision-making to or from TxDOT or the CLG

- **1.** The ENV SME or the district environmental staff provides information regarding the project to the CLG by email, telephone conversation, or letter.
- 2. In the Coordination, the ENV SME or the district environmental staff selects the drop-down response "Certified Local Government (CLG)" for the "Agency Name" field.
- **3.** In the Coordination, the field labeled, "Are Correspondence Detailed Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME or district environmental staff fills-in the correspondence details.
- 4. The ENV SME or district environmental staff uploads any correspondence to or from TxDOT and the CLG under the Coordination using the following naming convention: "HIST CLG CSJ MM-YY" (e.g. HIST CLG 2222-15-027 02-19).
- 5. Once either all comments from the CLG have been addressed or no response has been received within the review period (30 days), the ENV SME or district environmental staff selects "Completed" from the drop-down menu for the field labeled, "Coordination Status."
- **6.** The ENV SME or district environmental staff finalizes the Coordination.



#### Historical Consulting Parties (CPL-H) Coordination process

If the ENV SME determines that the project must be coordinated with historical consulting parties (CPL-H) based on **ENV's Historical Studies Analysis Tool**, then the ENV SME or district environmental staff uploads the following documentation under the Coordination:

• Any correspondence documenting decision-making to or from TxDOT or the historical consulting parties

Follow the steps below to conduct the coordination.

- **1.** The ENV SME or the district environmental staff provides information regarding the project to the historical consulting parties by email, telephone conversation, or letter.
- 2. In the Coordination, the ENV SME or the district environmental staff selects the drop-down response "Historical Consulting Parties (CPL-H)" for the "Agency Name" field.

Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff or ENV SME (depending on who prepared the document):

- **7.** After the above-listed steps have been completed, including any coordination, the ENV SME finalizes this Activity.

#### THC/TSHPO Coordination process

- **4.** The ENV SME uploads each email or letter to or from TxDOT and the THC/TSHPO under the Coordination.
- **5.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- 6. The ENV SME finalizes the Coordination.

#### County Historical Commission (CHC) Coordination process

- **3.** In the Coordination, the field labeled, "Are Correspondence Detailed Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details.
- **4.** The ENV SME uploads any correspondence to or from TxDOT and the CHC under the Coordination using the following file naming convention: "HIST CHC MON CSJ MM-YY" (e.g., HIST MON CHC 2222-15-027 02-19).
- 5. Once either all comments from the CHC have been addressed or no response has been received within the review period (30 days), the ENV SME selects "Completed" from the drop-down menu for the field labeled, "Coordination Status."
- **6.** The ENV SME finalizes the Coordination.

### Certified Local Government (CLG) Coordination process

If the ENV SME determines that the monitoring commitments must be coordinated with the Certified Local Government (CLG) based on the commitment, then the ENV SME uploads the following documentation under the Coordination:

- 2. In the Coordination, the ENV SME selects the drop-down response "Certified Local Government (CLG)" for the "Agency Name" field.
- **3.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details.
- 4. The ENV SME uploads any correspondence to or from TxDOT and the CLG under the Coordination using the following naming convention: "HIST CLG MON CSJ MM-YY" (e.g. HIST CLG MON 2222-15-027 02-19).
- 5. Once either all comments from the CLG have been addressed or no response has been received within the review period (30 days), the ENV SME selects "Completed" from the drop-down menu for the field labeled, "Coordination Status."
- 6. The ENV SME finalizes the Coordination.

### Historical Consulting Parties (CPL-H) Coordination process



If the ENV SME determines that the monitoring commitments must be coordinated with historical consulting parties (CPL-H) based on the commitment, then the ENV SME uploads the following documentation under the Coordination:

- **4.** The ENV SME uploads any correspondence to or from TxDOT and the historical consulting parties under the Coordination using the following naming convention: "HIST CPL MTG CSJ MM-YY" (e.g. HIST CPL MTG 2222-15-027 02-19).
- 5. Once either all comments from the historical consulting parties have been addressed or no response has been received within the review period (30 days), the ENV SME selects "Completed" from the drop-down menu for the field labeled, "Coordination Status."
- 6. The ENV SME finalizes the Coordination.

# "Perform Historical Studies Project Coordination Request (PCR)" Activity

If the project meets the requirements of the categorical exclusion criterion listed at 23 CFR 771.117(c)(1) regarding activities that do not involve or lead directly to construction such as planning and research activities, or the categorical exclusion criterion listed at 23 CFR 771.117(c)(29) regarding the purchase, construction, replacement or rehabilitation of ferry vessels, then district environmental staff inserts the following statement in the "Comments" field of this Activity: "This project does not require a PCR," and finalizes this Activity.

If neither of the above-listed categorical exclusion criteria apply, but district environmental staff nevertheless believes that the project does not warrant a PCR, then district environmental staff must contact the ENV SME assigned to the respective district to discuss the project. If the ENV SME agrees that a PCR is not warranted, then district environmental staff:

- inserts the following statement in the "Comments" field of this Activity: "This project does not require a PCR per [insert name], ENV SME" and
- finalizes this Activity.
- 2. District environmental staff prepares a Project Coordination Request (PCR) according to ENV's Project Coordination Request (PCR) for Historical Studies form and ENV's Instructions for Completing Project Coordination Request (PCR) for Historical Studies.

Important notes about preparing the PCR:

• ENV's Project Coordination Request (PCR) for Historical Studies calls for a screen capture of the WPD I screen in ECOS to be attached to the PCR. By attaching a screen capture of the WPD I screen in ECOS to the PCR, the preparer is confirming that the WPD I screen contains a project description and that the WPD I project description is the description of the project upon which the PCR is based. If there is any discrepancy between the description of the project upon which this PCR is based and the WPD I project description, such discrepancy must be resolved before the WPD I screen is attached to the PCR and the background study is submitted to ENV for review.

Note that it is not necessary to attach a screen capture of the WPD I screen to the PCR when the PCR is being prepared in connection with a reevaluation. The partially completed reevaluation form uploaded to ECOS will have a description of any design changes (see instructions for "Perform Reevaluation").

 As explained in ENV's Instructions for Completing Project Coordination Request (PCR) for Historical Studies, certain bridge projects require coordination with County Historical Commissions, as determined by ENV's Guidance: Determining Appropriate Level of Review for Bridge Projects. When this is the case, district environmental staff completes the coordination with the County Historical Commission as part of preparing the PCR (which is different than the other types of coordinations for historical studies, which the ENV SME creates as indicated below). So, in this instance district



environmental staff must create a Coordination for "County Historical Commission (CHC)," and complete the Coordination according to the instructions below, prior to uploading the PCR and proceeding with these Activity Instructions.

- **3.** District environmental staff uploads the PCR under this Activity using this file naming convention: HIST PCR CSJ MM-YY (e.g., HIST PCR 2222-15-027 02-19).
- 4. District environmental staff creates a Review of the PCR under this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the PCR that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 5. If the ENV SME (and ENV Project Delivery staff, if applicable) finalized his or her Review of the original version of the PCR uploaded by district environmental staff by indicating "Approved no comments," or "Approved with comments" but district environmental staff determines that the comments do not warrant a new version of the PCR, then the reviewed PCR is the Approved PCR for purposes of this Activity. If the ENV SME's comments warranted a new version of the PCR, then once the ENV SME has no further comments and has finalized his or her Review, the district environmental staff uploads the final PCR with the word, "Approved," at the beginning of the file name.

### Survey required

- 1. If, based on the results of the PCR, the ENV SME determines that a survey is required in accordance with **ENV's Historical Studies Analysis Tool**, then the ENV SME does the following:
  - finalizes this Activity;
  - creates the "Perform Historical Studies Research Design" Activity, indicates the type of survey required (desktop, windshield, reconnaissance, or intensive) in the "Assignment Details" field of the "Perform Historical Studies Research Design" Activity, and assigns it to the district environmental staff (if responsible for performing the survey) or to the ENV SME (if responsible for performing the survey);
  - creates the "Obtain Section 4(f) Approval" Activity (if appropriate);
  - creates the "Perform Chapter 26 Analysis" Activity (if appropriate); and
  - notifies the district environmental staff of the newly created Activity(ies).



(1) No survey required **and** (2) no historic-age properties (45 years old or greater) in the project's Area of Potential Effects (or project is listed on Appendix 4) **and** (3) no sensitive property types in the project's Area of Potential Effects

- 1. If, based on the results of the PCR, the ENV SME determines that an additional survey is <u>not</u> required, <u>and</u> that there are no historic-age properties (45 years old or greater) in the project's Area of Potential Effects (or there are such properties, but the project is listed on Appendix 4) <u>and</u> that there are no sensitive property types in the project's Area of Potential Effects, then the ENV SME does the following:
  - explains in the "Comments" field of this Activity that, based on the results of the PCR, there are no historic-age properties (45 years old or greater)/no sensitive property types in the project's Area of Potential Effects; and
  - finalizes this Activity.

(1) No survey required, and (2) one or more historic-age properties (45 years old or greater) within the project's Area of Potential Effects (and project is not listed on Appendix 4) or one or more sensitive property types in the project's Area of Potential Effects

If, based on the results of the PCR, the ENV SME determines that an additional survey is not required, <u>and</u> that there are one or more historic-age properties (45 years old or greater) in the project's Area of Potential Effects (and the project is not listed on Appendix 4), <u>or</u> there are one or more sensitive property types in the project's Area of Potential Effects, then the ENV SME does the following:
  - creates one or more of the following Coordinations based on ENV's Historical Studies Analysis Tool:
    - Environmental Historical (ENV-H)
    - Texas Historical Commission Historical (THC-H)
    - Texas Historical Commission Architecture (THC-R)
    - Advisory Council on Historic Preservation (ACHP)
    - County Historical Commission (CHC)
    - Certified Local Government (CLG)
    - Historical Consulting Parties (CPL-H)
  - proceeds according to the Coordination instructions below (subject to Step 2 below);
  - creates the "Perform Historical Studies Monitoring Commitment" Activity (for non-adverse effects, if appropriate);
  - creates the "Obtain Section 4(f) Approval" Activity (if appropriate);
  - creates the "Perform Chapter 26 Analysis" Activity (if appropriate);
  - notifies the district environmental staff of any newly created Activity(ies)); and
  - after all Coordinations are finalized, finalizes this Activity.

Alternatively, district environmental staff may request that the appropriate ENV SME prepare the historical studies reconnaissance survey.

Regardless of whether the historical studies reconnaissance survey is prepared by district environmental staff or an ENV SME, it must be prepared by a professional that meets the Secretary of the Interior's Professional Qualification Standards.

- 2. District environmental staff or the ENV SME (depending on who prepared the document) uploads the historical studies reconnaissance survey under this Activity using this file naming convention: HIST RS CSJ MM-YY (e.g., HIST RS 2222-15-027 02-19).
- 3. District environmental staff or the ENV SME (depending on who prepared the document) creates a Review of the historical studies reconnaissance survey under this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff or the ENV SME also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff or ENV SME (depending on who prepared the document):
  - prepares a new, revised version of the historical studies reconnaissance survey that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 4. - **12.** The ENV SME uploads the ACHP's signed letter concluding the consultation using the following file naming convention: "Approved\_HIST ACHP CSJ MM-YY" (e.g., Approved\_HIST ACHP 2222-15-027 02-19).
- **13.** The ENV SME uploads each email or letter to or from TxDOT and the ACHP under the Coordination.
- **14.** In the Coordination, the ENV SME selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status."
- **15.** The ENV SME finalizes the Coordination.

#### County Historical Commission (CHC) Coordination process

If the ENV SME determines that the project must be coordinated with the County Historical Commission (CHC) based on **ENV's Historical Resources Studies Tool**, then the ENV SME or district environmental staff uploads the following documentation under the Coordination:

• Any correspondence documenting decision-making to or from TxDOT or the CHC

- 1. The ENV SME or the district environmental staff provides information regarding the project to the CHC by email, telephone conversation, or letter. Depending on the project, the ENV SME or district environmental staff could, but is not required to use the one following templates:
  - ENV's Template for CHC General Correspondence 106
  - ENV's Template for CHC Letter Non-Truss Bridges 106
  - ENV's Template for CHC Letter Truss Bridges 106
- **2.** In the Coordination, the ENV SME or the district environmental staff selects the drop-down response "County Historical Commission (CHC)" for the "Agency Name" field.
- In the Coordination, the field labeled, "Are Correspondence Detailed Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME or district environmental staff fills-in the correspondence details.



- **4.** The ENV SME or district environmental staff uploads any correspondence to or from TxDOT and the CHC under the Coordination using the following file naming convention: "HIST CHC CSJ MM-YY" (e.g., HIST CHC 2222-15-027 02-19).
- 5. Once either all comments from the CHC have been addressed or no response has been received within the review period (30 days), the ENV SME or district environmental staff selects "Completed" from the drop-down menu for the field labeled, "Coordination Status."
- 6. The ENV SME or district environmental staff finalizes the Coordination.

## Certified Local Government (CLG) Coordination process

If the ENV SME determines that the project must be coordinated with the Certified Local Government (CLG) based on **ENV's Historical Studies Analysis Tool**, then the ENV SME or district environmental staff uploads the following documentation under the Coordination:

• Any correspondence documenting decision-making to or from TxDOT or the CLG

Follow the steps below to conduct the coordination.

- **1.** The ENV SME or the district environmental staff provides information regarding the project to the CLG by email, telephone conversation, or letter.
- 2. In the Coordination, the ENV SME or the district environmental staff selects the drop-down response "Certified Local Government (CLG)" for the "Agency Name" field.
- **3.** In the Coordination, the field labeled, "Are Correspondence Detailed Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME or district environmental staff fills-in the correspondence details.
- 4. The ENV SME or district environmental staff uploads any correspondence to or from TxDOT and the CLG under the Coordination using the following naming convention: "HIST CLG CSJ MM-YY" (e.g. HIST CLG 2222-15-027 02-19).
- 5. Once either all comments from the CLG have been addressed or no response has been received within the review period (30 days), the ENV SME or district environmental staff selects "Completed" from the drop-down menu for the field labeled, "Coordination Status."
- 6. The ENV SME or district environmental staff finalizes the Coordination.

### Historical Consulting Parties (CPL-H) Coordination process

If the ENV SME determines that the project must be coordinated with historical consulting parties (CPL-H) based on **ENV's Historical Studies Analysis Tool**, then the ENV SME or district environmental staff uploads the following documentation under the Coordination:

 Any correspondence documenting decision-making to or from TxDOT or the historical consulting parties



- **1.** The ENV SME or the district environmental staff provides information regarding the project to the historical consulting parties by email, telephone conversation, or letter.
- 2. In the Coordination, the ENV SME or the district environmental staff selects the drop-down response "Historical Consulting Parties (CPL-H)" for the "Agency Name" field.
- **3.** In the Coordination, the field labeled, "Are Correspondence Detailed Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME or district environmental staff fills-in the correspondence details.
- **4.** The ENV SME or district environmental staff uploads any correspondence to or from TxDOT and the historical consulting parties under the Coordination using the following naming convention: "HIST CPL CSJ MM-YY" (e.g. HIST CPL 2222-15-027 02-19).
- 5. Once either all comments from the historical consulting parties have been addressed or no response has been received within the review period (30 days), the ENV SME or district environmental staff selects "Completed" from the drop-down menu for the field labeled, "Coordination Status."
- 6. The ENV SME or district environmental staff finalizes the Coordination.

## "Noise SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of noise. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding noise, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding noise.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.



## "Perform Noise Analysis" Activity

1. District environmental staff conducts a traffic noise analysis in accordance with ENV's Traffic Noise Policy Implementation Guidance.

Note that if the project is a "Super 2 project" (a project that just installs passing lanes), then district environmental staff <u>first</u> contacts the ENV SME assigned to the respective district to determine the level of analysis required.

- 2. District environmental staff prepares a traffic noise analysis report in accordance with ENV's Traffic Noise Policy Implementation Guidance.
- 3. District environmental staff uploads the following under this Activity:
  - Traffic noise analysis report as specified in ENV's Traffic Noise Analysis Report template
  - A zip file (TNM.zip) containing the noise model files (objects.dat and objects.idx files in separate named folders for each model) as described in ENV's Traffic Noise Policy Implementation Guidance

District environmental staff may, at its discretion, upload additional documentation in support of the traffic noise analysis either separately or included in the TNM.zip.file.

District environmental staff may, at its discretion, upload additional documentation in support of the traffic noise analysis.

- 4. If, as part of the noise analysis, the design engineer conducted the constructability analysis and completed ENV's Form Constructability Assessment for Proposed Noise Barrier, then district environmental staff creates the "Perform Noise Constructability Assessment" Activity and uploads the completed form under that Activity and follows the instructions in that Activity.
- 5. If the traffic noise analysis report is prepared for an EIS project, <u>or</u> if the traffic noise analysis report indicates predicted noise impacts, then district environmental staff creates a Review of this Activity and assigns it to the appropriate resource area ENV SME assigned to the respective district.

Additionally, even if the traffic noise analysis report does not indicate predicted noise impacts, district environmental staff may, at its discretion, create a Review of this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district.

If district environmental staff creates an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff.

**6.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review (if a Review was created), if there are pending comments, the district environmental staff:



- prepares a new, revised version of the traffic noise analysis report (and any new or revised supporting documentation) that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling in the "How Addressed," "New Page," and "New Section columns and uploads the matrix under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 7. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if a Review was created), district environmental staff uploads the final traffic noise analysis report with the word, "Approved," at the beginning of the file name, and finalizes this Activity.
- 8. District environmental staff creates the "Perform Notification of Noise Information to Local Officials" Activity, unless noise contours were not calculated because there were no undeveloped areas adjacent to the project.
- 9. If the traffic noise analysis report included a preliminary barrier proposal for one or more noise abatement barriers and the design engineer has not yet conducted the constructability analysis and completed ENV's Form Constructability Assessment for Proposed Noise Barrier, then district environmental staff creates the "Perform Noise Constructability Assessment" Activity and follows the instructions in that Activity.
- **10.** If an EA or EIS is being prepared for the project, then district environmental staff uses the traffic noise analysis report to complete the appropriate section of the EA or EIS.

## "Perform Noise Constructability Assessment" Activity

- 1. A constructability assessment using ENV's Form Constructability Assessment for Proposed Noise Barrier <u>must</u> be conducted <u>prior</u> to scheduling and holding a noise workshop.
- **2.** In the "Comments" field of this Activity, district environmental staff indicates the following for each barrier proposed for possible implementation in the traffic noise analysis report:
  - the Noise Barrier ID,
  - location of the preliminarily proposed barrier,
  - any other identifying information from the traffic noise analysis report, such as neighborhood name, side of roadway, and CSJ (if the project is broken into multiple CSJs),
  - current status of barrier (i.e., "awaiting results of constructability assessment," "determined to be not constructable," or "determined to be constructable").

Note that the fourth bullet point above will need to be updated as the procedure set forth below is completed so it shows a real-time status of the barrier.

- 3. The design engineer performs the constructability assessment by completing **ENV's Form Constructability Assessment for Proposed Noise Barrier**. The constructability assessment for proposed noise barrier form must be completed prior to distributing the solicitation packet for the noise workshop, and it must include an analysis and determination on whether the preliminarily proposed barrier(s) is/are still feasible and reasonable (with or without adjustments) based on constructability (i.e., site constraints, costs, or other factors). For additional information about constructability assessments see **ENV's Traffic Noise Policy Implementation Guidance** at Section 9.0.
- **4.** District environmental staff uploads the completed constructability assessment for proposed noise barrier form under this Activity.
- 5. District environmental staff creates a Review of this Activity and assigns it to the appropriate ENV SME assigned to the respective district. If the project is anticipated to be cleared or has been cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff.
- 6. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review of the completed constructability assessment for proposed noise barrier form, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the completed constructability assessment for proposed noise barrier form that is responsive to the comments made and uploads it under this Activity.
  - completes the comment response matrix by filling in the "How Addressed," "New Page," and "New Section columns and uploads the matrix under this Activity, and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).



- 7. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff uploads under this Activity the final completed constructability assessment for proposed noise barrier form with the word, "Approved," at the beginning of the file name.
- 8. If <u>any</u> of the proposed barrier(s) is/are <u>not</u> still feasible and reasonable (with or without adjustments) based on constructability (i.e., site constraints, costs, or other factors), then district environmental staff updates the status of the proposed barrier(s) in the "Comments" field of this Activity (i.e., "Status: determined to be not constructable").
- **9.** If <u>all</u> of the proposed barrier(s) is/are <u>not</u> still feasible and reasonable (with or without adjustments) based on constructability (i.e., site constraints, costs, or other factors), then district environmental staff updates the status of the proposed barrier(s) in the "Comments" field of this Activity, explains that no noise workshop will be held, and finalizes this Activity (i.e., "Status: determined to be not constructable").
- **10.** If district environmental staff determined that at least one of the proposed barrier(s) <u>is/are</u> still feasible and reasonable (with or without adjustments) based on constructability (i.e., site constraints, costs, or other factors), then district environmental staff updates the status of the proposed barrier(s) in the "Comments" field of this Activity (i.e., "Status: determined to be constructable"), finalizes this Activity, and creates the "Perform Noise Workshop" Activity. Note that, if more than one noise workshops will be held, it is at the district's discretion whether to create one or multiple "Perform Noise Workshop" Activities.

## "Perform Noise Mitigation" Activity

- 1. District environmental staff identifies the noise barriers approved for construction during the noise workshop(s) held for the project in the "Comments" field of this Activity. For each such barrier, provide the Noise Barrier ID, which is the unique name for the constructed barrier that was used in the traffic noise analysis report and the noise workshop summary report.
- 2. After each noise barrier has been constructed, district environmental staff completes ENV's Noise Barrier Tracking Spreadsheet and uploads it under this Activity.
- **3.** If it is determined that any of the noise barriers approved for construction during the noise workshop(s) held for the project will not actually be constructed, district environmental staff provides an explanation in the "Comments" field of this Activity.
- **4.** Once all noise barriers have been constructed, and the information required by 23 CFR 772.13(f) has been uploaded for all constructed barriers, district environmental staff finalizes this Activity.

## "Perform Noise Workshop" Activity

- **1.** The "Perform Noise Constructability Assessment" Activity must be completed and finalized prior to scheduling and holding a noise workshop.
- **2.** In the "Comments" field of this Activity, district environmental staff indicates the following for each barrier proposed for possible implementation in the traffic noise analysis report:
  - the Noise Barrier ID,
  - location of the preliminarily proposed barrier,
  - any other identifying information from the traffic noise analysis report, such as neighborhood name, side of roadway, and CSJ (if the project is broken into multiple CSJs),
  - current status of barrier (i.e., "awaiting results of noise workshop," "rejected as a result of noise workshop," or "approved as a result of noise workshop").

Note that the fourth bullet point above will need to be updated as the procedure set forth below is completed so it shows a real-time status of the barrier.

- **3.** District environmental staff plans and holds a noise workshop(s) meeting, following policies and recommended best practices in **ENV's Traffic Noise Policy Implementation Guidance**. The primary components of a noise workshop are as follows:
  - Identifying eligible voters
  - Distribution of solicitation materials (notice, ballot, and barrier information)
  - Holding the workshop meeting
- 4. In accordance with ENV's Traffic Noise Policy Implementation Guidance, district environmental staff receives ballots from eligible voters and determines voting results. If, after receiving ballots from eligible voters, additional outreach efforts are required by ENV's Traffic Noise Policy Implementation Guidance, then those additional outreach efforts must be completed before moving on to the next step below.
- District environmental staff prepares the documentation of noise workshop in accordance with ENV's Template: Documentation of Noise Workshop Cover Page and uploads it under this Activity.

If multiple workshops are held for the project (e.g., because there are multiple barriers proposed in different neighborhoods), then it is recommended that district environmental staff prepare separate documentation for each workshop. In rare situations, it may be possible to prepare one documentation for multiple workshops; however, district environmental staff should consult with the ENV SME assigned to the respective district before doing so.

- **6.** District environmental staff creates a Review of this Activity and assigns it to the appropriate ENV SME assigned to the respective district.
- **7.** Once the ENV SME has finalized his or her Review of the documentation of noise workshop, if there are pending comments, the district environmental staff:



- prepares a new, revised version of the documentation of noise workshop that is responsive to the comments made and uploads it under this Activity.
- completes the comment response matrix by filling in the "How Addressed," "New Page," and "New Section columns and uploads the matrix under this Activity, and
- creates a new Review under this Activity, and assigns it to the ENV SME.
- **8.** Once the ENV SME has no further comments and has finalized his or her Review, district environmental staff:
  - uploads under this Activity the final documentation of noise workshop with the word, "Approved," at the beginning of the file name; and
  - enters the decision to build or not build the proposed barrier(s) resulting from the noise workshop in the "Comments" field of this Activity-
- **9.** District environmental staff notifies eligible voters by letter of the workshop results, and uploads the letters under this Activity.
- **10.** District environmental staff updates the current status of barrier in the "Comments" field of this Activity (i.e., "rejected as a result of noise workshop," or "approved as a result of noise workshop").
- **11.** If the decision resulting from the noise workshop is to build one or more barriers, then district environmental staff creates the "Perform Noise Mitigation" Activity. Note that, if more than one noise workshops are held, each of which results in a decision to build one or more barriers, it is <u>not</u> necessary to create multiple "Perform Noise Mitigation" Activities. There must only be one "Perform Noise Mitigation" Activity for any given project.
- **12.** District environmental staff finalizes this Activity.

# "Perform Notification of Noise Information to Local Officials" Activity

- 1. District environmental staff prepares a customized letter using ENV's Template: Letter Related to Noise Contours for Land Use Planning.
- 2. After the environmental clearance (CE determination, FONSI, or ROD), but no later than 30 days after the environmental clearance, district environmental staff transmits the customized letter to the applicable mayor's office if the project is in an incorporated area, or to the county judge's office if the project is in an unincorporated area. If the project extends into multiple jurisdictions, then all applicable mayors' offices and county judges' offices must be sent the customized letter.
- **3.** District environmental staff uploads copy of signed letter(s) under this Activity and finalizes this Activity.

# "Add CSJ After Environmental Clearance" Activity

1. District environmental staff uses this Activity to associate a new CSJ that has <u>not</u> been environmentally cleared, with a main CSJ for a project in ECOS that <u>has already been</u> environmentally cleared.

Because CSJs are associated with each other in ECOS <u>purely</u> for allowing multiple CSJs to be covered by a single environmental clearance (CE, FONSI, or ROD), there should never be a reason for associating two CSJs that have both already been environmentally cleared. However, if this situation arises due to an error or other unforeseen issue, it will be necessary to revoke the environmental clearance of the new CSJ before associating it with a previously cleared main CSJ (see "Revoke Environmental Clearance" Activity 1-pager).

- 2. Note that the new CSJ must first have been created in ECOS (i.e., fill-in the eight required fields and click the save icon as described in Environmental Guide Volume 1, Section 1.9). Additionally, the "Anticipated Environmental Clearance" on WPD I of the new CSJ must match that of the main CSJ, and any Activities with a milestone of "Prior to Env Clearance\*" created in the new CSJ must be finalized, before this Activity can be used to associate the new CSJ with a previously cleared main CSJ. Note also that this procedure cannot be used to add a new CSJ to a main CSJ that was previously cleared using an expedited (c)(22) CE. If such a need arises, district environmental staff must instead simply clear the new CSJ using the expedited (c)(22) CE process.
- **3.** District environmental staff creates this Activity in the previously cleared main CSJ with which staff intends to associate the new CSJ.
- **4.** District environmental staff fills-in the "Add New Associate CSJ" field with the new CSJ that staff intends to associate with the previously cleared main CSJ.
- **5.** District environmental staff selects the appropriate "Reason(s) for Adding CSJ" from the list provided.

Important note regarding ROW CSJs: It is preferred that ROW CSJs be created and associated with the main CSJ prior to environmental clearance; however, sometimes ROW CSJs are not created until after environmental clearance and need to be added using this Activity. When that happens, it is important for ROW agents and other TxDOT personnel to understand that the addition of a ROW CSJ to the main using this Activity does <u>not</u> environmentally clear the acquisition of <u>additional</u> parcels not covered by the environmental clearance (i.e., CE determination, FONSI, or ROD). If additional parcels beyond those covered by the environmental clearance will need to be acquired in the future (e.g., if there is a design change), and such acquisition will occur under the same ROW CSJ that is being used to acquire the parcels that were already environmentally cleared, then it is okay to add the ROW CSJ to the main CSJ using this Activity; <u>however</u>, the acquisition of those additional parcels cannot occur until they are cleared with a reevaluation.



- 6. If district environmental staff selected a "Reason(s) for Adding CSJ" that is marked with an asterisk (\*), then the new CSJ may be associated with the previously cleared main CSJ only if a reevaluation has been completed for the work associated with the new CSJ.
- 7. District environmental staff selects the appropriate response to the question regarding whether the new CSJ involves activities that were <u>not</u> covered in the original environmental clearance for the previously cleared main CSJ and previously associated CSJs. If staff answers, "yes," then enter the date the reevaluation for the activities associated with the new CSJ was approved.
- **8.** District environmental staff assigns this Activity to the ENV project delivery manager assigned to the respective district.
- **9.** ENV project delivery manager ensures that any Activities with a milestone of "Prior to Env Clearance\*" created in the new CSJ have been finalized.

Note that there should never be a reason why <u>any</u> Activities were created in the new CSJ, because there is no need to complete the project work plan process for the new CSJ, and even if the new CSJ represents new work for which a reevaluation is required, the reevaluation and any associated Activities must be tracked in the <u>main</u> CSJ, not in the new CSJ that will be added to the main CSJ. Therefore, this step 9 is meant to address those unusual situations in which an Activity was inadvertently or incorrectly created in the new CSJ prior to adding it to the previously cleared main CSJ.

- **10.** ENV project delivery manager ensures that the "Reason for Adding CSJ" entered by district environmental staff in this Activity is consistent with:
  - the project description on the WPD I Project Definition screen for the new CSJ;
  - the project description for the environmental clearance for the main CSJ; and
  - the description of any new work as set forth in any reevaluation.
- **11.** If the ENV project delivery manager disapproves the information provided and reason for associating the new CSJ with the previously cleared main CSJ, the ENV project delivery manager contacts the district environmental staff to discuss, and the district environmental staff either corrects the identified deficiency or deletes this Activity.

If the ENV project delivery manager approves the information provided and reason for associating the new CSJ with the previously cleared main CSJ, the ENV project delivery manager assigns this Activity to an ENV Deputy Director.

**12.** If the ENV Deputy Director disapproves the information provided and reason for associating the new CSJ with the previously cleared main CSJ, the ENV Deputy Director contacts the district environmental staff to discuss, and the district environmental staff either corrects the identified deficiency or deletes this Activity.

If the ENV Deputy Director approves the information provided and reason for associating the new CSJ with the previously cleared main CSJ, the ENV Deputy Director finalizes this Activity. Finalizing this Activity will:

- associate the new CSJ with the previously cleared main CSJ;
- auto-fill the "Anticipated Environmental Classification" field in the newly associated CSJ;



- auto-fill the "Approved Environmental Classification" field in the newly associated CSJ;
- auto-fill the "Environmental Clearance Date" field in the newly associated CSJ;
- auto-fill the "Environmental LOA Date" field in the newly associated CSJ (if the main CSJ had already been LOA-cleared when the new CSJ is associated); and
- update DCIS TxDOTCONNECT.



# "CE/EA/EIS SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of a CE, EA, or EIS. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding a CE, EA, or EIS, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding a CE, EA, or EIS.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.
- **5.** This Activity may also be used to record any important notes or details regarding the processing of the project as a CE, EA, or EIS.



# "Climate Change SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of climate change. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding climate change, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding climate change.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.



# "Induced Growth SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of induced growth. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding induced growth, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding induced growth.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.



# "Obtain Letter of Authority (LOA) Clearance" Activity

This Activity is always automatically generated in the main CSJ. Normally, there is no reason to also manually create this Activity in any of the associate CSJs. However, for a long project with multiple sections and multiple corresponding CSJs, district environmental staff may want to LOA-clear one or more of the associate CSJs that correspond to a specific section of the project, even if other sections of the project are not ready to be LOA-cleared because there are still open Activities that only affect those sections. If this is the case, district environmental staff must manually create this Activity in the associate CSJ that the district environmental staff assigned to the respective district to request a separate LOA clearance for just that associate CSJ.

- 1. ENV Project Delivery Staff assigned to the respective district will proceed with the steps below to LOA-clear the project approximately four months before the scheduled letting. District environmental staff should not ask the ENV Project Delivery Staff to LOA-clear the project before this time frame.
- 2. ENV Project Delivery Staff determines whether there is a valid environmental clearance for the project. If not, ENV Project Delivery Staff informs the district environmental staff that the project cannot be LOA-cleared.
- **3.** ENV Project Delivery Staff determines whether there is any open Activity with a milestone of "Reevaluation". If so, ENV Project Delivery Staff informs the district environmental staff that the project cannot be LOA-cleared unless:
  - district environmental staff has requested separate LOA clearance for an associate CSJ, and ENV Project Delivery Staff concludes that the reevaluation does not affect the section of the project for which LOA clearance is being requested by district environmental staff), or
  - the ENV Director or ENV Deputy Director gives their approval, in which case district environmental staff must follow any special instructions given by the ENV Director or ENV Deputy Director.

# 4. <u>Activities with a DEFAULT milestone of "Prior to LOA" (these either need to be finalized or changed to "Prior to Construction")</u>

ENV Project Delivery Staff identifies all Activities with a default milestone of "Prior to LOA" and confirms that all of these Activities have been completed (i.e., the Activity has been finalized and the resolution of the Activity has been recorded in the "Comments" field or in documentation uploaded under the Activity). To assist in identifying Activities with a default milestone of "Prior to LOA", ENV Project Delivery Staff may consult the list of Activities in the instructions for the "Reasonable Assurances for Activities That Could Not Be Completed Prior to LOA".

If any Activity with a default milestone of "Prior to LOA" is still open, then see the instructions for the "Reasonable Assurances for Activities That Could Not Be Completed Prior to LOA" Activity.



For any Activity with a default milestone of "Prior to LOA", if the milestone has been changed to "Prior to Construction" or some other milestone, then ENV Project Delivery Staff must confirm that the "reasonable assurances" process has been followed – see the instructions for the "Reasonable Assurances for Activities That Could Not Be Completed Prior to LOA" Activity.

### 5. Activities with a DEFAULT milestone of "Prior to Construction"

ENV Project Delivery Staff identifies all Activities with a milestone of "Prior to Construction" that have been <u>finalized</u> and confirms that all of these Activities have, in fact, been completed (i.e., the Activity has been finalized and the resolution of the Activity has been recorded in the "Comments" field or in documentation uploaded under the Activity).

For any Activities that are finalized but have no documentation or comments indicating that the Activity has, in fact, been completed, ENV Project Delivery Staff contacts the district environmental staff to resolve the discrepancy (unless district environmental staff has requested separate LOA clearance for an associate CSJ, and ENV Project Delivery Staff concludes that the Activity does not affect the section of the project for which LOA clearance is being requested by district environmental staff).

- 6. ENV Project Delivery Staff checks the environmental clearance date to determine whether three years have elapsed since the date on which the environmental clearance was issued. If so, then ENV Project Delivery Staff determines whether a reevaluation has been completed in accordance with Environmental Guide Volume 1, Chapter 18. If a reevaluation is required but not completed, then ENV Project Delivery Staff reminds the district environmental staff that a reevaluation must be completed prior to LOA clearance as explained in Environmental Guide Volume 1, Chapter 18.
- 7. Once any discrepancies have been resolved as described above, ENV Project Delivery Staff finalizes this "Obtain Letter of Authority (LOA) Clearance" Activity, which auto-fills the "Approved for Letting" field with the date the Activity is finalized. Finalizing this Activity also automatically updates the "Environmental LOA Date" on the WPD I screen. Then, in real-time, ECOS sends the "Environmental LOA Date" from ECOS to populate the "Environmental Clear to Let Date" in TxDOTConnect.

Under normal circumstances, this is done in the main CSJ, and the "Approved for Letting" field in all associate CSJs will be auto-filled with the same date. In the unusual circumstance in which this Activity was manually created and then finalized in an associate CSJ at district environmental staff's request, the "Approved for Letting" field in only the associate CSJ will be auto-filled. Note that when the main CSJ is eventually LOA-cleared, it will auto-fill a new "Approved for Letting" field in the associate CSJ that was previously LOA-cleared. However, the previous LOA-clearance date will be preserved on the "Clearance History" page accessible from the Project Summary page of the associate CSJ.



# "Obtain Planning Consistency Documentation" Activity

For a non-FHWA project, if after this Activity was created district environmental staff determines that the project is not "regionally significant" for planning and programming purposes, then district environmental staff explains in the "Comments" field that the project is not federally funded and is not regionally significant, and therefore is not required to be individually listed in the MPO's 20-year plan or the STIP/TIP, and finalizes this Activity. For the definition of "regionally significant" see 23 CFR 450.104.

If this situation does not apply, proceed as instructed below. There are separate instructions based on whether the project is or is not within an MPO area.

#### Instructions for projects WITHIN an MPO area

- 1. <u>Check the MTP/RTP</u> District environmental staff determines whether the project is listed in and consistent with the MPO's 20-year plan, which may be called either the metropolitan transportation plan (MTP) or the regional transportation plan (RTP).
  - If the project <u>is</u> listed in and consistent with the current MTP/RTP, then district environmental staff uploads excerpts from the MTP/RTP that indicate both the title and year of the MTP/RTP, the section of the MTP/RTP in which the project is listed, and the project listing under this Activity. Move on Step 2 below.
  - If the project is <u>not</u> listed in and consistent with the current MTP/RTP, then district environmental staff must discuss the issue with their district's planning and programming staff as this Activity cannot be completed until the project is listed in and consistent with the current MTP/RTP.
- 2. <u>Check the STIP</u> District environmental staff determines whether the project is listed in and consistent with the current, FHWA-approved 4-year statewide transportation improvement program (STIP) by accessing TxDOT's eSTIP portal, logging-in, and using the "Search for Projects" function under "Project Management" tab (contact TxDOT's Transportation Planning and Programming Division to obtain a log-in password). At a minimum at least one of the project phases for the actual project must be listed in the STIP (Engineering, ROW, or Construction). In other words, the project CSJ must be listed with either an "E," "R," or "C" indicating the level of funding for the project.
  - If TxDOT's eSTIP portal indicates that the project <u>is</u> listed in and consistent with the current STIP, then district environmental staff uploads an excerpt from the eSTIP showing this project under this Activity, and finalizes this Activity.
  - If TxDOT's eSTIP portal does <u>not</u> indicate that the project is listed in and consistent with the current STIP (e.g., only part of the project is listed, or only some of the CSJs for the project are listed), then district environmental staff moves on to Step 3 below.
- **3.** <u>If not in the STIP, check the appendix to the TIP</u> District environmental staff determines whether the project is listed in the MPO's current 4-year transportation improvement program (TIP) for illustrative purposes as a project undergoing environmental review (typically in Appendix D or another appendix to the TIP).
  - If the project <u>is</u> listed in the MPO's current 4-year TIP for illustrative purposes as a project undergoing environmental review, then district environmental staff:



- uploads excerpts from the TIP that indicate both the title and year of the TIP, the section of the TIP in which the project is listed, and the project listing under this Activity; and
- o finalizes this Activity.
- If the project is <u>not</u> listed in the MPO's current 4-year TIP for illustrative purposes as a project undergoing environmental review, then district environmental staff must discuss the issue with their district's planning and programming staff as this Activity cannot be completed until the project is either listed in the STIP, or listed for illustrative purposes as a project undergoing environmental review in the TIP.

# Instructions for projects NOT WITHIN an MPO area

- 1. <u>Check the STIP</u> District environmental staff determines whether the project is listed in and consistent with the current, FHWA-approved 4-year statewide transportation improvement program (STIP) by accessing TxDOT's eSTIP portal, logging-in, and using the "Search for Projects" function under "Project Management" tab (contact TxDOT's Transportation Planning and Programming Division to obtain a log-in password). At a minimum at least one of the project phases for the actual project must be listed in the STIP (Engineering, ROW, or Construction). In other words, the project CSJ must be listed with either an "E," "R," or "C" indicating the level of funding for the project.
  - If TxDOT's eSTIP portal indicates that the project <u>is</u> listed in and consistent with the current STIP, then district environmental staff uploads an excerpt from the eSTIP showing this project under this Activity, and finalizes this Activity.
  - If TxDOT's eSTIP portal does <u>not</u> indicate that the project is listed in and consistent with the current STIP (e.g., only part of the project is listed, or only some of the CSJs for the project are listed), then district environmental staff moves on to Step 2 below.
- 2. If not in the STIP, check the "Rural Develop Authority Project List" District environmental staff determines whether the project is listed in the "Rural Development Authority Project List," which is included as an appendix to the STIP. The "Rural Develop Authority Project List" is available on TPP's STIP page on www.txdot.gov (click on the link for the current STIP and look for a file named, "DA Summary and Projects").
  - If the project <u>is</u> listed in the Rural Development Authority Project List, then district environmental staff:
    - uploads excerpts from the STIP that indicate both the title and year of the STIP and the project listing in the Rural Development Authority Project List under this Activity; and
    - o finalizes this Activity.
  - If the project is <u>not</u> listed in the Rural Development Authority Project List, then district environmental staff moves on to Step 3 below.
- 3. If not in the STIP, and not on the "Rural Develop Authority Project List", check the "Rural Plan <u>Authority Project List"</u> - District environmental staff determines whether the project is listed in the "Rural Plan Authority Project List," which is included as an appendix to the STIP. The "Rural Plan Authority Project List" is available on TPP's STIP page on <u>www.txdot.gov</u> (click on the link for the current STIP and look for a file named, "PA Summary and Projects").
  - If the project is listed in the Rural Plan Authority Project List, then district environmental staff:



- uploads excerpts from the STIP that indicate both the title and year of the STIP and the project listing in the Rural Plan Authority Project List under this Activity; and
- o finalizes this Activity.
- If the project is <u>not</u> listed in the Rural Plan Authority Project List, then district environmental staff moves on to Step 4 below.
- 4. If not in the STIP, and not on the "Rural Develop Authority Project List," and not on the "Rural Plan Authority Project List", check to see if fully funded in years 5-10 of the UTP District environmental staff determines whether the project is listed as being fully funded in years 5-10 of the UTP (these projects are technically included in the STIP by virtue of their right-of-way and preliminary engineering having been "grouped").
  - If the project <u>is</u> listed as being fully funded in years 5-10 of the UTP, then district environmental staff:
    - uploads excerpts from the UTP that indicate both the title and year of the UTP and the project listing under this Activity; and
    - o finalizes this Activity.
  - If the project is <u>not</u> listed as being fully funded in years 5-10 of the UTP, then district environmental staff must discuss the issue with their district's planning and programming staff as this Activity cannot be completed and the project cannot be environmentally cleared until the above requirements have been satisfied.



# "Obtain Project Classification Approval" Activity

This Activity may be used for five different types of classification approvals:

#### Classification of project as open-ended (d) CE

1. When district environmental staff intends to process a project as an open-ended (d) CE, and the project is expected to require 30 acres or less of total new right-of-way <u>and</u> ten or fewer total displacements (residential and commercial), then district environmental staff indicates in the "Comments" field of this Activity that the project is expected to require 30 acres or less of total new right-of-way and ten or fewer total displacements, and finalizes this Activity.

If the project is expected to require more than 30 acres of total new right-of-way or more than 10 total displacements (residential and commercial), then district environmental staff proceeds as indicated below.

- District environmental staff uploads under this Activity ENV's Open-Ended (d) Categorical Exclusion Classification Request Form (the form should have already been emailed to ENV Project Delivery staff and informally approved prior to submittal of the project work plan).
- **3.** District environmental staff assigns this Activity to the ENV project delivery manager assigned to the respective district.
- **4.** ENV project delivery manager reviews the uploaded form, and assigns this Activity to the ENV Project Delivery Section Director.
- 5. If ENV's Project Delivery Section Director has comments on the requested classification of the project as an open-ended (d) CE, then ENV's Project Delivery Section Director inserts their comments in the "Comments" field of the "Obtain Project Classification Approval" Activity, notifies the ENV project delivery manager that comments have been added, and leaves the "Obtain Project Classification Approval" Activity open until the comments have been addressed.
- 6. If ENV's Project Delivery Section Director approves of classification of the project as an openended (d) CE, then ENV's Project Delivery Section Director records his or her approval in the "Comments" field and finalizes this Activity.

IMPORTANT NOTE REGARDING ENV'S APPROVAL OF CLASSIFICATION OF THE PROJECT AS AN OPEN-ENDED (D) CE: ENV'S approval to proceed with an open-ended (d) CE classification is <u>not</u> the final CE determination. District environmental staff must proceed with conducting the CE analysis and any further public involvement or technical analyses required for

the project, and then make a final CE determination in ECOS, if warranted. If at any time during the environmental review it becomes apparent that the project is not expected to meet the requirements of 23 CFR 771.117(a) and (b) (or, for a state project, 43 TAC 2.81), or that there is a potential for significant environmental impacts, district environmental staff will not proceed with a CE determination, and will instead prepare an environmental assessment or environmental impact statement, as appropriate.



If ENV's Project Delivery Section Director determines that the project is not eligible for an openended (d)-list CE, then ENV's Project Delivery Section Director records his or her disapproval in the "Comments" field, and finalizes this Activity.

- **7.** ENV Project Delivery Section Director emails the district environmental staff of the approval/disapproval of the classification request.
- District environmental staff ensures that the project classification indicated on the Project Definition screen matches the project classification approved by the ENV Project Delivery Section Director.
- 9. Prior to issuing a notice and opportunity to comment, notice of public meeting, notice affording an opportunity for a public hearing, or notice of public hearing, district environmental staff must email the draft notice to the ENV project delivery manager assigned to their district for review. Additionally, prior to holding a public meeting or public hearing, district environmental staff must email the anticipated meeting or hearing presentation materials to the ENV project delivery manager assigned to their district for review. This allows the ENV project delivery manager an opportunity to make sure that the project has not changed from the description in the approved Open-Ended (d) Categorical Exclusion Classification Request Form (or Amendment to Open-Ended (d) CE Classification Request Form). (Note: These reviews are only required if the project is expected to require more than 30 acres of new right-of-way or more than ten displacements. For projects with 30 acres or less of new right-of-way and ten or fewer displacements, no ENV review of the public involvement materials is required.)

# Amendment of open-ended (d) CE classification request

1. If, after this Activity is finalized, there are project changes and associated updates to WPD I that result in a new version of this Activity being generated, and if the project (as updated) is expected to require 30 acres or less of new right-of-way and ten or fewer displacements, then district environmental staff indicates in the "Comments" field of the new version of this Activity that the project is expected to require 30 acres or less of total new right-of-way and ten or fewer total displacements, and finalizes the new version of this Activity.

This next part only applies if ENV has already approved an Open-Ended (d) Categorical Exclusion Classification Request Form, and then there are changes to the project description or preliminary schematic or increases in the right-of-way acreage or number of displacements as previously provided to ENV. If this is the case, district environmental staff proceeds as indicated below.

- 2. District environmental staff fills-out ENV's Amendment to Open-Ended (d) CE Classification Request Form and uploads it under this Activity.
- **3.** District environmental staff assigns this Activity to the ENV project delivery manager assigned to the respective district.
- **4.** ENV project delivery manager reviews the uploaded form, and assigns this Activity to the ENV Project Delivery Section Director.



- 5. ENV Project Delivery Section Director records his or her approval or disapproval of the continued classification of the project as an open-ended (d) CE in the "Comments" field, and finalizes this Activity.
- **6.** ENV Project Delivery Section Director emails the district environmental staff of the approval/disapproval of the classification request.
- District environmental staff ensures that the project classification indicated on the Project Definition screen matches the project classification approved by the ENV Project Delivery Section Director.
- 8. Prior to issuing a notice and opportunity to comment, notice of public meeting, notice affording an opportunity for a public hearing, or notice of public hearing, district environmental staff must email the draft notice to the ENV project delivery manager assigned to their district for review. Additionally, prior to holding a public meeting or public hearing, district environmental staff must email the anticipated meeting or hearing presentation materials to the ENV project delivery manager assigned to their district for review.

# Classification of project from EIS to EA

1. It is recommended that, prior to submitting the project work plan (WPD III) to the department delegate for review and acceptance, district environmental staff complete ENV's Template for EIS to EA Classification Approval and email it to ENV Project Delivery staff. This way, district environmental staff will know whether ENV approves of the downgrade to an EA before the project work plan is submitted for approval, which will hopefully avoid district environmental staff having to re-do the project work plan process with a different selection for the "Anticipated Environmental Classification" field on WPD I.

Regardless of whether district environmental staff emails the request to ENV for preliminary review prior to submitted the project work plan (WPD III), once the project work plan has been accepted and this Activity has been created, district environmental staff proceeds as indicated below to complete this Activity.

- 2. While ECOS will allow the project work plan to be finalized pending the ENV Director's approval of the classification of the project as an EA, <u>no work on preparing a draft environmental</u> <u>assessment document may be conducted until the ENV Director has approved</u>.
- **3.** District environmental staff prepares a written request to classify the project as an EA instead of an EIS using **ENV's Template for EIS to EA Classification Approval** and uploads it under this Activity.

Note that this template is prepared as an internal TxDOT Memorandum. If a local government is the official project sponsor, then the local government formats the written request as a letter from the local government to the ENV Director using the content from the body of **ENV's Template for EIS to EA Classification Approval**.

**4.** District environmental staff assigns this Activity to the ENV project delivery manager assigned to the respective district.



- **5.** ENV project delivery manager reviews the written request, and assigns this Activity to the ENV Project Delivery Section Director.
- 6. ENV Project Delivery Section Director presents the written request to the ENV Director.
- **7.** ENV Director indicates approval or disapproval of the request by checking "Approved" or "Disapproved" on the written request, and then signing and dating the written request.

If the ENV Director disapproves, then an EIS is required and the district environmental staff must update "Anticipated Environmental Classification" field on WPD I and re-submit the project work plan for approval by the department delegate.

- 8. ENV Project Delivery Section Director uploads the written request with the ENV Director's decision and signature, records the final decision in the "Comments" field, and finalizes this Activity.
- **9.** ENV Project Delivery Section Director emails the district environmental staff of the approval/disapproval of the classification request.
- **10.** District environmental staff ensures that the project classification indicated on the Project Definition screen matches the project classification approved by the ENV Director.

# <u>Classification of project when there is a local government project sponsor, and work plan has not been</u> <u>finalized within 30 days of submittal of project work plan</u>

- For CEs, within 30 days of the initial submittal of the project work plan for the district's approval, the district environmental staff transmits to the local government a letter notifying the local government of his or her preliminary determination regarding the project classification using either ENV's Classification Letter Template (concur) or ENV's Classification Letter Template (no concur). District environmental staff uploads the letter under this Activity, and finalizes this Activity.
- 2. For EAs and EISs, the ENV project delivery manager assigns this Activity to the ENV Project Delivery Section Director, and within 30 days of the initial submittal of the project work plan for ENV's approval, the ENV Project Delivery Section Director transmits to the local government a letter notifying the local government of his or her preliminary determination regarding the project classification using either ENV's Classification Letter Template (concur) or ENV's Classification Letter Template (no concur). The ENV Project Delivery Section Director uploads the letter under this Activity, and finalizes this Activity.
- **3.** Local government project sponsor ensures that the project classification indicated on the Project Definition screen matches the project classification approved by the department delegate.

# "Obtain WPD-Activity Creation Access for Consultant-Local Government (PMJFM)" Activity

- 1. District environmental staff assigns this Activity to a consultant or local government representative to allow him or her access to manage most aspects of the environmental review process for a specific project within ECOS as the project sponsor (e.g., complete work plan, create and assign Activities, etc.). This is also referred to as "Project Management Joint Full Mode" (PMJFM).
- 2. Before district environmental staff may assign this Activity to a consultant or local government representative, the consultant or local government representative must have first obtained an ECOS User ID and general access to ECOS. To obtain an ECOS User ID and general access to ECOS, the consultant or local government representative contacts ENV's ECOS administrative team as explained in ENV's Environmental Guide: Volume 1 Process.
- 3. District environmental staff MUST finalize this Activity if the consultant or local government representative no longer needs to have PMJFM-level ECOS access for this project due to a job change, completion of the environmental review, or any other reason. Finalizing the Activity will automatically remove the PMJFM-level ECOS access for the individual to whom this Activity was originally assigned.



# "Other Project-Related Information" Activity

This Activity provides a location for documents that may be relevant to more than one technical analysis, in order to avoid the same document being uploaded multiple times under different program area-specific Activities.

- District environmental staff uploads the documents listed in the bullet points below using a file name that indicates the date of the document (e.g., "Project schematic for FM 1234 10-04-2017") to the extent they are available. If any of the documents listed in the bullet points below have been created for the project, then they <u>must</u> be uploaded under this Activity:
  - Project location map (may be topographical map, aerial photograph, or other format)
  - Project schematic
  - Plan and profile sheet ("P&P sheet")
  - Typical sections
- 2. District environmental staff, at their discretion, may also upload any miscellaneous documents that he or she believes should be included in ECOS using a file name that indicates the date of the document (e.g., "Project site photographs for FM 1234 10-04-2017"). Examples of types of documents that may be uploaded under this Activity include the following:
  - Design concept conference meeting notes
  - Design summary report
  - ROW and survey maps
  - Detail sheets: traffic control, roadway details, drainage, utilities, etc.
  - Field notes
  - Project site photographs
  - Constraint maps
  - Interstate access justification request (IAJR) and approval
  - Crash records/crash data report
  - Bridge inspection reports
  - Bike/pedestrian accommodation analysis
  - Land use analysis
  - PEL study
  - Feasibility study
  - Corridor study
  - Travel demand model
  - Traffic data and/or memo



# "Perform CE Determination" Activity

This Activity generates a CE Determination Form containing the following fields, which will be automatically filled-in based on the information entered on the WPD Section I – Project Definition screen:

- "Highway"
- "Main CSJ"
- "Project Limits From"
- "Project Limits To"
- "Associated CSJs"
- "CE Type"
- "Criterion"

This Activity has different instructions depending on how the following questions on "WPD Section I – Project Definition" are answered:

- "Who is the lead agency responsible for the approval of the entire project?"
- "Who is the project sponsor as defined by 43 TAC 2.7?"

#### Lead agency is "FHWA – Assigned to TxDOT" or "TxDOT – No Federal Funding"

If the lead agency is "FHWA – Assigned to TxDOT" or "TxDOT – No Federal Funding," then the instructions for completing this Activity depend on whether the project sponsor is "TxDOT" or "Local Government," as explained below.

#### Project sponsor is "TxDOT"

- 1. District employee with delegated authority to approve the CE reviews the Activities console to confirm that all Activities designated with a milestone of "prior to environmental clearance" have been completed and finalized. This Activity cannot be completed until all such Activities are completed and finalized.
- 2. District employee with delegated authority to approve the CE checks TxDOTConnect to make sure there are no ROW CSJs associated with the project that have not been created in ECOS and associated with the main CSJ in ECOS. If there are any such ROW CSJs, then the district employee with delegated authority to approve the CE must create them in ECOS, and then associate them with the main CSJ in ECOS. This will require re-submittal and re-acceptance of the project work plan (WPD III).
- **3.** If all Activities designated with a milestone of "prior to environmental clearance" have been completed and finalized, then the district employee with delegated authority to approve the CE reviews the statements on the CE determination form to confirm that they are accurate.
- 4. If the district employee with delegated authority to approve the CE determines that all Activities designated with a milestone of "Prior to environmental clearance" have been completed and finalized, and that the statements on the CE determination form are accurate, then he or she clicks the "Click here to approve" button. A pop-up window will appear and it will read, "Clicking



OK will record a CE determination for the main and any associated CSJs." District employee with delegated authority to approve the CE then clicks "OK" to approve the CE. This will automatically update the "Environmental Clearance Date" on WPD I and the "Env NEPA Clear Date" in TxDOTCONNECT (updates to TxDOTCONNECT typically occur overnight).

**5.** ECOS will send an email to the "Sponsor Point of Contact" listed on WPD I notifying them of the environmental clearance of the project.

#### Project sponsor is "Local Government"

- 1. Local government representative reviews the Activities console to confirm that all Activities designated with a milestone of "Prior to environmental clearance" have been completed and finalized. This Activity cannot be completed until all such Activities are completed and finalized.
- 2. If all Activities designated with a milestone of "Prior to environmental clearance" have been completed and finalized, then the local government representative reviews the statements on the CE determination form to confirm that they are accurate.
- **3.** If the local government representative determines that all Activities designated with a milestone of "Prior to environmental clearance" have been completed and finalized, and that the statements on the CE determination form are accurate, then he or she clicks the "Click here to submit" button.
- **4.** A pop-up window will appear and it will read, "Clicking OK will submit the CE determination form to the department delegate for approval."
- **5.** Local government representative then clicks "OK." The system will generate an email to the "Delegate Point Of Contact" listed on WPD I notifying him or her that the CE determination has been submitted for his or her review and approval.
- 6. To <u>approve</u> the CE determination, the district employee with delegated authority to approve the CE clicks the "Click here to approve" button. A pop-up window will appear and it will read, "Clicking OK will record a CE determination for the main and any associated CSJs." The district employee with delegated authority to approve the CE then clicks "OK" to approve the CE. This will automatically update the "Environmental Clearance Date" on WPD I and the "Env NEPA Clear Date" in TxDOTCONNECT (updates to TxDOTCONNECT typically occur overnight). ECOS will send an email to the "Sponsor Point of Contact" listed on WPD I notifying them of the environmental clearance of the project.
- 7. To <u>disapprove</u> the CE determination, the district employee with delegated authority to approve the CE enters an explanation for disapproval in the "Comments" field, and clicks "Click here to not approve." A pop-up window will appear and it will read, "Clicking OK will disapprove the CE determination for the main and any associated CSJs." The district employee with delegated authority to approve the CE then clicks "OK" to disapprove the CE. The system will generate an email to the "Sponsor Point of Contact" listed on WPD I notifying them that the CE determination has been disapproved.



8. If the CE determination is disapproved, the local government representative will have to address any noted deficiencies, create a new "Perform CE Determination" Activity (by re-submitting the project work plan to the delegate for approval), and repeat the process outlined above.

# "FHWA – Not Assigned to TxDOT"

If the lead agency is "FHWA – Not Assigned to TxDOT," then FHWA must make the actual CE determination and provide TxDOT with documentation of that determination. Follow the instructions below to complete this Activity.

- District environmental staff prepares and send a letter to FHWA requesting a CE determination using ENV's Template – Letter to FHWA requesting CE approval for non-NEPA assigned project.
- 2. District environmental uploads the signed FHWA concurrence under this Activity.
- **3.** District employee with delegated authority to approve the CE uses the calendar icon to select the date on which FHWA approved the CE determination.
- 4. District employee with delegated authority to approve the CE clicks "Click here to confirm." A pop-up window will appear and it will read, "ECOS will record a NEPA Clear date for the main CSJ and any associated CSJs that matches the date on which FHWA approved the CE determination as indicated on this form." District employee with delegated authority to approve the CE then clicks "OK." This will automatically update the "Environmental Clearance Date" on WPD I and the "Env NEPA Clear Date" in TxDOTCONNECT (updates to TxDOTCONNECT typically occur overnight).
- **5.** ECOS will send an email to the "Sponsor Point of Contact" listed on WPD I notifying them of the environmental clearance of the project.

# "Perform Draft EA Preparation" Activity

1. For an FHWA project, if, prior to completion of this Activity, it becomes clear that neither the notice of availability of the final EA (if one is required) or notice of availability of the FONSI will be issued more than 1 year after the first acceptance of the project work plan in ECOS - i.e., the "Project Start Date" on WPD III (or if a classification memo signed by the Environmental Affairs Division Director is required to classify the project as an EA, more than 1 year after the date on which the Environmental Affairs Division Director signs the classification memo), then the Director of the Environmental Affairs Division must approve a new deadline for the notice of availability of the final EA (if one is required) or notice of availability of the FONSI in an email (the ENV core team member emails the Director of the Environmental Affairs Division to request this approval. and no formal email template language is required). If the Director of the Environmental Affairs Division approves a new deadline for the notice of availability of the final EA (if one is required) or notice of availability of the FONSI, the ENV core team member must add a note to the "Comments" field of this Activity noting the new deadline for the notice of availability of the final EA (if one is required) or notice of availability of the FONSI, and upload the email under this Activity.

This Activity is comprised of four phases: (1) coordination with any cooperating agency, (2) administrative completeness review, (3) technical review, and (4) completion of technical review.

# Coordination with any cooperating agency

- 2. If the project will require another Federal agency to issue a NEPA approval for the project in connection with a permit, real estate agreement, or other reason, then TxDOT should invite the other Federal agency to be a "cooperating agency." This can be done informally by email. If the other Federal agency agrees to be a cooperating agency, then TxDOT should informally share drafts of the EA with the cooperating agency prior to public review so that TxDOT and the cooperating agency can work out any issues ahead of public review. This should make it easier for the cooperating agency to ultimately adopt the EA instead of having to prepare its own EA for the project.
- **3.** It is not necessary to upload email exchanges with any cooperating agency to ECOS. As specified in **ENV's EA Handbook**, any key exchanges can be included in Appendix E of the EA at the preparer's discretion.

# Administrative completeness review

4. District environmental staff prepares the draft EA according to ENV's Environmental Handbook: Preparing an Environmental Assessment, ENV's Environmental Assessment Outline, and ENV's Environmental Assessment Cover Page.

The EA must not be longer than 75 pages (not including citations or appendices).

- 5. District environmental staff:
  - creates the "Submit Draft EA" deliverable Activity (on the Activities screen, click the "D+" next to the "Perform Draft EA Preparation" Activity),



- assigns the "Submit Draft EA" deliverable Activity to him or herself,
- uploads the draft EA under the "Submit Draft EA" deliverable Activity, and
- finalizes the "Submit Draft EA" deliverable Activity.

District environmental staff must not upload the draft EA under the "Submit Draft EA" deliverable Activity until all other Activities with a milestone of "Prior to Env Clearance\*" have been completed with the following exceptions, which may remain open at the time the draft EA is uploaded:

- "Perform Opportunity for Public Hearing (OPH)/Public Hearing (PH),"
- "Obtain Planning Consistency Documentation,"
- "Perform Final EA Preparation,"
- "Perform Notice of Availability (NOA) for Final EA listed at 23 CFR 771.115(a)" (if applicable), and
- any other Activity if the ENV core team member and appropriate ENV SME for the Activity agree that the Activity may remain open until after the opportunity for public hearing or public hearing, and have noted such using the "CE/EA/EIS SME Consultation" Activity.
- **6.** District environmental staff creates a Review of the draft EA under the "Submit Draft EA" deliverable Activity, and assigns it to the ENV core team member.
- 7. ENV core team member reviews the draft EA to determine whether the draft EA is administratively complete (i.e., all Activities that affect the content of the draft EA have been finalized, and the draft EA is consistent with ENV's Environmental Assessment Outline).

If the draft EA is administratively complete, then:

• The ENV core team member creates individual Reviews of the draft EA under the "Submit Draft EA" deliverable Activity, and assigns them to the district core team member and individual ENV subject matter experts (SMEs).

If the draft EA is <u>not</u> administratively complete, then:

- The ENV core team member does <u>not</u> create individual Reviews for the district core team member and individual ENV SMEs, and instead explains in his or her Review why the document is not administratively complete, and finalizes his or her Review with a "not approved" determination.
- The above steps are repeated until the ENV core team member determines that the draft EA is administratively complete.

# Technical review

8. The ENV core team member, district core team member, and individual ENV SMEs complete their reviews of the draft EA according to the instructions in the "Review Draft EA" Activity Instructions.

#### Completion of technical review

**9.** Once the ENV core team member has finalized his or her Review, if there are pending comments on the draft EA, the district environmental staff:



- prepares a new, revised version of the draft EA that is responsive to the comments made;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns;
- creates a new "Submit Draft EA" deliverable Activity;
- assigns the new "Submit Draft EA" deliverable Activity to him or herself;
- uploads the new, revised version of the draft EA and the completed comment response matrix under the new "Submit Draft EA" deliverable Activity;
- finalizes this deliverable Activity; and
- creates a Review under the new "Submit Draft EA" deliverable Activity, and assigns it to the ENV core team member.
- **10.** ENV core team member creates Reviews of the new, revised version of the draft EA and assigns them to the district core team member and any ENV SMEs that had made comments on the previous version.
- 11. If further revisions to the draft EA are needed after this second round of reviews, the district environmental staff creates a new "Submit Draft EA" deliverable Activity (on the Activities screen, click the "D+" next to the "Perform Draft EA Preparation" Activity), prepares and uploads a new version of the draft EA under the new "Submit Draft EA" deliverable Activity, and creates and assigns a Review to the ENV core team member for each new version of the draft EA. The process set forth above is repeated until the ENV core team member has indicated in his or her Review that the draft EA is "Approved no comments," and finalizes his or her Review.
- **12.** Once the ENV core team member has no further comments on the draft EA and has finalized his or her Review, the ENV core team member assigns a Review to the ENV Project Delivery Section Director.
- **13.** If the ENV Project Delivery Section Director has comments on the draft EA, then the district environmental staff creates a new "Submit Draft EA" deliverable Activity (on the Activities screen, click the "D+" next to the "Perform Draft EA Preparation" Activity), uploads the new version of the draft EA, and creates and assigns a Review to the ENV Project Delivery Section Director.
- **14.** Once the ENV Project Delivery Section Director has no further comments on the draft EA, the ENV Project Delivery Section Director finalizes his or her Review (selecting "Approved no comments"), and notifies the ENV core team member that the draft EA is approved for circulation.
- **15.** ENV core team member uploads the approved version of the draft EA with the word, "Approved," at the beginning of the file name under the last "Submit Draft EA" deliverable Activity.
- 16. ENV core team member fills-in the "Approval Date of Draft EA" field with the date that the ENV Project Delivery Section Director finalized his or her Review. If the applicable deadline under Transportation Code 201.759 was missed, then the ENV core team member selects, "No," in the drop-down menu for field labeled, "Was the applicable deadline at Transportation Code 201.759 met?" The ENV core team member then finalizes this "Perform Draft EA Preparation" Activity.

# "Perform Draft EIS Preparation" Activity

1. For an FHWA project, if, prior to completion of this Activity, it becomes clear that the e-NEPA notice of availability of the FEIS will be published in the Federal Register more than two years after the date the notice of intent is published in the Federal Register, then the Director of the Environmental Affairs Division must approve a new deadline in an email (the ENV core team member emails the Director of the Environmental Affairs Division to request this approval, and no formal email template language is required). If the Director of the Environmental Affairs Division approves a new deadline for publication of the e-NEPA notice of availability of the FEIS in the Federal Register, the ENV core team member must add a note to the "Comments" field of the "Perform EIS Scoping" Activity noting the new deadline, and upload the ENV Director's email under the "Perform EIS Scoping" Activity.

This Activity is comprised of three phases: (1) administrative completeness review, (2) technical review, and (3) completion of technical review.

# Administrative completeness review

 District environmental staff prepares the draft EIS. As of the date of these Activity Instructions, ENV has prepared <u>drafts</u> of ENV's Environmental Impact Statement Outline and ENV's Environmental Handbook – Required Content for an Environmental Impact Statement. Contact ENV Project Delivery staff for the current versions of these drafts.

If the (1) "Purpose and Need for Action" section, (2) "Alternatives Including the Proposed Action" section, and (3) "Affected Environment and Environmental Consequences" section have a combined length of more than 200 pages, then the ENV Director must approve the longer page length in an email (the ENV core team member emails the Director of the Environmental Affairs Division to request this approval, and no formal email template language is required). If the Director of the Environmental Affairs Division approves a longer page length, the ENV core team member shall add a note to the "Comments" field of this Activity and upload the ENV Director's email under this Activity. Regardless of whether the ENV Director approves a longer page length for the three sections identified above, the overall length of the EIS must not exceed 300 pages (not including any citations or appendices).

# **3.** District environmental staff:

- creates the "Submit Draft EIS" deliverable Activity (on the Activities screen, click the "D+" next to the "Perform Draft EIS Preparation" Activity),
- assigns the "Submit Draft EIS" deliverable Activity to him or herself,
- uploads the draft EIS under the "Submit Draft EIS" deliverable Activity, and
- finalizes the "Submit Draft EIS" deliverable Activity.

District environmental staff must not upload the draft EIS under the "Submit Draft EIS" deliverable Activity until all other Activities with a milestone of "Prior to Env Clearance\*" have been completed with the following exceptions, which may remain open at the time the draft EIS is uploaded:

- "Perform Opportunity for Public Hearing (OPH)/Public Hearing (PH),"
- "Obtain Planning Consistency Documentation,"



- "Perform Final EIS/Record of Decision (ROD) Preparation," and
- any other Activity if the ENV core team member and appropriate ENV SME for the Activity agree that the Activity may remain open until after the public hearing, and have noted such using the "CE/EA/EIS SME Consultation" Activity.
- **4.** District environmental staff creates a Review of the draft EIS under the "Submit Draft EIS" deliverable Activity and assigns it to the ENV core team member.
- 5. ENV core team member reviews the draft EIS to determine whether it is administratively complete (i.e., all Activities that affect the content of the draft EIS have been finalized, and it address all of the resource areas that are listed in ENV's Environmental Impact Statement Outline, but is not required to follow that outline exactly).

If the draft EIS is administratively complete, then:

• The ENV core team member creates individual Reviews of the draft EIS under the "Submit Draft EIS" deliverable Activity, and assigns them to the ENV Project Delivery Section Director, district core team member and individual ENV subject matter experts (SMEs).

If the draft EIS is not administratively complete, then:

- The ENV core team member does <u>not</u> create individual Reviews for the ENV Project Delivery Section Director, district core team member and individual ENV SMEs, and instead explains in his or her Review why the document is not administratively complete, and finalizes his or her Review with a "not approved" determination.
- The above steps are repeated until the ENV core team member determines that the draft EIS is administratively complete.

# Technical review

6. The ENV core team member, the ENV Project Delivery Section Director, district core team member, and individual ENV SMEs complete their reviews of the draft EIS according to the instructions in the "Review Draft EIS" Activity Instructions.

# Completion of technical review

- **7.** Once the ENV core team member has finalized his or her Review, if there are pending comments on the draft EIS, the district environmental staff:
  - prepares a new, revised version of the draft EIS that is responsive to the comments made;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns;
  - creates a new "Submit Draft EIS" deliverable Activity;
  - assigns the new "Submit Draft EIS" deliverable Activity to him or herself;
  - uploads the new, revised version of the draft EIS and the completed comment response matrix under the new "Submit Draft EIS" deliverable Activity;
  - finalizes this deliverable Activity; and
  - creates a Review under the new "Submit Draft EIS" deliverable Activity, and assigns it to the ENV core team member.



- 8. ENV core team member creates Reviews of the new, revised version of the draft EIS and assigns them to the ENV Project Delivery Section Director, district core team member and any ENV SMEs that had made comments on the previous version.
- 9. If further revisions to the draft EIS are needed after this second round of reviews, the district environmental staff creates a new "Submit Draft EIS" deliverable Activity (on the Activities screen, click the "D+" next to the "Perform Draft EIS Preparation" Activity), prepares and uploads a new version of the draft EIS under the new "Submit Draft EIS" deliverable Activity, and creates and assigns a Review to the ENV core team member for each new version of the draft EIS. The process set forth above is repeated until the ENV core team member has indicated in his or her Review that the draft EIS is "Approved no comments," and finalizes his or her Review.
- **10.** The ENV core team member emails the draft EIS to TxDOT's General Counsel Division for review (this is not the formal legal sufficiency review that happens at the FEIS stage). GCD's comments, response to GCD's comments, revisions to the draft EIS made in response to GCD's comments, and correspondence regarding GCD's comments and associated revisions and responses are not tracked in ECOS.
- 11. Once the General Counsel Division has completed its review and agrees with proceeding to pubic review of the draft EIS, the ENV core team member uploads under the latest "Submit Draft EIS" deliverable Activity (1) the version of the draft EIS that was approved by GCD with the phrase, "GCD-approved," at the beginning of the file name; and (2) an email from the General Counsel Division indicating that it has completed its review and agrees with proceeding to public review of the draft EIS.
- **12.** ENV core team member provides (1) a hard copy of an email exchange or other written statement showing that both core team members have reviewed the draft EIS for both content and accuracy, and (2) a hard copy of the draft EIS cover page to the ENV Division Director for review and approval.
- **13.** After the ENV Division Director has signed the draft EIS, the ENV core team member uploads the approved version of the draft EIS with the word, "Approved," at the beginning of the file name under the last "Submit Draft EIS" deliverable Activity.
- **14.** ENV core team member fills-in the "Approval date of DEIS" field with the date that the ENV Division Director signed the draft EIS, and finalizes this "Perform Draft EIS Preparation" Activity.

# "Perform EIS Scoping" Activity

#### PRE-NOTICE OF INTENT

#### Preparation of scoping materials and preparation for agency scoping meeting

- 1. District environmental staff drafts purpose and need in accordance with **ENV's Preparing a Purpose and Need Statement Guidance** and emails to the ENV core team member for review.
- **2.** District environmental staff drafts range of alternatives, which can be as simple as a map showing the various alignments under consideration, and emails to ENV core team member for review.
- **3.** District environmental staff obtains the standard ENV methodologies and level of detail document for scoping meetings that is used for all EIS projects.
- **4.** District environmental staff prepares a coordination plan and schedule and emails to the ENV core team member for review. The coordination plan is a plan for coordinating public and agency participation in and comment on the environmental review process for the project. The schedule must include the following milestones:
  - Publication of the NOI
  - Issuance of DEIS
  - Public comment period on the DEIS
  - Issuance of the FEIS/ROD
  - Any other environmental permits that must be obtained for the project (i.e., Section 404 permit, Section 9 permit, etc.)

Additionally, the schedule must:

 provide for the e-NEPA notice of availability of the FEIS to be published in the Federal Register within two years of the issuance of the notice of intent, unless the ENV Division Director approves a longer timeline – see Step 22 below; and

In the unusual case that the project is identified as a "major project" under 23 USC 139(a)(7), the schedule must also account for issuance of all Federal authorization decisions needed for construction (e.g., USACE permit) within 90 days after issuance of the ROD, unless the ENV Division Director extends this deadline in accordance with 23 USC 139(d)(10)(C). Note that TxDOT's EIS projects generally do not meet the definition of a "major project" at the outset of the EIS project because the project is typically not listed in both the fiscally constrained portion of the MPO's 20-year Metropolitan Transportation Plan and the 4-year Statewide Transportation Improvement Program



(STIP) with full funding needed to complete the project, and therefore does not meet the part of the "major project" definition that reads, "the project sponsor has identified the reasonable availability of funds sufficient to complete the project." 23 USC 139(a)(7)).

4. District environmental staff identifies potential participating and cooperating agencies.

A cooperating agency is a Federal, State, Tribal, or local agency that has jurisdiction by law or special expertise with respect to any environmental impact involved in the project.<sup>1</sup>

A participating agency is a Federal, State, local, or federally recognized Indian Tribal government unit that may have an interest in the proposed project and has accepted an invitation to be a participating agency, or in the case of a Federal agency, has not declined the invitation.<sup>2</sup>

TxDOT generally has discretion regarding which agencies to invite as participating or cooperating agencies, except that any *Federal* agency with jurisdiction by law or special expertise with respect to any environmental impact involved in the project *must* be invited to be a cooperating agency.<sup>3</sup>

5. District environmental staff drafts letters (1) inviting entities to be participating or cooperating agencies; (2) inviting the potential participating and cooperating agencies to an agency scoping meeting that will take place prior to the notice of intent; and (3) transmitting the draft purpose and need, range of alternatives, methodologies and level of detail for analyzing alternatives, and coordination plan and schedule, and requesting review and comment on these materials (15-day comment deadline from date of agency scoping meeting). District environmental staff emails the letters to ENV core team member for review.

# District environmental staff sends letters to potential participating or cooperating agencies

- 6. Once ENV core team member has approved draft letters to participating and cooperating agencies, district environmental staff mails letters. If an invited cooperating agency or participating agency does not respond to the letter, they should continue to be treated as a cooperating or participating agency throughout the EIS process, until such time that they indicate in writing that thy do not want to be a cooperating or participating agency.
- 7. District environmental staff uploads the following under this Activity:
  - letters to participating and cooperating agencies; and
  - responses from potential participating or cooperating agencies.

#### Agency scoping meeting

- 8. At the agency scoping meeting, district environmental staff presents the following:
  - draft purpose and need
  - draft range of alternatives;
  - draft methodologies and level of detail for analyzing alternatives; and
  - draft coordination plan and schedule.

- **9.** District environmental staff also requests comments on these materials, as well as any expected environmental impacts, anticipated permits or other authorizations, and any significant issues that should be analyzed in depth in the EIS. District environmental staff also requests identification of potential alternatives, information, and analyses relevant to the proposed action (15-day comment deadline from date of agency scoping meeting).
- **10.** District environmental staff determines whether any of the cooperating agencies will need to do an EIS for their respective authorizations, and if so, discusses and determines whether TxDOT will prepare a single EIS and issue a joint ROD with any cooperating agency.
- **11.** District environmental staff follows the instructions in the "Perform Public Meeting" Activity Instructions with respect to the agency scoping meeting (i.e., prepare the meeting documentation and upload it and assign a Review to the ENV core team member); however, there is <u>no need</u> to prepare a comment/response matrix in connection with the agency scoping meeting. If district environmental staff prepared minutes of the agency scoping meeting, then district environmental staff may include the minutes in the documentation. Also, upload the agency scoping meeting documentation under this Activity, instead of under a "Perform Public Meeting" Activity.

Note that these Instructions are written to include only one agency scoping meeting. However, district environmental staff may hold multiple agency scoping meetings on an EIS project. If multiple agency scoping meetings are held, document them each separately as instructed above.

# NOTICE OF INTENT

**12.** District environmental staff follows the instructions in the "Perform Notice of Intent (NOI)" Activity Instructions.

# POST-NOTICE OF INTENT

#### Preparation for public scoping meeting

- **13.** District environmental staff prepares public outreach materials for public scoping meeting and emails to ENV core team member for review.
- **14.** District environmental staff conducts public outreach for public scoping meeting.

#### Public scoping meeting

- **15.** At the public scoping meeting, district environmental staff presents the following:
  - draft purpose and need
  - draft range of alternatives;
  - draft methodologies and level of detail for analyzing alternatives; and
  - draft coordination plan and schedule.



- **16.** District environmental staff also requests comments on these materials, as well as any expected environmental impacts, anticipated permits or other authorizations, and any significant issues that should be analyzed in depth in the EIS. District environmental staff also requests identification of potential alternatives, information, and analyses relevant to the proposed action (15-day comment deadline from date of public scoping meeting).
- **17.** District environmental staff follows the instructions in the "Perform Public Meeting" Activity Instructions with respect to the public scoping meeting; however, there is <u>no need</u> to prepare a comment/response matrix in connection with the public scoping meeting.

Note that these Instructions are written to include only one public scoping meeting. However, district environmental staff may hold multiple public scoping meetings on an EIS project. If multiple public scoping meetings are held, document them each separately as instructed above, including creating a new "Perform Public Meeting" Activity for each public meeting held.

#### Finalize coordination plan and schedule

- **18.** District environmental staff prepares the following:
  - final coordination plan and schedule, and
  - transmittal letters or emails to transmit the final coordination plan and schedule to participating and cooperating agencies.

District environmental staff emails the above items to the ENV core team member for review.

- 19. After the ENV core team member has approved the above items, the district environmental staff sends the final coordination plan and schedule to the participating/cooperating agencies, and posts the final coordination plan and schedule on the project website.<sup>4</sup> This must be done no later than 90 days after publication of the notice of intent in the Federal Register see 23 USC 139(g)(1)(A) and (g)(1)(E).
- **20.** District environmental staff uploads the following under this Activity:
  - letters or emails transmitting the final coordination plan and schedule to participating or cooperating agencies; and
  - final coordination plan and schedule with the word, "Approved," at the beginning of the file name.

#### Finalization of Activity

**21.** Once all of the above-listed steps have been completed, the district environmental staff finalizes this Activity.

# ENV Director approval of timeline longer than 2 years

**22.** For an FHWA project, if at any time it becomes clear that the e-NEPA notice of availability of the FEIS will not be published in the Federal Register within two years from publication of the notice

of intent in the Federal Register, then the ENV Director must approve a new deadline for publication of the e-NEPA notice of availability of the FEIS in the Federal Register in an email, in which case the ENV core team member shall add a note to the "Comments" field of this Activity noting the new deadline and upload the ENV Director's email under this Activity.

# "Perform Final EA Preparation" Activity

- 1. For an FHWA project, if, prior to completion of this Activity, it becomes clear that neither the notice of availability of the final EA (if one is required) or notice of availability of the FONSI will be issued more than 1 year after the first acceptance of the project work plan in ECOS - i.e., the "Project Start Date" on WPD III (or if a classification memo signed by the Environmental Affairs Division Director is required to classify the project as an EA, more than 1 year after the date on which the Environmental Affairs Division Director signs the classification memo), then the Director of the Environmental Affairs Division must approve a new deadline for the notice of availability of the final EA (if one is required) or notice of availability of the FONSI in an email (the ENV core team member emails the Director of the Environmental Affairs Division to request this approval. and no formal email template language is required). If the Director of the Environmental Affairs Division approves a new deadline for the notice of availability of the final EA (if one is required) or notice of availability of the FONSI, the ENV core team member must add a note to the "Comments" field of this Activity noting the new deadline for the notice of availability of the final EA (if one is required) or notice of availability of the FONSI, and upload the email under this Activity (this is not necessary if the ENV Director previously approved a longer time period under the "Perform Draft EA Preparation" Activity, and the notice of availability of the final EA (if one is required) or notice of availability of the FONSI is issued within that previously approved longer time period).
- 2. After the public hearing documentation or opportunity for public hearing documentation has been completed and approved by the ENV core team member, and after all Activities with a milestone of "Prior to Environmental Clearance" are finalized, district environmental staff prepares the final EA in accordance with ENV's Environmental Handbook: Preparing an Environmental Assessment, ENV's Environmental Assessment Outline, and ENV's Environmental Assessment Cover Page. The final EA will include any changes resulting from public comment received in connection with the public hearing or opportunity for public hearing.

The EA must not be longer than 75 pages (not including citations or appendices).

- **3.** District environmental staff:
  - creates the "Submit Final EA" deliverable Activity (on the Activities screen, click the "D+" next to the "Perform Final EA Preparation" Activity),
  - assigns this "Submit Final EA" deliverable Activity to him or herself,
  - uploads the final EA under the "Submit Final EA" deliverable Activity, and
  - finalizes the "Submit Final EA" deliverable Activity.
- **4.** District environmental staff creates a Review of the final EA under the "Submit Final EA" deliverable Activity, and assigns it to the ENV core team member.
- 5. The ENV core team member creates individual Reviews of the final EA under the "Submit Final EA" deliverable Activity, and assigns them to the district core team member and individual ENV subject matter experts (SMEs) for resource areas for which there have been changes from the draft EA to the final EA.



- 6. The ENV core team member, district core team member, and individual ENV SMEs complete their reviews of the final EA according to the instructions in the "Review Final EA" Activity Instructions.
- **7.** Once the ENV core team member has finalized his or her Review, if there are pending comments on the final EA, the district environmental staff:
  - prepares a new, revised version of the final EA that is responsive to the comments made;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns;
  - creates a new "Submit Final EA" deliverable Activity;
  - assigns the new "Submit Final EA" deliverable Activity to him or herself;
  - uploads the new, revised version of the final EA and the completed comment response matrix under the new "Submit Final EA" deliverable Activity;
  - finalizes this deliverable Activity; and
  - creates a Review under the new "Submit Final EA" deliverable Activity, and assigns it to the ENV core team member.
- 8. ENV core team member creates Reviews of the new, revised version of the final EA and assigns them to the district core team member and any ENV SMEs that had made comments on the previous version.
- 9. If further revisions to the final EA are needed after this second round of reviews, the district environmental staff creates a new "Submit Final EA" deliverable Activity (on the Activities screen, click the "D+" next to the "Perform Final EA Preparation" Activity), uploads a new version of the EA under the "Submit Final EA" deliverable Activity, and creates and assigns a Review to the ENV core team member for each new version of the final EA. The process set forth above is repeated until the ENV core team member has indicated in his or her Review that the final EA is "Approved no comments," and finalizes his or her Review.
- **10.** Once the ENV core team member has no further comments on the final EA, and has confirmed all of the above, the ENV core team member assigns a Review to the ENV Project Delivery Section Director.
- 11. If the ENV Project Delivery Section Director has comments on the final EA, then the district environmental staff creates a new "Submit Final EA" deliverable Activity (on the Activities screen, click the "D+" next to the "Perform Final EA Preparation" Activity), uploads the final EA under the new "Submit Final EA" deliverable Activity, and creates and assigns a Review to the ENV Project Delivery Section Director.
- **12.** Once the ENV Project Delivery Section Director has no further comments on the final EA, the ENV Project Delivery Section Director finalizes his or her Review (selecting "Approved no comments").
- **13.** ENV core team member uploads the Project Delivery Section-approved version of the final EA with the words, "Project Delivery Section-Approved Final EA" at the beginning of the file name under the most recent "Submit Final EA" deliverable activity.



- 14. ENV core team member prepares a draft FONSI using ENV's Finding of No Significant Impact for State or FHWA Project template, emails the draft FONSI to the ENV Project Delivery Section Director for review. Any comments or edits are emailed to the ENV core team member.
- 15. For an FHWA project that is NOT of a type for which an EIS would normally be required according to 23 C.F.R. §771.115(a), once the ENV Project Delivery Section Director has no further comments on the draft FONSI, the ENV project Delivery Section Director emails the draft FONSI to the ENV Division Director for review and approval stating that (1) both core team members have reviewed the final EA and FONSI for both content and accuracy and (2) the project is not an FHWA project that is of a type for which an EIS would normally be required according to 23 CFR 771.115(a), and therefore a 30-day wait period before signing the FONSI is not required.

For an FHWA project that IS of a type for which an EIS would normally be required according to 23 C.F.R. §771.115(a), once the ENV Project Delivery Section Director has no further comments on the draft FONSI, the ENV core team member directs district environmental staff to issue a notice of availability of the final EA prior to the ENV Division Director signing the FONSI. The notice of availability of the final EA is tracked under the "Perform Notice of Availability (NOA) for Final EA listed at 23 CFR 771.115(a)" Activity (for the FONSI itself there will be a separate NOA tracked under the "Perform FONSI Notice of Availability (NOA)" Activity). After the 30-day period following the notice of availability of the final EA has expired, the ENV project Delivery Section Director emails the draft FONSI to the ENV Division Director for review and approval stating that (1) both core team members have reviewed the final EA and FONSI for both content and accuracy and (2) the project is an FHWA project that is of a type for which an EIS would normally be required according to 23 CFR 771.115(a), and the 30-day wait period before signing the FONSI has expired.

- **16.** After the ENV Division Director has signed the FONSI, the ENV Project Delivery Section Director sends the signed FONSI to the ENV core team member. The ENV core team member uploads the signed FONSI with the word, "Approved," at the beginning of the file name under the most recent "Submit Final EA" deliverable Activity.
- 17. ENV core team member fills-in the "Finding of No Significant Impact Date" field with the date that the ENV Division Director signed the FONSI. If the applicable deadline under Transportation Code 201.759 was missed, then the ENV core team member selects, "No," in the drop-down menu for field labeled, "Was the applicable deadline at Transportation Code 201.759 met?" The ENV core team member then finalizes this "Perform Final EA Preparation" Activity. Finalizing this Activity will automatically update the "Environmental Clearance Date" on WPD I and the "Env NEPA Clear Date" in TxDOTCONNECT (updates to TxDOTCONNECT typically occur overnight).
- **18.** ECOS will send an email to the "Sponsor Point of Contact" and "District Core Team Member" listed on WPD I notifying them of the environmental clearance of the project.

# "Perform Final EIS/Record of Decision (ROD) Preparation" Activity

The final EIS and ROD must be combined into one document, except in the following unusual circumstances:

- the final EIS makes substantial changes to the proposed action that are relevant to environmental or safety concerns; or
- there are significant new circumstances or information relevant to environmental concerns that bear on the proposed action or the impacts of the proposed action.

The process outlined immediately below is for the normal circumstance of a combined final EIS/ROD. Special instructions for the unusual circumstance of a separate final EIS and ROD are provided at the end of these Activity Instructions.

1. For an FHWA project, if, prior to completion of this Activity, it becomes clear that the e-NEPA notice of availability of the FEIS will be published in the Federal Register more than two years after the date the notice of intent is published in the Federal Register, then the Director of the Environmental Affairs Division must approve a new deadline in an email (the ENV core team member emails the Director of the Environmental Affairs Division to request this approval, and no formal email template language is required). If the Director of the Environmental Affairs Division approves a new deadline for publication of the e-NEPA notice of availability of the FEIS in the Federal Register, the ENV core team member must add a note to the "Comments" field of the "Perform EIS Scoping" Activity noting the new deadline, and upload the ENV Director's email under the "Perform EIS Scoping" Activity.

# Combined final EIS/ROD

2. After the public hearing documentation has been completed and approved by the ENV core team member, and after all Activities with a milestone of "Prior to Env Clearance\*" are finalized, district environmental staff prepares the final EIS/ROD in accordance with ENV's Guidance – Assembling a Combined Final Environmental Impact Statement/Record of Decision. The final EIS/ROD will include any changes resulting from public comment received in connection with the public hearing.

If the (1) "Purpose and Need for Action" section, (2) "Alternatives Including the Proposed Action" section, and (3) "Affected Environment and Environmental Consequences" section have a combined length of more than 200 pages, then the ENV Director must approve the longer page length in an email (the ENV core team member emails the Director of the Environmental Affairs Division to request this approval, and no formal email template language is required). If the Director of the Environmental Affairs Division approves a longer page length, the ENV core team member shall add a note to the "Comments" field of this Activity and upload the ENV Director's email under this Activity (this is not necessary if the ENV Director previously approved a longer page length for the draft EIS, and the final EIS is less than that previously approved longer page length). Regardless of whether the ENV Director approves a longer page length for the three



sections identified above, the overall length of the EIS (not counting the ROD) must not exceed 300 pages (not including any citations or appendices).

- **3.** District environmental staff:
  - creates the "Submit Final EIS/Record of Decision (ROD)" deliverable Activity (on the Activities screen, click the "D+" next to the "Perform Final EIS/Record of Decision (ROD) Preparation" Activity),
  - assigns the "Submit Final EIS/Record of Decision (ROD)" deliverable Activity to him or herself,
  - uploads the final EIS/ROD under the "Submit Final EIS/Record of Decision (ROD)" deliverable Activity, and
  - finalizes the "Submit Final EIS/Record of Decision (ROD)" deliverable Activity.
- **4.** District environmental staff creates a Review of the final EIS/ROD under the "Submit Final EIS/Record of Decision (ROD)" deliverable Activity and assigns it to the ENV core team member.
- 5. The ENV core team member creates individual Reviews of the final EIS/ROD under the "Submit Final EIS/Record of Decision (ROD)" deliverable Activity and assigns them to the ENV Project Delivery Section Director, district core team member, and individual ENV subject matter experts (SMEs) for resource areas for which there have been changes from the draft EIS to the final EIS.
- 6. The ENV core team member, the ENV Project Delivery Section Director, district core team member, and individual ENV SMEs complete their reviews of the final EIS/ROD according to the instructions in the "Review Final EIS/ROD" Activity Instructions.
- **7.** Once the ENV core team member has finalized his or her Review, if there are pending comments on the final EIS/ROD, the district environmental staff:
  - prepares a new, revised version of the final EIS that is responsive to the comments made;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns;
  - creates a new "Submit Final EIS/Record of Decision (ROD)" deliverable Activity;
  - assigns the new "Submit Final EIS/Record of Decision (ROD)" deliverable Activity to him or herself;
  - uploads the new, revised version of the final EIS and the completed comment response matrix under the new "Submit Final EIS/Record of Decision (ROD)" deliverable Activity;
  - finalizes this deliverable Activity; and
  - creates a Review under the new "Submit Final EIS/Record of Decision (ROD)" deliverable Activity, and assigns it to the ENV core team member.
- 8. ENV core team member creates Reviews of the new, revised version of the final EIS/ROD and assigns them to the ENV Project Delivery Section Director, district core team member and any ENV SMEs that had made comments on the previous version.
- **9.** If further revisions to the final EIS/ROD are needed after this second round of reviews, the district environmental staff creates a new "Submit Final EIS/Record of Decision (ROD)" deliverable



Activity (on the Activities screen, click the "D+" next to the "Perform Final EIS/Record of Decision (ROD) Preparation" Activity), uploads a new version of the final EIS/ROD under the "Submit Final EIS/Record of Decision (ROD)" deliverable Activity, and creates and assigns a Review to the ENV core team member for each new version of the final EIS/ROD. The process set forth above is repeated until the ENV core team member has indicated in his or her Review that the final EIS/ROD is "Approved no comments," and finalizes his or her Review.

- 10. The ENV core team member emails the final EIS/ROD to TxDOT's General Counsel Division for legal sufficiency review. GCD's comments, response to GCD's comments, revisions to the final EIS/ROD made in response to GCD's comments, and correspondence regarding GCD's comments and associated revisions and responses are not tracked in ECOS.
- **11.** Once the General Counsel Division determines that the final EIS/ROD is legally sufficient, ENV core team member uploads under the latest "Submit Final EIS/Record of Decision (ROD)" deliverable Activity (1) the version of the final EIS/ROD that was determined to be legally sufficient by GCD with the phrase, "GCD-approved," at the beginning of the file name; and (2) an email from the General Counsel Division indicating that legal sufficiency review is complete and that the final EIS/ROD is legally sufficient.
- **12.** ENV core team member provides (1) a hard copy of an email exchange or other written statement showing that both core team members have reviewed the final EIS/ROD for both content and accuracy, and (2) a hard copy of the final EIS/ROD cover page to the ENV Division Director for review and approval.
- **13.** After the ENV Division Director has signed the final EIS/ROD, the ENV core team member uploads the signed final EIS/ROD with the word, "Approved," at the beginning of the file name under the most recent "Submit Final EIS/Record of Decision (ROD)" deliverable Activity.
- 14. ENV core team member fills-in the "Record of Decision (ROD) Date" field with the date the ENV Director signs the final EIS/ROD. If the applicable deadline under Transportation Code 201.759 was missed, then the ENV core team member selects, "No," in the drop-down menu for field labeled, "Was the applicable deadline at Transportation Code 201.759 met?" The ENV core team member then finalizes this "Perform Final EIS/Record of Decision (ROD) Preparation" Activity. Finalizing this Activity will automatically update the "Environmental Clearance Date" on WPD I and the "Env NEPA Clear Date" in TxDOTCONNECT (updates to TxDOTCONNECT typically occur overnight).
- **15.** ECOS will send an email to the "Sponsor Point of Contact" and "District Core Team Member" listed on WPD I notifying them of the environmental clearance of the project.

## Separate final EIS and ROD

- 1. In the unusual circumstance of a separate final EIS and ROD, there will be separate pdf documents of the final EIS and the ROD. Complete Steps 1 through 11 above for both documents.
- 2. After both the final EIS and the ROD have been approved by the General Counsel Division, the ENV core team member provides (1) a hard copy of an email exchange or other written statement



showing that both core team members have reviewed the final EIS and the ROD for both content and accuracy, and (2) hard copies of the final EIS cover page and the ROD to the ENV Division Director for review and approval.

- **3.** Once the ENV Division Director has determined that the final EIS and ROD are approved, the ENV Division Director signs the final EIS.
- **4.** The ENV core team member uploads the signed final EIS with the word, "Approved," at the beginning of the file name under the most recent "Submit Final EIS/Record of Decision (ROD)" deliverable Activity.
- 5. The ENV core team member directs the district environmental staff to issue a notice of availability of the final EIS. The notice of availability of the final EIS is tracked under the "Perform Final EIS/ROD Notice of Availability (NOA)" Activity. The ENV core team member must wait 30 days after the NOA is issued before requesting that the ENV Division Director sign the ROD.
- 6. Once 30 days have passed since the issuance of the NOA of the final EIS, the ENV Division Director signs the ROD.
- 7. After the ENV Division Director has signed the ROD, the ENV core team member uploads the signed ROD with the word, "Approved," at the beginning of the file name under the most recent "Submit Final EIS/Record of Decision (ROD)" deliverable Activity.
- 8. ENV core team member fills-in the "Record of Decision (ROD) Date" field with the date the ENV Director signs the ROD. If the applicable deadline under Transportation Code 201.759 was missed, then the ENV core team member selects, "No," in the drop-down menu for field labeled, "Was the applicable deadline at Transportation Code 201.759 met?" The ENV core team member then finalizes this "Perform Final EIS/Record of Decision (ROD) Preparation" Activity. Finalizing this Activity will automatically update the "Environmental Clearance Date" on WPD I and the "Env NEPA Clear Date" in TxDOTCONNECT (updates to TxDOTCONNECT typically occur overnight).
- **9.** ECOS will send an email to the "Sponsor Point of Contact" and "District Core Team Member" listed on WPD I notifying them of the environmental clearance of the project.
- **10.** The ENV core team member directs the district environmental staff to issue a notice of availability of the ROD. The notice of availability of the ROD is tracked under a <u>new</u> "Perform Final EIS/ROD Notice of Availability (NOA)" Activity.

## "Perform Induced Growth Analysis" Activity

1. District environmental staff uses ENV's Induced Growth Indirect Impacts Decision Tree to determine if no induced growth impacts are anticipated, or if a more detailed six-step induced growth analysis ("six-step analysis") is required. After making a preliminary determination on this question, district environmental staff informally discusses with the ENV Project Delivery Staff assigned to the respective district to make sure they agree. This can be an informal Teams call or email exchange. There is no need to document this informal discussion in ECOS (if the district environmental staff wants to do so they can use the "Induced Growth SME Consultation" Activity).

If **ENV's Induced Growth Indirect Impacts Decision Tree** indicates that no induced growth impacts are anticipated, then district environmental staff identifies in the "Comments" field of this Activity the path through the decision tree that led to the conclusion that no induced growth impacts are anticipated, and finalizes this Activity. District environmental staff will also include an explanation of how it was determined that no induced growth impacts are anticipated in the appropriate section of the EA or EIS.

If **ENV's Induced Growth Indirect Impacts Decision Tree** indicates that a six-step analysis is required, then proceed as indicated below.

2. District environmental staff consults the ENV core team member to determine whether the sixstep analysis will be prepared separately from the EA or EIS and then only summarized in the EA or EIS, or if it will be included in its entirety in the EA or EIS.

## Six-step analysis prepared separately from EA or EIS and then summarized in EA or EIS

- **3.** District environmental staff prepares the six-step analysis in accordance with **ENV's Guidance**: **Induced Growth Analysis**, and uploads it under this Activity.
- **4.** District environmental staff creates a Review of the six-step analysis under this Activity, and assigns it to ENV Project Delivery staff. Once ENV Project Delivery staff has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the six-step analysis that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to ENV Project Delivery staff.
- **5.** Once ENV Project Delivery staff has no further comments and has finalized his or her Review, district environmental staff uploads the final six-step analysis with the word, "Approved," at the beginning of the file name, and finalizes this Activity.
- **6.** District environmental staff includes a summary of the six-step analysis in the appropriate section of the EA or EIS.



It is recommended that the same person or persons who prepared the six-step analysis prepare the summary of the six-step analysis to be included in the EA or EIS.

#### Six-step analysis included in its entirety in EA or EIS

- **3.** District environmental staff notes in the "Comments" field of this Activity that the six-step analysis will not be prepared as a separate deliverable, but rather will be written as part of the EA or EIS.
- **4.** District environmental staff finalizes this Activity.
- 5. District environmental staff prepares the six-step analysis as part of the EA or EIS in accordance with **ENV's Guidance: Indirect Impacts Analysis**. The appropriate resource area ENV SME assigned to the respective district will review the six-step analysis as part of his or her review of the EA or EIS.

# "Perform Notice of Intent (NOI)" Activity

This Activity is only for EIS projects. There is no notice of intent for an EA or CE-level project.

The steps for completing this Activity are different depending on whether the project is a state project or FHWA project:

#### NOI for a state project

- 1. District environmental staff prepares a draft NOI using ENV's Template: Notice of Intent for a State Project, and emails it to the ENV core team member for review.
- 2. After the ENV core team member has approved the draft NOI, district environmental staff publishes the approved NOI in a local newspaper having general circulation in the area affected by the project. If there is no local newspaper in the area affected by the project, district environmental staff will publish the NOI in any newspaper having general circulation in the area affected by the project. District environmental staff uploads the newspaper clipping showing publication of the NOI in the newspaper under this Activity.
- 3. After the ENV core team member has approved the draft NOI, the ENV core team member emails the NOI to the General Counsel Division (GCD) for publication in the Texas Register at least two weeks prior to the intended publication date. Once the NOI has been published in the Texas Register, the ENV core team member:
  - fills-in the "Date NOI was published in the Federal Register (or Texas Register for a state project)" field,
  - notifies the district core team member that the NOI has been published,
  - uploads the Texas Register-published NOI under this Activity,
  - confirms that the newspaper notice has been uploaded, and
  - finalizes this Activity.

#### NOI for an FHWA project


- 1. District environmental staff prepares a draft NOI using ENV's Template: Notice of Intent for an FHWA Project, and emails it to the ENV core team member for review.
- 2. After the ENV core team member has approved the draft NOI, the ENV core team member forwards the draft NOI to TxDOT's GCD for legal sufficiency review, and provides at least three days for GCD to review. GCD's comments, response to GCD's comments, revisions to the NOI made in response to GCD's comments, and correspondence regarding GCD's comments and associated revisions and responses are not tracked in ECOS.
- **3.** ENV core team member uploads GCD's legal sufficiency determination email under this Activity.
- 4. After GCD has approved the draft NOI, district environmental staff publishes the approved NOI in a local newspaper having general circulation in the area affected by the project. If there is no local newspaper in the area affected by the project, district environmental staff will publish the NOI in



any newspaper having general circulation in the area affected by the project. District environmental staff uploads the newspaper clipping showing publication of the NOI in the newspaper under this Activity.

- **5.** After GCD has approved the draft NOI, the ENV core team member coordinates publication of the NOI in the Federal Register by emailing it to FHWA Texas Division and requesting that he arrange for it to be published in the Federal Register at its earliest convenience.
- 6. When the NOI has been published in the Federal Register, the ENV core team member:
  - fills-in the "Date NOI was published in the Federal Register (or Texas Register for a state project)" field,
  - notifies the district core team member that the NOI has been published,
  - uploads the Federal Register-published NOI under this Activity,
  - confirms that the newspaper notice has been uploaded, and
  - finalizes this Activity.

# "Perform Post-Environmental Clearance File Correction" Activity

This Activity is used when it is discovered after environmental clearance that some documentation is missing, incomplete, or incorrect, and there is no previously created Activity under which the complete or corrected documentation can be uploaded.

For example, if it is discovered after environmental clearance that the "Obtain Project-Level Conformity Determination" Activity was properly created but the transportation conformity report form was not properly uploaded under the "Obtain Project-Level Conformity Determination" Activity, then district environmental staff corrects the error by simply uploading the transportation conformity report form under the previously created "Obtain Project-Level Conformity Determination" Activity. However, if the "Obtain Project-Level Conformity Determination" Activity. However, if the "Obtain Project-Level Conformity Determination" Activity. However, if the "Obtain Project-Level Conformity Determination" Activity and upload the transportation conformity report form under it.

## Documentation was created but not properly uploaded

If, after environmental clearance, it is discovered that some documentation was created prior to environmental clearance, but was not properly uploaded to ECOS prior to environmental clearance (e.g., it was omitted, or a defective electronic or incorrect version of a file was uploaded), then district environmental staff proceeds as follows:

- 1. District environmental staff provides an explanation in the "Comments" field of this Activity regarding the documentation that was discovered as not having been properly uploaded to ECOS prior to environmental clearance, including the date that it was created, and identification of the Activity under which the documentation has now been uploaded. If multiple documents are being uploaded on the same day, provide separate explanations in the "Comments" field for each uploaded document.
- 2. Finalize this Activity. If, on a later date, it is determined that additional documents need to be uploaded, create an additional second "Perform Post-Environmental Clearance File Correction" Activity.

## Documentation was created but is unable to be recovered

If, after environmental clearance, it is discovered that some documentation was created prior to environmental clearance, but was not properly uploaded to ECOS prior to environmental clearance (e.g., it was omitted, or a defective electronic or incorrect version of a file was uploaded), <u>and the documentation cannot be recovered and uploaded</u> (e.g., the TNM files are missing), then district environmental staff proceeds as follows:

1. District environmental staff provides an explanation in the "Comments" field of this Activity regarding the documentation that was discovered as not having been properly uploaded to ECOS prior to environmental clearance, including the date (or approximate date) that it was created, and an explanation of why it is unable to be recovered and uploaded. If multiple unrecoverable

documents were discovered as not having been uploaded, provide separate explanations for each.

2. Finalize this Activity. If, on a later date, additional unrecoverable documents are discovered as having not been uploaded, create an additional "Perform Post-Environmental Clearance File Correction" Activity.

#### Failure to perform required work

If, after environmental clearance, it is discovered that some required work was not performed, then district environmental staff consults with the appropriate resource area ENV SME(s) assigned to the respective district to determine the appropriate course of action.



## "Perform Recreational Trails Analysis" Activity

- **1.** The designated ENV Project Delivery Manager (PDM) uploads any email correspondence with TPWD or FHWA regarding the project under this Activity.
- 2. The ENV PDM creates Reviews of the packet of documents provided by TPWD under this Activity, and assigns them to the appropriate ENV SMEs for biology, archeology, and historical studies.

If the cover letter provided by TPWD indicates that the project is subject to air conformity requirements, the ENV PDM also creates a Review and assigns it the appropriate ENV SME for air.

- **3.** If coordination with the Texas Historical Commission is required, it will be done by TxDOT ENV CRM Staff. If surveys or field work is required, it will be done by the grant applicant per instructions provided by TxDOT ENV CRM Staff.
- 4. If TxDOT ENV NRM Staff determines that consultation with USFWS is required, the consultation will be done by TxDOT ENV NRM Staff, unless TxDOT designates TPWD to perform informal consultation or prepare a biological assessment under 50 CFR 402.08, in which case TPWD will perform the designated task.
- 5. Each of the three (or four if the ENV SME for air was assigned a Review) ENV SMEs will finalize their respective Reviews by indicating, "Approved," once they have determined that the project will have no significant environmental impact and requires no further coordination with the Texas Historical Commission or USFWS or other actions.
- **6.** Once all three ENV SMEs (or four) have finalized their respective Reviews by indicated, "Approved," the ENV PDM finalizes this Activity.

## "Perform Reevaluation" Activity

#### Instructions for when an actual reevaluation is not needed

- 1. If district environmental staff or an ENV SME created the "Perform Reevaluation" Activity solely as a workaround to create one or more other Activities with a milestone of either "Prior to Env Clearance\*" or "Prior to LOA," then district environmental staff or the ENV SME:
  - selects "Omission/new information" for the field labeled, "Reason for Reevaluation;"
  - selects "Yes" from the drop-down menu for the field labeled, "Was the applicable deadline at Transportation Code 201.759 met?;"
  - selects "Original Environmental Decision Remains Valid" from the drop-down menu for the field labeled, "Reevaluation Result;"
  - enters the following statement in the "Comments" field of this Activity: "No reevaluation is actually required under Environmental Guide: Volume 1 Process, Chapter 18. This "Perform Reevaluation" Activity was created in order to allow the creation of one or more other Activities that should have been created prior to environmental clearance or LOA clearance, but were not."
  - creates the other Activity or Activities that should have been created prior to environmental clearance or LOA clearance, but were not; and
  - after all of the other Activity or Activities (and associated Reviews and Coordinations) have been finalized, assigns this "Perform Reevaluation" Activity to the ENV Project Delivery Staff assigned to the respective district, who then finalizes this Activity.

#### Instructions for when an actual reevaluation is needed

These instructions apply for all reevaluations, except for those done to correct a Program Review finding, or those done because three years have passed since the DEIS and the FEIS has still not been issued, which are discussed in their own sections at the end of these Activity Instructions.

1. If district environmental staff created the "Perform Reevaluation" Activity because a reevaluation was actually required under Environmental Guide: Volume 1 Process, Chapter 18, then district environmental staff proceeds as indicated below.

Note that WPD section I, II, III, and IV are frozen in time when the project is environmentally cleared. Even if there are reevaluations on the project, once it is cleared, the WPD sections I, II, III, and IV can never be changed. They must remain unchanged from how they existed on the date of the environmental clearance. Any project changes after environmental clearance will be described only in the reevaluation form that is uploaded under the "Perform Reevaluation" Activity and will be reflected in any new Activities that are created in connection with that reevaluation.

- **2.** District environmental staff determines whether any additional Activities must be completed in order to confirm the validity of the original environmental clearance, or to comply with any other environmental law or regulation. District environmental staff then:
  - completes Sections I., II., and III. of ENV's Reevaluation Form and uploads it under this Activity (only if the additional Activities will require involvement by ENV SMEs);



- copies the "summary of reason for reevaluation" from Section 1. of ENV's Reevaluation Form into the "Comments" field of this "Perform Reevaluation" Activity; and
- creates the needed additional Activities.

When creating additional Activities in connection with a reevaluation, "Reevaluation" will not be visible as a selection in the drop-down menu for the "Milestone" field in the new Activity. Instead, the drop-down menu will just show the default milestone for that Activity highlighted in gray (e.g., "Prior to Env Clearance\*"), and it will not let the user select any other value. Just create the Activity like normal (click the "save" icon"). If the Activity has a default milestone of "Prior to Env Clearance\*", ECOS will automatically change the milestone to "Reevaluation," locked. Also, if the project has already been LOA-cleared, and the Activity you are creating has a default milestone of "Prior to LOA," ECOS will automatically change the milestone to "Reevaluation," locked.

If district environmental staff is not sure whether a particular Activity needs to be created in connection with a reevaluation, then he or she may discuss with the appropriate ENV SME assigned to the respective district, and document the decision whether or not to create the Activity using the appropriate "\_\_\_\_\_ SME Consultation" Activity.

Any additional Activities that need to be created at the reevaluation stage must be created in the main CSJ, regardless of whether any work was previously tracked in an associate CSJ. <u>Do not</u> create a "Perform Reevaluation" Activity or any other Activities associated with the reevaluation in an associate CSJ.

Identify in the "Comments" field of each newly created Activity the reevaluation with which the Activity is associated (e.g., "Reevaluation 1").

- 3. Once district environmental staff has created any needed Activities, district environmental staff contacts the Project Delivery Staff assigned to their respective district to ensure that Project Delivery Staff agrees with district environmental staff's creation of Activities (i.e., whether the Activities created by district environmental staff are actually needed, and whether any additional Activities need to be created).
- **4.** Follow the instructions in this Step 4 for impacts to species.

If the reevaluation is being done in connection with a design change and district environmental staff concludes that the design changes will <u>not</u> affect any of the previous determinations in the species analysis spreadsheet, then district environmental staff may simply explain the basis for that conclusion in Section IV. of **ENV's Reevaluation Form.** 

However, if the design changes <u>do</u> affect one or more of the previous determinations in the species analysis spreadsheet (i.e., changing from "no effect" to "may affect"), then district environmental staff must create a new "Perform Species Analysis" Activity to document the change in the determination. The district may download and complete a new species analysis spreadsheet from the Natural Resources Toolkit, or update the existing species analysis spreadsheet utilizing the addendum tab. Consult with the appropriate ENV SME immediately.

Regardless of whether there are design changes that affect any previous determinations regarding species, district environmental staff must do the following on all reevaluations:



- Obtain a new IPaC and RTEST list per ENV Instructions: Preparing a Species Analysis Spreadsheet.
- If <u>no newly listed species</u> have been added to the USFWS IPaC system and/or the TPWD RTEST county list, then district environmental staff uploads the new list of federally listed species and critical habitat for the project from the USFWS IPaC system and the TPWD RTEST county list under this "Perform Reevaluation" Activity, and explains in Section IV. of ENV's Reevaluation Form under "Biology" the date(s) on which the USFWS IPaC system and/or the TPWD RTEST county list were updated and that no species were added. Use the following file naming convention for the IPaC list: "CSJ\_Project or Road Name\_USFWS Species List\_YYYYMMDD" (e.g., CSJ 1234-56-789\_SH 151\_USFWS Species List\_20220331.pdf).
- If the new lists <u>do</u> include newly listed species, create and complete a new "Perform Species Analysis" per the instructions in ENV Instructions: Preparing a Species Analysis Spreadsheet and the instructions for the "Perform Species Analysis" Activity in this Environmental Guide Volume 2. The district may download and complete a new species analysis spreadsheet from the Natural Resources Toolkit, or update the existing species analysis spreadsheet utilizing the addendum tab. If the new species analysis indicates that any new federally listed species that may be affected or taken, consult with the appropriate district assigned NRM biologist immediately.
- 5. For guidance on when a reevaluation must be coordinated with TPWD, see ENV's Guidance: TPWD Coordination Under the 2021 MOU.

For instructions on how to coordinate a reevaluation with TPWD, see **ENV's Guidance: TPWD Coordination Under the 2021 MOU** or the instructions for "Perform Species Analysis" in this Environmental Guide Volume 2, specifically the section labeled, "TPWD Coordination Process for a Reevaluation."

6. After any newly created Activities needed for the reevaluation have been finalized (if any were created), district environmental staff completes **ENV's Reevaluation Form** and uploads the completed reevaluation form under this Activity. It is important that the steps below do not occur until any other Activities (e.g., "Obtain Project-Level Conformity Determination," "Perform Noise Analysis," etc.) are completed because there is a common understanding that approval of a reevaluation means that all applicable environmental laws (not just NEPA) have been appropriately addressed.

Note that only those Activities that normally have a milestone of "Prior to Env Clearance\*" (e.g., "Perform Community Impacts Assessment" or "Perform Surface Water Analysis") need to be finalized during the reevaluation stage. Activities that normally have other milestones and therefore are not normally completed until after environmental clearance (e.g., "Obtain Section 404/10 Permit") may remain open; however, they must be created during the reevaluation stage.

Note that TxDOT's environmental review rules refer to two different forms of reevaluations: "documented reevaluations" and "consultation reevaluations," however **ENV's Reevaluation Form** is now used for both.

**7.** District environmental staff creates a Review of the completed reevaluation form under this Activity and assigns it to the ENV Project Delivery staff assigned to the respective district and, if



the project is an EA- or EIS-level project, the ENV SME for biology. Once the ENV Project Delivery staff and ENV SME for biology (if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:

- prepares a new, revised version of the completed reevaluation form that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.
- 8. Once the ENV Project Delivery staff and ENV SME for biology (if applicable) has no further comments and has confirmed that all Activities associated with this reevaluation have been finalized, he or she finalizes his or her Review.
- **9.** ENV Project Delivery staff does the following in this existing "Perform Reevaluation" Activity that was created by district environmental staff in Step 1 above (do not create a second "Perform Reevaluation" Activity):
  - for the field labeled, "Reason for Reevaluation," selects one of the drop-down options based on which reason is indicated on **ENV's Reevaluation Form**;
  - selects "Yes" or "No from the drop-down menu for the field labeled, "Was the applicable deadline at Transportation Code 201.759 met?;"
  - selects "Original Environmental Decision Remains Valid" or "New Environmental Decision Needed" from the drop-down menu for the field labeled, "Reevaluation Result;" and
  - proceeds as indicated below, depending on the project classification:
    - For a reevaluation of a CE other than an open-ended (d)-list CE, ENV Project Delivery staff finalizes this Activity.
    - For a reevaluation of an open-ended (d)-list CE, EA, or EIS, ENV Project Delivery staff does not finalize this Activity. Instead, ENV Project Delivery staff clicks the "save" icon in this Activity and assigns a Review of this Activity to ENV's Project Delivery Section Director, and the ENV Project Delivery Section Director proceeds as instructed below.
- **10.** If ENV's Project Delivery Section Director has comments on the reevaluation, then ENV's Project Delivery Section Director inserts their comments in the "Comments" field of the "Perform Reevaluation" Activity, notifies ENV Project Delivery Staff that comments have been added, and leaves the "Perform Reevaluation" Activity open until the comments have been addressed.
- **11.** ENV's Project Delivery Section Director may, at his or her discretion, assign this "Perform Reevaluation" Activity to the ENV Deputy Director if he or she would like a higher level of authority to review the reevaluation.
- **12.** If ENV's Project Delivery Section Director does <u>not</u> assign this "Perform Reevaluation" Activity to the ENV Deputy Director, and agrees with the reevaluation result, he or she finalizes this Activity.

If ENV's Project Delivery Section Director <u>does</u> assign this "Perform Reevaluation" Activity to the ENV Deputy Director, then the ENV Deputy Director finalizes this Activity if he or she agrees with the reevaluation result.



If the reevaluation was done for work that will be performed under a new CSJ that will need to be "added" to the previously cleared main CSJ, then this "Perform Reevaluation" Activity must be finalized before attempting to add the new CSJ using the "Add CSJ After Environmental Clearance" Activity.

**13.** If the result of the reevaluation is "New Environmental Decision Needed," then district environmental staff creates the "Revoke Environmental Clearance" in the same main CSJ in which the reevaluation was conducted, and follows the steps in the Activity Instructions for that Activity to revoke the environmental clearance.

## Instructions for when a reevaluation is done to correct a Program Review finding

- 1. Sometimes, after environmental clearance, ENV's Program Review Section will identify an issue that requires a reevaluation to resolve. When this occurs, district environmental staff follows the normal process for doing a reevaluation, except that instead of creating and assigning a Review to ENV's Project Delivery Section, district environmental staff instead creates and assigns a Review to ENV's Program Review Section.
- 2. Once the ENV Program Review Section staff has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the completed reevaluation form that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Program Review Section staff.
- 3. Once the ENV Program Review Section staff has no further comments and has confirmed that all Activities associated with this reevaluation have been finalized, he or she finalizes his or her Review.
- 4. ENV Program Review Section staff does the following in this "Perform Reevaluation" Activity:
  - for the field labeled, "Reason for Reevaluation," selects "File correction;"
  - selects "Yes" or "No from the drop-down menu for the field labeled, "Was the applicable deadline at Transportation Code 201.759 met?;"
  - selects "Original Environmental Decision Remains Valid" or "New Environmental Decision Needed" from the drop-down menu for the field labeled, "Reevaluation Result;" and
  - finalizes this Activity.

Special instructions for reevaluations required because three years have passed since publication of the notice of availability of the DEIS in the Federal or Texas Register and the FEIS has still not yet been issued

1. In this situation, it is not possible to create a "Perform Reevaluation" Activity because the project has not yet been environmentally cleared in ECOS. Therefore, it will be necessary for ENV to review and approve the reevaluation outside of ECOS.



- 2. District environmental staff modifies **ENV's Reevaluation Form** to have a signature block at the end for either the ENV Project Delivery Section Director or the ENV Deputy Director.
- 3. District environmental staff completes ENV's Reevaluation Form. <u>The reevaluation is limited to</u> <u>an analysis of the preferred alternative only.</u> The purpose of the reevaluation is to determine whether, <u>for the preferred alternative only</u>, there have been design changes or new information or circumstances as compared to the DEIS that would result in significant environmental impacts that were not evaluated in the DEIS, in which case a supplemental DEIS would be required. Therefore, the description of the project changes in the reevaluation form must include any changes that have been made to the preferred alternative as described in the DEIS.

Also, keep in mind that, unlike other reevaluations that are done <u>after</u> environmental clearance, in this case we are doing the reevaluation <u>before</u> environmental clearance; therefore, if there have been project changes since the DEIS, they should be reflected in an updated project description on WPD I (which is not the case on a normal reevaluation that is done after environmental clearance).

- **4.** District environmental staff emails the completed reevaluation form to ENV Project Delivery staff for review outside of ECOS.
- 5. Once ENV Project Delivery staff determines that the reevaluation form is ready for final review, ENV Project Delivery staff emails the reevaluation form to the ENV Project Delivery Section Director or the ENV Deputy Director.
- **6.** If the ENV Project Delivery Section Director or ENV Deputy Director approve, they sign the reevaluation form and email it back to ENV Project Delivery staff.
- **7.** ENV Project Delivery staff uploads the reevaluation form the with the word, "Approved," at the beginning of the file name under the "Perform Draft EIS Preparation" Activity.

# "Reasonable Assurances for Activities That Could Not Be Completed Prior to LOA" Activity

**1.** This Activity can be used for the following "Prior to LOA" Activities if there are extenuating circumstances that prevent the district from completing the Activity prior to LOA clearance:

- Archeology "Obtain Project Information or Access"
- Archeology "Perform Archeology Data Recovery"
- Archeology "Perform Archeology Survey"
- Archeology "Perform Archeology Testing"
- Archeology "Perform Cemetery Investigation"
- Archeology "Perform Cemetery Removal"
- Archeology "Perform Native American Graves Protection and Repatriation Act (NAGPRA) Analysis"
- Community Impacts "Perform Community Impacts Mitigation"
- Hazardous Materials "Perform Haz Mat Issue Identification and Resolution (IIR)"
- Protected Lands "Obtain Section 6(f) Approval"
- Protected Lands "Perform Protected Lands Mitigation"
- Water "Obtain International Boundary and Water Commission (IBWC) Approval"
- Water "Obtain Section 9 Bridge Permit"
- Water -- "Obtain Section 404/10 permit"
- Water "Perform Texas Commission on Environmental Quality (TCEQ) Edwards Aquifer Rules Analysis"
- Water "Perform Water Compensatory Mitigation"

For any "Prior to LOA" Activity that is not listed above, the individual Activity <u>must</u> be finalized prior to LOA clearance (unless the ENV Director or ENV Deputy Director approves the use of reasonable assurances for an Activity that is not listed above).

2. District environmental staff creates this Activity as soon as it becomes evident that one or more of the Activities listed above will not, in fact, be finalized prior to LOA clearance, and therefore "reasonable assurance" statements need to be recorded for the Activity.

The purpose of this Activity is to collect, in one place, the reasonable assurance statements for any such Activities.

There should only be one of these "Reasonable Assurances for Activities That Could Not Be Completed Prior to LOA" Activities for the project (although it might contain reasonable assurance explanations for multiple other Activities).

3. In the "Comments" field of the individual "Prior to LOA" Activity that cannot be completed prior to LOA clearance, district environmental staff explains that the Activity cannot be completed prior to proceeding to letting, and references the explanation in this "Reasonable Assurances for Activities That Could Not Be Completed Prior to LOA" Activity.



- 4. If district environmental staff has not yet created a "Coordination" and "Review" off of the individual "Prior to LOA" Activity that cannot be completed prior to LOA clearance, then they should go ahead and create them prior to proceeding as instructed below. This will avoid the possibility of later needing to create a "Perform Reevaluation" Activity just to unlock the ability to create that Coordination or Review after LOA clearance.
- 5. In the "Comments" field <u>of this "Reasonable Assurances for Activities That Could Not Be</u> <u>Completed Prior to LOA" Activity</u>, district environmental staff indicates the following for each Activity with a default milestone of "Prior to LOA" that could not, in fact, be finalized prior to LOA clearance:
  - Name of Activity
  - Explanation of why the Activity could not be finalized prior to LOA clearance (a future version of ECOS may export the language entered here into TxDOTCONNECT).
  - Plan for completing the Activity in the future in order to demonstrate reasonable assurance that the Activity will be completed prior to the start of construction (a future version of ECOS may export the language entered here into TxDOTCONNECT).

(It is anticipated that in future updates to ECOS and TxDOTCONNECT, ECOS will send the information in the "Comments" field of this "Reasonable Assurances for Activities That Could Not Be Completed Prior to LOA" Activity.)

- **6.** District environmental staff notifies the ENV Project Delivery Staff assigned to the respective district that the steps above have been completed.
- **7.** ENV Project Delivery Staff checks to make sure that the steps above have been completed, and if so, then ENV Project Delivery Staff:
  - finalizes this Activity, and
  - changes the milestone of the individual Activity in question from "Prior to LOA" to "Prior to Construction".



## "Review Draft EA"

- 1. The district core team member, ENV core team member, ENV SME, or ENV Project Delivery Section Director selects his or her name from the drop-down menu for the field labeled, "Reviewed By."
- 2. The district core team member, ENV core team member, ENV SME, or ENV Project Delivery Section Director fills-in the "Document Name" field with the <u>exact</u> file name of the draft EA that is being reviewed (suggest using copy and paste).
- **3.** The district core team member, ENV core team member, ENV SME, or ENV Project Delivery Section Director clicks on the calendar icon next to the "Upload Date" field and selects the date that the draft EA that is being reviewed was uploaded to ECOS.
- **4.** The district core team member, ENV core team member, ENV SME, or ENV Project Delivery Section Director reviews the draft EA.
- 5. If they have comments on the draft EA, the district core team member, ENV core team member, ENV SME, or ENV Project Delivery Section Director records his or her comments on the draft EA using ENV's Technical Review Comment Response Matrix. For Reviews of the draft EA, the reviewer must use the matrix to record comments rather than making edits or adding comments to a draft of the document. This is because the ENV core team member will have to compile comments from multiple reviewers in a master matrix, as explained below.

The district core team member, ENV SME, ENV core team member, or ENV Project Delivery Section Director follows the instructions below for completion of the Review based on his or her role.

## District core team member's completion of Review

- **6.** The district core team member selects one of the following drop-down responses under the "Review Results" field in this Review:
  - "Approved no comments"
  - "Approved with comments"
  - "Not Approved"

Select "Approved with comments" only if the comments are so minor or straightforward that the reviewer, in his or her judgment, does not expect that an additional review will be assigned to him or her to back-check the response to the comments.

- 7. If they have comments on the draft EA, the district core team member uploads his or her completed Technical Review Comment Response Matrix under the district core team member's Review.
- 8. The district core team member finalizes his or her Review.



#### ENV SME's completion of Review

- **6.** The ENV SME selects one of the following drop-down responses under the "Review Results" field in this Review:
  - "Approved no comments"
  - "Approved with comments"
  - "Not Approved"

Select "Approved with comments" only if the comments are so minor or straightforward that the reviewer, in his or her judgment, does not expect that an additional review will be assigned to him or her to back-check the response to the comments.

- **7.** If they have comments on the draft EA, the ENV SME uploads his or her completed Technical Review Comment Response Matrix under the ENV SME's Review.
- 8. The ENV SME finalizes his or her Review

#### ENV core team member's completion of Review

- 6. - 8. The ENV core team member checks TxDOTConnect to make sure there are no ROW CSJs associated with the project that have not been created in ECOS and associated with the main CSJ in ECOS (in TxDOTConnect, under "Project Information" on the left side of the screen, click on "Letting" and then "Controlling and Subordinate Projects"). If there are any such ROW CSJs, then district environmental staff must create them in ECOS, and then associate them with the main CSJ in ECOS. This will require re-submittal and re-acceptance of the project work plan (WPD III).
- **9.** The ENV core team member selects one of the following drop-down responses under the "Review Results" field in this Review:
  - "Approved no comments"
  - "Not Approved"

The ENV core team member must not select "Approved with comments" for this particular review because the ENV core team member must review and approve the final version of the EIS/ROD.



In other words, there must not be any further changes to the document after the ENV core team member approves.

- **10.** The ENV core team member uploads the master TxDOT comment response matrix under the ENV core team member's Review using the following file-naming convention: "TxDOT combined comments on final EIS/ROD (<insert date matrix if finalized>)."
- **11.** The ENV core team member finalizes his or her Review.



## "Review Recreational Trails Analysis"

- 1. ENV SME selects his or her name from the drop-down menu for the field labeled, "Reviewed By."
- 2. ENV SME fills-in the "Document Name" field with the <u>exact</u> file name of the documentation that is being reviewed (suggest using copy and paste). The document(s) that require review will have been identified by the individual who assigned the Review in the "Assignment Details" field of the Review, and uploaded under the same Activity for which the review was assigned. To see which documents have been uploaded under the relevant Activity, the reviewer may click on the "upload" icon next to the Activity on the "Activities" screen.

If the ENV SME reviews multiple documents under a single Review, the ENV SME fills-in the <u>exact</u> file name of the <u>primary</u> document reviewed, and identifies in the "Comments" field of the Review the exact file name of any additional documents reviewed.

**3.** The ENV SME clicks on the calendar icon next to the "Upload Date" field and selects the date that the documentation that is being reviewed was uploaded to ECOS.

If the ENV SME reviews multiple documents under a single Review, the ENV SME selects the upload date for the <u>primary</u> document reviewed, and identifies in the "Comments" field of the Review the upload date of any additional documents reviewed.

- **4.** ENV SME reviews the packet of information uploaded under the "Perform Recreational Trails Analysis" Activity, and determines, based on the information in that packet of information, if there is reason to believe that the project would not qualify as a categorical exclusion because it does not meet the requirements at 23 C.F.R. §771.117(a) and (b).
- 5. If the ENV SME determines that there <u>is</u> reason to believe that the project would not qualify as a categorical exclusion because it does not meet the requirements at 23 C.F.R. §771.117(a) and (b), then the ENV SME selects "Not Approved with Comments" from the drop-down menu under the "Review Results:" field in this review activity, and then finalizes this review activity.
- 6. If the ENV SME determines that there is <u>not</u> reason to believe that the project would not qualify as a categorical exclusion because it does not meet the requirements at 23 C.F.R. §771.117(a) and (b), then the ENV SME proceeds as follows.
- 7. If the ENV SME determines, based on the packet of information uploaded under the "Perform Recreational Trails Analysis" Activity, that no additional Activities under his or her respective discipline needs to be created, then the ENV SME selects "Approved" from the drop-down menu under the "Review Results:" field in this review activity, and then finalizes this review activity.
- 8. If the ENV SME determines, based on the packet of information uploaded under the "Perform Recreational Trails Analysis" Activity, that an additional Activity or Activities under his or her respective discipline need to be created, then the ENV SME creates the appropriate Activity or Activities, and leaves this review activity open.

- **9.** The ENV SME for biology must upload the following under the "Perform Recreational Trails Analysis" Activity:
  - list of federally listed species and critical habitat for the project from the USFWS Information for Planning and Conservation (IPaC) system;
  - TPWD RTEST county list for the county(ies) in which the project is located;
  - PDFs of the "Species" and "References" tabs of the project-specific species analysis spreadsheet; and
  - completed ENV's Form Biological Impact Evaluation for Recreational Trails Fund Grant.
- **10.** Once any additional Activities created by the SME have been completed and finalized, the ENV SME selects "Approved" from the drop-down menu under the "Review Results:" field in this review activity, and then finalizes this review activity.





## "Revoke Environmental Clearance" Activity

This Activity is used by district environmental staff to request that ENV revoke an environmental clearance. This Activity can only be created in a main CSJ. It cannot be created in a CSJ that is associated with a main CSJ.

- **1.** District environmental staff clicks on "Assignment Details," and enters the following information in the "Comments" field of the "Assignment Details" screen:
  - state whether the environmental clearance for <u>all</u> CSJs associated with the main CSJ should be revoked, <u>or</u> whether <u>only some</u> of the CSJs associated with the main CSJ should be revoked;
  - if the environmental clearances for <u>only some</u> of the CSJs associated with the main CSJ should be revoked, list the specific CSJs for which the environmental clearance should be revoked; and
  - provide an explanation for the revocation.
- **2.** District environmental staff assigns this Activity to the ENV project delivery manager assigned to the respective district.
- **3.** If the ENV project delivery manager approves of the request to revoke, he or she assigns this Activity to the ENV Project Delivery Section Director or an ENV Deputy Director.
- 4. If the ENV Project Delivery Section Director or ENV Deputy Director approves the request to revoke, he or she proceeds as indicated below, depending on whether only some or all CSJs associated with the main CSJ are being revoked:

To <u>revoke a main CSJ that has no associate CSJs</u>, the ENV Project Delivery Section Director or ENV Deputy Director:

- enters an explanation for revoking in the "Comments" field (which may be copied over from the explanation on the "Assignment Details" screen); and
- finalizes this Activity.

To <u>revoke only some or all of a main CSJ's associate CSJs</u>, <u>but leave the main CSJ</u> <u>environmentally cleared</u>, the ENV Project Delivery Section Director or ENV Deputy Director:

- uses the checkboxes to select the associate CSJs to be revoked;
- enters an explanation for revoking in the "Comments" field (which may be copied over from the explanation on the "Assignment Details" screen); and
- finalizes this Activity.

To <u>revoke a main CSJ and all of its associate CSJs</u>, the ENV Project Delivery Section Director or ENV Deputy Director:

• selects the "Select All" checkbox to indicate that all associate CSJs should be revoked;



- enters an explanation for revoking in the "Comments" field (which may be copied over from the explanation on the "Assignment Details" screen); and
- finalizes this Activity.
- creates a <u>second</u> "Revoke Environmental Clearance" Activity in the main CSJ;
- in that <u>second</u> "Revoke Environmental Clearance" Activity, enters an explanation for revoking in the "Comments" field (which may be copied over from the explanation on the "Assignment Details" screen of the <u>first</u> "Revoke Environmental Clearance" Activity); and
- finalizes that <u>second</u> Activity.

Finalizing this Activity will revoke the environmental clearance, and the LOA clearance if it has already been granted, for all selected CSJs (for expedited CEs, this will also remove the "Anticipated Environmental Classification" from WPD I). Finalizing this Activity will also break the associations for all CSJs for which the environmental clearance has been revoked. A new environmental clearance will have to be issued in order for the any of the CSJs for which the CE clearance was revoked to receive LOA-clearance, proceed to letting or construction, or continue construction if construction has already begun.

**5.** ECOS will send an email to all of the project contacts listed on WPD I notifying them of the revocation.



## "Obtain Section 4(f) Approval" Activity

This Activity is used to track Section 4(f) approvals (i.e., Section 4(f) exceptions, *de minimis* Section 4(f) determinations, programmatic Section 4(f) evaluations, or individual Section 4(f) determinations) for any park, recreation area, wildlife or waterfowl refuge, or historic site for which there would be a "use." Note that for an EIS project, TxDOT will make the Section 4(f) approval either in the final EIS or in the ROD (*see* 23 CFR 774.9(b)). Therefore, for an EIS project, not all of the processes set forth below need be followed, so long as compliance with FHWA's Section 4(f) regulations is documented in the final EIS or ROD.

These Activity Instructions are long, but that is because they separately explain the processes for Section 4(f) exceptions, *de minimis* determinations, programmatic evaluations, and individual determinations first for parks, recreation areas, and wildlife or waterfowl refuges, and then for historic sites. Here is a table of contents/quick reference guide:

\* The ENV Deputy Director only finalizes this Activity after being notified by ENV PD staff or ENV SME that an approval has been completed for <u>all</u> 4(f) properties listed in the "Comments' field of this Activity – see page 26 of 27.



Note that some properties may qualify as <u>both</u> a park, recreation area, or wildlife or waterfowl refuge <u>and</u> an historic site. Such properties will need to be listed twice in the "Comments" field of this Activity and approved separately as described below, once as a park, recreation area, or wildlife or waterfowl refuge; and once as an historic site. In other words, for an historic park, there must be two separate exception, *de minimis*, or programmatic checklists for the property, one for the park/recreation/refuge aspect of the property, and the other for the historic aspect of the property (for an individual 4(f) evaluation, a single document may be prepared to satisfy both requirements).

#### Parks, recreation areas, and wildlife or waterfowl refuges

Listing parks, recreation areas, and wildlife or waterfowl refuges for which there will be a "use"

1. District environmental staff lists in the "Comments" field all properties that district environmental staff determined to be publicly owned land from a <u>public</u> park, recreation area or wildlife or waterfowl refuge <u>of national, State, or local significance</u> and would be subject to a <u>"use"</u> as described in the Activity Instructions for the "Perform Section 4(f) Analysis" Activity. Include any such properties even if it is anticipated that a Section 4(f) exception will apply.

Use the same name for the property used in the "Perform Section 4(f) Analysis" Activity.

Do <u>not</u> list any properties that district environmental staff determined to <u>not</u> be publicly owned land from a public park, recreation area or wildlife and waterfowl refuge of national, State, or local significance, or would <u>not</u> be subject to a "use" as described in the Activity Instructions for the "Perform Section 4(f) Analysis" Activity.

# Determination of anticipated Section 4(f) approval type for parks, recreation areas, and wildlife or waterfowl refuges

1. District environmental staff determines which type of Section 4(f) approval is anticipated to be used for each park, recreation area, and wildlife or waterfowl refuge that district environmental staff has listed in the "Comments" field.

There are four categories of Section 4(f) approvals that may be used, listed below in order of intensity from least to greatest:

- Section 4(f) exceptions
- *De minimis* Section 4(f) determinations
- Programmatic Section 4(f) evaluations
- Individual Section 4(f) determinations

Each of these categories of Section 4(f) approvals are addressed separately below.

- **2.** District environmental staff first determines whether any of the following Section 4(f) exceptions applies by referring to the conditions for each exception in the CFR subsection cited below:
  - Temporary occupancy see 23 CFR 774.13(d)
  - Recreational trails, paths, bikeways, and sidewalks that occupy a transportation facility right-of-way see 23 CFR 774.13(f)(3)
  - Trails, paths, bikeways, and sidewalks that function primarily for transportation 23 CFR 774.13(f)(4)



- Transportation enhancement activities, transportation alternatives projects, and mitigation activities see 23 CFR 774.13(g)
- **3.** If none of the Section 4(f) exceptions listed above apply, district environmental staff determines whether the project's use of the property would potentially qualify for a *de minimis* Section 4(f) determination. In order to qualify for *de minimis*, the project must not adversely affect the features, attributes, or activities of the park, recreation area, or wildlife or waterfowl refuge.
- **4.** If none of the Section 4(f) exceptions listed above apply <u>and</u> the project's use of the property would not potentially qualify for a *de minimis* Section 4(f) determination, district environmental staff determines whether the following Section 4(f) programmatic evaluation applies by referring to the project description and conditions for the programmatic evaluation on FHWA's Section 4(f) toolkit:
  - "Section 4(f) Evaluation and Approval for Transportation Projects That Have a <u>Net Benefit</u> to a Section 4(f) Property."
- 5. If none of the Section 4(f) exceptions listed above apply <u>and</u> the project's use of the property would not potentially qualify for a *de minimis* Section 4(f) determination, <u>and</u> the programmatic evaluation listed above does not apply, then an individual Section 4(f) determination is required (see the heading labeled, "Process for an individual Section 4(f) determination for a park, recreation area, or wildlife or waterfowl refuge" below).
- 6. For each park, recreation area, and/or wildlife or waterfowl refuge that has been listed in the "Comments" field of this Activity, district environmental staff adds a note in the "Comments" field indicating the anticipated Section 4(f) approval type for each property, and proceeds as indicated below, depending on which Section 4(f) approval type is anticipated (Section 4(f) exception, *de minimis* Section 4(f) determination, programmatic Section 4(f) evaluation, or individual Section 4(f) determination).

### Process for a Section 4(f) exception for a park, recreation area, or wildlife or waterfowl refuge

- 1. If district environmental staff intends to use either (1) the exception for recreational trails, paths, bikeways, and sidewalks that occupy a transportation facility right-of-way or (2) the exception for trails, paths, bikeways, and sidewalks exception that function primarily for transportation then no coordination with the OWJ is required. Skip to Step 8 below.
- 2. If district environmental staff intends to use either (1) the exception for temporary occupancy or (2) the exception for transportation enhancement activities, transportation alternatives projects, and mitigation activities, then district environmental staff creates either the "Coordinate Park/Rec Area/Refuge Exception Temporary Occupancy" Coordination or the "Coordinate Park/Rec Area/ Refuge Exception Trans. Enhancement Activ., Trans. Alt. Proj., and Mitigation Activ." Coordination.
- District environmental staff prepares a letter to the official with jurisdiction over the park, recreation area, or wildlife or waterfowl refuge notifying him or her of the intent to pursue a Section 4(f) exception using (1) ENV's Letter Template: Notification of Intent to Pursue an Exception for Temporary Occupancy, or (2) ENV's Letter Template: Notification of Intent to



# Pursue an Exception for Transportation Enhancement Activities, Transportation Alternatives Projects, and Mitigation Activities.

- 4. District environmental staff signs and mails and/or emails the letter to the official with jurisdiction.
- **5.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. District environmental staff fills-in the correspondence details for each letter or email sent to or from the official with jurisdiction.
- **6.** District environmental staff uploads each email or letter to or from TxDOT and the official with jurisdiction under the Coordination.
- 7. Once the official with jurisdiction has indicated concurrence by returning a signed version of the original letter notifying him or her of the intent to pursue a Section 4(f) exception, district environmental staff selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- 8. District environmental staff completes ENV's Checklist for Section 4(f) Exceptions for Public Parks, Recreation Land, Wildlife and Waterfowl Refuges, and Historic Sites. If there are multiple properties, district environmental staff can either complete a separate checklist (with a separate Review) for each property or cover multiple properties in a single checklist, so long as they are covered by the same exception. As indicated above, for an historic park/recreation area/refuge, there must be two separate checklists for the property, one for the park/recreation/refuge aspect of the property, and the other for the historic aspect of the property.
- **9.** District environmental staff uploads the completed checklist for Section 4(f) exceptions with all required attachments as a single packet under this Activity using the following file naming convention: "Park-rec-refuge 4f CSJ (mo-yr)\_property name."
- **10.** If project-specific mitigation requirements have been established as part of the Section 4(f) approval, then district environmental staff creates the "Perform Protected Lands Mitigation" Activity.
- **11.** District environmental staff creates a Review of the checklist for Section 4(f) exceptions and assigns it to the ENV Project Delivery staff assigned to the respective district. Once the ENV Project Delivery staff has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the checklist for Section 4(f) exceptions that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.

If ENV Project Delivery staff determines that the exception simply does not apply to the project, then district environmental staff must start over with a new Section 4(f) approval type.



- 12. Once the ENV Project Delivery staff has no further comments and has finalized his or her Review, he or she selects, "Approved no comments," from the "Review Results" field in the Review, finalizes the Review, and uploads the checklist with all required attachments as a single packet under this Activity using the following file naming convention: "Approved park-rec-refuge 4f CSJ (mo-yr)\_property name."
- **13.** If a Section 4(f) approval has been recorded for <u>all</u> parks, recreation areas, wildlife or waterfowl refuges, <u>and</u> historic sites listed in the "Comments" field of this Activity, then the ENV Project Delivery staff proceeds as indicated on page 26 below under "Finalizing this Activity."

# Process for *a de minimis* Section 4(f) determination for a park, recreation area, or wildlife or waterfowl refuge

**1.** District environmental staff provides for public notice and comment on the proposed *de minimis* determination by describing it in the notice of a public meeting, opportunity for public hearing, or public hearing.

If no public meeting, opportunity for public hearing, or public hearing is being held on the project, district environmental staff:

- provides a separate public notice and opportunity for comment on the proposed *de* minimis determination using ENV's Template: Notice of Proposed Section 4(f) *De* Minimis Determination for Parks as described in ENV's Public Involvement Handbook (note that this is different than the "notice and opportunity to comment" that is required to be sent to adjacent landowners and affected local governments under certain circumstances because the notice and opportunity to comment on a proposed *de minimis* determination must be a public notice);
- uploads proof of public posting of the notice (there are multiple ways this can be accomplished see ENV's Public Involvement Handbook) under this Activity; and
- uploads any comments received under this Activity.
- **2.** District environmental staff creates the "Coordinate Park/Rec Area/Refuge De Minimis" Coordination.
- **3.** After the deadline for receiving comment on the proposed *de minimis* determination has expired and all comments on the proposed *de minimis* determination have been reviewed, district environmental staff follows the steps below to conduct the coordination:
  - District environmental staff prepares a letter to the official with jurisdiction over the park, recreation area, or wildlife or waterfowl refuge notifying him or her of the intent to pursue a Section 4(f) *de minimis* determination using ENV's Letter Template for Official with Jurisdiction Notification of Intent to Pursue De Minimis.
  - District environmental staff signs and mails and/or emails the letter to the official with jurisdiction.
  - In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required.



District environmental staff fills-in the correspondence details for each letter or email sent to or from the official with jurisdiction.

- District environmental staff uploads each email or letter to or from TxDOT and the official with jurisdiction under the Coordination.
- Once the official with jurisdiction has indicated concurrence by returning a signed version of the original letter notifying him or her of the intent to pursue a Section 4(f) *de minimis* determination, district environmental staff selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- 4. District environmental staff completes ENV's Checklist for Section 4(f) *De Minimis* for Public Parks, Recreation Land, Wildlife & Waterfowl Refuges, and Historic Properties. If there are multiple properties, district environmental staff can either complete a separate checklist (with a separate Review) for each property or cover multiple properties in a single checklist. As indicated above, for an historic park/recreation area/refuge, there must be two separate checklists for the property, one for the park/recreation/refuge aspect of the property, and the other for the historic aspect of the property.
- **5.** District environmental staff uploads the completed checklist for Section 4(f) *de minimis* with all required attachments as a single packet under this Activity using the following file naming convention: "Park-rec-refuge 4f CSJ (mo-yr)\_property name."
- 6. If project-specific mitigation requirements have been established as part of the Section 4(f) approval, then district environmental staff creates the "Perform Protected Lands Mitigation" Activity.
- 7. District environmental staff creates a Review of the checklist for Section 4(f) *de minimis* and assigns it to the ENV Project Delivery staff assigned to the respective district. Once the ENV Project Delivery staff has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the checklist for Section 4(f) *de minimis* that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.

If ENV Project Delivery staff determines that a *de minimis* determination cannot be used for the project, then district environmental staff must start over with a new Section 4(f) approval type.

- 8. Once the ENV Project Delivery staff has no further comments and has finalized his or her Review, he or she selects, "Approved no comments," from the "Review Results" field in the Review, finalizes the Review, and uploads the checklist with all required attachments as a single packet under this Activity using the following file naming convention: "Approved park-rec-refuge 4f CSJ (mo-yr)\_property name."
- **9.** If a Section 4(f) approval has been recorded for <u>all</u> parks, recreation areas, wildlife or waterfowl refuges, <u>and</u> historic sites listed in the "Comments" field of this Activity, then the ENV Project Delivery staff proceeds as indicated on page 26 below under "Finalizing this Activity."



Process for use of a programmatic Section 4(f) evaluation for a park, recreation area, or wildlife or waterfowl refuge

- **1.** District environmental staff creates the "Coordinate Park/Rec Area/Refuge Programmatic" Coordination.
- 2. District environmental staff follows the steps below to conduct the coordination:
  - District environmental staff prepares a letter to the official with jurisdiction over the park, recreation area, or wildlife or waterfowl refuge notifying him or her of the intent to use the programmatic Section 4(f) evaluation, requesting concurrence that the project includes all possible planning to minimize harm and includes appropriate mitigation measures with respect to the Section 4(f) property, and including any other information required by the specific programmatic evaluation being used.
  - District environmental staff signs and mails and/or emails the letter to the official with jurisdiction.
  - In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. District environmental staff fills-in the correspondence details for each letter or email sent to or from the official with jurisdiction.
  - District environmental staff uploads each email or letter to or from TxDOT and the official with jurisdiction under the Coordination.
  - Once the official with jurisdiction has indicated concurrence by returning a signed version of the original letter, district environmental staff selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- **3.** If the net benefit programmatic evaluation is being used, and if a public meeting and/or public hearing will be held, district environmental staff confirms that information on the proposed use of the Section 4(f) property is communicated at the meeting and/or hearing.
- 4. District environmental staff completes ENV's Checklist for Programmatic Net Benefit (parks, recreation areas, refuges). If there are multiple properties, district environmental staff can either complete a separate checklist (with a separate Review) for each property or cover multiple properties in a single checklist. As indicated above, for an historic park/recreation area/refuge, there must be two separate checklists for the property, one for the park/recreation/refuge aspect of the property, and the other for the historic aspect of the property.
- 5. District environmental staff uploads the completed checklist with all required attachments as a single packet under this Activity using the following file naming convention: "Park-rec-refuge 4f CSJ (mo-yr)\_property name."
- 6. If project-specific mitigation requirements have been established as part of the Section 4(f) approval, then district environmental staff creates the "Perform Protected Lands Mitigation" Activity.
- 7. District environmental staff creates a Review of the checklist and assigns it to the ENV Project Delivery staff assigned to the respective district. Once the ENV Project Delivery staff has finalized his or her Review, if there are pending comments, the district environmental staff:



- prepares a new, revised version of the checklist that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.

If ENV Project Delivery staff determines that the programmatic evaluation cannot be used for the project, then district environmental staff must start over with a new Section 4(f) approval type.

- 8. Once the ENV Project Delivery staff has no further comments and has finalized his or her Review, he or she selects, "Approved no comments," from the "Review Results" field in the Review, finalizes the Review, and uploads the checklist with all required attachments as a single packet under this Activity using the following file naming convention: "Approved park-rec-refuge 4f CSJ (mo-yr)\_property name."
- **9.** If a Section 4(f) approval has been recorded for <u>all</u> parks, recreation areas, wildlife or waterfowl refuges, <u>and</u> historic sites listed in the "Comments" field of this Activity, then the ENV Project Delivery staff proceeds as indicated on page 26 below under "Finalizing this Activity."

# Process for an individual Section 4(f) determination for a park, recreation area, or wildlife or waterfowl refuge

- District environmental staff prepares an individual Section 4(f) evaluation using ENV's Documentation Standard for an Individual Section 4(f) Evaluation. Note that if the same property qualifies both as a park, recreation area, or wildlife or waterfowl refuge and an historic site, only one individual Section 4(f) evaluation needs to be prepared.
- 2. District environmental staff uploads the individual Section 4(f) evaluation and all attachments as a single packet under this Activity using the following file naming convention: "Park-rec-refuge 4f CSJ (mo-yr)\_property name."
- **3.** If project-specific mitigation requirements have been established as part of the Section 4(f) approval, then district environmental staff creates the "Perform Protected Lands Mitigation" Activity.
- **4.** District environmental staff creates a Review of the individual Section 4(f) evaluation and assigns it to the ENV Project Delivery staff assigned to the respective district. Once the ENV Project Delivery staff has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the individual Section 4(f) evaluation that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.

If ENV Project Delivery staff determines that a Section 4(f) exception, *de minimis* Section 4(f) determination, or programmatic Section 4(f) evaluation can be used for the project, then district environmental staff must start over with a new Section 4(f) approval type.



- 5. Once the ENV Project Delivery staff has no further comments and has finalized his or her Review, the ENV Project Delivery staff emails the individual Section 4(f) evaluation to TxDOT's General Counsel Division (GCD) for review (this is <u>not</u> the formal legal sufficiency review that happens after the individual Section 4(f) evaluation has been coordinated as indicated below).
- 6. GCD reviews the individual Section 4(f) evaluation outside of ECOS, and provides its comments directly to the ENV Project Delivery staff. GCD's comments, response to GCD's comments, revisions to the individual Section 4(f) evaluation made in response to GCD's comments, and correspondence regarding GCD's comments and associated revisions and responses are not tracked in ECOS.
- 7. After GCD has completed its review, district environmental staff creates separate Coordinations for (1) the Department of the Interior and (2) the official with jurisdiction over the park, recreation area, or wildlife or waterfowl refuge (and, if they may reasonably be expected to be interested in the property, the Department of Agriculture and/or the Department of Housing and Urban Development).
- **8.** District environmental staff follows the steps below to conduct the coordination for each entity with which the individual Section 4(f) evaluation is being coordinated:
  - District environmental staff prepares a cover letter referring to the individual Section 4(f) evaluation and requesting comments. For the Department of the Interior (and the Department of Agriculture and/or the Department of Housing and Urban Development, if applicable), the letter will state a comment receipt deadline of 30 days after receipt. For the official with jurisdiction, the letter will state a comment receipt deadline of 45 days after receipt.
  - District environmental staff signs the letter and mails or emails it and the individual Section 4(f) evaluation to the entity with which the individual Section 4(f) evaluation is being coordinated.
    - For the Department of the Interior, email the individual Section 4(f) evaluation and cover letter (via attachment or link) to the Department of the Interior's Office of Environmental Policy and Compliance (OEPC) using the following email address: <u>environmental review@ios.doi.gov</u>. It is not necessary to also mail a hard copy to the Department of the Interior. For more information on DOI's environmental review process and how and where to submit environmental documents for review, please see the revised submission guidelines for DOI Review of Non-Interior Environmental Documents available on the OEPC website at https://www.doi.gov/sites/doi.gov/files/doi-externalenvironmental-review-feb-2022.pdf.
  - In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. District environmental staff fills-in the correspondence details for each letter or email sent to or from the entity with which the individual Section 4(f) evaluation is being coordinated.
  - District environmental staff uploads each email or letter to or from the entity with which the individual Section 4(f) evaluation is being coordinated.
  - Once the entity with which the individual Section 4(f) evaluation is being coordinated has provided written comments, district environmental staff selects "Completed" from the



drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

- If the Department of the Interior (and the Department of Agriculture and/or the Department of Housing and Urban Development, if applicable) does not respond within 45 days of the date the letter and individual Section 4(f) evaluation was emailed to it (or within 48 days if the letter and individual Section 4(f) evaluation was only mailed), then district environmental staff explains in the "Comments" field that no response was received within 45/48 days of the date the letter and Section 4(f) evaluation was sent; selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- If the official with jurisdiction does not respond within 60 days of the date the letter and individual Section 4(f) evaluation was emailed to it (or within 63 days if the letter and individual Section 4(f) evaluation was only mailed), then district environmental staff explains in the "Comments" field that no response was received within 60/63 days of the date the letter and Section 4(f) evaluation was sent; selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- **9.** District environmental staff amends the individual Section 4(f) evaluation to reflect the coordination.
- **10.** District environmental staff uploads the individual Section 4(f) evaluation under this Activity (again using the following file naming convention: "Park-rec-refuge 4f CSJ (mo-yr)\_property name") and creates a Review of the individual Section 4(f) evaluation, and assigns it to the ENV Project Delivery staff assigned to the respective district. Once the ENV Project Delivery staff has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the individual Section 4(f) evaluation that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.
- **11.** Once the ENV Project Delivery staff has no further comments and has finalized his or her Review, the ENV Project Delivery staff emails the individual Section 4(f) evaluation to TxDOT's General Counsel Division (GCD) for legal sufficiency review.
- **12.** GCD reviews the individual Section 4(f) evaluation outside of ECOS, and provides its comments directly to the ENV Project Delivery staff. GCD's comments, response to GCD's comments, revisions to the individual Section 4(f) evaluation made in response to GCD's comments, and correspondence regarding GCD's comments and associated revisions and responses are not tracked in ECOS.
- **13.** ENV Project Delivery staff uploads 1) the version of the individual Section 4(f) evaluation that was determined to be legally sufficient by GCD with the phrase, "GCD-approved," at the beginning of the file name; and 2) an email from GCD indicating that legal sufficiency review is complete and that the individual Section 4(f) evaluation is legally sufficient.



- **14.** ENV Project Delivery staff provides the individual Section 4(f) evaluation to the ENV Director for his or her approval.
- **15.** If the ENV Director disapproves of the individual Section 4(f) evaluation, he or she notifies the ENV Project Delivery staff to discuss.
- 16. If the ENV Director approves of the individual Section 4(f) evaluation, he or she indicates approval by email, and ENV Project Delivery staff uploads the individual Section 4(f) evaluation and all attachments as a single packet under this Activity using the following file naming convention: "Approved park-rec-refuge 4f CSJ (mo-yr)\_property name." The ENV Project Delivery staff also uploads the ENV Director's email under this Activity, and proceeds as indicated on page 26 below under "Finalizing this Activity."

#### **Historic sites**

#### Listing historic sites for which there will be a "use"

1. The ENV SME lists in the "Comments" field all historic sites that the ENV SME determined to be historic sites and would be subject to a "use." Use the same name for the property used in the "Obtain Historical Studies Section 106/Antiquities Code of Texas (ACT) Approval" or "Obtain Archeology Section 106/Antiquities Code of Texas (ACT) Approval" Activity.

If there are many historic sites that would be subject to a "use," the ENV SME may upload a list instead of listing each historic site in the "Comments" field.

An "historic site" includes any prehistoric or historic district, site, building, structure, or object included in, or eligible for inclusion in, the National Register. 23 CFR 774.17.

For purposes of this step, "use" occurs when any of the following apply:

- land is permanently incorporated into a transportation facility;
- there is a temporary occupancy of land;
- there is a constructive use of a Section 4(f) property (see 23 CFR 774.15); or
- work proposed on an historic transportation facility.

Note that, even if one of the above conditions applies, it may be possible for the project to fall under a Section 4(f) exception, in which case, technically speaking, there is no "use" as defined in FHWA's rules – see 23 CFR 774.17. However, <u>for purposes of this step</u>, do <u>not</u> consider whether the project will fall under a Section 4(f) exception. Instead, just consider whether any of the four above-listed conditions applies. If so, there is a "use" <u>for purposes of this step</u> and the property must be listed in the "Comments" field. Whether an exception applies will be determined in a later step.

With respect to non-archeological historic sites, whether an historic site would be subject to a "use" may have been determined as part of any of the following Activities:

- "Perform Historical Studies Project Coordination Request (PCR),"
- "Perform Historical Studies Desktop Survey,"
- "Perform Historical Studies Windshield Survey,"
- "Perform Historical Studies Reconnaissance Survey," or



• "Perform Historical Studies Intensive Survey."

With respect to archeological sites, whether an historic site would be subject to a "use" may have been determined as part of any of the following Activities:

- "Perform Archeology Background Study"
- "Perform Archeology Survey"
- "Perform Archeology Testing"

The vast majority of archeological sites are not protected under Section 4(f) because they are not included in, or eligible for inclusion in, the National Register. Therefore, for the vast majority of archeological sites, the "4(f) Property" field in the "Perform Archeology Survey" or "Perform Archeology Testing" will be answered, "No," in which case there is no need to address the property in this "Obtain Section 4(f) Approval" Activity.

Do <u>not</u> add any historic site that the ENV SME concluded would <u>not</u> be subject to a use as described above.

#### Determination of anticipated Section 4(f) approval type for historic sites

**1.** The ENV SME determines which type of Section 4(f) approval is anticipated to be used for each historic site that the ENV SME has listed in the "Comments" field.

There are four categories of Section 4(f) approvals that may be used, listed below in order of intensity from least to greatest:

- Section 4(f) exceptions
- *De minimis* Section 4(f) determinations
- Programmatic Section 4(f) evaluations
- Individual Section 4(f) determinations

Each of these categories of Section 4(f) approvals are addressed separately below.

- **2.** The ENV SME first determines whether any of the following Section 4(f) exceptions applies by referring to the conditions for each exception in the CFR subsection cited below:
  - Improvement of certain railroad or rail transit lines see 23 CFR 774.13(a)(2)
  - Historic transportation facilities see 23 CFR 774.13(a)(3)
  - Archeological sites see 23 CFR 774.13(b)
  - Temporary occupancy see 23 CFR 774.13(d)
  - Recreational trails, paths, bikeways, and sidewalks that occupy a transportation facility right-of-way see 23 CFR 774.13(f)(3)
  - Trails, paths, bikeways, and sidewalks that function primarily for transportation 23 CFR 774.13(f)(4)
  - Transportation enhancement activities, transportation alternatives projects, and mitigation activities see 23 CFR 774.13(g)
- **3.** If none of the Section 4(f) exceptions listed above apply, the ENV SME determines whether the project's use of the property would potentially qualify for a *de minimis* Section 4(f) determination. In order to qualify for *de minimis*, the project must have no adverse effect on the historic site.



- 4. If none of the Section 4(f) exceptions listed above apply <u>and</u> the project's use of the property would not potentially qualify for a *de minimis* Section 4(f) determination, the ENV SME determines whether either of the following Section 4(f) programmatic evaluations apply by referring to the project descriptions and conditions in the applicable programmatic evaluation on FHWA's Section 4(f) toolkit:
  - "Programmatic Section 4(f) Evaluation and Approval for FHWA Projects that Necessitate the Use of <u>Historic Bridges</u>"
  - "Section 4(f) Evaluation and Approval for Transportation Projects That Have a <u>Net Benefit</u> to a Section 4(f) Property"
- 5. If none of the Section 4(f) exceptions listed above apply <u>and</u> the project's use of the property would not potentially qualify for a *de minimis* Section 4(f) determination, <u>and</u> neither of the programmatic evaluations listed above apply, then an individual Section 4(f) determination is required (*see* the heading labeled, "Process for an individual Section 4(f) determination for an historic site" below).
- **6.** For each historic site that has been listed in the "Comments" field, the ENV SME adds a note in the "Comments" field indicating the anticipated Section 4(f) approval type for each property, and proceeds as indicated below, depending on which Section 4(f) approval type is anticipated (Section 4(f) exception, *de minimis* Section 4(f) determination, programmatic Section 4(f) evaluation, or individual Section 4(f) determination).

#### Process for a Section 4(f) exception for an historic site

**1.** The coordination process for a Section 4(f) exception is described in step 3 below. This coordination process will normally have been completed as part of one of the Activities listed below using a joint Section 106/Section 4(f) letter.

Historical studies:

- "Perform Historical Studies Project Coordination Request (PCR),"
- "Perform Historical Studies Desktop Survey,"
- "Perform Historical Studies Windshield Survey,"
- "Perform Historical Studies Reconnaissance Survey"
- "Perform Historical Studies Intensive Survey"

Archeology:

- "Perform Archeology Background Study"
- "Perform Archeology Survey"
- "Perform Archeology Testing"

If the coordination process described in step 3 below was completed and documented as part of one of the Activities listed above using a joint Section 106/Section 4(f) letter, the ENV SME skips steps 2 and 3.

- 2. The ENV SME creates one of the Coordinations listed below, depending on which Section 4(f) exception is being used:
  - "Coordinate Historic Exception Archeological Sites"



- "Coordinate Historic Exception Historic Transportation Facilities"
- "Coordinate Historic Exception Temporary Occupancy"
- "Coordinate Historic Exception Trail, Path, Bikeway or Sidewalk"
- "Coordinate Historic Exception Trans. Enhancement Activ., Trans. Alt. Proj., and Mitigation Activ."
- **3.** The ENV SME follows the steps below to conduct the coordination.
  - The ENV SME prepares a letter to the Texas Historical Commission/Texas State Historic Preservation Officer (THC/TSHPO) notifying it of the intent to pursue a Section 4(f) exception using ENV's Template for 4f Exception Letter (Joint 106 and 4f) (for a nonarcheological historic site) or ENV's Template for TSHPO/THC Consultation Regarding Archeological Historic Properties (for an archeological historic site).
  - The ENV SME transmits the letter to the THC/TSHPO via the THC eTRAC System.
  - In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter sent to or from the THC/TSHPO.
  - The ENV SME uploads each letter documenting decision-making to or from TxDOT and the THC/TSHPO under the Coordination.
  - Once the THC/TSHPO has indicated concurrence by returning a signed version of the original letter notifying him or her of the intent to pursue a Section 4(f) exception, the ENV SME selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
  - If the THC/TSHPO does not respond within 20 days of the date the original letter was transmitted to the THC/TSHPO, the ENV SME explains in the "Comments" field that no response was received within 20 days of the date the original letter; selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- 4. The ENV SME completes ENV's Checklist for Section 4(f) Exceptions for Public Parks, Recreation Land, Wildlife and Waterfowl Refuges, and Historic Sites. If there are multiple properties, the ENV SME can either complete a separate checklist (with a separate Review) for each property or cover multiple properties in a single checklist so long as they are covered by the same exception. As indicated above, for an historic park/recreation area/refuge, there must be two separate checklists for the property, one for the park/recreation/refuge aspect of the property, and the other for the historic aspect of the property.
- 5. The ENV SME uploads the completed checklist for Section 4(f) exceptions with all required attachments as a single packet under this Activity using the following file naming convention: "HIST 4f CSJ (mo-yr)\_property name."
- **6.** If project-specific mitigation requirements have been established as part of the Section 4(f) approval, then they will be tracked under one or more of the following Activities:
  - "Perform Historical Studies Mitigation"
  - "Perform Historical Studies Monitoring Commitments"
  - "Perform Archeology Data Recovery"
  - "Perform Archeology Mitigation"



• "Perform Archeology Monitoring Commitments"

Therefore, there is no reason to create the "Perform Protected Lands Mitigation" Activity.

- 7. The ENV SME may, at his or her discretion, create a Review of the checklist for Section 4(f) exceptions and assign it to the ENV SME. Once the ENV SME has finalized his or her Review (if one was created), if there are pending comments, the ENV SME:
  - prepares a new, revised version of the checklist for Section 4(f) exceptions that is
    responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME.

If the ENV SME determines that the exception simply does not apply to the project, then the ENV SME must start over with a new Section 4(f) approval type.

- 8. Once the ENV SME has no further comments and has finalized his or her Review (if one was created), the ENV SME creates a Review of the checklist and assigns it to the Director of ENV's Cultural Resources Section. Once the Director of ENV's Cultural Resources Section has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the checklist that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the Director of ENV's Cultural Resources Section.
- **9.** If the Director of ENV's Cultural Resources Section disapproves of the Section 4(f) exception, he or she notifies the ENV SME to discuss.
- 10. If the Director of ENV's Cultural Resources Section approves of the Section 4(f) exception, he or she selects, "Approved no comments," from the "Review Results" field in the Review, finalizes the Review, and emails the ENV SME staff to let him or her know that the Section 4(f) exception is approved. The ENV SME uploads the checklist with all required attachments as a single packet under this Activity using the following file naming convention: "Approved HIST 4f CSJ (mo-yr)\_property name."
- **11.** If a Section 4(f) approval has been recorded for <u>all</u> parks, recreation areas, wildlife or waterfowl refuges, <u>and</u> historic sites listed in the "Comments" field of this Activity, then the ENV SME proceeds as indicated on page 26 below under "Finalizing this Activity."

#### Process for a de minimis Section 4(f) determination for an historic site

1. The coordination process for a *de minimis* Section 4(f) determination is described in step 3 below. This coordination process will normally have been completed as part of one of the Activities listed below using a joint Section 106/Section 4(f) letter.

  - The ENV SME transmits the letter to the THC/TSHPO via the THC eTRAC System.
  - In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter sent to or from the THC/TSHPO.
  - The ENV SME uploads each letter documenting decision-making to or from TxDOT and the THC/TSHPO under the Coordination.
  - Once the THC/TSHPO has indicated concurrence by returning a signed version of the original letter notifying him or her of the intent to pursue a Section 4(f) *de minimis* determination, the ENV SME selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- 4. The ENV SME completes ENV's Checklist for Section 4(f) De Minimis for Public Parks, Recreation Land, Wildlife & Waterfowl Refuges, and Historic Properties. If there are multiple properties, the ENV SME can either complete a separate checklist (with a separate Review) for each property or cover multiple properties in a single checklist. As indicated above, for an historic park/recreation area/refuge, there must be two separate checklists for the property, one for the park/recreation/refuge aspect of the property, and the other for the historic aspect of the property.
- 5. The ENV SME uploads the completed checklist for Section 4(f) *de minimis* with all required attachments as a single packet under this Activity using the following file naming convention: "HIST 4f CSJ (mo-yr)\_property name."



- **6.** If project-specific mitigation requirements have been established as part of the Section 4(f) approval, then they will be tracked under one or more of the following Activities:
  - "Perform Historical Studies Mitigation"
  - "Perform Historical Studies Monitoring Commitments"
  - "Perform Archeology Data Recovery"
  - "Perform Archeology Mitigation"
  - "Perform Archeology Monitoring Commitments"

Therefore, there is no reason to create the "Perform Protected Lands Mitigation" Activity

- 7. The ENV SME may, at his or her discretion, create a Review of the checklist for Section 4(f) *de minimis* and assign it to the ENV SME. Once the ENV SME has finalized his or her Review (if one was created), if there are pending comments, the ENV SME:
  - prepares a new, revised version of the checklist for Section 4(f) *de minimis* that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME.

If the ENV SME determines that a *de minimis* determination cannot be used for the project, then the ENV SME must start over with a new Section 4(f) approval type.

- 8. Once the ENV SME has no further comments and has finalized his or her Review (if one was created), the ENV SME creates a Review of the checklist and assigns it to the Director of ENV's Cultural Resources Section. Once the Director of ENV's Cultural Resources Section has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the checklist that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the Director of ENV's Cultural Resources Section.
- **9.** If the Director of ENV's Cultural Resources Section disapproves of the Section 4(f) *de minimis*, he or she notifies the ENV SME to discuss.
- 10. - **11.** If a Section 4(f) approval has been recorded for <u>all</u> parks, recreation areas, wildlife or waterfowl refuges, <u>and</u> historic sites listed in the "Comments" field of this Activity, then the ENV SME proceeds as indicated on page 26 below under "Finalizing this Activity."



#### Process for use of a programmatic Section 4(f) evaluation for an historic site

1. The coordination process for a programmatic Section 4(f) evaluation is described in step 3 below. This coordination process will normally have been completed as part of one of the Activities listed below using a joint Section 106/Section 4(f) letter.

- "Perform Historical Studies Desktop Survey,"
- "Perform Historical Studies Windshield Survey,"

- "Perform Archeology Background Study"
- "Perform Archeology Survey"
- "Perform Archeology Testing"

If the coordination process described in step 3 below was completed and documented as part of one of the Activities listed above using a joint Section 106/Section 4(f) letter, the ENV SME skips steps 2 and 3.

- **2.** The ENV SME creates the "Coordinate Historic Programmatic" Coordination.
- **3.** The ENV SME follows the steps below to conduct the coordination:
  - The ENV SME prepares a letter to the Texas Historical Commission/Texas State Historic Preservation Officer (THC/TSHPO) notifying it of the intent to use the programmatic Section 4(f) evaluation, requesting concurrence that the project includes all possible planning to minimize harm and includes appropriate mitigation measures with respect to the Section 4(f) property, and including any other information required by the specific programmatic evaluation being used.

If the programmatic evaluation for historic bridges is being used, then the ENV SME uses ENV's Template for Programmatic Bridge 4f Letter (Joint 106 and 4f).

- The ENV SME transmits the letter to the THC/TSHPO via the THC eTRAC System.
- In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter sent to or from the THC/TSHPO.
- The ENV SME uploads each letter documenting decision-making to or from TxDOT and the THC/TSHPO under the Coordination.
- Once the THC/TSHPO has indicated concurrence by returning a signed version of the original letter, the ENV SME selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- 4. If the net benefit programmatic evaluation is being used, and if a public meeting and/or public hearing will be held, the ENV SME confirms that information on the proposed use of the Section 4(f) property is communicated at the meeting and/or hearing.



- 5. The ENV SME completes (1) ENV's Checklist for Section 4(f) Net Benefit for Historic Sites or (2) ENV's Checklist for Section 4(f) Programmatic Evaluation of Historic Bridge Projects. If there are multiple properties, the ENV SME can either complete a separate checklist (with a separate Review) for each property or cover multiple properties in a single checklist. As indicated above, for an historic park/recreation area/refuge, there must be two separate checklists for the property, one for the park/recreation/refuge aspect of the property, and the other for the historic aspect of the property.
- 6. The ENV SME uploads the completed checklist with all required attachments as a single packet under this Activity using the following file naming convention: "HIST 4f CSJ (mo-yr)\_property name."
- **7.** If project-specific mitigation requirements have been established as part of the Section 4(f) approval, then they will be tracked under one or more of the following Activities:
  - "Perform Historical Studies Mitigation"
  - "Perform Historical Studies Monitoring Commitments"
  - "Perform Archeology Data Recovery"
  - "Perform Archeology Mitigation"
  - "Perform Archeology Monitoring Commitments"

Therefore, there is no reason to create the "Perform Protected Lands Mitigation" Activity.

- 8. The ENV SME may, at his or her discretion, create a Review of the checklist and assign it to the ENV SME. Once the ENV SME has finalized his or her Review (if one was created), if there are pending comments, the ENV SME:
  - prepares a new, revised version of the checklist that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME.

If the ENV SME determines that the programmatic evaluation cannot be used for the project, then the ENV SME must start over with a new Section 4(f) approval type.

- **10.** Once the ENV SME has no further comments and has finalized his or her Review (if one was created), the ENV SME creates a Review of the checklist and assigns it to the Director of ENV's Cultural Resources Section. Once the Director of ENV's Cultural Resources Section has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the checklist that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the Director of ENV's Cultural Resources Section.
- **11.** If the Director of ENV's Cultural Resources Section disapproves of the use of the Section 4(f) programmatic evaluation, he or she notifies the ENV SME to discuss.



- 12. If the Director of ENV's Cultural Resources Section approves of the use of the Section 4(f) programmatic evaluation, he or she selects, "Approved no comments," from the "Review Results" field in the Review, finalizes the Review, and emails the ENV SME staff to let him or her know that the Section 4(f) programmatic evaluation is approved. The ENV SME uploads the checklist with all required attachments as a single packet under this Activity using the following file naming convention: "Approved HIST 4f CSJ (mo-yr)\_property name."
- **13.** If a Section 4(f) approval has been recorded for <u>all</u> parks, recreation areas, wildlife or waterfowl refuges, <u>and</u> historic sites listed in the "Comments" field of this Activity, then the ENV SME proceeds as indicated on page 26 below under "Finalizing this Activity."

#### Process for an individual Section 4(f) determination for an historic site

- 1. The ENV SME prepares an individual Section 4(f) evaluation using **ENV's Documentation Standard for an Individual Section 4(f) Evaluation**. Note that if the same property qualifies both as a park, recreation area, or wildlife or waterfowl refuge <u>and</u> an historic site, only one individual Section 4(f) evaluation needs to be prepared.
- 2. The ENV SME uploads the individual Section 4(f) evaluation with all attachments as a single packet under this Activity using the following file naming convention: "HIST 4f CSJ (moyr)\_property name."
- **3.** If project-specific mitigation requirements have been established as part of the Section 4(f) approval, then they will be tracked under one or more of the following Activities:
  - "Perform Historical Studies Mitigation"
  - "Perform Historical Studies Monitoring Commitments"
  - "Perform Archeology Data Recovery"
  - "Perform Archeology Mitigation"
  - "Perform Archeology Monitoring Commitments"

Therefore, there is no reason to create the "Perform Protected Lands Mitigation" Activity.

- **4.** The ENV SME creates a Review of the individual Section 4(f) evaluation and assigns it to the ENV SME. Once the ENV SME has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the individual Section 4(f) evaluation that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME.

If the ENV SME determines that a Section 4(f) exception, *de minimis* Section 4(f) determination, or programmatic Section 4(f) evaluation can be used for the project, then the ENV SME must start over with a new Section 4(f) approval type.

5. Once the ENV SME has no further comments and has finalized his or her Review, the ENV SME creates a Review of the individual Section 4(f) evaluation and assigns it to the Director of ENV's



Cultural Resources Section. Once the Director of ENV's Cultural Resources Section has finalized his or her Review, if there are pending comments, the ENV SME:

- prepares a new, revised version of the individual Section 4(f) evaluation that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the Director of ENV's Cultural Resources Section.
- 6. Once the Director of ENV's Cultural Resources Section staff has no further comments and has finalized his or her Review, the ENV SME emails the individual Section 4(f) evaluation to TxDOT's General Counsel Division (GCD) for review (this is <u>not</u> the formal legal sufficiency review that happens after the individual Section 4(f) evaluation has been coordinated as indicated below).
- 7. GCD reviews the individual Section 4(f) evaluation outside of ECOS, and provides its comments directly to the ENV SME. GCD's comments, response to GCD's comments, revisions to the individual Section 4(f) evaluation made in response to GCD's comments, and correspondence regarding GCD's comments and associated revisions and responses are not tracked in ECOS.
- 8. After GCD has completed its review, the ENV SME creates separate Coordinations for (1) the Department of the Interior and (2) the Texas Historical Commission/Texas State Historic Preservation Officer (THC/TSHPO) (and, if they may reasonably be expected to be interested in the property, the Advisory Council on Historic Preservation, the Department of Agriculture and/or the Department of Housing and Urban Development).
- **9.** The ENV SME follows the steps below to conduct the coordination for each entity with which the individual Section 4(f) evaluation is being coordinated:
  - The ENV SME prepares a cover letter referring to the individual Section 4(f) evaluation and requesting comments. For the Department of the Interior (and the Department of Agriculture and/or the Department of Housing and Urban Development, if applicable), the letter will state a comment receipt deadline of 30 days after receipt. For the official with jurisdiction, the letter will state a comment receipt deadline of 45 days after receipt.
  - The ENV SME signs the letter and mails or emails it and the individual Section 4(f) evaluation to the entity with which the individual Section 4(f) evaluation is being coordinated.
  - For the Department of the Interior, email the individual Section 4(f) evaluation and cover letter (via attachment or link) to the Department of the Interior's Office of Environmental Policy and Compliance (OEPC) using the following email address:
     <u>environmental\_review@ios.doi.gov</u>. It is not necessary to also mail a hard copy to the Department of the Interior. For more information on DOI's environmental review process and how and where to submit environmental documents for review, please see the revised submission guidelines for DOI Review of Non-Interior Environmental Documents available on the OEPC website at https://www.doi.gov/sites/doi.gov/files/doiexternal-environmental-review-feb-2022.pdf.
  - In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The



ENV SME fills-in the correspondence details for each letter sent to or from the entity with which the individual Section 4(f) evaluation is being coordinated.

- The ENV SME uploads each letter documenting decision-making to or from the entity with which the individual Section 4(f) evaluation is being coordinated.
- Once the entity with which the individual Section 4(f) evaluation is being coordinated has provided written comments, the ENV SME selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- If the Department of the Interior (and the Department of Agriculture and/or the Department of Housing and Urban Development, if applicable) does not respond within 45 days of the date the letter and individual Section 4(f) evaluation was emailed to it (or within 48 days if the letter and individual Section 4(f) evaluation was only mailed), then the ENV SME explains in the "Comments" field that no response was received within 45/48 days of the date the letter and Section 4(f) evaluation was sent; selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- If the official with jurisdiction does not respond within 60 days of the date the letter and individual Section 4(f) evaluation was emailed to it (or within 63 days if the letter and individual Section 4(f) evaluation was only mailed), then the ENV SME explains in the "Comments" field that no response was received within 60/63 days of the date the letter and Section 4(f) evaluation was sent; selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.
- **10.** The ENV SME amends the individual Section 4(f) evaluation to reflect the coordination.
- **11.** The ENV SME uploads the individual Section 4(f) evaluation under this Activity (again using the following file naming convention: "HIST 4f CSJ (mo-yr)\_property name") and creates a Review of the individual Section 4(f) evaluation, and assigns it to the ENV SME. Once the ENV SME has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the individual Section 4(f) evaluation that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME.
- **12.** Once the ENV SME has no further comments and has finalized his or her Review, the ENV SME creates a Review of the individual Section 4(f) evaluation and assigns it to the Director of ENV's Cultural Resources Section. Once the Director of ENV's Cultural Resources Section has finalized his or her Review, if there are pending comments, the ENV SME:
  - prepares a new, revised version of the individual Section 4(f) evaluation that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the Director of ENV's Cultural Resources Section.



- **13.** Once the Director of ENV's Cultural Resources Section staff has no further comments and has finalized his or her Review, the ENV SME emails the individual Section 4(f) evaluation to TxDOT's General Counsel Division (GCD) for legal sufficiency review.
- **14.** GCD reviews the individual Section 4(f) evaluation outside of ECOS, and provides its comments directly to the ENV SME. GCD's comments, response to GCD's comments, revisions to the individual Section 4(f) evaluation made in response to GCD's comments, and correspondence regarding GCD's comments and associated revisions and responses are not tracked in ECOS.
- **15.** The ENV SME uploads 1) the version of the individual Section 4(f) evaluation that was determined to be legally sufficient by GCD with the phrase, "GCD-approved," at the beginning of the file name; and 2) an email from GCD indicating that legal sufficiency review is complete and that the individual Section 4(f) evaluation is legally sufficient.
- **16.** The ENV SME provides the individual Section 4(f) evaluation to the ENV Director for his or her approval.
- **17.** If the ENV Director disapproves of the individual Section 4(f) evaluation, he or she notifies the ENV SME to discuss.
- 18. If the ENV Director approves of the individual Section 4(f) evaluation, he or she indicates approval by email, and the ENV SME uploads the individual Section 4(f) evaluation with all attachments as a single packet under this Activity using the following file naming convention: "Approved HIST 4f CSJ (mo-yr)\_property name." The ENV SME also uploads the ENV Director's email under this Activity.

#### Finalizing this "Obtain Section 4(f) Approval" Activity

- 1. ENV Project Delivery staff or the ENV SME, depending on which uploaded the "Approved" packet for the last remaining property in the "Comments" field requiring a Section 4(f) approval, does the following:
  - confirms that an approval has been recorded for <u>all</u> parks, recreation areas, wildlife or waterfowl refuges, <u>and</u> historic sites listed in the "Comments" field. If the same property is listed in the "Comments" field twice, once as a park, recreation area, or wildlife or waterfowl refuge, and once as an historic site, there must be separate approvals for each listing;
  - confirms that the Section 4(f) approval type listed for each property in the "Comments" field of this Activity matches the actual Section 4(f) approval made;
  - if the "Perform Section 4(f) Analysis" Activity has been created, confirms that it has been finalized; and
  - if the "Obtain Historical Studies Section 106/Antiquities Code of Texas (ACT) Approval" and "Obtain Archeology Section 106/Antiquities Code of Texas (ACT) Approval" Activities were created, confirms that they have been finalized.
- **2.** If all of the above-listed conditions are confirmed, then ENV Project Delivery staff or the ENV SME assigns this Activity to the ENV Deputy Director.



**3.** If the ENV Deputy Director agrees that all uses of Section 4(f) properties for the project have been approved, then the ENV Deputy Director finalizes this Activity.

## "Obtain Section 6(f) Approval" Activity

District environmental staff should be aware that the Section 6(f) process can be extremely lengthy due to the need to find suitable replacement property that must be approved by multiple agencies. For this reason, if there is <u>any</u> way to avoid using a Section 6(f) property, it should be strongly considered.

- 1. If it has not already done so, district environmental staff contacts the Texas Parks and Wildlife Department's Local Park Grants Coordinator to request a map showing the exact boundary of the property to confirm that the portion of the property impacted is, in fact, protected under Section 6(f) (i.e., the boundary of the property protected under Section 6(f) does not always match the current boundary of the park, refuge, etc).
- 2. District environmental staff determines if the project will temporarily or permanently convert any property protected under Section 6(f) of the Land and Water Conservation Fund Act to a use other than public outdoor recreation. Construction staging or storage areas count as a non-public outdoor recreation use. For more information, see the National Park Service's Land and Water Conservation Fund State Assistance Program Federal Financial Assistance Manual ("NPS Manual") (Chapter 8, Section F. of the March 11, 2021 version of the NPS Manual).

If <u>not</u>, then district environmental staff provides an explanation in the "Comments" field of this Activity, and finalizes this Activity.

If district environmental staff determines that the project <u>will</u> temporarily or permanently convert property protected under Section 6(f) to a use other than public outdoor recreation, <u>and</u> there is no practical alternative to such conversion, proceed as indicated below, depending on whether the non-public outdoor recreation use will be less than or greater than six months in duration, as explained below.

For a temporary use of less than six months, follow Steps 3-13 below.

For a permanent use or a temporary use of more than six months, follow Steps 14-36 below.

#### Temporary non-public outdoor recreation use of six months or less in duration

- **3.** As explained in the NPS Federal Financial Assistance Manual, a request for a temporary use of six months or less must be submitted to NPS prior to proceeding with the non-public outdoor recreation use.
- 4. District environmental staff works with the owner of the 6(f) property (e.g., the city or county) to prepare a written request for a determination by NPS that the temporary use does not qualify as a conversion. In preparing the written request, refer to the criteria that NPS will use to evaluate the request as listed in the NPS Manual, and include the required proposal documentation listed in the NPS Manual (Chapter 8, Section K of the March 11, 2021 version of the NPS Manual).
- **5.** District environmental staff uploads the written request and creates a Review of the written request and assigns it to the ENV Project Delivery staff assigned to the respective district. Once



the ENV Project Delivery staff has finalized his or her Review, if there are pending comments, the district environmental staff:

- prepares a new, revised version of the written request that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.
- **6.** Once the ENV Project Delivery staff has no further comments and has finalized his or her Review district environmental staff proceeds according to the coordination process explained below.

#### Coordination process for Temporary non-public outdoor recreation use of six months or less in duration

District environmental staff creates a Coordination under this Activity, and uploads all of the following documentation under the Coordination:

- The owner of the 6(f) property's (e.g., the city or county's) transmittal of the written request to the Land and Water Conservation Fund State Liaison Officer at TPWD
- The Land and Water Conservation Fund State Liaison Officer at TPWD's transmittal of the written request to the National Park Service
- The National Park Service's written approval of the written request

Follow the steps below to conduct the coordination.

- **7.** District environmental staff transmits the written request to owner of the 6(f) property (e.g., the city or county).
- **8.** The owner of the 6(f) property (e.g., the city or county) transmits the written request to the Land and Water Conservation Fund State Liaison Officer at TPWD.
- **9.** District environmental staff uploads the owner of the 6(f) property's transmittal of the written request to the Land and Water Conservation Fund State Liaison Officer at TPWD.
- **10.** The Land and Water Conservation Fund State Liaison Officer at TPWD transmits the written request to the National Park Service.
- **11.** District environmental staff uploads the Land and Water Conservation Fund State Liaison Officer at TPWD's transmittal of the written request to the National Park Service under the Coordination.
- **12.** The National Park Service issues a written approval of the written request.
- **13.** District environmental staff uploads the National Park Service's written approval of the written request under the Coordination.
- **14.** District environmental staff finalizes the Coordination.



### <u>Permanent non-public outdoor recreation use, or temporary non-public outdoor recreation use of</u> <u>more than six months in duration.</u>

- 1. As explained in the NPS Federal Financial Assistance Manual, continued use beyond six months is not considered temporary, but will result in a conversion of use. Therefore, for both permanent uses, and temporary uses longer than six months in duration, proceed as instructed below.
- 2. District environmental staff works with the owner of the 6(f) property (e.g., the city or county) to identify a property to be substituted for the Section 6(f) property that will be converted to a use other than outdoor recreation, in consideration of the criteria listed at 36 CFR 59.3(b) and the NPS Manual (Chapter 8, Section F of the March 11, 2021 version of the NPS Manual).
- **3.** District environmental staff works with the owner of the 6(f) property (e.g., the city or county) to prepare an informal written conversion proposal explaining how the proposed conversion satisfies the criteria listed at 36 CFR 59.3(b) and the NPS Manual (Chapter 8, Section F of the March 11, 2021 version of the NPS Manual) (to be used by the owner of the 6(f) property (e.g., the city or county) in proposing the conversion to TPWD, and ultimately, NPS, as explained below).
- 4. District environmental staff uploads the informal written conversion proposal and creates a Review and assigns it to the ENV Project Delivery staff assigned to the respective district. Once the ENV Project Delivery staff has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the informal written conversion proposal that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.
- **5.** Once the ENV Project Delivery staff has no further comments and has finalized his or her Review district environmental staff proceeds according to the coordination process explained below.

#### Coordination process for informal written conversion proposal

District environmental staff creates a Coordination under this Activity, and uploads all of the following documentation under the Coordination:

- The owner of the 6(f) property's (e.g., the city or county's) transmittal of the informal written conversion proposal to the Land and Water Conservation Fund State Liaison Officer at TPWD
- The Land and Water Conservation Fund State Liaison Officer at TPWD's transmittal of the informal written conversion proposal to the National Park Service
- The National Park Service's informal approval of the informal written conversion proposal

Follow the steps below to conduct the coordination.

**6.** District environmental staff transmits the informal written conversion proposal to the owner of the 6(f) property (e.g., the city or county).



- **7.** The owner of the 6(f) property (e.g., the city or county) transmits informal written conversion proposal to the Land and Water Conservation Fund State Liaison Officer at TPWD.
- **8.** District environmental staff uploads the owner of the 6(f) property's transmittal of the written conversion proposal to the Land and Water Conservation Fund State Liaison Officer at TPWD.
- **9.** The Land and Water Conservation Fund State Liaison Officer at TPWD transmits the informal written conversion proposal to the National Park Service.
- **10.** District environmental staff uploads the Land and Water Conservation Fund State Liaison Officer at TPWD's transmittal of the informal written conversion proposal to the National Park Service under the Coordination.
- **11.** The National Park Service issues an informal approval of the informal written conversion proposal.
- **12.** District environmental staff uploads the National Park Service's informal approval of the informal written conversion proposal under the Coordination.
- **13.** District environmental staff finalizes the Coordination.

#### Preparation of formal conversion proposal

- 14. District environmental staff works with the owner of the 6(f) property (e.g., the city or county) to prepare a formal conversion proposal that contains all of the documentation set forth in the NPS Manual (Chapter 8, Section F of the March 11, 2021 version of the NPS Manual). Note that one of the requirements is an "EA" document analyzing the entire conversion proposal. If the project is an EA or EIS project, the proposed conversion should be described in the EA or EIS, and so a separate EA should not be required. If the project is a CE, then it may be necessary to explain to NPS that because TxDOT has NEPA assignment, our CE determination for the project should suffice.
- **15.** District environmental staff uploads the formal conversion proposal and creates a Review and assigns it to the ENV Project Delivery staff assigned to the respective district. Once the ENV Project Delivery staff has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the formal conversion proposal that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV Project Delivery staff.
- **16.** Once the ENV Project Delivery staff has no further comments and has finalized his or her Review district environmental staff proceeds as explained below.
- **17.** <u>After</u> the project has been environmentally cleared (CE, FONSI, or ROD), and after all environmental permits for the project have been acquired (e.g., USACE permit under Section 404), district environmental staff proceeds with the coordination process set forth below. *See* the



NPS Manual (Chapter 8, Section F. of the March 11, 2021 version of the NPS Manual): "NPS final review of the State's proposal shall not occur until the NPS is assured all environmental review requirements for the other federal action have been met, e.g., Army Corps of Engineer permits."

#### Coordination process for formal conversion proposal

District environmental staff creates a Coordination under this Activity, and uploads all of the following documentation under the Coordination:

- The owner of the 6(f) property's (e.g., the city or county's) transmittal of the written conversion proposal to the Land and Water Conservation Fund State Liaison Officer at TPWD
- The Land and Water Conservation Fund State Liaison Officer at TPWD's transmittal of the written conversion proposal to the National Park Service
- The National Park Service's formal approval of the conversion proposal

Follow the steps below to conduct the coordination.

- **18.** District environmental staff transmits the formal conversion proposal to the owner of the 6(f) property (e.g., the city or county).
- **19.** The owner of the 6(f) property (e.g., the city or county) transmits the formal conversion proposal to the Land and Water Conservation Fund State Liaison Officer at TPWD.
- **20.** District environmental staff uploads the owner of the 6(f) property's transmittal of the formal written conversion proposal to the Land and Water Conservation Fund State Liaison Officer at TPWD.
- **21.** The Land and Water Conservation Fund State Liaison Officer at TPWD transmits the formal conversion proposal to the National Park Service.
- **22.** District environmental staff uploads the Land and Water Conservation Fund State Liaison Officer at TPWD's transmittal of the formal conversion proposal to the National Park Service under the Coordination.
- **23.** The National Park Service issues a written formal approval of the conversion proposal.
- **24.** District environmental staff uploads the National Park Service's written formal approval of the conversion proposal under the Coordination.
- **25.** District environmental staff finalizes the Coordination.

#### Finalizing this Activity

**26.** District environmental staff creates the "Perform Protected Lands Mitigation" Activity to track the acquisition and transfer of the substitution property to the entity that owns the Section 6(f) resource.



- **27.** District environmental staff assigns this Activity to the ENV Project Delivery staff assigned to the respective district.
- **28.** If the ENV Project Delivery staff agrees that the Section 6(f) requirements have been satisfied, he or she finalizes this Activity. Note that for a permanent or temporary use of longer than six months, this Activity will need to stay open through environmental clearance, because final formal coordination with NPS cannot occur until after environmental clearance.

## "Perform Chapter 26 Analysis" Activity

1. District environmental staff determines if the project will permanently convert any property protected under Chapter 26 of the Texas Parks and Wildlife Code from one type of use to another. If not, then there is no "use or taking" under Chapter 26, in which case District environmental staff provides an explanation in the "Comments" field of this Activity, and finalizes this Activity.

Note that the mere existence of a "use agreement" between TxDOT and the entity with jurisdiction over the Chapter 26 resource does not necessarily mean that there will be a permanent conversion of uses. If district environmental staff is uncertain as to whether a project will or will not represent a permanent conversion of use of the Chapter 26 resource, district environmental staff should contact the ENV SME assigned to the respective district.

(Note: If multiple properties protected by Chapter 26 will be affected by the project, but there will only be a "use or taking" with respect to one or some of those properties, provide an explanation for why there is no "use or taking" with respect to the others in the comments field of this Activity.)

**2.** If district environmental staff determines that the project will permanently convert property protected under Chapter 26 from one type of use to another, proceed as indicated below.

After a hearing is held in accordance with the requirements of Chapter 26, district environmental staff completes **ENV's Checklist: Parks and Wildlife Code, Chapter 26 Compliance,** and uploads it, including any applicable attachments, under this Activity.

- **3.** If project-specific mitigation requirements have been established as part of the Chapter 26 approval, then district environmental staff creates the "Perform Protected Lands Mitigation" Activity.
- **4.** District environmental staff assigns this Activity to the ENV core team member, or for a CE, the ENV Project Delivery staff assigned to the respective district.
- **5.** If the ENV core team member or ENV Project Delivery staff agrees that the Chapter 26 requirements have been satisfied, he or she uploads the approved version of the Chapter 26 checklist under this Activity with the word, "Approved," at the beginning of the file name; and finalizes this Activity.

## "Perform Protected Lands Mitigation" Activity

- 1. District environmental staff fills-in the "Comments" field with an explanation of any protected lands mitigation commitments for the project (i.e., mitigation required by Section 4(f) of the Department of Transportation Act of 1966, Section 6(f) of the Land and Water Conservation Act, or Chapter 26 of the Texas Parks and Wildlife Code).
- **2.** District environmental staff uploads any documentation associated with protected lands mitigation commitments for the project under this Activity.
- **3.** After all protected lands mitigation commitments for the project have been completed, district environmental staff finalizes this Activity.

Citation: 23 USC 138; 23 CFR 774; Texas Parks and Wildlife Code, Chapter 26; 36 CFR 59.3



# "Perform Section 4(f) Analysis" Activity

This Activity is used to determine whether the project will use any park, recreation area, or wildlife or waterfowl refuge protected by Section 4(f), and therefore will require a Section 4(f) approval (i.e., Section 4(f) exception, *de minimis* Section 4(f) determination, programmatic Section 4(f) determination, or individual Section 4(f) determination).

This Activity is <u>not</u> used to make any determinations regarding whether the project will use any historic site. (Determinations regarding whether the project will use any <u>historic</u> site are made by ENV SMEs in the course of completing other Activities specific to the Historic Resources and Archeology resource areas. Note that some properties may qualify as both a park, recreation area, or wildlife or waterfowl refuge <u>and</u> an historic site. The Activity Instructions for "Obtain Section 4(f) Approval" explain what happens when a property that will be used by the project is both a park, recreation area, or wildlife or waterfowl refuge <u>and</u> an historic site.)

#### Listing all parks, recreation areas, and wildlife or waterfowl refuges within or adjacent to the project area.

1. District environmental staff lists individual parks, recreation areas, and/or wildlife or waterfowl refuges in the "Comments" field of this Activity. Each park, recreation area, and/or wildlife or waterfowl refuge within or adjacent to the project area must be listed, <u>regardless of whether</u> <u>district environmental staff believes the property to be protected under Section 4(f) or will be subject to a "use."</u>

#### Determination of whether property is "public"

- 1. For each property, district environmental staff determines whether the property is "<u>publicly</u> owned land from a <u>public</u> park, recreation area or wildlife and waterfowl refuge." 23 USC 138. For guidance in making this determination see FHWA's Section 4(f) Policy Paper, July 20, 2012, Section II.1, "Identification of Section 4(f) Properties."
- 2. If the property is determined <u>not</u> to be a "<u>publicly</u> owned land from a <u>public</u> park, recreation area or wildlife and waterfowl refuge," district environmental staff explains in the "Comments" field how it was determined that the property is not "<u>publicly</u> owned land from a <u>public</u> park, recreation area or wildlife and waterfowl refuge."
- **3.** If the property <u>is</u> determined to be "<u>publicly</u> owned land from a <u>public</u> park, recreation area or wildlife and waterfowl refuge," continue to the next section.

#### Determination of whether property is of "national, State, or local significance"

- 1. For each property that is "<u>publicly</u> owned land from a <u>public</u> park, recreation area or wildlife and waterfowl refuge," district environmental staff determines whether the property is of "national, State, or local significance." For guidance in making this determination see FHWA's Section 4(f) Policy Paper, July 20, 2012, Section II.1, "Identification of Section 4(f) Properties."
- **2.** If district environmental staff believes that the property is <u>not</u> of "national, State, or local significance," district environmental staff requests a letter from the governmental entity that owns



or otherwise has jurisdiction over the property confirming that the property is not of "national, State, or local significance." The property may be considered as being not of "national, State, or local significance" <u>only</u> if the governmental entity that owns or otherwise has jurisdiction over the property agrees in writing.

- **3.** If the property is <u>not</u> "of national, State, or local significance," and the governmental entity that owns or otherwise has jurisdiction over the property has agreed in writing, then district environmental staff explains in the "Comments" field how it was determined that the property is not "of national, State, or local significance" including a reference to the date and author of the letter from the governmental entity that owns or otherwise has jurisdiction over the property, and uploads the letter from the governmental entity that owns or otherwise has jurisdiction over the property under this Activity.
- **4.** If the property <u>is</u> determined to be "of national, State, or local significance," continue to the next section.

#### Determination of whether property will be subject to a "use"

- 1. For each property that is "<u>publicly owned</u> land from a <u>public</u> park, recreation area or wildlife and waterfowl refuge <u>of national</u>, <u>State</u>, <u>or local significance</u>," district environmental staff determines whether the project would "use" the property. For purposes of this Activity, a "use" occurs when any of the following apply:
  - land is permanently incorporated into a transportation facility;
  - there is a temporary occupancy of land; or
  - there is a constructive use of a Section 4(f) property (see 23 CFR 774.15) (this is unusual and would require FHWA approval – see the TxDOT/FHWA NEPA assignment renewal MOU at Section 3.2.8).

Note that, even if one of the above conditions applies, it may be possible for the project to fall under a Section 4(f) exception, in which case, technically speaking, there is no "use" as defined in FHWA's rules – see 23 CFR 774.17. However, <u>for purposes of this Activity</u>, do <u>not</u> consider whether the project will fall under a Section 4(f) exception. Instead, just consider whether any of the three above-listed conditions applies. If so, there is a "use" <u>for purposes of this Activity</u>, and whether an exception applies will be determined under the "Obtain Section 4(f) Approval" Activity.

2. If the property is determined to <u>not</u> be subject to a "use" as defined by the three bullet points listed above, then district environmental staff explains in the "Comments" field how it was determined that the project will not "use" the property. The explanation must conclude with the following statement:

"No part of the property will be permanently incorporated into a transportation facility; there will be no temporary occupancy of any part of the property; and the project's proximity impacts are not so severe that the protected activities, features, or attributes that qualify the property for protection under Section 4(f) will not be substantially impaired (i.e., no constructive use)."



**3.** If the property <u>is</u> determined to be subject to a "use" as defined by the three bullet points listed above, then district environmental staff explains in the "Comments" field that a Section 4(f) approval is required for the property, and creates the "Obtain Section 4(f) Approval" Activity, unless it has already been created.

#### **Finalizing Activity**

1. After all parks, recreation areas, and wildlife or waterfowl refuges within or adjacent to the project area have been listed in the "Comments" field, and all required explanations have been added to the "Comments" field, district environmental staff finalizes this Activity.

## "Protected Lands SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of protected lands. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding protected lands, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding protected lands.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.



# *"Perform 139(I) Notice of Limitation on Claims for Judicial Review" Activity*

- **1.** During work plan development, district environmental staff assigns this Activity to the ENV project delivery staff assigned to the respective district.
- 2. Once a month, ENV Project Delivery Section Director uses the monthly list of NEPA assignment approvals and decisions that is submitted to FHWA to determine if any RODs, FONSIs, or openended (d)-list CE determinations were made during the month, and emails the ENV project delivery staff for the respective districts to request preparation of a project-specific insert for a batch 139(I) notice (ENV's Project Delivery Section Director includes a template for preparing the project-specific insert).
- **3.** ENV project delivery staff prepares a project-specific insert and emails it to the ENV Project Delivery Section Director.
- 4. On a quarterly basis, ENV Project Delivery Section Director prepares a batch 139(I) notice using the customized project-specific inserts provided by ENV project delivery staff and the most recent batch 139(I) notice as a template.

NOTE: Under certain circumstances, it may be determined that a 139(I) notice should be issued for an individual project sooner than would otherwise happen on the quarterly cycle.

- 5. ENV Project Delivery Section Director emails the draft batch Section 139(I) notice to the General Counsel Division (GCD) for legal sufficiency review, and provides at least three days for GCD to review. GCD's comments, response to GCD's comments, revisions to the batch Section 139(I) notice made in response to GCD's comments, and correspondence regarding GCD's comments and associated revisions and responses are not tracked in ECOS.
- 6. After GCD has provided an email indicating that the batch Section 139(I) notice is legally sufficient, ENV Project Delivery Section Director coordinates publication of the batch Section 139(I) notice in the Federal Register by emailing it to Mike Leary at FHWA and requesting that he arrange for it to be published in the Federal Register at its earliest convenience.
- 7. After the batch Section 139(I) notice has been published in the Federal Register, ENV Project Delivery Section Director emails a pdf of the Federal Register notice and the email documenting GCD's legal sufficiency determination to ENV project delivery staff.
- **8.** ENV project delivery staff uploads the pdf of the Federal Register notice and the email documenting GCD's legal sufficiency determination under this Activity, and finalizes this Activity.
- **9.** Note that this Activity is only automatically created for open-ended (d)-list CEs, EAs, and EISs for which the WPD I field, "Who is the lead agency responsible for the approval of the entire project?," is answered, "FHWA –Assigned to TxDOT." However, 139(I) notices may be published for other types of CE projects, and for CE, EA, or EIS projects for which the WPD I field, "Who is the lead agency responsible for the approval of the entire project?," is answered, "FHWA –Not



Assigned to TxDOT" (e.g., a project that crosses a state boundary). If a 139(I) notice is published and this Activity has not been automatically created, then the ENV SME assigned to the respective district must manually create this Activity in order to document the publication of the 139(I) notice.

## "Perform Additional Public Outreach" Activity

1. This Activity is used to document any additional, non-legally required outreach with members of the public such as small group meetings, telephone conferences, or emails with individuals or groups that the district environmental staff elects to include in the record for the environmental review process.

No formal documentation format is required for documenting any such additional outreach. Do <u>not</u> use ENV's Template: Documentation of Notice and Opportunity to Comment, ENV's Template: Documentation of Public Meeting, ENV's Template: Documentation of Public Hearing Opportunity, or ENV's Template: Documentation of Public Hearing.

This Activity is <u>not</u> used to document a required notice and opportunity to comment, public meeting, opportunity for public hearing, or public hearing.

- **2.** District environmental staff uploads any documentation of additional public outreach described above under this Activity.
- **3.** Once district environmental staff determines that further public outreach is not expected, district environmental staff then finalizes this Activity.



## "Perform Final EIS/ROD Notice of Availability (NOA)" Activity

The final EIS and ROD must be combined into one document, except in the following unusual circumstances:

- the final EIS makes substantial changes to the proposed action that are relevant to environmental or safety concerns; or
- there are significant new circumstances or information relevant to environmental concerns that bear on the proposed action or the impacts of the proposed action.

The process outlined immediately below is for the normal circumstance of a combined final EIS/ROD. Special instructions for the unusual circumstance of a separate final EIS and ROD are provided at the end of these Activity Instructions.

#### Combined final EIS/ROD

- 1. District environmental staff drafts the NOA of the final EIS/ROD using ENV's Template: FEIS/ROD Notice of Availability.
- **2.** District environmental staff:
  - emails the NOA to the ENV core team member, so that the ENV core team member can arrange for publication in the Texas or Federal Register as indicated below;
  - provides the NOA to the MPO (by U.S. Mail or email);
  - provides the NOA to affected public officials or federal, state, or local agencies or tribes (by U.S. Mail or email);
  - provides the NOA to any entities that have requested in writing to receive notices regarding the environmental review of the project (by U.S. Mail or email);
  - provides the NOA to any other entities with which environmental review of the project is being coordinated (by U.S. Mail or email), except that the NOA need not be provided to TCEQ, TPWD, or THC because TxDOT's MOUs with those agencies do not require it;
  - provides the NOA to any persons, organizations, or agencies that made substantive comments on the draft EIS or requested a copy (by U.S. Mail or email);
  - publishes the NOA in a local newspaper having general circulation in the area affected by the project (or if there is no local newspaper in the area affected by the project, the project sponsor publishes the NOA in any newspaper having general circulation in the area affected by the project);
  - as instructed by EPA's e-NEPA website, for an FHWA project, sends an electronic copy of the FEIS/ROD to Office of Communities, Tribes and Environmental Assessment, US EPA Region 6, 1201 Elm Street, Suite 500, Mail Code: ORACN, Dallas, TX 75270-2102 (check EPA's website to make sure this address is still correct); and
  - posts the NOA on the "Hearings, meetings and notices schedule" web page on txdot.gov (even if the project sponsor is a local government).
- **3.** District environmental staff uploads documentation of compliance with the above requirements under this Activity.



4. <u>For a state project</u>, the ENV core team member emails the NOA to the General Counsel Division for publication in the Texas Register, at least two weeks prior to the intended publication date. Once the notice has been published in the Texas Register, the ENV core team member notifies the district environmental staff that the notice has been published, and uploads the published notice under this Activity.

<u>For an FHWA project</u>, the ENV core team member uses e-NEPA to publish the NOA in the Federal Register. Once the notice has been published in the Federal Register, the ENV core team member notifies the district environmental staff that the notice has been published, and uploads the published notice under this Activity.

**5.** Once the district environmental staff has confirmed that all of the above requirements have been fulfilled, the district environmental staff finalizes this Activity.

#### Separate final EIS and ROD

In the unusual circumstance of a separate final EIS and ROD, there will be one NOA for the final EIS, and another NOA for the ROD.

#### Final EIS NOA

- District environmental staff drafts the NOA of the final EIS by modifying ENV's Template: FEIS/ROD Notice of Availability to refer only to the final EIS.
- **2.** District environmental staff and the ENV core team member complete Steps 2 through 5 above, with the only change being that the NOA is just for the final EIS, not a combined final EIS/ROD.

#### ROD NOA

- 1. District environmental staff creates a <u>new</u> "Perform Final EIS/ROD Notice of Availability (NOA)" Activity for the NOA for the ROD.
- District environmental staff drafts the NOA of the ROD by <u>modifying</u> ENV's Template: FEIS/ROD Notice of Availability to refer <u>only</u> to the ROD.
- **3.** District environmental staff:
  - provides the NOA to the MPO (by U.S. Mail or email);
  - provides the NOA to affected public officials or federal, state, or local agencies or tribes (by U.S. Mail or email);
  - provides the NOA to any entities that have requested in writing to receive notices regarding the environmental review (by U.S. Mail or email);
  - provides the NOA to any other entities with which environmental review of the project is being coordinated (by U.S. Mail or email), except that the NOA need not be provided to TCEQ, TPWD, or THC because TxDOT's MOUs with those agencies do not require it; and
  - posts the NOA on the "Hearings, meetings and notices schedule" web page on txdot.gov (even if the project sponsor is a local government).



**4.** District environmental staff uploads documentation of compliance with the above requirements under this Activity and finalizes this Activity.

# "Perform FONSI Notice of Availability (NOA)" Activity

- 1. District environmental staff drafts the NOA of the FONSI using ENV's Template: FONSI Notice of Availability.
- 2. District environmental staff:
  - provides the NOA to the MPO (by U.S. Mail or email);
  - provides the NOA to affected public officials or federal, state, or local agencies or tribes (by U.S. Mail or email);
  - provides the NOA to any entities that have requested in writing to receive notice regarding the environmental review (by U.S. Mail or email);
  - provides the NOA to any other entities with which environmental review of the project is being coordinated (by U.S. Mail or email), except that the NOA need not be provided to TCEQ, TPWD, or THC because TxDOT's MOUs with those agencies do not require it; and
  - posts the NOA on the "Hearings, meetings and notices schedule" web page on txdot.gov (even if the project sponsor is a local government).
- **3.** District environmental staff uploads documentation of compliance with the above requirements under this Activity, and finalizes this Activity.

### "Perform Notice and Opportunity to Comment" Activity

If a notice and opportunity to comment is not required per the Activity Instructions for "Perform Public Involvement Analysis," but the district environmental staff is conducting voluntary public outreach that is similar to a notice and opportunity to comment, then district environmental staff does not create this Activity, but rather creates the "Perform Additional Public Outreach" Activity.

For a required notice and opportunity to comment, proceed as instructed below.

- 1. NOTE: If a property owner has already transferred ownership of the property to the entity advancing the project (advance acquisition by TxDOT or a local government), or formally consented to acquisition of their property in writing (e.g., agreement, letter, etc.), then there is no need to issue a notice and opportunity to comment to that property owner. Explain in the "Comments" field of this Activity any such situation.
- District environmental staff prepares a written notification using ENV's Template: Notice and Opportunity to Comment informing the recipient of the project, and inviting the recipient to submit comments by a deadline specified in the notification.
- **3.** For an open-ended (d)-list CE, if the project is expected to require more than 30 acres of total new right-of-way or more than ten total displacements (residential and commercial), then district environmental staff emails the draft notice to the ENV project delivery manager assigned to their district for review to confirm that the open-ended (d)-list CE classification remains valid.
- 4. If the project would require acquisition of new right-of-way (including a temporary or permanent easement), district environmental staff provides the written notification to the owner or owners of real property that would be acquired for the project.
- **5.** If the project would involve either added capacity or construction of a highway at a new location, district environmental staff also provides the written notification to owners of real property that is adjacent to the project, and to affected local governments and public officials.
- 6. District environmental staff may provide the notification by U.S. Mail or email.

If the notification is provided by U.S. mail, the comment deadline specified in the notification must be at least 18 days after notification is mailed.

If the notification is provided by email, the comment deadline specified in the notification must be at least 15 days after the date of the email.

 After expiration of the comment deadline specified in the notification, district environmental staff prepares Documentation of Notice and Opportunity to Comment using ENV's Template: Documentation of Notice and Opportunity to Comment.

Note that email addresses for members of the public must be redacted from the documentation of notice and opportunity to comment that is uploaded to ECOS; original copies of emails or other



documents showing email addresses for members of the public must be retained by district environmental staff, but are not publicly posted or uploaded to ECOS.

- **8.** District environmental staff uploads the Documentation of Notice and Opportunity to Comment under this Activity.
- **9.** District environmental staff makes the comment/response matrix, or the responses contained therein, available to the commenters.
- **10.** District environmental staff finalizes this Activity.
- 11. If, as part of the environmental review process, the district environmental staff has conducted other outreach with members of the public such as meetings, telephone conferences, or emails with individuals or groups, and the district environmental staff intends for such outreach to be included as part of the environmental review process, then the district environmental staff creates the "Perform Additional Public Outreach" and uploads documentation of such outreach under that Activity.

# "Perform Notice of Availability (NOA) for Final EA listed at 23 CFR 771.115(a)" Activity

- 1. District environmental staff drafts the NOA of the Final EA using ENV's Template: Final EA Notice of Availability.
- **2.** District environmental staff:
  - provides the NOA to the MPO (by U.S. Mail or email);
  - provides the NOA to affected public officials or federal, state, or local agencies or tribes (by U.S. Mail or email);
  - provides the NOA to any entities that have requested in writing to receive notices regarding the environmental review (by U.S. Mail or email);
  - provides the NOA to any other entities with which environmental review of the project is being coordinated (by U.S. Mail or email), except that the NOA need not be provided to TCEQ, TPWD, or THC because TxDOT's MOUs with those agencies do not require it;
  - publishes the NOA in a local newspaper having general circulation in the area affected by the project (or if there is no local newspaper in the area affected by the project, the project sponsor publishes the NOA in any newspaper having general circulation in the area affected by the project); and
  - posts the NOA on the "Hearings, meetings and notices schedule" web page on txdot.gov (even if the project sponsor is a local government).
- **3.** District environmental staff uploads documentation of compliance with the above requirements under this Activity.
- **4.** District environmental staff finalizes this Activity.
- **5.** District environmental staff emails the ENV core team member when the 30-day period following issuance of the NOA of the Final EA has expired to request that the FONSI be signed.

# "Perform Opportunity for Public Hearing (OPH)/ Public Hearing (PH)" Activity

This Activity may be used for an Opportunity for Public Hearing or Public Hearing for a CE, EA, or EIS.

### CE PROJECT

#### Opportunity for Public Hearing for a CE project

- 1. District environmental staff prepares a notice of opportunity for public hearing using ENV's Template: Notice Affording an Opportunity for a Public Hearing.
- 2. For an open-ended (d)-list CE, if the project is expected to require more than 30 acres of total new right-of-way or more than ten total displacements (residential and commercial), then district environmental staff emails the draft notice to the ENV project delivery manager assigned to their district for review to confirm that the open-ended (d)-list CE classification remains valid.
- **3.** District environmental staff:
  - provides the notice to landowners abutting the roadway within the proposed project limits (by U.S. Mail or email);
  - provides the notice to affected local governments and public officials (by U.S. Mail or email);
  - provides the notice to any public official, individual, or affected interest group that has expressed interest in the project (by U.S. Mail or email);
  - publishes the notice in a local newspaper having general circulation in the area affected by the project (or if there is no local newspaper in the area affected by the project, district environmental staff publishes the notice in any newspaper having general circulation in the area affected by the project); and
  - provides notice to the public using at least one additional public outreach method.
- **4.** All notices required above must be provided or published at least 15 days prior to the deadline specified in the notice for requesting a hearing. For notices provided by U.S. Mail, the notice is considered to be provided on the third day after the date of mailing.
- **5.** District environmental staff determines whether a hearing is required.
  - If less than 10 requests for a hearing and no request for a hearing from an agency with jurisdiction is received by the deadline specified in the notice (which must be at least 15 days after the date the notice is provided), then no hearing is required.
  - If 10 or more requests for a hearing or if a request for a hearing from an agency with jurisdiction is received by the deadline specified in the notice, then a public hearing is required.
  - If the number of requests received exceeds 10 (but is not substantially more than 10), or if a request from an agency with jurisdiction is received, then district staff should contact the submitter(s) and discuss whether their concerns can be addressed without a hearing.



- Any submitted requests that are subsequently withdrawn in writing by the requester are not counted in determining whether a hearing is required, and the written withdrawal must be included in the documentation of opportunity for public hearing.
- 5. If a hearing <u>is</u> required, district environmental staff prepares the documentation of opportunity for public hearing using **ENV's Template: Documentation of Public Hearing Opportunity** (without the certification), and uploads the documentation of opportunity for public hearing under this Activity.

Note that email addresses for members of the public must be redacted from the documentation of opportunity for public hearing that is uploaded to ECOS; original copies of emails or other documents showing email addresses for members of the public must be retained by district environmental staff, but are not publicly posted or uploaded to ECOS.

District environmental staff proceeds as instructed below under "<u>Public Hearing for a CE</u> <u>Project</u>, and includes any written comments received in response to the noticed opportunity for public hearing in the documentation of public hearing.

6. If <u>no</u> hearing is required, district environmental staff prepares the documentation of opportunity for public hearing using **ENV's Template: Documentation of Public Hearing Opportunity**, and uploads the documentation of opportunity for public hearing under this Activity.

Note that email addresses for members of the public must be redacted from the documentation of opportunity for public hearing that is uploaded to ECOS; original copies of emails or other documents showing email addresses for members of the public must be retained by district environmental staff, but are not publicly posted or uploaded to ECOS.

- **7.** District environmental staff selects "OPH" from the drop-down responses for the "An OPH or PH was conducted" field.
- **8.** District environmental staff makes the comment/response matrix, or the responses contained therein, available to the commenters.
- **9.** District environmental staff finalizes this Activity.

#### Public Hearing for a CE project

1. If the hearing was triggered <u>solely</u> by the addition of bicycle lanes (i.e., none of the other hearing triggers were met), and the project was addressed in a local hearing held under 43 TAC 25.55, "Comment Solicitation on Bicycle Road Use," then district environmental staff adds a statement in the "Comments" field of this Activity indicating that the project was addressed in a local hearing held under 43 TAC 25.55 and the date of that local hearing, and finalize this Activity.

Otherwise, proceed as instructed below.

2. District environmental staff prepares a notice of public hearing using ENV's Template: Notice of a Virtual Public Hearing or ENV's Template: Notice of a Virtual Public Hearing with In-Person Option depending on which form of public hearing is appropriate.



- **3.** For an open-ended (d)-list CE, if the project is expected to require more than 30 acres of total new right-of-way or more than ten total displacements (residential and commercial), then district environmental staff emails the draft notice to the ENV project delivery manager assigned to their district for review to confirm that the open-ended (d)-list CE classification remains valid.
- 4. District environmental staff:
  - provides the notice to landowners abutting the roadway within the proposed project limits (by U.S. Mail or email);
  - provides the notice to affected local governments and public officials (by U.S. Mail or email);
  - provides the notice to any public official, individual, or affected interest group that has expressed interest in the project (by U.S. Mail or email);
  - publishes the notice in a local newspaper having general circulation in the area affected by the project (or if there is no local newspaper in the area affected by the project, district environmental staff publishes the notice in any newspaper having general circulation in the area affected by the project);
  - provides notice to the public using at least one additional public outreach method; and
  - posts the notice on the "Hearings, meetings and notices schedule" web page on txdot.gov (even if the project sponsor is a local government).
- **5.** All notices required above must be provided or published at least 15 days prior to the hearing. For notices provided by U.S. Mail, the notice is considered to be provided on the third day after the date of mailing.
- **6.** If the hearing is being held to satisfy Transportation Code, Section 203.021 (bypass of a municipality), then the following notice requirements must also be followed:
  - There must be an additional newspaper notice between 3 and 10 days prior to the hearing.
  - At least seven days before the date of the public hearing, district environmental staff provides the governing body of the county or municipality with the design and schematic layout of the project.
- 7. If the hearing is being held to satisfy Chapter 26 of the Parks and Wildlife Code (the taking of public land designated and used as a park, recreation area, wildlife refuge, historic site, or scientific area), then the following notice requirements must also be followed:
  - At least 30 days before the public hearing, district environmental staff provides the notice to the person, organization, department, or agency that has supervision of the land proposed to be used or taken.
  - Notice of the hearing also must be published in a newspaper once a week for three consecutive weeks, with the last day of publication not less than one week or more than two weeks before the date of the hearing. The newspaper must be one that is published at least six days a week.
- 8. For an open-ended (d)-list CE, if the project is expected to require more than 30 acres of total new right-of-way or more than ten total displacements (residential and commercial), then district environmental staff emails the anticipated hearing presentation materials to the ENV project



delivery manager assigned to their district for review to confirm that the open-ended (d)-list CE classification remains valid.

- 9. District environmental staff conducts the hearing in accordance with ENV's Environmental Handbook for Public Involvement.
- After the expiration of the comment period following the public hearing (at least 15 days), district environmental staff prepares the documentation of public hearing using ENV's Template:
   Documentation of Public Hearing, and uploads the documentation of public hearing under this Activity.

Note that email addresses for members of the public must be redacted from the documentation of public hearing that is uploaded to ECOS; original copies of sign-in sheets, emails, or other documents showing email addresses for members of the public must be retained by district environmental staff, but are not publicly posted or uploaded to ECOS.

- **11.** District environmental staff:
  - selects "PH" from the drop-down responses for the "An OPH or PH was conducted" field;
  - selects the date of the public hearing in the "Date of PH" field (either the date the virtual hearing went live or the date of the in-person option, whichever was later);
  - fills-in the "Total number of attendees for the PH" field with the number indicated on the cover of the Public Hearing Documentation;
  - selects "N/A" from the drop-down responses for the "This PH addressed Texas PWC Chapter 26 requirements" field if the requirements of Chapter 26 of the Texas Parks and Wildlife Code are <u>not</u> triggered by the project;
  - selects "Yes" from the drop-down responses for the "This PH addressed Texas PWC Chapter 26 requirements" field if the requirements of Chapter 26 of the Texas Parks and Wildlife Code are triggered by the project, and if the public hearing was noticed and held in accordance with the requirements of Chapter 26 of the Texas Parks and Wildlife Code (e.g., weekly newspaper notices for three consecutive weeks);
  - selects "No" from the from the drop-down responses for the "This PH addressed Texas PWC Chapter 26 requirements" field if the requirements of Chapter 26 of the Texas Parks and Wildlife Code are triggered by the project, and if the public hearing was not noticed and held in accordance with the requirements of Chapter 26 of the Texas Parks and Wildlife Code (in which case a separate public hearing must be held by either TxDOT or the relevant local government in order to satisfy Chapter 26).
- **12.** District environmental staff makes the comment/response matrix, or the responses contained therein, available to the commenters.
- **13.** District environmental staff finalizes this Activity.

### EA PROJECT

Determination of whether a public hearing will be held, or whether an opportunity for a public hearing will be afforded



- **1.** District environmental staff determines whether any of the following conditions apply. If any of these conditions apply then a public hearing is required:
  - Ten or more individuals submit a written request for a hearing, or an agency with jurisdiction over the project submits a written request for a hearing that is supported by reasons why a hearing will be helpful. However, a public hearing is not required if:
    - $\circ$   $\,$  a public hearing was held concerning the project before the requests are received,
    - the hearing request(s) are received after the environmental review document or CE determination for the project is approved
    - the hearing request(s) are received after the deadline specified in an notice affording an opportunity for a public hearing, or
    - $\circ~$  district environmental staff has addressed all of the concerns of the agency or persons requesting the hearing.
  - The project involves substantial public interest or controversy
  - The project substantially changes the layout or function of a connecting roadway or an existing facility, including the addition of managed lanes, high-occupancy vehicle lanes, bicycle lanes, bus lanes, and transit lanes
  - TxDOT determines it is in the public interest
  - The project bypasses a municipality (see Transportation Code, Section 203.021)
  - The project requires the taking of public land designated and used as a park, recreation area, wildlife refuge, historic site, or scientific area, as covered under Chapter 26 of the Texas Parks and Wildlife Code
  - The project requires the use or taking of private land encumbered by an agricultural conservation easement purchased under Chapter 84 of the Parks and Wildlife Code

If <u>none</u> of these conditions apply, then district environmental staff may proceed with affording an opportunity for a public hearing.

#### Opportunity for Public Hearing for an EA project

- 1. District environmental staff prepares a <u>combined</u> notice of opportunity for public hearing/notice of availability (NOA) of the draft EA using ENV's Template: Draft EA Notice of Availability and Opportunity for Public Hearing.
- 2. District environmental staff distributes the <u>combined</u> notice as indicated below (the requirements are organized by those applicable to an NOA and those applicable to an OPH notice, but the <u>combined</u> notice must meet <u>all</u> of the requirements listed below):

NOA requirements:

- provides the notice to the appropriate metropolitan planning organization (by U.S. Mail or email);
- provides the notice to any other affected public officials or federal, state, or local agencies or tribes (by U.S. Mail or email);
- provides the notice to any entities that <u>requested in writing</u> to receive notices regarding the environmental review of the project (by U.S. Mail or email);
- provides the notice to any other entities with which environmental review of the project is being coordinated, except that if the project is being coordinated under a memorandum of



understanding, the terms of the memorandum of understanding govern the provision of notice (by U.S. Mail or email);

- provides the notice to TCEQ by emailing it to the following email address: NEPA@tceq.texas.gov (subject line: "Draft environmental assessment for a highway project", body of email: "Attached please find a Notice of Availability of a DRAFT environmental assessment for a highway project.");
- provides the notice to TPWD by emailing it to the following email address: <u>WHAB\_TxDOT@tpwd.texas.gov</u> (see the TPWD coordination section of the "Perform Species Analysis" Activity Instructions for more information about the body of the email to TPWD);

OPH notice requirements:

- provides the notice to landowners abutting the roadway within the proposed project limits (by U.S. Mail or email);
- provides the notice to affected local governments and public officials (by U.S. Mail or email);
- provides the notice to any public official, individual, or affected interest group that has expressed interest in the project (by U.S. Mail or email);
- publishes the notice in a local newspaper having general circulation in the area affected by the project (or if there is no local newspaper in the area affected by the project, district environmental staff publishes the notice in any newspaper having general circulation in the area affected by the project); and
- provides notice to the public using at least one additional public outreach method.
- **3.** All notices required above must be provided or published at least 30 days prior to the deadline specified in the notice for requesting a hearing. For notices provided by U.S. Mail, the notice is considered to be provided on the third day after the date of mailing.
- **4.** District environmental staff determines whether a hearing is required.
  - If less than 10 requests for a hearing and no request for a hearing from an agency with jurisdiction is received by the deadline specified in the notice (which must be at least 30 days after the date the notice is provided), then no hearing is required.
  - If 10 or more requests for a hearing or if a request for a hearing from an agency with jurisdiction is received by the deadline specified in the notice, then a public hearing is required.
  - If the number of requests received exceeds 10 (but is not substantially more than 10), or if a request from an agency with jurisdiction is received, then district staff should contact the submitter(s) and discuss whether their concerns can be addressed without a hearing.
  - Any submitted requests that are subsequently withdrawn in writing by the requester are not counted in determining whether a hearing is required, and the written withdrawal must be included in the documentation of opportunity for public hearing.
- 5. If a hearing <u>is</u> required, district environmental staff prepares the documentation of opportunity for public hearing using **ENV's Template: Documentation of Public Hearing Opportunity** (without the certification), and uploads the documentation of opportunity for public hearing under this Activity.



Note that email addresses for members of the public must be redacted from the documentation of opportunity for public hearing that is uploaded to ECOS; original copies of emails or other documents showing email addresses for members of the public must be retained by district environmental staff, but are not publicly posted or uploaded to ECOS.

District environmental staff proceeds as instructed below under "<u>Public Hearing for an EA</u> <u>Project</u>," and includes any written comments received in response to the noticed opportunity for public hearing in the documentation of public hearing.

6. If <u>no</u> hearing is required, district environmental staff prepares the documentation of opportunity for public hearing using **ENV's Template: Documentation of Public Hearing Opportunity**, and uploads the documentation of opportunity for public hearing under this Activity.

Note that email addresses for members of the public must be redacted from the documentation of opportunity for public hearing that is uploaded to ECOS; original copies of emails or other documents showing email addresses for members of the public must be retained by district environmental staff, but are not publicly posted or uploaded to ECOS.

- 7. District environmental staff creates a Review of the documentation of opportunity for public hearing under this Activity and assigns it to the ENV core team member. Once the ENV core team member has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the documentation of opportunity for public hearing that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV core team member.
- 8. Once the ENV core team member has no further comments and has finalized his or her Review, district environmental staff uploads the documentation of opportunity for public hearing under this Activity with the word, "Approved," at the beginning of the file name.
- **9.** District environmental staff selects "OPH" from the drop-down responses for the "An OPH or PH was conducted" field and finalizes this Activity.

#### Public Hearing for an EA project

1. If the hearing was triggered <u>solely</u> by the addition of bicycle lanes (i.e., none of the other hearing triggers were met), and the project was addressed in a local hearing held under 43 TAC 25.55, "Comment Solicitation on Bicycle Road Use," then add a statement in the "Comments" field of this Activity indicating that the project was addressed in a local hearing held under 43 TAC 25.55 and the date of that local hearing, and finalize this Activity.

Otherwise, proceed as instructed below.

2. District environmental staff prepares a <u>combined</u> notice of public hearing/notice of availability (NOA) of the draft EA using ENV's Template: Draft EA Notice of Availability and Virtual



Public Hearing or ENV's Template: Draft EA Notice of Availability and Virtual Public Hearing with In-Person Option, depending on which form of public hearing is appropriate.

**3.** District environmental staff distributes the <u>combined</u> notice as indicated below (the requirements are organized by those applicable to an NOA and those applicable to a PH notice, but the <u>combined</u> notice must meet <u>all</u> of the requirements listed below):

NOA requirements:

- provides the notice to the appropriate metropolitan planning organization (by U.S. Mail or email);
- provides the notice to any other affected public officials or federal, state, or local agencies or tribes (by U.S. Mail or email);
- provides the notice to any entities that <u>requested in writing</u> to receive notices regarding the environmental review of the project (by U.S. Mail or email);
- provides the notice to any other entities with which environmental review of the project is being coordinated, except that if the project is being coordinated under a memorandum of understanding, the terms of the memorandum of understanding govern the provision of notice (by U.S. Mail or email);
- provides the notice to TCEQ by emailing it to the following email address: NEPA@tceq.texas.gov (subject line: "Draft environmental assessment for a highway project", body of email: "Attached please find a Notice of Availability of a DRAFT environmental assessment for a highway project.");
- provides the notice to TPWD by emailing it to the following email address: <u>WHAB\_TxDOT@tpwd.texas.gov</u> (see the TPWD coordination section of the "Perform Species Analysis" Activity Instructions for more information about the body of the email to TPWD);

Public hearing notice requirements:

- provides the notice to landowners abutting the roadway within the proposed project limits (by U.S. Mail or email);
- provides the notice to affected local governments and public officials (by U.S. Mail or email);
- provides the notice to any public official, individual, or affected interest group that has expressed interest in the project (by U.S. Mail or email);
- publishes the notice in a local newspaper having general circulation in the area affected by the project (or if there is no local newspaper in the area affected by the project, district environmental staff publishes the notice in any newspaper having general circulation in the area affected by the project);
- provides notice to the public using at least one additional public outreach method; and
- posts the notice on the "Hearings, meetings and notices schedule" web page on txdot.gov (even if the project sponsor is a local government).
- **4.** All notices required above must be provided or published at least 15 days prior to the hearing. For notices provided by U.S. Mail, the notice is considered to be provided on the third day after the date of mailing.



- **5.** If the hearing is being held to satisfy Transportation Code, Section 203.021 (bypass of a municipality), then the following notice requirements must also be followed:
  - There must be an additional newspaper notice between 3 and 10 days prior to the hearing.
  - At least seven days before the date of the public hearing, district environmental staff provides the governing body of the county or municipality with the design and schematic layout of the project.
- 6. If the hearing is being held to satisfy Chapter 26 of the Parks and Wildlife Code (the taking of public land designated and used as a park, recreation area, wildlife refuge, historic site, or scientific area), then the following notice requirements must also be followed:
  - At least 30 days before the public hearing, district environmental staff provides the notice to the person, organization, department, or agency that has supervision of the land proposed to be used or taken.
  - Notice of the hearing also must be published in a newspaper once a week for three consecutive weeks, with the last day of publication not less than one week or more than two weeks before the date of the hearing. The newspaper must be one that is published at least six days a week.
- 7. District environmental staff conducts the hearing in accordance with ENV's Environmental Handbook for Public Involvement.
- After the expiration of the comment period following the public hearing (at least 15 days), district environmental staff prepares the documentation of public hearing using ENV's Template:
   Documentation of Public Hearing, and uploads the documentation of public hearing under this Activity.

Note that email addresses for members of the public must be redacted from the documentation of public hearing that is uploaded to ECOS; original copies of sign-in sheets, emails, or other documents showing email addresses for members of the public must be retained by district environmental staff, but are not publicly posted or uploaded to ECOS.

- **9.** District environmental staff creates a Review of the public hearing documentation under this Activity and assigns it to the ENV core team member. Once the ENV core team member has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the public hearing documentation that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV core team member.
- **10.** Once the ENV core team member has no further comments and has finalized his or her Review, district environmental staff uploads the public hearing documentation under this Activity with the word, "Approved," at the beginning of the file name.
- **11.** District environmental staff:
  - selects "PH" from the drop-down responses for the "An OPH or PH was conducted" field;



- selects the date of the public hearing in the "Date of PH" field (either the date the virtual hearing went live or the date of the in-person option, whichever was later);
- fills-in the "Total number of attendees for the PH" field with the number indicated on the cover of the Public Hearing Documentation;
- selects "N/A" from the drop-down responses for the "This PH addressed Texas PWC Chapter 26 requirements" field if the requirements of Chapter 26 of the Texas Parks and Wildlife Code are <u>not</u> triggered by the project;
- selects "Yes" from the drop-down responses for the "This PH addressed Texas PWC Chapter 26 requirements" field if the requirements of Chapter 26 of the Texas Parks and Wildlife Code <u>are</u> triggered by the project, <u>and</u> if the public hearing <u>was</u> noticed and held in accordance with the requirements of Chapter 26 of the Texas Parks and Wildlife Code (e.g., weekly newspaper notices for three consecutive weeks);
- selects "No" from the from the drop-down responses for the "This PH addressed Texas PWC Chapter 26 requirements" field if the requirements of Chapter 26 of the Texas Parks and Wildlife Code are triggered by the project, and if the public hearing was not noticed and held in accordance with the requirements of Chapter 26 of the Texas Parks and Wildlife Code (in which case a separate public hearing must be held by either TxDOT or the relevant local government in order to satisfy Chapter 26); and
- finalizes this Activity.

#### **EIS PROJECTS**

#### Public Hearing for an EIS project

- District environmental staff prepares a combined notice of public hearing/notice of availability (NOA) of the draft EIS using ENV's Template: Draft EIS Notice of Availability and Virtual Public Hearing or ENV's Template: Draft EIS Notice of Availability and Virtual Public Hearing with In-Person Option, depending on which form of public hearing is appropriate.
- 2. District environmental staff distributes the <u>combined</u> notice as indicated below (the requirements are organized by those applicable to an NOA (generally), those specifically applicable to an EIS NOA, and those applicable to a PH notice, but the <u>combined</u> notice must meet <u>all</u> of the requirements listed below).

Note that, for an FHWA project, the ENV core team member must also electronically file the DEIS with EPA and arrange for a notice of availability to be published in the Federal Register via the e-NEPA website. The e-NEPA website includes a "note to submitters" indicating "*Copies of the EIS must be mailed to your distribution list prior to submittal of the EIS using e-NEPA. A federal agency must submit the EIS to the appropriate EPA regional office no later than the date that agency files and submits the EIS in e-NEPA. EISs should be sent to the EPA region where the project is located. EPA will not publish your EIS in the weekly Federal Register Notice of Availability if the distribution has not occurred.*" Therefore, all required emails/mail-outs described in the bullet points below must occur before the ENV core team member can upload the EIS to e-NEPA and request that a notice of availability be published in e-NEPA (the newspaper notices and additional public outreach notices can occur after).

### NOA requirements:



- provides the notice to the appropriate metropolitan planning organization (by U.S. Mail or email);
- provides the notice to any other affected public officials or federal, state, or local agencies or tribes (by U.S. Mail or email);
- provides the notice to any entities that <u>requested in writing</u> to receive notices regarding the environmental review of the project (by U.S. Mail or email);
- provides the notice to any other entities with which environmental review of the project is being coordinated, except that if the project is being coordinated under a memorandum of understanding, the terms of the memorandum of understanding govern the provision of notice (by U.S. Mail or email);
- provides the notice to TCEQ by emailing it to the following email address: NEPA@tceq.texas.gov (subject line: "Draft environmental impact statement for a highway project", body of email: "Attached please find a Notice of Availability of a DRAFT environmental impact statement for a highway project.");
- provides the notice to TPWD by emailing it to the following email address: <u>WHAB\_TxDOT@tpwd.texas.gov</u> (see the TPWD coordination section of the "Perform Species Analysis" Activity Instructions for more information about the body of the email to TPWD);

EIS-specific NOA requirements:

- provides the notice to public officials, interest groups, and members of the public known to have an interest in the proposed action of the DEIS;
- provides the notice to any state and federal land management entities that may be significantly affected by the proposed action or any of the alternatives (by U.S. Mail or email);
- provides the notice to any tribal agencies that are known to have interest in the project;
- as instructed by EPA's e-NEPA website, for an FHWA project, sends an electronic copy of the DEIS to Office of Communities, Tribes and Environmental Assessment, US EPA Region 6, 1201 Elm Street, Suite 500, Mail Code: ORACN, Dallas, TX 75270-2102. (check EPA's website to make sure this address is still correct);
- if the project is a state (i.e., non-FHWA project), emails the notice to the ENV core team member, so that the ENV core team member can arrange for publication in the Texas Register.

Public hearing notice requirements:

- provides the notice to landowners abutting the roadway within the proposed project limits (by U.S. Mail or email);
- provides the notice to affected local governments and public officials (by U.S. Mail or email);
- provides the notice to any public official, individual, or affected interest group that has expressed interest in the project (by U.S. Mail or email);
- publishes the notice in a local newspaper having general circulation in the area affected by the project (or if there is no local newspaper in the area affected by the project, district environmental staff publishes the notice in any newspaper having general circulation in the area affected by the project);
- provides notice to the public using at least one additional public outreach method; and



- posts the notice on the "Hearings, meetings and notices schedule" web page on txdot.gov (even if the project sponsor is a local government).
- **3.** All notices required above must be provided or published at least 15 days prior to the hearing. For notices provided by U.S. Mail, the notice is considered to be provided on the third day after the date of mailing.
- **4.** If the hearing is being held to satisfy Transportation Code, Section 203.021 (bypass of a municipality), then the following notice requirements must also be followed:
  - There must be an additional newspaper notice between 3 and 10 days prior to the hearing.
  - At least seven days before the date of the public hearing, district environmental staff provides the governing body of the county or municipality with the design and schematic layout of the project.
- **5.** If the hearing is being held to satisfy Chapter 26 of the Parks and Wildlife Code (the taking of public land designated and used as a park, recreation area, wildlife refuge, historic site, or scientific area), then the following notice requirements must also be followed:
  - At least 30 days before the public hearing, district environmental staff provides the notice to the person, organization, department, or agency that has supervision of the land proposed to be used or taken.
  - Notice of the hearing also must be published in a newspaper once a week for three consecutive weeks, with the last day of publication not less than one week or more than two weeks before the date of the hearing. The newspaper must be one that is published at least six days a week.
- 6. For a state project, the ENV core team member submits the combined hearing notice/NOA to the General Counsel Division for publication in the Texas Register at least two weeks prior to the intended publication date. The combined hearing notice/NOA in the Texas Register must specify a comment deadline that is both 15 days after the hearing and 45 days after publication of the notice in the Texas Register. Once the notice has been published in the Texas Register, ENV core team member fills-in the "Date of Publication in the Texas or Federal Register" field in this Activity, and notifies the district environmental staff that the notice has been published. District environmental staff includes documentation of compliance with the above requirement in the documentation of public hearing.
- 7. As mentioned earlier at the beginning of Step 2, for an FHWA project, ENV core team member uses e-NEPA to publish a notice of availability of the DEIS in the Federal Register (specifying a comment deadline that is both 15 days after the hearing and 45 days after publication of the notice in the Federal Register). After the notice has been published, the ENV core team member fills-in the "Date of Publication in the Texas or Federal Register" field in this Activity, and uploads the published notice under this Activity.
- 8. District environmental staff conducts the hearing in accordance with ENV's Environmental Handbook for Public Involvement.
- **9.** After the public hearing comment period expires (which is on a date that is both 15 days after the hearing and 45 days after the notice of availability in the Federal Register, or for a state project,



the Texas Register), district environmental staff prepares the documentation of public hearing using **ENV's Template: Documentation of Public Hearing**, and uploads the documentation of public hearing under this Activity.

Note that email addresses for members of the public must be redacted from the documentation of public hearing that is uploaded to ECOS; original copies of sign-in sheets, emails, or other documents showing email addresses for members of the public must be retained by district environmental staff, but are not publicly posted or uploaded to ECOS.

- **10.** District environmental staff creates a Review of the public hearing documentation under this Activity and assigns it to the ENV core team member. Once the ENV core team member has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the public hearing documentation that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV core team member.
- **11.** Once the ENV core team member has no further comments and has finalized his or her Review, district environmental staff uploads the public hearing documentation under this Activity with the word, "Approved," at the beginning of the file name.
- 12. <u>Positive, Negative, or Neutral Public Comments Report.</u>
  - District environmental staff prepares this report using ENV's Template EIS Positive, Negative, or Neutral Public Comments Report. For guidance on tallying positive, negative, or neutral comments see Section 4.4 in ENV's Guidance – Public Meetings and Public Hearings Comment/Response Matrix.
  - District environmental staff emails the draft report to the ENV core team member.
  - ENV core team member reviews the draft report for consistency with the comment/response matrix prepared for the public hearing.
  - ENV core team member emails the report to the ENV Division Director.
  - ENV Division Director arranges for the report to be added to the agenda for the Commission's upcoming December meeting, and presents the report at the Commission December meeting (ENV will already have an item on the December meeting agenda which is the semi-annual report regarding compliance with Transportation Code Chapter 201, Subchapter I-1).
  - After the December Commission meeting, ENV core team member requests that the ENV Web Coordinator arrange for the report to be posted on txdot.gov.
- **13.** District environmental staff:
  - selects "PH" from the drop-down responses for the "An OPH or PH was conducted" field;
  - selects the date of the public hearing in the "Date of PH" field (either the date the virtual hearing went live or the date of the in-person option, whichever was later);
  - fills-in the "Total number of attendees for the PH" field with the number indicated on the cover of the Public Hearing Documentation;



- selects "N/A" from the drop-down responses for the "This PH addressed Texas PWC Chapter 26 requirements" field if the requirements of Chapter 26 of the Texas Parks and Wildlife Code are <u>not</u> triggered by the project;
- selects "Yes" from the drop-down responses for the "This PH addressed Texas PWC Chapter 26 requirements" field if the requirements of Chapter 26 of the Texas Parks and Wildlife Code <u>are</u> triggered by the project, <u>and</u> if the public hearing <u>was</u> noticed and held in accordance with the requirements of Chapter 26 of the Texas Parks and Wildlife Code (e.g., weekly newspaper notices for three consecutive weeks);
- selects "No" from the from the drop-down responses for the "This PH addressed Texas PWC Chapter 26 requirements" field if the requirements of Chapter 26 of the Texas Parks and Wildlife Code are triggered by the project, and if the public hearing was not noticed and held in accordance with the requirements of Chapter 26 of the Texas Parks and Wildlife Code (in which case a separate public hearing must be held by either TxDOT or the relevant local government in order to satisfy Chapter 26); and
- finalizes this Activity.

## "Perform Public Involvement Analysis" Activity

- **1.** District environmental staff determines whether the project involves <u>any</u> of the following conditions requiring a public hearing:
  - Ten or more individuals submit a written request for a hearing, or an agency with jurisdiction over the project submits a written request for a hearing that is supported by reasons why a hearing will be helpful. However, a public hearing is not required if:
    - $\circ$   $\,$  a public hearing was held concerning the project before the requests are received,
    - the hearing request(s) are received after the environmental review document or CE determination for the project is approved,
    - the hearing request(s) are received after the deadline specified in a notice affording an opportunity for a public hearing, or
    - district environmental staff has addressed all of the concerns of the agency or persons requesting the hearing.
  - The project involves substantial public interest or controversy
  - The project is the subject of an environmental impact statement
  - The project substantially changes the layout or function of a connecting roadway or an existing facility, including the addition of managed lanes, high-occupancy vehicle lanes, bicycle lanes, bus lanes, and transit lanes
  - TxDOT determines it is in the public interest
  - The project bypasses a municipality (see Transportation Code, Section 203.021)
  - The project requires the taking of public land designated and used as a park, recreation area, wildlife refuge, historic site, or scientific area, as covered under Chapter 26 of the Texas Parks and Wildlife Code
  - The project requires the use or taking of private land encumbered by an agricultural conservation easement purchased under Chapter 84 of the Parks and Wildlife Code.

If <u>any</u> of these conditions apply, a public hearing is required; therefore, district environmental staff:

- explains in the "Comments" field of this Activity which condition(s) requiring a public hearing apply;
- finalizes this Activity; and
- creates the "Perform Opportunity for Public Hearing (OPH)/Public Hearing (PH)" Activity.

If none of these conditions apply, proceed to #2 below.

- **2.** District environmental staff determines whether the project involves <u>any</u> of the following conditions requiring an <u>opportunity</u> for public hearing:
  - The project requires the acquisition of significant amounts of right-of-way
  - The project has a substantial adverse impact on or abutting real property
  - The project is the subject of an environmental assessment



If <u>any</u> of these conditions apply, an opportunity for a public hearing is required; therefore, district environmental staff:

- explains in the "Comments" field of this Activity which condition(s) requiring an opportunity for public hearing apply;
- finalizes this Activity; and
- creates the "Perform Opportunity for Public Hearing (OPH)/Public Hearing (PH)" Activity."
- NOTE: The district environmental staff may determine to hold a public hearing for the project rather than merely affording the opportunity for one, in which case district environmental staff:
  - explains in the "Comments" field of this Activity which condition(s) requiring an opportunity for public hearing apply, and explains that a hearing will be held;
  - o finalizes this Activity; and
  - creates the "Perform Opportunity for Public Hearing (OPH)/Public Hearing (PH)" Activity.

If the project does not require a public hearing or opportunity for public hearing, proceed to #3 below.

- **3.** District environmental staff determines whether the project involves <u>any</u> of the following conditions:
  - Acquisition of new right-of-way, new permanent easement, or new temporary easement (a license does not count)
  - Added capacity
  - Construction of a highway at a new location

If <u>any</u> of these conditions apply, a notice and opportunity to comment is required; therefore, district environmental staff:

- explains in the "Comments" field of this Activity which condition(s) requiring a notice and opportunity to comment apply;
- finalizes this Activity; and
- creates the "Perform Notice and Opportunity to Comment" Activity.
- NOTE: The district environmental staff may determine to hold a public meeting, afford an opportunity for public hearing, or hold a public hearing rather than merely providing a notice and opportunity to comment, in which case district environmental staff:
  - explains in the "Comments" field of this Activity which condition(s) requiring a notice and opportunity to comment apply, and explains that a meeting, opportunity for hearing, or hearing will instead be held/afforded;
  - finalizes this Activity; and
  - creates the "Perform Public Meeting" Activity or "Perform Opportunity for Public Hearing (OPH)/Public Hearing (PH)" Activity," as appropriate.
- **4.** In addition to the three required forms of public involvement discussed above, district environmental staff may, at their discretion, determine to also hold a public meeting, or conduct other types of outreach (such as small group meetings, telephone conferences, or emails with individuals or groups).



If district environmental staff decides to also hold a public meeting, then district environmental staff creates the "Perform Public Meeting" Activity and follows the instructions for that Activity.

If district environmental staff decides to conduct other types of outreach (such as small group meetings, telephone conferences, or emails with individuals or groups), then district environmental staff creates the "Perform Additional Public Outreach" Activity and follows the instructions for that Activity.

Citation: 43 TAC 2.104, 2.105, 2.106, & 2.107; and 23 CFR 771.111(h)



### "Perform Public Meeting (PM)" Activity

1. If a district holds a meeting with certain groups or people (e.g., affected property owners), but does not intend to hold a public meeting that is advertised to the public at-large and held in accordance with **ENV's Public Involvement Handbook**, then district environmental staff does not create this Activity, but rather creates the "Perform Additional Public Outreach" Activity and documents the meeting under that Activity.

For a public meeting that is advertised to the public at-large and held in accordance with ENV's Public Involvement Handbook, then proceed as instructed below.

- 2. District environmental staff prepares a notice of public meeting, notice of virtual public meeting, or notice of a virtual public meeting with in-person option, depending on which form of public meeting is appropriate, in accordance with ENV's Public Involvement Handbook. Note that use of one of ENV's templates (ENV's Template: Notice of a Virtual Public Meeting or ENV's Template: Notice of a Virtual Public Meeting or ENV's meeting notice is optional it is not required.
- **3.** If the meeting will be held to satisfy the requirement to provide a notice and opportunity for comment, the district environmental staff also:
  - provides the notice to the owner or owners of real property that would be acquired for the project (by U.S. Mail or email), and
  - provides the notice to owners of real property that is adjacent to the project and to affected local governments and public officials (added capacity or construction of a highway at a new location only) (by U.S. Mail or email).
- **4.** For an open-ended (d)-list CE, if the project is expected to require more than 30 acres of total new right-of-way or more than ten total displacements (residential and commercial), then district environmental staff emails the draft notice to the ENV project delivery manager assigned to their district for review to confirm that the open-ended (d)-list CE classification remains valid.
- **5.** District environmental staff:
  - provides notice to any public official, individual, or affected interest group that has expressed interest in the relevant transportation project (by U.S. Mail or email);
  - posts the notice on the "Hearings, meetings and notices schedule" web page on txdot.gov (even if the project sponsor is a local government) (the TxDOT website notice must be posted at least 15 days before the meeting); and
  - notifies the public using additional outreach methods to the extent determined appropriate by district environmental staff.
- 6. For an open-ended (d)-list CE, if the project is expected to require more than 30 acres of total new right-of-way or more than ten total displacements (residential and commercial), then district environmental staff emails the anticipated meeting presentation materials to the ENV project delivery manager assigned to their district for review to confirm that the open-ended (d)-list CE classification remains valid.



- 7. District environmental staff holds the public meeting in accordance with ENV's Environmental Handbook for Public Involvement.
- 8. After the public meeting, district environmental staff prepares the documentation of public meeting using ENV's Template: Documentation of Public Meeting.

Note that email addresses for members of the public must be redacted from the documentation of public meeting that is uploaded to ECOS as instructed below; original copies of sign-in sheets, emails, or other documents showing email addresses for members of the public must be retained by district environmental staff, but are not publicly posted or uploaded to ECOS.

- **9.** For a CE project, the district environmental staff:
  - uploads the documentation of public meeting under this Activity;
  - makes the comment/response matrix, or the responses contained therein, available to the commenters;
  - completes the "Date of the PM" (either the date the virtual meeting went live or the date of the in-person option, whichever was later) and "Total number of attendees for this PM;" and
  - finalizes this Activity.
- **10.** For an EA or EIS project, the district environmental staff uploads the documentation of public meeting under this Activity, creates a Review of the documentation of public meeting under this Activity, and assigns it to the ENV core team member. Once the ENV core team member has finalized his or her Review, if there are pending comments
- **11.** , the district environmental staff:
  - prepares a new, revised version of the documentation of public meeting that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV core team member.

Once the ENV core team member has no further comments and has finalized his or her Review, district environmental staff:

- uploads the documentation of public meeting under this Activity with the word, "Approved," at the beginning of the file name;
- completes the "Date of the PM" and "Total number of attendees for this PM;"
- makes the comment/response matrix, or the responses contained therein, available to the commenters; and
- finalizes this Activity.
- **12.** If one or more additional public meetings are held for the project, district environmental staff creates a new "Perform Public Meeting" activity for each one.
- **13.** If, as part of the environmental review process, the district environmental staff has conducted other outreach with members of the public such as meetings, telephone conferences, or emails with individuals or groups, and the district environmental staff intends for such outreach to be included as part of the environmental review process, then the district environmental staff creates



the "Perform Additional Public Outreach" and uploads documentation of such outreach under that Activity.

## "Public Involvement SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of public involvement. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding public involvement, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding public involvement.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.
- **5.** This Activity may also be used to record any important notes or details regarding public involvement.



# "Obtain International Boundary and Water Commission (IBWC) Approval" Activity

- 1. District environmental staff confirms that the project will comply with the IBWC's Criteria For Construction Activities Within The Limits Of USIBWC Floodways, which are available on the IBWC's website at https://www.ibwc.gov/home.html.
- 2. District environmental staff prepares an application for an IBWC approval (which may be a license or permit) according to the IBWC's instructions, which are available on the IBWC's website at https://www.ibwc.gov/home.html.
- **3.** Note that the IBWC's instructions specify that the application must include written concurrence from the following agencies, if coordination with these agencies was required:
  - Texas Historical Commission/Texas State Historic Preservation Officer
  - United States Fish and Wildlife Service
  - United States Army Corps of Engineers
  - Texas Parks and Wildlife Department
  - Texas Commission on Environmental Quality

Therefore, if coordination with any of the above-listed agencies is required for the project (or, in the case of the USACE, if a permit other than an assumed permit is required), the application for the IBWC approval will not be considered complete until the coordination has been completed (or for the USACE, the permit/PCN approval has been issued).

If coordination with any of the above-listed agencies is not required for the project, the application must explain why coordination with that agency is not required.

- 4. District environmental staff may, at its discretion, upload the application under this Activity and create a Review of the application and assign it to the appropriate ENV SME assigned to the respective district. If district environmental staff elects to create an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review (if one was created), if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the application that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **5.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if one was created), the district environmental staff creates a Coordination and follows the steps below to conduct the coordination with the IBWC.

#### Coordination process



- 6. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for each letter or email sent to or from the IBWC.
- 7. District environmental submits the application for an IBWC approval (which may be a license or permit) to the IBWC according to the IBWC's instructions, which are available on the IBWC's website at https://www.ibwc.gov/home.html.

Note that the IBWC's instructions allow for submittal of the application either manually or electronically through the IBWC's on-line portal.

- **8.** Regardless of whether the application is submitted to the IBWC manually or through the on-line portal, district environmental staff uploads the entire submitted application under the Coordination.
- **9.** District environmental staff uploads all correspondence between TxDOT and the IBWC under the Coordination.
- **10.** District environmental staff uploads the final approval issued by the IBWC (license or permit) under the Coordination.
- **11.** After the IBWC issues the final approval, district environmental staff finalizes the Coordination.

#### Finalizing this Activity

**12.** After the district environmental staff finalizes the Coordination, district environmental staff finalizes this Activity.

### "Obtain Section 9 Bridge Permit" Activity

- 1. District environmental staff sends an email to the ENV USCG SME (Mario Mata) and the TxDOT Maritime Division's Planning and Development Section Director (Travis Milner) to explain that the project is expected to require coordination with the USCG (this is just an "FYI"-type email, as the Maritime Division has requested that it be notified of these types of projects).
- 2. District environmental staff determines if a bridge permit is required. A bridge permit is required for construction, reconstruction, rehabilitation, or replacement of a bridge over waters deemed navigable under Section 9 of the Rivers and Harbors Act. If so, then the process described below under "Coordination with USCG to obtain a bridge permit" must be completed.

However, for a federally funded project, TxDOT must, through FHWA, pursue a bridge permit exemption request (as explained below under "Coordination with USCG to obtain a bridge permit exemption request") if the bridge is over a navigable water that:

- is not used or is not susceptible to use in their natural condition or by reasonable improvement as a means to transport interstate or foreign commerce [i.e., you can't drive a commercial boat on the water], and
- is (i) not tidal, or (ii) if tidal, used only by recreational boating, fishing, and other small vessels less than 21 feet in length.
- **3.** District environmental staff determines if a navigational lighting authorization is needed. If any lights or signals will be installed, modified, or removed then a navigational lighting authorization is required. If so, then the process described below under "Coordination with USCG to obtain a navigational lighting authorization" must be completed (unless TxDOT is pursuing a bridge permit exemption request, in which case navigational lighting is handled as part of the bridge permit exemption request).

However, TxDOT may pursue a navigational lighting exemption (as explained below) if the waterway has no significant nighttime navigation. If so, then the process described below under "Coordination with USCG to obtain an exemption from the requirement to obtain navigational lighting authorization" must be completed (unless TxDOT is pursuing a bridge permit exemption request, in which case navigational lighting is handled as part of the bridge permit exemption request).

- 4. District environmental staff determines if a maintenance work plan is needed. A maintenance work plan is needed when a bridge maintenance project does not need a bridge permit because the project does not involve the construction, reconstruction, rehabilitation, or replacement of a bridge, but the maintenance work will require activity in the waterway that could temporarily impact navigation. If so, then the process described below under "Coordination to obtain USCG approval of a maintenance work plan" must be completed.
- 5. If district environmental staff is uncertain regarding the need for a bridge permit or bridge permit exemption request, a navigational lighting authorization/exemption, or a maintenance work plan, district environmental staff informally contacts USCG staff by email at <u>D08-DG-</u> <u>D8DPBAII@uscg.mil</u> to discuss whether a bridge permit/bridge permit exemption, navigational



lighting authorization/exemption, or maintenance work plan are needed. Upload any email correspondence with USCG staff under this Activity.

6. District environmental staff indicates in the "Comments" field what type(s) of authorization is/are required from the USGG (i.e., "bridge permit," "bridge permit exemption request," "navigational lighting authorization," "exemption from navigational lighting authorization," and/or "maintenance work plan") and prepares appropriate documentation as instructed below.

#### Coordination with USCG to obtain a bridge permit

- **1.** District environmental staff creates a "Coordinate Section 9 Bridge Permit" Coordination, and selects "U.S. Coast Guard (USCG)" as the agency with whom coordination is being conducted.
- 2. District environmental staff prepares the USCG a bridge permit application in accordance with the current USCG Bridge Permit Application Guide (BPAG) and Coast Guard Permit Application Template.

Note that throughout the Coast Guard Permit Application Template there are instructions to "cite location(s) in the application package" for various types of documents. All such documents must be attached to the application package.

**3.** If the proposed project is <u>not</u> located within the Texas Coastal Management Program (CMP) boundary, skip to Step 4 below.

If the proposed project <u>is</u> located within the Texas Coastal Management Program (CMP) boundary, a CMP Consistency Certification Letter from the Texas General Land Office (GLO) is required and district environmental staff will follow the steps below to obtain a CMP Consistency Certification Letter from the GLO.

District environmental staff contacts the ENV USCG SME (Mario Mata) for guidance on how to prepare the Consistency with the Texas Coastal Management Program (TCMP) application packet. The TCMP application packet must include the following:

- CMP Coordination Letter with the project description
- Project Location Map
- Project Plan Sheets

District environmental staff uploads the TCMP application packet under this Activity.

District environmental staff creates a Review of the TCMP application packet and assigns it to the ENV USCG SME, Mario Mata. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:

- prepares a new, revised version of the TCMP application packet that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and



 creates a new Review under this Activity, and assigns it to the ENV USCG SME, Mario Mata (and ENV Project Delivery staff, if applicable).

Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff or the ENV USCG SME (Mario Mata) will submit the completed TCMP application packet to the GLO.

The GLO will review the TCMP application packet and post the TCMP application packet on the Texas General Land Office's Public Notices site for a 30-day comment period. The GLO will issue a CMP Consistency Certification letter to the district environmental staff to include with the USCG bridge permit application package.

- 4. If the project will involve regulated activity in jurisdictional waters and will rely on a NWP for Section 404 authorization (in which case an individual Section 401 water quality certification likely has not already been obtained for the project), then an individual Section 401 water quality certification must be obtained from TCEQ before submitting the bridge permit application package, as the USCG will not accept coverage under the blanket Section 401 water quality certification for nationwide permits. Therefore, in this situation, district environmental staff must obtain such a certification from TCEQ before proceeding as instructed below. See instructions for obtaining an individual Section 401 water quality certification in the instructions for the "Obtain Section 404/10 Permit" Activity. If the project will <u>not</u> involve regulated activity in jurisdictional waters, then no individual Section 401 water quality certification is required to be obtained and included in the bridge permit application package.
- 5. District environmental staff uploads the USCG bridge permit application package (which will include the CMP Consistency Certification Letter from the GLO and the Section 401 water quality certification issued by TCEQ, if applicable) under this Activity.
- 6. District environmental staff creates a Review of the USCG bridge permit application package and assigns it to the ENV USCG SME, Mario Mata. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the USCG bridge permit application package that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV USCG SME, Mario Mata (and ENV Project Delivery staff, if applicable).
- 7. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff submits the USCG bridge permit application package to the USCG and follows the instructions below.
- 8. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for each letter or email sent to or from the USCG in connection with the request for a bridge permit.



- **9.** District environmental staff uploads the transmitted bridge permit application, any additional correspondence with the USCG, and the bridge permit issued by the USCG under this Coordination.
- **10.** In the Coordination, the district environmental staff selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

#### Coordination with USCG to obtain a bridge permit exemption request

- **1.** District environmental staff creates a "Coordinate Section 9 Bridge Permit" Coordination, and selects "U.S. Coast Guard (USCG)" as the agency with whom coordination is being conducted.
- **2.** District environmental staff completes the USCG/FHWA form titled, "23 CFR 650.805 Bridges not requiring a U.S. Coast Guard Permit" (the USCG/FHWA Questionnaire).

In completing the USCG/FHWA Questionnaire, answer all questions, even if the answer is "not applicable."

If the water is tidal, the form must clearly state that the water at the location of the crossing is used only by recreational boating, fishing, and other small vessels less than 21 feet in length. If the water is used by any boat that is 21 feet or greater, the project does not qualify for an exemption.

Include the latitude and longitude of the crossing and adequate photos to characterize the area (including photos of the types of vessels that use the water, if applicable).

**3.** If the proposed project is <u>not</u> located within the Texas Coastal Management Program (CMP) boundary, skip to Step 4 below.

If the proposed project <u>is</u> located within the Texas Coastal Management Program (CMP) boundary, a CMP Consistency Certification Letter from the Texas General Land Office (GLO) is required and district environmental staff will follow the steps below to obtain a CMP Consistency Certification Letter from the GLO.

District environmental staff contacts the ENV USCG SME (Mario Mata) for guidance on how to prepare the Consistency with the Texas Coastal Management Program (TCMP) application packet. The TCMP application packet must include the following:

- CMP Coordination Letter with the project description
- Project Location Map
- Project Plan Sheets

District environmental staff uploads the TCMP application packet under this Activity.

District environmental staff creates a Review of the TCMP application packet and assigns it to the ENV USCG SME, Mario Mata. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once



the ENV USCG SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:

- prepares a new, revised version of the TCMP application packet that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV USCG SME, Mario Mata (and ENV Project Delivery staff, if applicable).

Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff or the ENV USCG SME (Mario Mata) will submit the completed TCMP application packet to the GLO.

The GLO will review the TCMP application packet and post the TCMP application packet on the Texas General Land Office's Public Notices site for a 30-day comment period. The GLO will issue a CMP Consistency Certification letter to the district environmental staff to include with bridge permit exemption package.

- **4.** District environmental staff prepares a cover letter from TxDOT to FHWA stating that the purpose of the submittal to FHWA is to request an exemption from USCG bridge permitting pursuant to 23 CFR 650, Subpart H.
- **5.** District environmental staff uploads the cover letter, completed questionnaire, and supporting documentation (which will include the CMP Consistency Certification Letter from the GLO, if applicable) under this Activity.
- 6. District environmental staff creates a Review of the cover letter, completed questionnaire, and supporting documentation and assigns it to the ENV USCG SME, Mario Mata. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the cover letter, completed questionnaire, and supporting documentation that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV USCG SME, Mario Mata (and ENV Project Delivery staff, if applicable).
- 7. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff emails the cover letter, completed questionnaire, and any supporting documentation to FHWA. District environmental staff contacts the ENV USCG SME (Mario Mata) for guidance on the correct FHWA email address(es).
- **8.** If the FHWA bridge engineer determines that the project does not qualify for an exemption, they will notify the USCG bridge administrator and the district environmental staff.



If the FHWA bridge engineer's preliminary determination is that the project does qualify for an exemption, FHWA will notify the USCG bridge administrator.

**9.** If the USCG bridge administrator determines that the project qualifies for an exemption, they will notify FHWA in writing and copy the district environmental staff.

Note that even if the project qualifies for an exemption from the requirement to obtain a bridge permit, it may still need a navigational lighting authorization if it will install, modify, or remove any lighting or signals (see 33 CFR 650.805(e)).

- **10.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for each letter or email sent to or from FHWA and the USCG in connection with the request for a bridge permit exemption.
- **11.** District environmental staff uploads the transmitted request for a bridge permit exemption, any additional correspondence with FHWA and the USCG, and the bridge permit exemption issued by the USCG under this Coordination.
- **12.** In the Coordination, the district environmental staff selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

#### Coordination with USCG to obtain a navigational lighting authorization

- **1.** District environmental staff creates a "Coordinate Section 9 Bridge Permit" Coordination, and selects "U.S. Coast Guard (USCG)" as the agency with whom coordination is being conducted.
- 2. District environmental staff prepares and uploads under this Activity a navigational lighting authorization application, which consists of a letter accompanied by two copies of each of the following (a) drawings showing the plan and elevation of the structure showing lights and signals proposed, and (b) small scale vicinity chart showing proposed bridge and all other bridges within 1,000 feet above or below the proposed bridge (33 CFR 118.25). Plan sheets must adhere to the current USCG Bridge Lighting Manual.
- 3. District environmental staff creates a Review of the navigational lighting authorization application and assigns it to the ENV USCG SME, Mario Mata. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the navigational lighting authorization application that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV USCG SME, Mario Mata (and ENV Project Delivery staff, if applicable).



- 4. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff submits the navigational lighting authorization application to the USCG.
- 5. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for each letter or email sent to or from the USCG in connection with the request for a navigational lighting authorization.
- **6.** District environmental staff uploads the transmitted navigational lighting authorization application, any additional correspondence with the USCG, and the navigational lighting authorization issued by the USCG under this Coordination.
- 7. In the Coordination, the district environmental staff selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

## Coordination with USCG to obtain an exemption from the requirement to obtain navigational lighting authorization

- **1.** District environmental staff creates a "Coordinate Section 9 Bridge Permit" Coordination, and selects "U.S. Coast Guard (USCG)" as the agency with whom coordination is being conducted.
- **2.** District environmental staff prepares and uploads under this Activity a letter explaining that the project is over a waterway with no significant nighttime navigation and requesting an exemption from the requirement to obtain navigational lighting authorization.
- 3. District environmental staff creates a Review of the letter and assigns it to the ENV USCG SME, Mario Mata. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the letter that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV USCG SME, Mario Mata (and ENV Project Delivery staff, if applicable).
- 4. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff submits the letter to the USCG.
- 5. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for each letter or email sent to or from the USCG in connection with the request for an exemption from the requirement to obtain navigational lighting authorization.



- **6.** District environmental staff uploads the transmitted request for an exemption from the requirement to obtain navigational lighting authorization, any additional correspondence with the USCG, and the exemption issued by the USCG under this Coordination.
- 7. In the Coordination, the district environmental staff selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

#### Coordination to obtain USCG approval of a maintenance work plan

- **1.** District environmental staff creates a "Coordinate Section 9 Bridge Permit" Coordination, and selects "U.S. Coast Guard (USCG)" as the agency with whom coordination is being conducted.
- **2.** District environmental staff contacts the ENV USCG SME (Mario Mata) to obtain a sample maintenance work plan from a previous project to use as a go-by.
- **3.** District environmental staff prepares a maintenance work plan for the project using the go-by provided by the ENV USCG SME (Mario Mata).
- 4. District environmental staff creates a Review of the maintenance work plan and assigns it to the ENV USCG SME, Mario Mata. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the maintenance work plan that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV USCG SME, Mario Mata (and ENV Project Delivery staff, if applicable).
- 5. Once the ENV USCG SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, district environmental staff submits the maintenance work plan to the USCG.
- 6. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for each letter or email sent to or from the USCG in connection with the maintenance work plan.
- 7. District environmental staff uploads the transmitted maintenance work plan, any additional correspondence with the USCG, and the USCG's approval of the maintenance work plan under this Coordination.
- 8. In the Coordination, the district environmental staff selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.



Finalizing this Activity

**1.** After all required Coordinations are finalized, district environmental staff finalizes this Activity.

## "Obtain Section 404/10 Permit" Activity

**1.** If, at any time after creating this Activity, district environmental staff determines that no regulated activity will take place in jurisdictional waters, then enter an explanation to that effect in the "Comments" field of this Activity, and finalize this Activity.

If, at any time after creating this Activity, district environmental staff determines that all regulated activity in jurisdictional waters will be authorized under a non-reporting nationwide permit (NWP), then enter an explanation to that effect in the "Comments" field of this Activity, including the specific NWP number that will be used, and finalize this Activity.

If any of the above situations apply, it is at the district environmental staff's discretion whether to upload a delineation report and impacts table under this Activity; however, if district environmental staff does upload a delineation report and/or impacts table under this Activity, it is responsible for ensuring that the documentation is accurate and up-to-date at the time of LOA clearance, so that there will not be any inconsistency in the ECOS file.

#### Preparation of Waters of the U.S. Delineation Report and Section 404/10 Impacts Table

- 2. District environmental staff prepares a delineation report in accordance with ENV's Template: Water Features Delineation Report and uploads it under this Activity (unless the district environmental staff concludes that no regulated activity will take place in jurisdictional waters or all regulated activity in jurisdictional waters will be authorized under a non-reporting NWP, in which case the upload is optional – see Step 1 above).
- 3. District environmental staff may, at its discretion, create a Review of the completed delineation report under this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district. If district environmental staff elects to create an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the completed delineation report that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 4. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if a Review was created), district environmental staff uploads the final completed delineation report with the word, "Approved," at the beginning of the file name.
- 5. District environmental staff emails the wetland and stream geodatabase data that was used to prepare the delineation report to the ENV GIS email box at <u>env\_gis@txdot.gov</u> in accordance with ENV's TxDOT Water Submittal Geodatabase Template and ENV's Instructions:



**Wetland and Stream Delineation Data.** This allows the ENV GIS Specialist(s) to include the data for the project in a statewide database that is being built by ENV for informational purposes.

**6.** Based on the delineation report, the impacts identified for the project, and the following considerations, as applicable:

- USACE district (i.e., Galveston, Fort Worth, Tulsa, and/or Albuquerque) jurisdiction,
- whether the applicant is a "federal applicant" (i.e., the "FHWA Assigned to TxDOT" box is checked on WPD I), or the applicant is a "non-federal applicant" (i.e., the "TxDOT – No Federal Funding" or "FHWA – Not Assigned to TxDOT" box is checked on WPD I),
- project purpose, schedule, and amount and type(s) of impacts,
- whether the water is a Section 10 navigable water,
- available permit type and number (for NWP or RGP), if applicable,
- current Nationwide Permit General Conditions, if applicable
- current Regional Conditions for Texas and respective USACE district (published on Galveston District website)
- availability of mitigation banks/credits/permittee responsible mitigation (PRM), if applicable,
- direction provided by the USACE (such as during a pre-application meeting or regularly scheduled coordination call hosted by ENV),
- the current definition of waters of the U.S., as defined at 40 CFR Section 120.2, and
- ENV's Documentation Standard for USACE Pre-Construction Notification (PCN),

District environmental staff determines:

- which of the following types of USACE authorizations are needed for both Section 404 of the Clean Water Act and Section 10 of the Rivers and Harbors Act of 1899:
  - o non-reporting NWP
  - NWP w/ PCN,
  - o SP,
  - o LOP,
  - o RGP, or
  - o individual Section 10 permit
    - If the project requires a USCG Bridge Permit/Bridge Permit Exemption Request, the USCG may take the lead in regards to permitting and a Section 10 permit from the USACE may not be required (consult NRM); and
- which of the following jurisdictional determinations are needed:
  - o approved jurisdictional determination (AJD),
  - o preliminary jurisdictional determination (PJD),
  - joint PJD/AJD, and/or
  - no jurisdictional determination (JD)

, and completes **ENV's Section 404/10 Impacts Table** in accordance with **ENV's Instructions – Preparing a Section 404/10 Impacts Table** and uploads it under this Activity (unless the district environmental staff concludes that no regulated activity will take place in jurisdictional waters or all regulated activity in jurisdictional waters will be authorized under a non-reporting NWP, in which case the upload is optional – see Step 1 above).



In completing the Section 404/10 Impacts Table, if there is any uncertainty regarding any of the determinations required, district environmental staff must discuss the issue with the appropriate ENV SME assigned to the respective district, USACE liaison, and/or a USACE representative, as appropriate, prior to making the determination.

- 7. District environmental staff may, at its discretion, create a Review of the completed Section 404/10 Impacts Table under this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district. If district environmental staff elects to create an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the completed Section 404/10 Impacts Table that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 8. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if a Review was created), district environmental staff uploads the final completed Section 404/10 Impacts Table with the word, "Approved," at the beginning of the file name.
- **9.** If the result of preparing the Section 404/10 Impacts table is that no regulated activity will take place in jurisdictional waters, then enter an explanation to that effect in the "Comments" field of this Activity, and finalize this Activity.

If the result of preparing the Section 404/10 Impacts table is that a non-reporting NWP will suffice for all regulated activity in jurisdictional waters, then enter an explanation to that effect in the "Comments" field of this Activity, including the specific NWP number that will be used, and finalize this Activity.

If any of the above situations apply, it is at the district environmental staff's discretion whether to upload a delineation report and impacts table under this Activity; however, if district environmental staff does upload a delineation report and/or impacts table under this Activity, it is responsible for ensuring that the documentation is accurate and up-to-date at the time of LOA clearance, so that there will not be any inconsistency in the ECOS file.

If the result of the preparing the Section 404/10 Impacts table is that a non-reporting NWP will <u>not</u> suffice for all regulated activity in jurisdictional waters, then proceed as instructed below.

#### Preparation of permitting package

**10.** District environmental staff <u>indicates in the "Comments" field</u> which type(s) of USACE authorization(s) are needed and for which regulation (i.e., Section 404 of the Clean Water Act



and/or Section 10 of the Rivers and Harbors Act of 1899), and which type of jurisdictional determination is needed.

If USACE authorization(s) are needed for just one regulation (i.e., just Section 404 of the Clean Water Act or just Section 10 of the Rivers and Harbors Act of 1899), include in the "Comments" field a statement that no authorization is needed with respect to the other regulation (i.e., Section 404 of the Clean Water Act or Section 10 of the Rivers and Harbors Act of 1899).

**11.** District environmental staff prepares the appropriate permitting package (PCN, SP, LOP, RGP, or Individual Section 10 permit).

For all PCNs and SPs statewide, district environmental staff uses ENV's Documentation Standard for Pre-Construction Notification (PCN) and ENV's Documentation Standard for Individual Standard Permit (SP) Application, respectively.

Special note regarding projects in the USACE Galveston or Tulsa Districts: If the project is in the USACE Galveston or Tulsa District, then district environmental staff will need to eventually enter data into the RSS website. ENV has prepared an **RRS spreadsheet** to assist in preparing to enter data into the RSS website. District environmental staff should fill-out the **RRS spreadsheet** at this stage. If a Review of the permitting package will be assigned (see below), district environmental staff should include the completed RSS spreadsheet in the materials to be reviewed by the ENV SME (even though the completed RSS spreadsheet won't be included in the actual permitting package that is submitted to USACE).

For an LOP, RGP, or individual Section 10 permit, district environmental staff should contact the appropriate resource area ENV SME for guidance in preparing the permitting package.

The permitting package may also include a request for a jurisdictional determination and a mitigation plan, if either or both are needed. Jurisdictional determination request forms and processes are USACE district-specific. Mitigation plans must address all 12 required components set forth at 33 CFR 332.4(c).

For an SP, LOP, or RGP, district environmental staff will also need to request a Section 401 water quality certification using ENV's 401 guidance documentation. As indicated below, the Section 401 water quality certification will need to be coordinated with TCEQ, and after TCEQ waives or approves (see process steps, below), it will be submitted to the USACE as supplemental information to the permitting package.

- 12. District environmental staff may, at its discretion, create a Review of the permitting package under this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district. If district environmental staff elects to create an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the permitting package that is responsive to the comments made and uploads it under this Activity;



- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **13.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if a Review was created), district environmental staff proceeds according to the Coordination instructions provided below. If section 7 and or Section 106 consultation is triggered by the project, and TxDOT is the federal applicant for the Section 404/10 authorization, ENV recommends that the permitting package not be submitted to USACE until such consultation is completed.

#### "No practicable alternative" analysis under the Section 404(b)(1) Guidelines (Section 404 SPs only)

1. As explained in the EA and EIS Handbooks, if the project will require an SP, then the EA or EIS must demonstrate that there is no practicable alternative that would have less adverse effects on the aquatic ecosystem, and district environmental staff should seek USACE's written concurrence of this analysis. District environmental staff uploads such written concurrence (which may be an informal email) under this Activity.

#### Section 404/10 Permit Coordination with USACE

- **1.** District environmental staff creates a "Coordinate Section 404/10 Permit" Activity.
- 2. District environmental staff transmits the permitting package to the appropriate USACE district office. District environmental staff must copy ENV-water@txdot.gov on any regulatory submissions to USACE (i.e., SP, PCN, permit modifications for SPs, re-verifications for NWPs, and requests for Approved Jurisdictional Determinations [ADJs]). For an SP, LOP, or RGP, the permitting package will be later supplemented with the Section 401 water quality certification waived or approved by TCEQ and TCEQ's decision documentation.

Special note regarding projects in the USACE Galveston or Tulsa Districts: If the project is in the USACE Galveston or Tulsa District, then district environmental staff will also enter data into the RRS website using the completed RSS spreadsheet as a guide.

- **3.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for submittal of the permitting package and any subsequent letter or email sent to or received from the USACE.
- **4.** District environmental staff uploads the transmitted permitting package and any additional correspondence with the USACE under this Coordination.
- **5.** Once the USACE has issued the permit or LOP, or approved the use of a NWP or RGP, district environmental staff uploads the USACE's authorization under this Coordination.



6. In the Coordination, the district environmental staff selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

Section 401 Water Quality Certification Coordination with TCEQ (only if Section VII.C. of **ENV's Surface** Water Analysis form is checked)

1. If Section VII. of ENV's Surface Water Analysis form ("Section 401 of the Clean Water Act") has a checkmark for:

**"C. Any other situation –** Check this box in any other situation, such as:

- It is not possible to determine prior to environmental clearance whether Section 401 compliance is required or, if so, how Section 401 compliance will be achieved, because of a lack of right-of-entry and/or a lack of sufficient design.
- A delineation or impacts table is needed to verify if Section 401 compliance is required and, if so, how Section 401 compliance will be achieved.
- The project will require a general permit (i.e., NWP with PCN or regional general permit), or individual permit (i.e., individual standard permit or letter of permission)."

Then district environmental staff explains in the "Comments" field of this Activity which of the above scenarios applies, and the status of the investigation into whether Section 401 compliance will be required. District environmental staff must update this explanation to reflect the final determination about whether Section 401 compliance is required, and if so, how compliance will be achieved (i.e., either by implementing TCEQ conditions for a NWP that is covered by TCEQ's blanket 401 water quality certification or by obtaining an individual Section 401 water qualify certification from TCEQ).

- **2.** If a Section 401 water quality certification will obtained from TCEQ, then district environmental staff proceeds as indicated below:
- **3.** District environmental staff creates a "Coordinate Section 404/10 Permit" Activity.
- 4. District environmental staff conducts the Section 401 coordination with TCEQ in accordance with ENV's Section 401 Guidance.
- 5. In the Coordination, for Agency Name select "TCEQ."
- 6. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for submittal of the Section 401 water quality certification to TCEQ and any subsequent letter or email sent to or received from TCEQ.
- 7. District environmental staff uploads the transmitted Section 401 water quality certification to TCEQ and any additional correspondence with TCEQ under this Coordination (e.g., pre-filing meeting request and Section 401 certification request form).
- **8.** Once TCEQ has waived, approved, or denied the Section 401 water quality certification, district environmental staff uploads TCEQ's decision documentation under this Coordination.



**9.** In the Coordination, the district environmental staff selects "Completed" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

#### Finalizing this Activity

- **1.** District environmental staff creates a "Perform Section 404/10 Permitting Commitments" Activity.
- 2. If applicable, district environmental staff creates a "Perform Compensatory Mitigation" Activity.
- **3.** District environmental staff finalizes this Activity.

#### NWP reverifications

1. Sometimes, after this "Obtain Section 404/10 Permit" Activity is finalized, it is necessary to reverify the applicability of a NWP because the USACE has issued new NWPs (which occurs every five years). When this occurs, if the construction work has been committed to (e.g., a construction contract has been executed) and cannot be completed with a 12-month grace period, then a reverification is required by the end of the 12-month grace period. Alternatively, if the work has not yet been committed to (e.g., no construction contract has been executed), a reverification is required prior to commencing work.

If a NWP reverification is needed, then it is necessary to create a new "Obtain Section 404/10 Permit" Activity to record the NWP reverification. Note that if the project has already been LOAcleared, then it will be necessary to first create a "Perform Reevaluation" Activity as a workaround in order to unlock the ability to create a new "Obtain Section 404/10 Permit." *See* the Activity Instructions for Perform Reevaluation, specifically the instructions in step 1 for "Instructions for when an actual reevaluation is *not* needed."

2. A new delineation report and impacts table is needed in connection with a reverification if a delineation report and impacts table was previously prepared and five years have passed since the previously completed delineation report and impacts table was prepared (or if site conditions have changed, which is unusual).

For a NWP reverification that does <u>not</u> require a new delineation report and impacts table, explain in the "Comments" field of the new "Obtain Section 404/10 Permit" Activity why no new delineation report and impacts table is needed, and follow the instructions set forth above starting at Step 11 under "Preparation of permitting package" through to finalization of the new "Obtain Section 404/10 Permit" Activity.

3. For a NWP reverification that <u>does</u> require a new delineation report and impacts table, follow the instructions set forth above starting at Step 3 under "Preparation of Waters of the U.S. Delineation Report and Section 404/10 Impacts Table" through to finalization of the new "Obtain Section 404/10 Permit" Activity.

# *"Perform Notification for Environmental Protection Agency (EPA) Edwards Aquifer MOU" Activity*

- 1. At or around the same time that the draft EA or draft EIS is made available for public review (and after the draft EA or draft EIS has been approved for public review by ENV), district environmental staff mails the following items to EPA Region 6:
  - Notice of availability of the draft EA or draft EIS
  - Paper or electronic copy (flash drive or CD) of the draft EA or draft EIS
- **2.** District environmental staff uses the following mailing address for EPA Region 6:

- **3.** District environmental staff indicates in the "Comments" box the date on which the notice of availability was mailed to EPA Region 6, and the format of the draft EA or draft EIS that was mailed to EPA Region 6 (e.g., paper copy, flash drive, or CD).
- **4.** District environmental staff uploads a copy of the notice of availability mailed to EPA Region 6 under this Activity.
- **5.** District environmental staff uploads any written responses provided by EPA Region 6, and any further correspondence between TxDOT and EPA Region 6 regarding EPA's review of the project under the sole source aquifer program, under this Activity.
- **6.** If EPA Region 6 provides a written response that does <u>not</u> raise any concerns about the project's impact on the Edwards Aquifer, then district environmental staff finalizes this Activity.

If EPA Region 6 provides a written response that <u>does</u> raise concerns about the project's impact on the Edwards Aquifer, then district environmental staff contacts the appropriate ENV SME assigned to the respective district to discuss how to proceed.

If EPA Region 6 has not provided a written response within 48 days after the notice availability and draft EA or draft EIS was mailed to EPA Region 6, then district environmental staff finalizes this Activity. Note that if EPA Region 6 provides a response after the 48-day period, it must still be considered by district environmental staff and uploaded under this Activity.

### "Perform Section 404/10 Permitting Commitments" Activity

1. District environmental staff lists any commitments that were established through the Section 404/10 permitting process in the "Comments" field of this Activity. Or, if the commitments are numerous, district environmental staff uploads a separate document under this Activity listing the commitments (not the permit itself), and provides a reference to that document in the "Comments" field of this Activity.

Examples of the types of commitments that may be listed in this Activity include, but are not limited to:

- Compensatory mitigation (which will be listed here, but documents related to compensatory mitigation will be uploaded under the "Perform Water Compensatory Mitigation" Activity).
- Permit special conditions
- 2. District environmental staff uploads any documentation showing compliance with any commitments that were established through the Section 404/10 permitting process under this Activity (but documents related to compensatory mitigation will instead be uploaded under the "Perform Water Compensatory Mitigation" Activity).

Examples of the types of documentation that may be uploaded under this Activity include, but are not limited to:

- Permit-related notifications
- Minutes from pre-construction meetings
- 3. Once the commitment(s) are complete, district environmental staff finalizes this Activity.





## "Perform Surface Water Analysis" Activity

- 1. District environmental staff completes ENV's Surface Water Analysis form and uploads it under this Activity.
- 2. District environmental staff may, at its discretion, create a Review of the completed surface water analysis form under this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district (however, district environmental staff should <u>not</u> create and assign a Review if Section II.A or II.B of the form are checked and there are no other unusual situations regarding the form). If district environmental staff elects to create an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the completed surface water analysis form that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- 3. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if a Review was created), district environmental staff uploads the final completed surface water analysis form with the word, "Approved," at the beginning of the file name.
- **4.** If Section II of the completed surface water analysis form ("Section 404 of the Clean Water Act") has a checkmark for:

**"C. Any other situation** – Check this box in any other situation, such as:

- It is not possible to determine prior to environmental clearance whether Section 404 compliance is required or, if so, how Section 404 compliance will be achieved, because of a lack of right-of-entry and/or a lack of sufficient design<sup>1</sup>.
- A delineation or impacts table is needed to verify if Section 404 compliance is required and, if so, how Section 404 compliance will be achieved.
- The project will require a general permit (i.e., NWP with PCN or regional general permit), or individual permit (i.e., individual standard permit or letter of permission)."

then district environmental staff:

- creates the "Obtain Section 404/10 Permit" Activity.
- **5.** If Section V of the completed surface water analysis form ("General Bridge Act/Section 9 of the Rivers and Harbors Act") has a checkmark for "This project <u>will</u> require a permit, bridge lighting authorization, or exemption from the United States Coast Guard under Section 9 of the Rivers and Harbors Act, which outlines the requirements for approval to construct dams, dikes, bridges, or causeways in or over a navigable waterway," then district environmental staff:



- creates the "Obtain Section 9 Bridge Permit" Activity.
- 6. If Section VI of the completed surface water analysis form ("Section 10 of the Rivers and Harbors Act") has a checkmark for "This project will use a reportable permit under Section 10, or it is not yet clear which permitting option will be used, if any, and so a delineation is needed or a delineation and impacts table are needed to make that determination," then district environmental staff:
  - creates the "Obtain Section 404/10 Permit" Activity (if it has not already been created).
- 7. District environmental staff finalizes this Activity.

**Citation(s):** Clean Water Act Sections 303(d), 401, 402, and 404; General Bridge Act/Section 9 of the Rivers and Harbors Act; Section 10 of the Rivers and Harbors Act; Section 14 of the Rivers and Harbors Act (33 USC 408); Executive Order 11990, Protection of Wetlands; and Executive Order 11988, Floodplain Management.





## "Perform Texas Coastal Management Program (TCMP) Analysis" Activity

District environmental staff determines whether or not the project would have a "direct and significant adverse effect" on a coastal natural resource area (CNRA). "Direct" refers to "impacts that are causally linked to an activity," and "significant" refers to "appreciable impacts on CNRAs." 31 TAC 29.30(b).

It would be unusual for district environmental staff to determine that a project <u>would</u> have a direct and significant adverse effect on a CNRA because compliance with TxDOT policies and applicable laws such as the Clean Water Act virtually ensures that such an adverse effect will be avoided.

2. If the project would avoid and <u>not</u> have a direct and significant adverse effect on a coastal natural resource area (CRNA), then district environmental staff inserts this statement into the "Comments" field of this Activity:

"The Texas Department of Transportation reviewed this proposed action for consistency with the Texas Coastal Management Program (Texas CMP) goals and policies in accordance with the regulations of the Coastal Coordination Advisory Council and determined that the proposed action will not have a direct and significant adverse effect on the coastal natural resource areas (CNRAs) identified in the applicable policies (31 TAC 29.30(b)(2))."

**3.** If the project <u>would</u> have a direct and significant adverse effect on a CNRA (again, this would be unusual), but the project is otherwise consistent with Texas CMP goals and policies, then district environmental staff inserts this statement into the "Comments" field of this Activity:

"The Texas Department of Transportation reviewed this proposed action for consistency with the Texas Coastal Management Program (Texas CMP) goals and policies in accordance with the regulations of the Coastal Coordination Advisory Council and determined that the proposed action is consistent with the applicable CMP goals and policies (31 TAC 26.31(a))."

**4.** If the project will be the subject of a CE or EA, then district environmental staff finalizes this Activity.

#### Additional steps for an EIS project

- **5.** If the project will be subject of an EIS, then district environmental staff also prepares a written explanation supporting the selected statement. The written explanation must:
  - provide the basis for TxDOT's determination;
  - include a description of the proposed action and its probable impacts on CNRAs;
  - identify the CMP goals and policies applied to the proposed action; and
  - explain how the proposed action is consistent with the applicable goals and policies or why the proposed action does not adversely affect any CNRAs.



- **6.** District environmental staff ensures that the written explanation is included in the body of the draft and final EIS.
- 7. District environmental staff finalizes this Activity.

## *"Perform Texas Commission on Environmental Quality (TCEQ) Edwards Aquifer Rules Analysis" Activity*

There are three parts to this Activity: (1) analysis of project; (2) preparation of application materials; and (3) coordination with the Texas Commission on Environmental Quality (TCEQ) to obtain authorization under TCEQ's Edwards Aquifer rules.

#### Analysis of project

**1.** District environmental staff determines whether or not the project will involve a "regulated activity."

"Regulated activity" includes:

- construction or installation of buildings, utility stations, utility lines, roads, highways, or railroads on either the recharge or contributing zone; and
- clearing, excavation, or any other activities that alter or disturb the topographic, geologic, or existing recharge characteristics of a site on either the recharge or contributing zone.
- installation of aboveground or underground storage tank facilities with a capacity of greater than 500 gallons on the recharge, contributing, or transition zone.

"Regulated activity" does not include:

- clearing of vegetation without soil disturbance;
- routine maintenance that does not involve additional site disturbance, such as, but not limited to:
  - the resurfacing of existing paved roads, parking lots, sidewalks, or other development-related impervious surfaces; or
  - the building of fences, or other similar activities in which there is little or no potential for contaminating groundwater, or there is little or no change to the topographic, geologic, or existing sensitive features.
- **2.** If the project does <u>not</u> involve a "regulated activity," district environmental staff indicates in the "Comments" field of this Activity that the project does not involve a "regulated activity," and finalizes this Activity.

If the project <u>does</u> involve a "regulated activity," proceed as indicated below.

**3.** If the project is located <u>only</u> within the Edwards Aquifer contributing zone <u>and</u> does <u>not</u> involve a regulated activity that disturbs 5 or more acres, and is not part of a larger common plan of development, then explain in the "Comments" field of this Activity that the project is located only within the Edwards Aquifer contributing zone and does not involve a regulated activity that disturbs 5 or more acres and is not part of a larger common plan of development, and therefore no authorization under TCEQ's Edwards Aquifer Rules is required, and finalize this Activity.

To determine whether a project is part of a larger common plan of development, district environmental staff must reach out to the Edwards Aquifer contact at TCEQ as this is a subjective determination and there are no thresholds for road projects in TCEQ's rules or guidance.



Otherwise, proceed as indicated below.

#### Preparation of application materials

- **4.** District environmental staff fills out the following form available on TCEQ's website: TCEQ-20872 Edwards Aquifer Protection Program Roadway Application (and Checklist)
- 5. In some instances, an <u>exception request</u> application may be submitted in lieu of the WPAP (see 43 TAC 213.9) or in lieu of the CZP (see 43 TAC 213.26). An exception can be granted only if TxDOT demonstrates equivalent water quality protection for the Edwards Aquifer.

To request an exception for a project that is on the recharge zone (or on both the recharge zone and contributing zone), district environmental staff prepares a Recharge and Transition Zone Exception Request using the following forms available on TCEQ's website:

- TCEQ-20705 Edwards Aquifer Application Cover Page
- TCEQ-0628 Recharge and Transition Zone Exception Request Form
- TCEQ-0628 Checklist Recharge and Transition Zone Exception Request Form --Checklist

To request an exception for a project that is on the contributing zone, district environmental staff prepares a Contributing Zone Exception Request using the following forms available on TCEQ's website:

- TCEQ-20705 Edwards Aquifer Application Cover Page
- TCEQ-10262 Contributing Zone Exception Request Form
- TCEQ-10262 Checklist Contributing Zone Exception Request Form -- Checklist
- 6. If the project involves <u>only</u> the installation of a tank in the transition zone (as described above), then district environmental staff prepares an Aboveground Storage Tank Facility Plan Application using the following forms available on TCEQ's website:
  - TCEQ-20705 Edwards Aquifer Application Cover Page
  - TCEQ-0575 Aboveground Storage Tank Facility Plan Application
  - TCEQ-0575 Checklist Aboveground Storage Tank Facility Plan Checklist
  - TCEQ-0583 Underground Storage Tank Facility Plan Application
  - TCEQ-0583 Checklist Underground Storage Tank Facility Plan Checklist
- 7. Prior to environmental clearance of the project, district environmental staff indicates in the "Comments" field of this Activity which type of application/exception is required (WPAP Application, CZP Application, Recharge and Transition Zone Exception Request, Contributing Zone Exception Request, or Aboveground Storage Tank Facility Plan Application).
- 8. District environmental staff may, at its discretion, create a Review of the application materials under this Activity and assign it to the appropriate resource area ENV SME assigned to the respective district. If district environmental staff elects to create an ENV SME Review and the project is anticipated to be cleared with an EA or EIS, then district environmental staff also



assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:

- prepares a new, revised version of the application materials that is responsive to the comments made and uploads it under this Activity;
- completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
- creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).
- **9.** Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review (if a Review was created), District environmental staff follows the steps below to conduct the coordination with the TCEQ.

#### Coordination process

- **10.** Prior to environmental clearance of the project, district environmental staff creates a "Coordinate Texas Commission on Environmental Quality (TCEQ) Edwards Aquifer Rules Approval" Coordination, and selects "Texas Commission on Environmental Quality (TCEQ)" as the agency with whom coordination is being conducted.
- **11.** District environmental staff submits the application materials to TCEQ in accordance with the instructions on TCEQ's website.
- **12.** In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The district environmental staff fills-in the correspondence details for each letter or email sent to or from TCEQ.
- **13.** District environmental staff uploads the transmitted application materials, any additional correspondence with the TCEQ, and the approval issued by TCEQ under this Coordination. If changes were made to a WPAP or CZP in response to a TCEQ request for information, district staff will upload the final approved plan under this Coordination.
- **14.** In the Coordination, the district environmental staff selects "Completed" or "Completed with Conditions" from the drop-down menu for the field labeled, "Coordination Status," and finalizes the Coordination.

#### Finalizing this Activity

- **15.** District environmental staff ensures that the approved WPAP or CZP, or any commitments made in a request for an exception, are communicated to the design and construction contractor.
- **16.** District environmental staff finalizes this Activity.

## "Perform Water Compensatory Mitigation" Activity

This Activity is only used to record water <u>compensatory</u> mitigation under Section 404 of the Clean Water Act.

- **1.** District environmental staff determines whether a TxDOT mitigation bank can be used.
- **2.** If a TxDOT mitigation bank <u>cannot</u> be used, district environmental staff determines whether a third-party mitigation bank can be used.
- **3.** If <u>neither</u> a TxDOT mitigation bank <u>nor</u> a third-party mitigation bank can be used, then district environmental staff determines whether an in-lieu fee program can be used.
- **4.** If <u>none</u> of the above-listed compensatory mitigation options are available, then permitteeresponsible mitigation (PRM) will be required.

This is an option of last resort, as it is typically more expensive and time-consuming than the other options. With PRM, TxDOT is responsible for identifying and acquiring the appropriate mitigation parcel(s), performing mitigation activities on the parcel (e.g., planting and maintaining vegetation, hydraulic engineering, etc.), monitoring the mitigation site for an extended period of time, and taking appropriate steps to protect the parcel(s) in perpetuity.

Before proceeding with PRM as a compensatory mitigation option, district environmental staff must ensure that all reasonable and feasible design options have been considered to avoid the impacts requiring the compensatory mitigation, including a complete re-design of the project.

- **5.** If district environmental staff determined that either a TxDOT mitigation bank or a third-party mitigation bank could be used, then district environmental staff does the following:
  - follows the instructions in ENV's Standard Operating Procedure For Acquiring and/or Purchasing Section 404 Compensatory Mitigation Credits to secure the mitigation credits and apply them to the project;
  - uploads the cover letter and copy of the mitigation bank ledger reflecting the deduction (for a TxDOT mitigation bank) or the letter from the mitigation bank confirming purchase of the mitigation credits (for a third-party mitigation bank) under this Activity; and
  - finalizes this Activity.
- **6.** If district environmental staff determined that PRM was required, then district environmental staff does the following:
  - follows the instructions in ENV's Standard Operating Procedure for Conducting Section 404 Compensatory Mitigation via Permittee Responsible Mitigation (PRM) to perform the PRM;
  - uploads the mitigation plan approved by the United States Army Corps of Engineers under this Activity;
  - uploads all documentation showing compliance with the USACE-approved mitigation plan for the project (e.g., plant monitoring reports, photographs, etc.) under this Activity;
  - confirms that the PRM has been completed to USACE's satisfaction; and
  - finalizes this Activity.

## "Perform Wild and Scenic Rivers Act (WSRA) Analysis" Activity

 District environmental staff determines whether the project will involve work below the ordinary high water mark (OHWM) of the reach of the Rio Grande that is designated as a Wild and Scenic river of National Importance, which is from (a) river mile 842.3 above Mariscal Canyon in Brewster County (at the boundary between the Mexican states of Chihuahua and Coahuila) to (b) river mile 651.1 at the Terrell-Val Verde county line.

If the project will <u>not</u> involve work below the OHWM of this reach of the Rio Grande, then district environmental staff explains in the "Comments" field of this Activity that the project will <u>not</u> involve work below the OHWM of this reach of the Rio Grande, and finalizes this Activity.

If the project <u>will</u> involve work below the OHWM of this reach of the Rio Grande, then the district environmental staff must obtain a "Section 7" determination from the National Park Service (NPS) regarding whether the project will have a direct and adverse effect on the values for which the river segment was established ("Section 7" here refers to section 7 of the WSRA, not Section 7 of the Endangered Species Act).

 District environmental staff prepares a letter requesting a Section 7 determination from the NPS in accordance with "A Compendium of Frequently Asked Questions Relating to Transportation & Infrastructure Projects, A Technical Report of the Interagency Wild and Scenic Rivers Coordinating Council," (July 2018).

In accordance with that guidance, the letter must include basic project information, including:

- Name and contact information of the project proponent;
- Map of the project area showing the location of the project; and
- Brief project description, including the type of project and structures involved, basic physical specifications (length, width, grading, etc.), and duration and timing of construction.
- 3. District environmental staff creates a Review of the draft letter and assigns it to the appropriate ENV SME assigned to the respective district. If the project is anticipated to be cleared with an EA or EIS, district environmental staff also assigns a separate Review to ENV Project Delivery staff. Once the ENV SME (and ENV Project Delivery staff, if applicable) has finalized his or her Review, if there are pending comments, the district environmental staff:
  - prepares a new, revised version of the draft letter that is responsive to the comments made and uploads it under this Activity;
  - completes the comment response matrix by filling-in the "How Addressed," "New Page," and "New Section" columns and uploads it under this Activity; and
  - creates a new Review under this Activity, and assigns it to the ENV SME (and ENV Project Delivery staff, if applicable).



4. Once the ENV SME (and ENV Project Delivery staff, if applicable) has no further comments and has finalized his or her Review, the ENV SME creates a Coordination and follows the steps below to conduct the coordination with the NPS.

#### Coordination Process

- 5. In the Coordination, the field labeled, "Are Correspondence Details Included?," will be automatically filled-in with "Yes" indicating that correspondence details are required. The ENV SME fills-in the correspondence details for each letter or email sent to or from the NPS.
- 6. The ENV SME submits the letter to the NPS.
- 7. The ENV SME uploads the submitted letter under the Coordination.
- **8.** The ENV SME uploads all correspondence between TxDOT and the NPS under the Coordination.
- 9. The ENV SME uploads the signed approval letter issued by the NPS under the Coordination.
- **10.** After the NPS issues the signed approval letter, the ENV SME finalizes the Coordination.

#### Finalizing this Activity

**11.** After the ENV SME finalizes the Coordination, the ENV SME finalizes this Activity.

## "Water SME Consultation" Activity

- 1. District environmental staff uses this Activity to formally record any particularly noteworthy telephone conversations, meetings, or email exchanges with subject matter experts ("SMEs") on the topic of water resources. This Activity is <u>not</u> used to document an ENV SME ECOS Review.
- 2. This Activity need not be created for every conversation, meeting, or email exchange with an SME regarding water resources, but only those that district environmental staff believes should be formally recorded in ECOS for purposes of preserving a decision or instruction regarding water resources.
- **3.** To record a telephone conversation, meeting, or email exchange, the district environmental staff summarizes the substance of the discussion in the comments field (include date and names) or upload relevant meeting minutes, notes, or emails under this Activity, and finalizes this Activity.
- **4.** For each new telephone conversation, meeting, or email exchange that district environmental staff intends to record in ECOS, the district environmental staff creates a new Activity.

• Remove unnecessary instruction about ENV SME transmitting a copy of his or her review to district environmental staff.

#### Archeology – "Perform Archeology Testing"

• Fix incorrect reference to "Work Status" field, other clarifying revisions.

#### Biology – "Obtain Endangered Species Act (ESA) Consultation"

- Add instructions about using a file naming convention for the IPaC list.
- Fix incorrect reference to "Step 21"

#### Biology - "Perform Endangered Species Act (ESA) Consultation Commitments"

 Add instructions about the need to use this Activity not only when commitments result from consultation with USFWS/NMFS, but also to document the need for consultation with USFWS/NMFS if a currently proposed species becomes listed within the lifecycle of the project.

#### Biology – "Perform Essential Fish Habitat (EFH) Analysis"

• Minor clarifying revisions.

#### Biology – "Perform Farmland Protection Policy Act (FPPA) Analysis"

• Minor clarifying revisions.

#### Biology – "Perform Marine Mammal Protection Act (MMRA) Analysis"

 Revise to indicate that when coordination with NMFS is needed, district environmental staff first creates the Coordination, and then confers with the ENV SME to determine who will prepare the application for an incidental take permit.

#### Biology – "Perform Non-Endangered Species Act (ESA) Biology Commitments"

• Clarify that district environmental staff can either list commitments in the "Comments" field of the Activity or upload a list of commitments.

#### Biology - "Perform Species Analysis"

- Add instructions about using a file naming convention for the IPaC list.
- Revise for consistency with current version of Species Analysis Form.
- Review of species analysis spreadsheet and form is now required if the project is an EA or EIS
  project, or if the second, third, or fourth checkbox on the species analysis form is checked (i.e.,
  consultation is required, consultation may be required for a proposed species, or voluntary
  conference for a proposed species).
- Revise to instruct that ENV SME, not district environmental staff, uploads documentation under the Coordination when BGEPA (Bald and Golden Eagle Protection Act) coordination is conducted.



• Other clarifying revisions.

#### Community Impacts - "Perform Community Impacts Assessment (CIA)"

- Revise to reflect new approach for community impact assessments, which includes three possible levels of analysis: (1) Summary Analysis <u>with no</u> ENV SME Review Required, (2) Summary Analysis <u>with</u> ENV SME Required, (3) Full Report.
- Revise to reflect new title of ENV's guidance: "Instructions How to Conduct Community Impacts Assessments".
- Remove reference in "Citation:" to Executive Order 12898.

#### Hazardous Materials - "Perform Haz Mat Initial Site Assessment (ISA)"

• Fix reference to incorrect Section no. on the ISA form (8.2 instead of 8.3).

#### Hazardous Materials - "Perform Haz Mat Issue Identification and Resolution (IIR)"

• Clarify that either district environmental staff or the ENV SME can determine that an issue has been fully and completely resolved (i.e., remove "... from ENV's perspective, ...").

#### Noise – "Perform Noise Analysis"

• Add instruction that if the design engineer conducted the constructability analysis as part of the noise analysis, then district environmental staff uploads Constructability Assessment for Proposed Noise Barrier form under the "Perform Noise Constructability Assessment" Activity and follows the instructions in that Activity.

In other words, don't just upload the form under "Perform Noise Analysis" Activity. The constructability form always gets uploaded under the "Perform Constructability Assessment Activity", regardless of whether it was done contemporaneously with the noise analysis or after the noise analysis.

#### Noise – "Perform Constructability Assessment"

- This will be its own Activity going forward, no longer combined with the "Perform Noise Workshop" Activity.
- This Activity must be created and completed regardless of whether the constructability assessment was done contemporaneously with the noise analysis or after the noise analysis.
- Clarify that it is "the design engineer" who performs the constructability assessment by completing ENV's form.
- Other clarifying revisions.

#### Noise – "Perform Noise Mitigation"

• Fix minor typo.



#### Noise – "Perform Noise Workshop"

• This will be its own Activity going forward, no longer combined with the "Perform Noise Constructability Assessment" Activity.

#### Project – "Add CSJ After Environmental Clearance"

• Update reference from "DCIS" to "TxDOTCONNECT".

#### Project - "Obtain Letter of Authority (LOA) Clearance"

- ENV Project Delivery Staff assigned to the respective district now issues the LOA clearances instead of a single ENV LOA manager for the whole State.
- Add reminder that if ENV Project Delivery Staff sees that the milestone has been changed for any Activity with a default milestone of "Prior to LOA", then he or she must confirm that the "reasonable assurances" process has been followed.
- Add reminder that ENV Project Delivery Staff can check the list of Activities in the instructions for the "Reasonable Assurances for Activities That Could Not Be Completed Prior to LOA" for a reminder on which ones have a default milestone of "Prior to LOA" (and therefore should be finalized or documented with reasonable assurances prior to LOA clearance).

#### Project – "Obtain Planning Consistency Documentation"

- The "Rural Develop Authority Project List" is now available on TPP's STIP page on <u>www.txdot.gov</u> (click on the link for the current STIP and look for a file named, "DA Summary and Projects").
- Add new option for clearing rural projects: the "Rural *Plan* Authority Project List" (should be available on TPP's STIP page on <u>www.txdot.gov</u> by the end of August.

#### Project – "Obtain Project Classification Approval"

Clarify that the amendment process for an open-ended (d)-list CE classification request only
applies if ENV has already approved an open-ended (d)-list classification, and then there are
changes to the project description or preliminary schematic or *increases* in the right-of-way
acreage or number of displacements.

• Update references from "DCIS" to "TxDOTCONNECT".

#### Project - "Perform Cumulative Impacts Analysis"

• Remove instructions as this Activity is not longer required.

#### Project – "Perform Draft EA Preparation"

• Clarify that the end of the one-year target is the notice of availability of the final EA or notice of availability of the FONSI (not issuance of the FONSI).



- Remove references to List of EAs and EISs in Development and Complete, which is no longer required after revocation of CEQ rules.
- Remove references to contractor disclosure statement email, which is no longer required after revocation of CEQ rules.
- Add instructions regarding coordination with "cooperating agencies" to reflect current EA Handbook instructions.
- Add reminder that subsequent versions of the EA should be uploaded under separate "Submit Draft EA" deliverable Activities.
- Other clarifying revisions.

#### Project – "Perform Draft EIS Preparation"

- Clarify that the end of the two-year target is the publication of the e-NEPA notice of availability of the FEIS in the Federal Register (not issuance of the ROD).
- Remove references to List of EAs and EISs in Development and Complete, which is no longer required after revocation of CEQ rules.
- Remove references to contractor disclosure statement email, which is no longer required after revocation of CEQ rules.
- Add reminder that subsequent versions of the EIS should be uploaded under separate "Submit Draft EIS" deliverable Activities.
- Other clarifying revisions.

#### Project – "Perform EIS Scoping"

- Clarify that the "range of alternatives" can be as simple as a map showing the various alignments under consideration.
- Add instruction about obtaining the standard "ENV methodologies and level of detail" document for the scoping meetings (should be released later in 2025).
- Add instructions about required components of the project schedule to be presented at the scoping meetings.
- Clarify that the end of the two-year target is the publication of the e-NEPA notice of availability of the FEIS in the Federal Register (not issuance of the ROD).
- Revise definitions of cooperating and participating agencies.

#### Project - "Perform Final EA Preparation"

- Clarify that the end of the one-year target is the notice of availability of the final EA or notice of availability of the FONSI (not issuance of the FONSI).
- Add reminder that subsequent versions of the EA should be uploaded under separate "Submit Final EA" deliverable Activities.
- Revise instructions for Project Delivery Section Director's next steps after approving the final EA (if no 30-day waiting period, then email FONSI to ENV Division Director; if there is a 30-day waiting period, then wait until conclusion of 30-day waiting period to email FONSI to ENV Division Director).
- Update references from "DCIS" to "TxDOTCONNECT".

#### Project - "Perform Final EIS/Record of Decision (ROD) Preparation"

- Clarify that the end of the two-year target is the publication of the e-NEPA notice of availability of the FEIS in the Federal Register (not issuance of the ROD).
- Add reminder that subsequent versions of the EIS should be uploaded under separate "Submit Final EIS" deliverable Activities.
- Update references from "DCIS" to "TxDOTCONNECT".
- Other clarifying revisions.

#### Project – "Perform Induced Growth Analysis"

• Add instruction for district environmental staff to check with ENV Project Delivery Staff to make sure they agree on whether or not the more detailed six-step analysis is required.

#### Project – "Perform Notice of Intent"

- Revise to indicate that no OWJ coordination is required when using the Section 4(f) exceptions for trails, paths, bikeways, and sidewalks.
- Add instructions for complying with public notice and comment requirement for a parks 4(f) *de minimis* determination when there is no public meeting/hearing being held for the project as a whole.
- Add references to "Perform Historical Studies Desktop Survey".
- Remove reference to uploading a list of historic sites under this Activity; it is sufficient to simply list them in the "Comments" field of the Activity.

Protected Lands - "Obtain Section 6(f) Approval"



• Add instructions for the district environmental staff to upload certain documents to this Activity.

#### Public Involvement – "Perform Final EIS/Record of Decision (ROD) Notice of Availability (NOA)"

- Clarify that the notice need not be provided to TCEQ, TPWD, or THC because TxDOT's MOUs with those agencies do not require it.
- For the electronic copy of the FEIS/ROD that gets sent to EPA Region 6, remove name of recipient ("Robert Houston") and instead instruct staff to check EPA's website to make sure address is correct.
- Clarify that the notice must be posted on the "Hearings, meetings and notices schedule" web page on txdot.gov.
- Remove reference to CEQ regulation that has been revoked.

#### Public Involvement – "Perform Notice of Availability (NOA) for Final EA listed at 23 CFR 771.115(a)"

- Clarify that the notice need not be provided to TCEQ, TPWD, or THC because TxDOT's MOUs with those agencies do not require it.
- Clarify that the notice must be posted on the "Hearings, meetings and notices schedule" web page on txdot.gov.

#### Public Involvement – "Perform Opportunity for Public Hearing (OPH)/Public Hearing (PH)"

• Minor clarifying revisions.

#### February 2025

The following change was made to this Environmental Guide: Volume 2 Process in February 2025:

• Remove references to the "Perform Project-Level Greenhouse Gas and Climate Change Technical Report" Activity. This Activity is no longer needed as EISs will summarize the statewide greenhouse gas analysis report instead of having individual project-level greenhouse gas analyses.

#### April 2024

Introduction to EG Volume 2



- In the list of Activities, Reviews, and Coordinations, move "Obtain Coastal Barrier Resources Act (CBRA) Opinion" and its Review and Coordination from the Water category to the Biology category.
- In the list of Activities, Reviews, and Coordinations, add a new "Perform Project-Level Greenhouse Gas and Climate Change Technical Report" Activity and Review under the Project category.
- In the list of Activities, Reviews, and Coordinations, add a new "Climate Change SME Consultation" Activity under the Project category.
- Change the default milestone of "Revoke Environmental Clearance" from "Post-Construction" to "During Construction."

#### "Review (generic)"

- Allow reviewer to record comments as tracked changes or margin comments instead of using the comment/response matrix (except for comments on EAs and EISs).
- Make due dates required when assigning Reviews.
- Add cross-reference to review timelines in EG Volume 1, Chapter 9 (all are a minimum of two weeks, some longer). Do not assign a review with a shorter timeline without the ENV reviewer's prior approval.
- Emphasize need for reviewer to meet the deadline, or work with the district staff to change it if needed, as the due dates may be reported to TP&Ds or others.

#### <u>Air – "Perform Mobile Source Air Toxics (MSAT) Analysis"</u>

• For a qualitative MSAT analysis, add a mandatory ENV Project Delivery staff Review for an EA or EIS project (we comprehensively added this Project Delivery Review step across all Activities in 2023, but inadvertently missed this one so we're adding it now).

#### Biology – "Obtain Coastal Barrier Resources Act (CBRA) Opinion"

• Moved this from the Water category to the Biology category.

#### Biology – "Obtain Endangered Species Act (ESA) Consultation"

• Update name of programmatic agreement for salamanders and karst invertebrates.

#### Biology – "Perform Species Analysis"

• Add instruction to label uploaded species analysis form as "approved" when district environmental staff chooses not to assign a Review.

#### Noise - "Perform Noise Analysis"

• Revise instructions regarding which documents to upload under this Activity. Previously gave option to upload approved traffic data separately from the traffic noise analysis report, but the traffic data should be included as an attachment to the report, not a separate upload.



• Add instruction that district environmental staff may, at their discretion, upload additional documentation not specifically called-for by the instructions in support of the traffic noise analysis.

#### Noise – "Perform Noise Constructability Assessment/Workshop"

- Revise to indicates that the alternate barrier cost assessment is a possible component of a contractability assessment, not a separate document (if there are site-specific factors that may increase the construction costs, then you do an alternate barrier cost assessment as part of the constructability assessment).
- Revise to clarify that for a constructability assessment, the only upload should be the constructability assessment (not a separate alternate barrier cost assessment or additional noise modeling like the previous instructions said).
- For the noise workshop, add steps for notifying eligible voters by letter of the workshop results, uploading the letters under this Activity, and updating the current status of the barrier in the "Comments" field (i.e., "rejected as a result of noise workshop," or "approved as a result of noise workshop").

#### Project – "Perform Project-Level Greenhouse Gas and Climate Change Technical Report"

• This is a new Activity for doing the project-level GHG analysis, which we're doing for EIS projects for which acceptance of the project work plan or publication of the NOI (whichever was first) occurred on or after January 2, 2024. There's a mandatory Review that gets assigned to Jackie Ploch and the ENV core team member for the project.

#### Project - "Climate Changes SME Consultation"

• This is a new Activity that can be used to document any particularly noteworthy conversations or emails with the ENV climate change SME (Jackie).

#### Project - "Obtain Planning Consistency Documentation"

- Add a reference to 23 CFR 450.104 for the definition of "regionally significant" (for non-FHWA projects, only "regionally significant" projects are required to be listed in the MPO's 20-year plan or the STIP/TIP, so if a <u>non</u>-FHWA project is <u>not</u> "regionally significant," then district environmental staff can just explain that in the "Comments" field and finalize).
- Update instructions for locating the "Rural Develop Authority Project List" (this used to be in the "Statewide Highway Financial" appendix to the STIP, but now you have to go into TPP's STIP portal, click on an "area" and then click on the various recent revisions to find a file labeled, "DA Summary).

#### Project – Perform Cumulative Impacts Analysis

• Revise to reflect that there is no longer a required Review for both an "ENV SME" for cumulative impacts and ENV Project Delivery staff. ENV Project Delivery staff are now the "ENV SME" for cumulative impacts, so the Review just gets assigned to ENV Project Delivery staff.

#### Project – Perform Induced Growth Analysis



- Revise to reflect that there is no longer a required Review for both an "ENV SME" for induced growth impacts and ENV Project Delivery staff. ENV Project Delivery staff are now the "ENV SME" for induced growth impacts, so the Review just gets assigned to ENV Project Delivery staff.
- Revise to reflect change from "ENV's Guidance: Indirect Impacts Analysis" to "ENV's Guidance: Induced Growth Analysis."

## Project – Perform Draft EA Preparation

• Revise to reflect that the 75-page limit (not including citations or appendices) is now a "hard" page limit (i.e., not a "soft" page limit that can be exceeded with ENV Director approval). The "hard" page limit was set by Congress when it recently amended NEPA as part of the debt ceiling bill.

#### Project – Perform Final EA Preparation

• Revise to reflect that the 75-page limit (not including citations or appendices) is now a "hard" page limit (i.e., not a "soft" page limit that can be exceeded with ENV Director approval). The "hard" page limit was set by Congress when it recently amended NEPA as part of the debt ceiling bill.

#### Project – Perform Draft EIS Preparation

• Revise to reflect a "hard" overall page limit of 300 pages (not included citations or appendices). The "hard" page limit was set by Congress when it recently amended NEPA as part of the debt ceiling bill.

#### Project – Perform Final EIS-Record of Decision (ROD) Preparation

 Revise to reflect a "hard" overall page limit of 300 pages (not included citations or appendices). The "hard" page limit was set by Congress when it recently amended NEPA as part of the debt ceiling bill.

#### Project – Perform Notice of Intent (NOI)

• Revise to reflect the new field in the Activity: "Date NOI was published in the Federal Register (or Texas Register for a state project)" (this date was previously just listed in the "Comments" field).

#### Project - Perform Reevaluation

- Remove requirement to create a "Perform Species Analysis" Activity for every reevaluation. A
  new "Perform Species Analysis" Activity only needs to be created in ECOS if there are design
  changes that affect one or more effect calls from the species analysis spreadsheet (i.e., changing
  from "no effect" to "may effect"). If the design changes do not result in any changes to the effect
  calls, then just note that in the "Biology" section of the reevaluation form.
  - No change here, but just a reminder: District environmental staff still needs to obtain a new IPaC and RTEST list. If there are no new species, just explain that in the "Biology" section of the reevaluation form. If there <u>are</u> new species, then create a new "Perform Species Analysis" Activity and update the species analysis spreadsheet.
- Revise to require a Review by the ENV SME for biology only if the reevaluation is being done for an EA or EIS project. Previously, the instructions required a "Perform Species Analysis" Activity



and mandatory Review of the "Perform Species Analysis" Activity by the ENV SME for biology for all reevaluations. Now, there is just a mandatory Review by the ENV SME for biology for EA/EIS projects, and it's a Review of the "Perform Reevaluation" Activity (not the "Perform Species Analysis" Activity).

- Add a requirement for district environmental staff to copy the "summary of reason for reevaluation" from Section 1 of the reevaluation form into the "Comments" field of the "Perform Reevaluation" Activity.
- Revise ENV approval process as follows:
  - For a reevaluation of a CE (other than an open-ended (d)-list CE), ENV Project Delivery Staff reviews and finalizes the "Perform Revaluation" Activity (i.e., there is no further review by the ENV Project Delivery Section Director).
  - For a reevaluation of an open-ended (d)-list CE, EA, or EIS, ENV Project Delivery staff does their own review and then assigns a Review to ENV's Project Delivery Section Director.

## Project – Reasonable Assurances For Activities That Could Not Be Completed Prior to LOA

• Revise so that (1) the explanation of why the Activity could not be finalized prior to LOA clearance and (2) the plan for completing the Activity in the future must be entered into the "Comments" field of the Activity instead of being uploaded (this is to allow ECOS to possibly export this language into TxDOTCONNECT in the future).

#### Protected Lands – Perform Section 4(f) Analysis

• Add a reminder that a determination of "constructive use" of a Section 4(f) property would be unusual and would require FHWA approval under our NEPA assignment MOU.

#### Protected Lands – Obtain Section 4(f) Approval

- For parks Section 4(f) exceptions, *de minimis*, and programmatic approvals, remove requirement of review by Director of ENV's Cultural Resources Section (Rebekah). The 4(f) paperwork will be reviewed by ENV Project Delivery Staff, and then the overall 4(f) approval will be made by the ENV Deputy Director (Mike).
- For historic resources 4(f) exceptions, *de minimis*, and programmatic approvals, remove requirement of review by Director of ENV's Project Delivery Section (Sonya). The 4(f) paperwork will be reviewed by the Director of ENV's Cultural Resources Section (Rebekah), and then the overall 4(f) approval will be made by the ENV Deputy Director (Mike).
- For individual 4(f) evaluations (parks and historic resources), clarify that coordination may be done by email (previous version specified mail).
- For individual 4(f) evaluations (parks and historic resources), revise process for ENV Director approval to be an email approval instead of by signing the individual Section 4(f) evaluation.

#### Public Involvement – Perform Opportunity for Public Hearing (OPH)/Public Hearing (PH)



- Remove references to 100% in-person/no virtual component hearings, as all public hearings must now have a virtual component.
- Remove references to virtual hearing components being appropriate "in light of health and safety considerations," which was a COVID holdover. Now, virtual hearing components are required regardless of health and safety considerations.
- Clarify that "Date of PH" field should be filled-in with either the date the virtual hearing went live or the date of the in-person option, whichever was later.
- Add instructions for preparing the "Positive, Negative, or Neutral Public Comments Report" that is required for EIS projects. The need for this report was discussed in the Public Involvement Handbook and in ENV's Guidance: Public Comment Response Matrix, but was not covered in the EG, so we're adding a reminder about this report in the instructions for the public hearing Activity.

## Public Involvement – Perform Public Meeting

- Remove references to 100% in-person/no virtual component meetings, as all public meetings must now have a virtual component.
- Remove references to virtual hearing components being appropriate "in light of health and safety considerations," which was a COVID holdover. Now, virtual hearing components are required regardless of health and safety considerations.
- Clarify that "Date of PM" field should be filled-in with either the date the virtual meeting went live or the date of the in-person option, whichever was later.

#### Water – Perform Surface Water Analysis

- Revise for consistency with latest version of surface water analysis form that was updated last November.
- Add instruction that while district environmental staff may assign a Review of the completed surface water analysis form, they should <u>not</u> assign a Review if Section II.A or II.B of the form are checked and there are no other unusual situations regarding the form. (If Section II.A or II.B are checked that basically means either there's no regulatory activity in any jurisdictional waters, or there is regulated activity but it's all covered by a non-reporting nationwide permit).

#### Water – Obtain Section 404/10 Permit

- Remove special instructions for using NWP 16 because NWP 16 is now covered by TCEQ's blanket water quality certification for compliance with Section 401.
- Add an instruction to email the wetland and stream geodatabase data that was used to prepare a
  delineation report to the ENV GIS email box at <u>env\_gis@txdot.gov</u>. This allows the ENV GIS
  Specialist(s) to include the data for the project in a statewide database that is being built by ENV
  for informational purposes.
- Add a reminder that if the project will require a standard permit, then district environmental staff must upload the USACE's written concurrence of the "no practiciable alternative" analysis under the Section 404(b)(1) guidelines under this Activity.



- Add requirement for district environmental staff to copy <u>ENV-water@txdot.gov</u> on any regulatory submissions to USACE (i.e., SP, PCN, permit modifications for SPs, re-verifications for NWPs, and requests for Approved Jurisdictional Determinations [ADJs]).
- Add instructions for explaining in the "Comments" field of this Activity how Section 401 compliance will be documented in situations when it is more complex than simply using a non-reporting NWP that is covered by TCEQ's blanket 401 water quality certification.
- Other revisions for consistency with latest version of surface water analysis form that was updated last November.

# Water - Obtain Section 9 Bridge Permit

- Add requirement for district environmental staff to email the ENV USCG SME and the TxDOT Maritime Division's Planning and Development Section Director when it becomes apparent that the project will require coordination with USCG (this is just an FYI-type email).
- Add instructions for when a "maintenance work plan" is needed. This may be needed when the project does not require an actual bridge permit, but maintenance work will require activity in the waterway that could temporarily impact navigation.
- Revise instructions for obtaining a Coastal Management Plan Consistency Certification Letter from the General Land Office, which is required when a project will need a bridge permit or bridge permit exemption and is located with the Texas Coastal Management Program (CMP) boundary. Basically, district prepares a Texas Coastal Management Program (TCMP) application packet and uploads for review by the ENV USCG SME (Mario), then the ENV USCG SME (Mario) transmits to the General Land Office, and the General Land Office will issue a CMP Consistency Certification letter that district will include in the bridge permit application package or bridge permit exemption package.
- Add a new requirement that an individual Section 401 water quality certification must be obtained from TCEQ before submitting a bridge permit application package, as the U.S. Coast Guard will not accept coverage under the blanket Section 401 water quality certification for nationwide permits.

## Water – Perform Texas Commission on Environmental Quality (TCEQ) Edwards Aquifer Rules Analysis

- For projects located only in the Edwards Aquifer contributing zone and are less than 5 acres, add new requirement to consider whether project is "part of a larger common plan of development." This is something that TCEQ requires be considered. If the project is "part of a larger common plan of development," then TCEQ authorization under the Edwards Aquifer rules may be required even if the project itself is less than 5 acres.
- Update references to TCEQ's Edwards Aquifer application forms. There is now just one form, which is "TCEQ-20872-Edwards Aquifer Protection Program Roadway Application (and Checklist)."
- Add step for an optional Review of the draft application materials by an ENV SME. We're just adding this so that district staff knows that ENV SMEs are available to review the draft application materials if the district would like them to.



#### March 2023

The following change was made to this Environmental Guide: Volume 2 Process in March 2023:

### "Obtain Planning Consistency Documentation"

- Revise instructions to improve readability (provide complete separate instructions for MPO and non-MPO areas)
- Provide way to environmentally clear rural projects that are not in STIP and not in the "Rural Develop Authority Project List" but are fully funded in years 5-10 of the UTP

## February 2023

The following changes were made to this Environmental Guide: Volume 2 Process in February 2023:

### Change to how Volume 2 is organized

• Activities are now grouped by subject area, and then listed alphabetically (i.e., all "Air" Activities are grouped together, all "Biology" Activities are grouped together, etc.).

#### Introduction to EG Volume 2

- Explain that if it is known that a Review or Coordination will be required with a newly created downstream Activity with a default milestone of "Prior to LOA," then it is advisable to create the Review or Coordination at the same time the Activity is created.

- Instruct that if constructability assessment and/or alternative barrier cost assessment was conducted as part of the traffic noise analysis, district environmental staff includes an explanation in the "Comments" field of this Activity.

#### Project – "Add CSJ After Environmental Clearance"

• Clarify that the CSJ to be added must have first been created in ECOS (e.g., fill-in the eight required fields and click save as described in EG Volume 1, Section 1.9).

#### Project - "Obtain Letter of Authority (LOA) Clearance"

- Add explanation that ENV LOA manager will attempt to LOA-clear approximately four months before scheduled letting, and district environmental staff should not ask the ENV LOA manager to LOA-clear the project before this time frame.
- Allow for a project to be LOA-cleared when an Activity with a milestone of "Reevaluation" is still open only if the ENV Director or ENV Deputy Director approves. This would be extremely unusual.

- Clarify that ENV Project Delivery staff review of public meeting/hearing materials on an openended (d)-list CE is only required if 30 acre or ten displacement threshold is exceeded.
- Clarify that amendment of open-ended (d)-list CE form is only required if 30 acre or ten displacement threshold is exceeded.

- Instructions list the Activities for which reasonable assurances can potentially be used.



 District environmental staff provides reasonable assurance statements in this Activity and notifies the ENV LOA manager. ENV LOA manager checks with ENV Program Review Section Director and then finalizes this Activity.

• Revise to emphasize that for reviews of the draft EA, the reviewer must use a matrix to record their comments so that the ENV core team member can easily compile.

• Revise to emphasize that for reviews of the draft EIS, the reviewer must use a matrix to record their comments so that the ENV core team member can easily compile.

## Project - "Review Final EA"

- Revise to emphasize that for reviews of the final EA, the reviewer must use a matrix to record their comments so that the ENV core team member can easily compile.
- Add instructions for ENV Project Delivery staff to check planning consistency, whether other Activities are finalized, and ROW CSJs in TxDOTCONNECT (these instructions were previously in the "Perform Final EA Preparation" Activity).

#### Project – "Review Final EIS/Record of Decision (ROD)"

- Revise to emphasize that for reviews of the final EIS, the reviewer must use a matrix to record their comments so that the ENV core team member can easily compile.
- Add instructions for ENV Project Delivery staff to check planning consistency, whether other Activities are finalized, and ROW CSJs in TxDOTCONNECT (these instructions were previously in the "Perform Final EIS/Record of Decision (ROD) Preparation" Activity).

#### Protected Lands - "Obtain Section 4(f) Approval"

- Clarifying edits to emphasize a property that is both historic and a park, there will be two separate exception, *de minimis*, or programmatic checklists for the property.
- Revise to indicate that if there are multiple park/recreation area/refuge properties that are covered by the same exception, *de minimis*, or programmatic evaluation, then they can be lumped together in a single checklist. Same for historic properties.
- Update deadline for U.S. Department of Interior comments on an individual Section 4(f) determination from 45 days to 30 days as provided for in the IIJA.
- Update instructions for conveying an individual Section 4(f) determination to the U.S. Department of Interior.

Protected Lands – "Obtain Section 6(f) Approval"



• Substantially revise to reflect requirements of the National Park Service's Land and Water Conservation Fund State Assistance Federal Financial Assistance Manual, including requirements applicable to temporary non-public outdoor recreation use of property of six months or less in duration (March 11, 2021).

- Update procedure for providing FEIS/ROD to EPA Region 6 to be consistent with instructions on EPA's website.
- Add reminder that notice must be posted on TxDOT's website even if the project sponsor is a local government.

- Update procedure for providing DEIS to EPA Region 6 to be consistent with instructions on EPA's website.

Public Involvement – "Perform Public Involvement Analysis"



• Clarify that a notice and opportunity to comment is triggered only by a <u>new</u> easement (work in a previously existing easement does not count).

## Public Involvement – "Perform Public Meeting"

- Clarify that on an open-ended (d)-list CE notices and materials only have to be reviewed by ENV Project Delivery staff if 30 acre or ten displacement threshold is exceeded.
- Add reminder that notice must be posted on TxDOT's website even if the project sponsor is a local government.
- Add instruction that district environmental staff must make the comment/response matrix, or the responses contained therein, available to the commenters.

## Water – "Obtain International Boundary and Water Commission (IBWC) Approval"

- Add instruction about how NOA of draft EA or draft EIS goes to TPWD.

## "Perform Public Meeting"



• For CE projects, remove mandatory review of Documentation of Public Meeting by district staff authorized to approve CE determination.

## "Perform Reevaluation"

- Add instructions about when a new species analysis should be performed, and an instruction to obtain a new IPaC and RTEST list even if the reevaluation does not include design changes that could impact previously evaluated protected species.
- Add instructions about when to coordinate a reevaluation with TPWD per the new MOU.

## "Perform Section 404/10 Permitting Commitments"

• Add examples of the types of commitments that may be listed, and the types of documentation that may be uploaded under this Activity.

## "Perform Species Analysis"

- Revise to reflect new separate guidance document about how to fill-out species analysis spreadsheet.
- Revise to reflect procedure for coordinating with TPWD under the new MOU.

#### "Perform Surface Water Analysis"

• Revise to reflect that districts will not ever do a delineation or impacts table as part of "Perform Surface Water Analysis." If the district is uncertain about whether a non-reporting nationwide permit will suffice, then go ahead and create "Obtain Section 404/10 Permit" and do the delineation under it.

#### July 2021

The following changes were made to this Environmental Guide: Volume 2 Process in July 2021:

#### Introduction to Environmental Guide Volume 2: Activity Instructions

• Add reminder about changing default activity milestones and a table showing all Activities, Reviews, and Coordinations with default milestones for easy reference.

#### "Add CSJ After Environmental Clearance"

 Clarify that when this Activity is used to add ROW CSJs after environmental clearance, if that ROW CSJ will be used to acquire additional parcels not included in the environmental clearance, the addition of the ROW CSJ to the clearance does not allow acquisition of those additional parcels, which must be covered by a reevaluation prior to acquisition.

#### "Obtain Endangered Species Act (ESA) Consultation"

- Add requirement that district environmental staff discuss the project with ENV SME as soon as possible.
- Clarify that the ENV SME may initiate "early coordination" with USFWS, which does not need to be tracked in ECOS.



- Add references to new Houston toad programmatic consultation agreement.
- Add requirement to obtain a new IPaC species list if preparation of the BE or BA has not begun within 90 days of completion of the "Perform Species Analysis" Activity.
- Add requirement to obtain a new IPaC species list if BE or BA has not been submitted to the USFWS within 180 days of completion of the "Perform Species Analysis" Activity.
- Clarify that any voluntary conservation measures and reasonable and prudent measures from USFWS consultation must be recorded using the "Perform Endangered Species Act (ESA) Consultation Commitments" Activity.

#### "Obtain Letter of Authority (LOA) Clearance"

- Add instruction for the ENV LOA manager to confirm, for any Activities for which the district has changed the default milestone, that district has entered in the "Comments" field an explanation and plan for accomplishing completion of the Activity in the future.
- Add instruction for ENV LOA manager to check with the ENV NRM Section Director if district has changed the default milestone for "Obtain Section 404/10 Permit" or "Obtain Section 9 Bridge Permit."

#### "Obtain Planning Consistency Documentation"

- Add instructions regarding how to handle a non-FHWA project that is not "regionally significant."
- Clarify that when a project must be individually listed, it is not sufficient that preliminary engineering or ROW acquisition is "grouped."
- Add instructions for how to handle rural projects that are outside the 4-year STIP window.

#### "Obtain Project Classification Approval"

- Add recommendation about requesting ENV approval of open-ended (d)-list CE classification prior to submitting WPD III to department delegate for review and acceptance.
- Explain that the ENV project delivery manager's review of the public involvement materials for an open-ended (d)-list CE allows the ENV project delivery manager an opportunity to make sure that the project has not changed from the description in the approved Open-Ended (d) Categorical Exclusion Classification Request Form (or Amendment to Open-Ended (d) CE Classification Request Form).
- Add recommendation about requesting ENV approval of a downgrade from EIS to EA prior to submitting WPD III to department delegate for review and acceptance.

## "Obtain Project-Level Conformity Determination"

• Clarify that hot-spot conformity requirements do not apply in areas outside of El Paso.

"Obtain Section 404/10 Permit"



- Clarify that if district prepared a Waters of the U.S. Delineation Report and Section 404/10 Impacts Table as part of the "Perform Surface Water Analysis" Activity (which is voluntary), and it results in the need for a permit (other than a non-reportable nationwide), then upload the report and table under the "Obtain Section 404/10 Permit."
- Change references to a Section 404 individual permit to an "individual standard permit."
- Add optional Review of Section 404/10 Impacts Table.
- Add instructions for complying with new Section 401 requirements when an individual standard permit under Section 404 is required.
- Add requirement to create a "Perform Section 404/10 Permitting Commitments" Activity (which is a new Activity being added with this update).

#### "Perform 139(I) Notice of Limitation on Claims for Judicial Review"

• Revise process for ENV Project Delivery Section Director to gather project-specific inserts and have the batch 139(I) notice published in the Federal Register.

## "Perform Additional Public Outreach"

• Clarify that ENV's formal public involvement documentation templates (Public Meeting, etc.) should not be used in documenting additional public outreach.

- Add reference to ENV's template for a letter to FHWA requesting CE approval for a non-NEPAassigned project (i.e., a project that crosses the state boundary).

#### "Perform Community Impacts Assessment"

• Add reminder about how for a complex EA or EIS with substantial community impacts, the district may prepare a narrative-style report using ENV's Community Impacts Assessment Technical Report form as an outline.

#### "Perform Draft EA Preparation"

- Add instructions regarding a schedule > 1 year, page length > 75 pages.
- Add instructions regarding the contractor disclosure statement email.

#### "Perform Draft EIS Preparation"

- Add instructions regarding a schedule > 2 years, page length > 150 pages (or > 300 pages for a
  project of unusual scope or complexity).
- Add instructions regarding the contractor disclosure statement email.

#### <u>"Perform EIS Scoping"</u>

• Various revisions to conform to EIS Roadmap guidance document, which was updated in the Summer of 2020 to reflect the CEQ rulemaking.



## "Perform Farmland Protection Policy Act (FPPA) Analysis"

- Add instructions for when project will not actually convert any special soil types to non-agricultural uses.
- Revise instructions for coordinating with the Natural Resources Conservation Service.

## "Perform Final EA Preparation"

- Add instructions regarding a schedule > 1 year, page length > 75 pages.
- Add reminder about checking for ROW CSJs in TxDOTConnect and associating in ECOS before clearing a project. Section 4.2, Project Association(s).
- Revise instructions for coordinating ENV Division Director approval of FONSI (ENV Project Delivery Section Director, rather than ENV Project Delivery Staff, presents the FONSI to the ENV Division Director).

## "Perform Final EIS/ROD Preparation"

- Add instructions regarding a schedule > 2 years, page length > 150 pages (or > 300 pages for a project of unusual scope or complexity).
- Add reminder about checking for ROW CSJs in TxDOTConnect and associating in ECOS before clearing a project. Section 4.2, Project Association(s).

#### "Perform Final EIS/ROD Notice of Availability (NOA)"

- Clarify that NOA is sent to "public officials or federal, state, or local agencies or tribes" (rather than "units of federal, state, and local government").
- Add instruction about sending a hard copy of FEIS, and CD or USB containing FEIS, to EPA Region 6.

#### "Perform FONSI Notice of Availability (NOA)"

• Clarify that NOA is sent to "public officials or federal, state, or local agencies or tribes" (rather than "units of federal, state, and local government").

#### "Perform Haz Mat Issue Identification and Resolution (IIR)"

- Clarify the situations under which haz mat sites should be listed individually versus grouped for purposes of listing in the IIR.
- Add reminder about not resolving individual issues within the IIR table until they are have been fully resolved from ENV's perspective.

#### "Perform Historical Studies Project Coordination Request (PCR)"

• Emphasize the need for PCR preparer to check the WPD I project description attached to the PCR (the PCR form will soon be revised to require a printout of the WPD I project description to be attached).



 Revise instructions for district completion of coordination with County Historical Commissions for certain bridge projects.

### "Perform Mobile Source Air Toxics (MSAT) Analysis"

• Revise instructions for determining whether an MSAT conference call is necessary.

"Perform Non-Endangered Species Act (ESA) Biology Commitments"

• Clarify that this Activity must be used to document non-ESA-related commitments (i.e., it is not discretionary).

#### "Perform Notice and Opportunity to Comment"

- Clarify that if district is not doing a required notice and opportunity to comment, but is conducting voluntary public outreach that is similar to a notice and opportunity to comment, then use the "Perform Additional Public Outreach" Activity instead.
- Revise to indicate that the public's email addresses are always redacted from version of documentation uploaded to ECOS (not just when documentation will be disclosed to the public).
- Fix typo to correctly indicate that the Review is assigned to the district employee with delegated authority to approve the CE (not an "ENV SME").

#### "Perform Notice of Availability (NOA) for Final EA listed at 23 CFR 771.115(a)"

• Clarify that NOA is sent to "public officials or federal, state, or local agencies or tribes" (rather than "units of federal, state, and local government").

#### "Perform Notice of Intent (NOI)"

• Revise process for ENV core team member to have the NOI published in the Federal Register.

#### "Perform Notification of Noise Information to Local Officials"

• Revise to indicate that this is always done by separate letter for CEs, EAs, and EISs (was previously done for EAs and EISs by including language in NOA).

#### "Perform Opportunity for Public Hearing (OPH)/Public Hearing (PH)"

- Revise to indicate that the public's email addresses are always redacted from version of documentation uploaded to ECOS (not just when documentation will be disclosed to the public).
- Add reminder about noting in the "Comments" field if the requirement to hold a hearing on a bike lane project was satisfied with an district-wide bike lane hearing under 43 TAC 25.55.
- Clarify that notices are posted on TxDOT's website even if the project sponsor is a local government.
- Clarify that notice is sent to "public officials or federal, state, or local agencies or tribes" (rather than "units of federal, state, and local government").
- Revise EIS notice requirements based on Summer 2020 CEQ rulemaking.



#### "Perform Public Involvement Analysis"

- Clarify that a construction license does not count as new ROW, permanent easement, or temporary easement.
- Add instruction that if district determines to hold a public meeting, then follow the instructions in the "Perform Public Meeting" instructions, and if district decides to conduct other types of outreach (small group meetings, telephone conferences, or emails with individuals or groups), then follow the instruction in "Perform Additional Public Outreach" instructions.

## "Perform Public Meeting"

- Clarify that if district holds a non-public meeting (i.e., meet with certain groups or people like affected property owners), then create and follow the instructions for "Perform Additional Public Outreach," not "Perform Public Meeting."
- Revise to indicate that the public's email addresses are always redacted from version of documentation uploaded to ECOS (not just when documentation will be disclosed to the public).

## "Perform Reevaluation"

- Add reminder about how WPD I, II, III, and IV are frozen in time when project is environmentally cleared.
- Clarify that when ENV PD staff approves of the reevaluation, they do not create a second "Perform Reevaluation" Activity. Rather, they assign the pre-existing "Perform Reevaluation" Activity to the ENV Project Delivery Section Director.
- Add new instructions for when a reevaluation is done to correct an ENV Program Review finding.

#### "Perform Section 404-10 Permitting Commitments"

• This is a new Activity that districts will use to record commitments that result from the Section 404/10 permitting process (except for compensatory mitigation, which has its own Activity).

#### "Perform Species Analysis"

- Add instruction that at the time this Activity is finalized, the IPaC list cannot be more than six months old.
- Add instruction that at the time of environmental clearance, the IPaC list cannot be more than six months old.
- Add instruction that in completing the species analysis spreadsheet, explain in the spreadsheet any methods used to reach a determination that there is no suitable habitat in the project area.

#### "Perform Surface Water Analysis"

• Explain that the district may, at its discretion, prepare a Waters of the U.S. Delineation Report and Section 404/10 Impacts Table if it would be helpful in determining how to answer the questions on ENV's Surface Water Analysis form.



However, if the district voluntarily prepares such a report and table as part of the "Perform Surface Water Analysis" Activity, do not upload it under this Activity. It will only be uploaded to ECOS if the result is a need for a nationwide permit with pre-construction notification, individual standard permit, letter of permission, or regional general permit, in which case the "Obtain Section 404/10 Permit" Activity must be created, and the report and table must be uploaded under the "Obtain Section 404/10 Permit" Activity, not the "Perform Surface Water Analysis" Activity.

• Change references to a Section 404 individual permit to an "individual standard permit."
