Overview

The Maintenance Division's Pavement Asset Management Section oversees TxDOT's certification program for inertial profilers and profiler operators. This program supports TxDOT's implementation of ride quality specifications based on measurements collected with inertial profilers. These ride quality specifications include Item 585, the Item 247 flexible base ride quality specification, and Special Specification 3012. Certifications are conducted following TxDOT Test Method Tex-1001-S.

TxDOT requires contractors and service providers to certify inertial profilers annually. As an independent testing agency, the Texas A&M Transportation Institute (TTI) conducts these profiler certifications. Upon successful completion of certification testing, TTI provides the profiler's owner with a certification decal and a summary of the test results as documentation of the profiler's certification. Only profilers with current Tex-1001-S certifications should be used for ride quality assurance testing on TxDOT projects.

This MPL identifies inertial profilers with current Tex-1001-S equipment certifications. The MPL is organized by profiler make and model. Engineers should check the credentials of the certified inertial profiler prior to ride quality assurance testing by verifying that the credentials, as given in the documentation of the profiler's certification, match the information shown in this MPL for the given profiler. In particular, check the profiler's serial number and vehicle identification number (VIN), which uniquely identify each profiler. Check the profiler's certification level to ascertain that the given profiler is certified to collect ride quality assurance data for the material placed on the project. Finally, check the expiration date of the profiler's certification to ensure that the certification is still current for the scheduled ride quality assurance tests. Note that the month and year of expiration are punched in the certification decal. The profiler's certification expires on the last day of the month of the year shown on the decal.

Highlighted cells in the tables identify updates from the previous MPL.
