Eva Garcia, called the meeting to order at 9:35 A.M.

#### AGENDA ITEM 4: Chair's Report

Eva Garcia presented this item at 9:42 A.M.

Eva mentioned that May is National Bike Month. A great time to promote the BPAC and TxDOT's work. She recognized that we are in a legislative year for Texas. There is a House Committee on transport and a Senate Committee on transportation as well. Eva mentioned that bills have been submitted that will impact transportation resources and how state funds will get through local communities. Everything is public and recordings can be watched live. Eva said her State Representative, Erin Gamez from District 38 recently authored House Bill 4417 relating to the use of money from the state highway fund for certain projects in the Safe Routes to School Program. This went to the subcommittee on transportation funding. She encourages BPAC members and fellow bike ped advocates to check out those committees on transportation, specifically.

Comments/Questions:

John Brigham said that in the Houston area, they met with the House and Senate about that same topic and discussed safety-related funding. They stressed a lot of the safety-related improvements in his area. John said they did get some favorable responses.

#### AGENDA ITEM 5: Report from TxDOT's Public Transportation Division (PTN) Director regarding statewide bicycle and pedestrian matters

Eric Gleason presented this item at 9:48 A.M.

Eric provided updates on the Transportation Alternatives (TA) Call for Projects and Phase II of the District Bike Plans. The current call for projects, preliminary applications are in, and the detailed application phase has started. There are 311 applications that were eligible for funding submitted by 247 different project sponsors. Total value of request is just under \$1.3 Billion. Total federal request is just over \$1.1 billion. According to Eric, at this point we have about \$260 million available. Similar to the 2023 Call, some applications will fall off in this phase but it is a good list of projects and will be reviewed over the summer and go to commission in October for their consideration of a recommended lists of projects. Eric said we will keep the committee up to speed on that.

Eric said there are 5 project applications with a request total of \$14 million, that have requested additional funding for projects previously approved in the 2023 Call. These projects will be reviewed for additional funding at the July Commission meeting.

District Bike Plans will kick-off in the Atlanta and Lufkin Districts in late spring/early summer, followed by efforts in Dallas, Ft. Worth and Paris, and then Amarillo, Odessa and Lufkin and finally in Houston.

Comments/Questions:

Philip Hiatt Haigh asked if the TA projects had a good representative group of applicants from the rural areas. Eric said he thinks we made some progress on that. There is a concern that a lot of applications haven't come from West Texas. There are more from there this time, but we would like more, according to Eric. However, we are making progress due to a concerted effort to get the word out.

# AGENDA ITEM 6: Update and discussion on TxDOT's Statewide Active Transportation Plan (SATP).

Chelsey Smith presented this item at 9:52 A.M.

Comments/Questions:

Philip Hiatt Haigh provided updates as an attendee at the Steering Committee Meeting on the Statewide Active Transportation Plan. He said he is noticing the growth in Texas that the number one issue is congestion. Active transportation becomes a critical part of that network and its smart the TxDOT is including this.

Eva Garcia recognized how the plan is giving attention to the integration with active transport and other travel modes and transit connections. She wants to highlight and elevate the intersection between public transportation options, accessibility and bicyclists and pedestrians.

John Brigham said he travels around the state and provides feedback on these type of active transport projects. He wants to know how engaged the cities and MPOs are with these projects.

Will Parrish said it would be interesting to see miles of new roadway constructed vs. miles of new facilities to see in comparison for the future.

Anita Janke, online participant, said Killeen-Temple MPO would love to have a meeting. Please consider the City of Temple as a location for public engagement. The Killeen-Temple MPO wants to support this effort.

Travis Buffa, online participant, said he lives on Fort Worth and the bicycle and pedestrian network here is severely lacking. The progress on protected bike lanes is almost non-existent and the idea of an integrated cycling (lane) network is just that, an idea. Is there an expectation of any noticeable progress in the next few years?

#### AGENDA ITEM 7: Presentation on Pedestrian Detection Using Video Analytics.

Theresa Poer, Director of Transportation Operations for the TxDOT Ft. Worth District presented this item at 10:15 A.M.

#### Comments/Questions:

John Brigham asked about the software and what was provided by Traffic Vision. He also asked if any other TxDOT districts are doing anything similar. Theresa mentioned that El Paso has shown interest in doing the same thing in their district. Some other states, Ohio is doing a wrong way detection project as well. He would like to share this information with other states.

Philip Hiatt Haigh asked if there are any limitations to expanding this program into a wider implementation. Theresa Poer said they are working with TxDOT Traffic Safety Division to help fund this technology. It is not a huge cost. The only limitation in the future could be the resources for funding. Other districts that have similar camera systems can also layer this technology.

#### AGENDA ITEM 8: Presentation on PROWAG (Public Right of Way Accessibility Guidelines) and TxDOT's (RDM) Roadway Design Manual updates.

Bill Macke, TxDOT Design Division, Pedestrian Facilities Project Manager presented this item at 10:46 A.M.

#### Comments/Questions:

John Brigham asked about the ADA 5ft sidewalk requirements. Are there ever any issues with a building being so close to ROW? What happens when there is a wall or an older building that cant be moved? Bill addressed these questions. Providing a passing area.

Andrew Bernet asked if there has been any discussion regarding tactile directional indicators / detectable warning indicators.

Will Parrish asked about any guidance to move away from ramps with truncated domes where pedestrians could walk into an intersection. Per Bill, TxDOT's guidance is to put the curb ramps in the line of travel so that as you leave one ramp, you are facing the next ramp.

Philip Hiatt Haigh asked about crosswalks behind curb ramps being moved back from intersections. And if there are any guidelines to help pedestrians follow the traffic flow more easily. According to Bill, there are some new design elements including more bulb outs in blended intersections being used more in design plans.

Eva Garcia asked if there is any external training that can be offered for local government projects. Bill said there are some companion courses for contractors that can be offered. He can take back the request for a public course to his division.

# AGENDA ITEM 9: Updates from committee members on local and statewide issues.

Eva Garcia introduced this item at 11:17 A.M.

Philip Hiatt Haigh mentioned DART (Dallas Area Rapid Transit) system has come under criticism from other cities that are working with legislators to take away some of the increment allocated to DART for transit and public transportation option. City of Dallas has passed a resolution to continue funding, as they are the largest funder and user of DART. This is causing a lot of people to look at what transportation options are available. City of Dallas Bike Plan is going for approval. First time there will be a bike plan for the city, in over a decade.

Will Parrish said in San Marcos a new section of bike trail called Limestone Link is being built to create an off-street connection through the city. An effort to get a cross Texas trail starting in El Paso through central Texas will take a lot of effort and is exciting to see it happen. Buda is applying for the TA grants. SRTS is becoming a political issue in central Texas because of an unintended consequence of when sidewalks are provided to schools, the buses stop running to some areas close to the school. Parents don't feel comfortable with smaller children walking to school, are now driving because buses aren't running, and it is creating more traffic during peak traffic hours. They are working around some of the politics of this traffic concern.

John Brigham mentioned he is part of a Transportation Advocacy Group, and they went to the TX House and Senate to ask for support in moving forward with transportation safety projects. John said he would find out in the near future if that helped. HGAC the MPO in Houston is embarking on an important youth safety education outreach program centered around bike and ped safety. The program will start in a few months.

Andrew Bernet said he will be going to the autonomous driving meeting in July. Waymo is in Austin now. Andrew said there are mixed reviews about the autonomous vehicles

in Austin. Andrew said there have been some incidents where Waymo vehicles did not yield to pedestrians in crosswalks. There have also been a lot of near misses with pedestrians. It is a topic to keep an eye on and keep awareness around, especially for the population of blind individuals in Austin.

Jaimie Lee said Wichita Falls is currently working on implementing the Safe Streets for All comprehensive safety action plan so they can be eligible for safety grants to finish the Circle Trail, to allow better access for pedestrians and bicyclists, and to create a safer alternative for pedestrians and bicyclists.

Aimee Schultze said that Harris County public health is relaunching the Safe Routes to School (SRTS) program. Any colleagues interested in SRTS in Harris County, she can connect you with that team. Her child's school does not have sidewalks connecting to the school, so SRTS is a beneficial and important program, and she would like to see those effort expand. In Precinct 4, they have completed Phase 1 of a linear forest to honor a local resident and activist. This is a huge area for walking and biking in the area. It was part of the heat mapping campaign that Harris County participated in, in 2020 where they mapped the hottest parts of the city.

Lynnette Wood said in the Tyler area, she noticed a new TxDOT bike billboard about bike lights required at night. She has seen that all rechargeable bike lights have been bought out in all her local Walmart. She has been purchasing them and giving them out after bikes are purchased. She checked with a TxDOT representative to see if bike lights are still available. TxDOT no longer offers free bike lights. She applied for a small grant for lights. She reached out to a company and received a donation for lights and funding to purchase additional lights. Lynnette said in total she received about \$1,500 worth of bike lights for \$200 dollars in grant funding and donations.

Ericka Cornejo mentioned there have been many incidents around the city. She keeps seeing incidents weekly with pedestrian and bicycle crashes. There is a lot of dry cracking concrete in her area (because of the desert climate) so sidewalks are difficult to walk and run on. She is looking for ways to provide more information to drivers about being aware of pedestrians and bicyclists. She is working with a group to do a sidewalk clean-up in May.

Kim Hooker provided notes, as she was unable to attend due to a work event. She noted that she was part of the SATP Statewide Steering Committee Meeting held on April 15th. She is part of the District Bike Plan that will be launching in Amarillo soon. Amarillo also has a SS4A grant and received a Demonstration Grant. The city is waiting for FHWA to approve the grant agreement. Kim also noted that she connected with Farm and City for ways to celebrate the bike ride from Amarillo to Canyon. Transformation Park officially opened on April 12<sup>th</sup>. The area was developed next to the new City of Amarillo Transit Station.

Eva Garcia mentioned the RGVMPO has been developing the SS4A comprehensive safety action plan. They hope to adopt that plan this month. This will open the eligibility

for the communities in her region to apply for grants due in June. The RGV also has start-up week an economic development effort for a downtown bike ride. Eva said it is a 2.5 hours long bike ride that will take riders through affordable housing developments. She said they will be able to bike through the Gladys Porter Zoo, which is the only zoo south of San Antonio, during the ride. Eva also mentioned that they are doing their TA assessments in the May revision cycle.




# Survey Results: How Much Do You Agree with the Proposed Priority Steps? (1–10 Scale)





# 1\_Traffic Calming near 5 schools



### Summary

Traffic calming improvements near five schools, including the Hamlet Elementary School, San Jacinto Elementary School, Margaret Wills Elementary School, Olsen Park Elementary School, and Crocket Middle School. Estimated Total Cost \$654,000 Awarded

# \* Priority 1 of 16

The focus on traffic calming near schools stemmed from community engagement findings and crash data. The five schools were selected based on crash history and public input. Three of the schools are in a disadvantaged community, meeting Federal Highway Administration (FHWA) equity priorities, which ensures the proposed project addresses critical safety issues while aligning with grant requirements.




