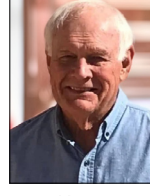

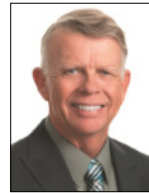

Honorable Curtis Parrish

Judge, Lubbock County, Advisory Committee Chair

Curtis Parrish was elected Lubbock County Judge in 2018, serving as the probate, guardianship and mental health judge for Lubbock County, as well as administrative duties with the Commissioners Court. Judge Parrish has always been active in the Lubbock community, having worked with and served on the boards of several organizations, including Civic Lubbock, Inc., Lubbock United Neighborhood Association and The Salvation Army of Lubbock. He also had an active part in establishing the Buddy Holly Museum and was an integral part of the Buddy Holly Walk of Fame for many years.



Mayor Lori Blong

Mayor, City of Midland, Advisory Committee Vice-Chair

Lori Blong was elected City of Midland Mayor in November 2022, becoming the first woman to serve as the city's mayor. She previously represented District 4 on the city council for over three years and has served as mayor pro tempore as well as council liaison for the Midland Development Corporation. She is also a member of Congressman August Pfluger's Energy Task Force and the Permian Basin Petroleum Association board, and is a founding member of the Midland Quality of Place Conservancy. Early in her career, Mayor Blong was a school teacher and later co-founded Octane Energy with her husband in 2013.

Alejandro "Alex" G. Meade III

Texas Transportation Commissioner

Alex Meade previously served as the city manager of Pharr, where he managed a \$200 million budget and almost 700 employees. He also has served as the chief executive officer of the Mission Economic Development Corporation. Meade is a member of the Texas Transportation Commission, which oversees statewide activities of the Texas Department of Transportation. Meade, who lives in Mission, was appointed by Governor Abbott on March 21, 2023.



Alvin New

Acting Chair, Texas Transportation Commissioner

Alvin New is a business investor, rancher and former San Angelo Mayor. He is a former member of the San Angelo Chamber of Commerce Board and the Concho Valley Center Economic Development Board. New is a member of the Texas Transportation Commission, which oversees statewide activities of the Texas Department of Transportation. New, who lives in San Angelo, was reappointed by Governor Abbott on April 8, 2021.

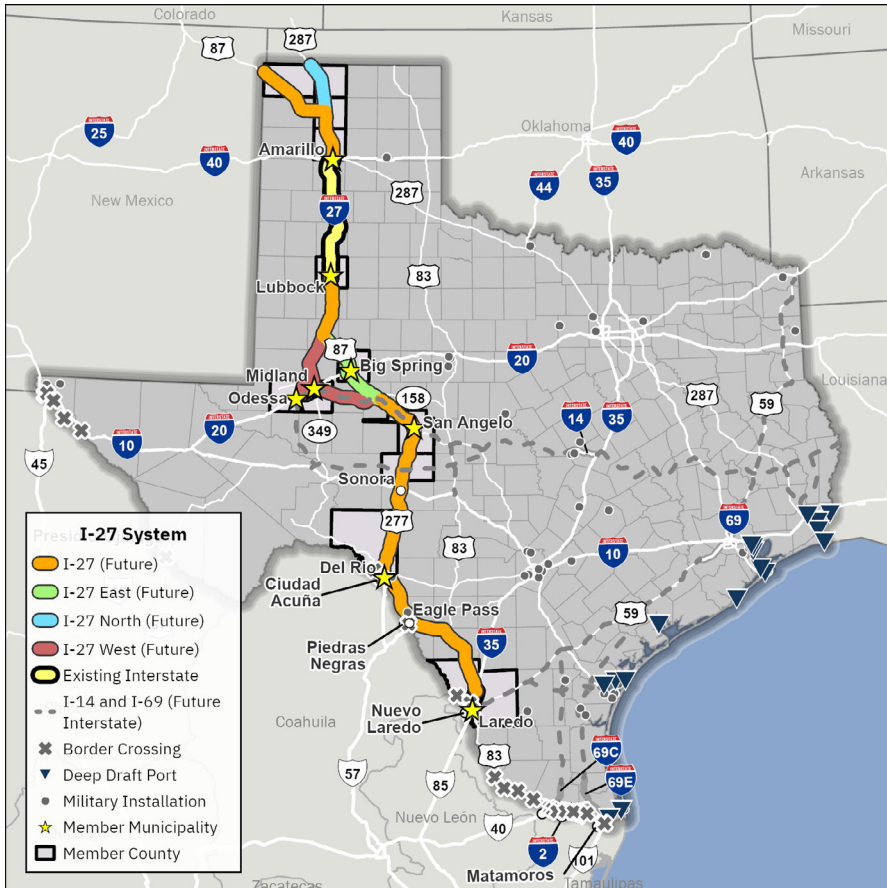
