Commercial Laboratories Approved for Flexible Base Referee Requests

Item 247, “Flexible Base,” of the Department’s *Standard Specifications for Construction and Maintenance of Highways, Streets, and Bridges*, allows the contractor to request referee testing when the Department’s test results do not meet any of the material requirements listed in Table 1. Referee testing may be requested for a single or multiple material properties. The contractor must sample the flexible base material with the Engineer in accordance with Tex-400-A and have the material tested for all the material properties listed in Table 1. The testing must be performed by an approved commercial laboratory listed in the table below. Testing by the Contractor is required to approve referee requests.

A commercial laboratory is defined as a laboratory that performs quality control testing for Contractors or material suppliers performing work associated with a Department project. Approval of a commercial laboratory for this material producer list requires verification of calibration records, technician certifications, and a site visit by TxDOT personnel.
