• Welcome to this meeting as we look forward to your input and discussion of developing topics important to this subcommittee

II. Priority Topics Update - TTI

• Focus:

- Should passenger AV services have Transportation Network Company (TNC) Licenses?
- O What are the legislative requirements for Texas registration, licensing, and enforcement for commercial operating AVs by type and agency responsibility?

Action Items

- o Explore how passenger AV deployments fit into existing regulator structures across the nation
- o What can Texas learn from national organizations like AAMVA about the standards and documents and information about other states?
- TTI met with TxDMV to understand how current structure for licensing registration and titling applies to passenger and freight AVs.
- Conduct similar meetings with DPS to discuss driver licensing and traffic enforcement.
- Available Literature on Passenger AV Deployment Experiences
 - Several academic studies have been completed to look specifically at AV deployments
 - o These studies range from 2017 through 2021
 - News stories and non-academic reports are also available and can be used to help partially tell the story about passenger AV deployments.
 - Suggested to gather input from subcommittee members involved in development who have gathered a collection of reviews, testimonials, and input from customer perspective. (If interested, reach out to Zeke or Bob who will put you in contact with right contact)

• Current Events

- o AV testing/operations are being conducted across the country, with significant deployments in Arizona, California, Michigan, and Texas.
- O Several states have produced information at some level on AV testing in their state, ranging form informational brochures to management plans and regulations

- States have varying degrees of regulations for AVs, including licensing and insurance standards
- o California implementing stricter regulation of AVs, especially trucks.

- Continue reviewing available literature on deployment experiences and success stories
- o Identify gaps and continue the literature search for regulatory impacts
- o Continue developing an outline of findings

• Met with the AAMVA

- American Association of Motor Vehicle Administrators formed in 1933 to represent agencies in US and Canada who administer and enforce motor vehicle laws
- This includes driver licensing and identity, vehicle titling and registration and law enforcement.
- Was introduced by Roland Luna (TxDMV) to Paul Steier, Director of Vehicle Programs, staff liaison to AAMVA Subcommittee on Automated Vehicles
 - Would this Subcommittee want to hear a presentation from Paul Steier at next meeting on May 20th?

• TTI Meeting with TxDMV Division Leaders

- o Important to understand TxDMV stakeholders, partners, and regulated parties
 - Vehicle dealers and manufacturers
 - Tax assessor-collectors in all 254 Texas counties
 - Motor carriers
- We will be seeking information to outline current regulations that affect passenger and commercial AVs

• Interacting with Texas DPS

- o Will follow up after TxDMV meetings to engage with DPS
- o Will discuss driver licensing and traffic law enforcement
 - DPS is solely responsible for driver licensing (Texas Department of Licensing and Regulation administers driver education licensing)
 - DPS troopers face traffic law enforcement issues that will be shared by other law enforcement agencies
