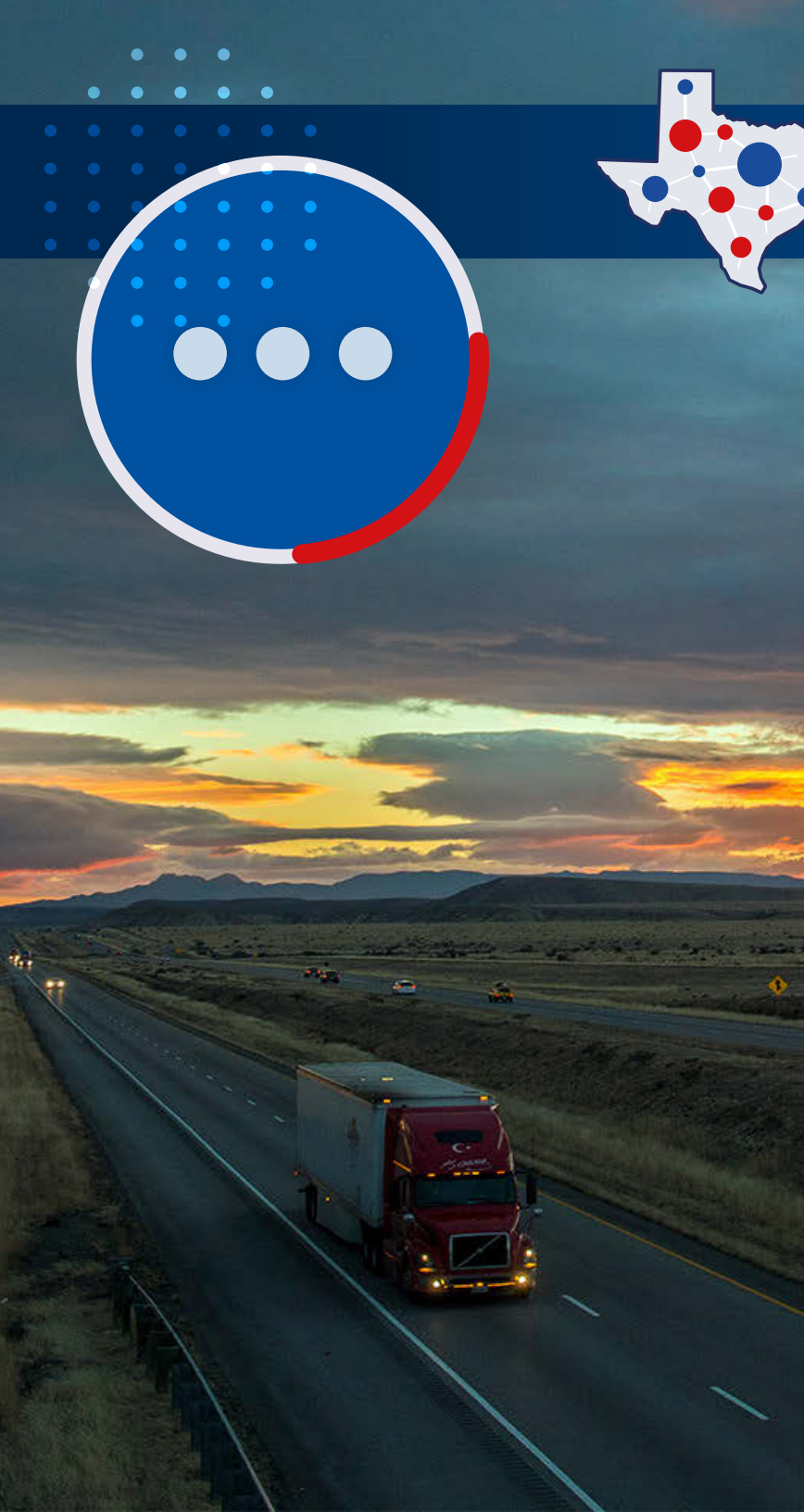

2. Title VI of the Civil Rights Act of 1964, as amended (**42 U.S.C. 2000d-1**) and **49 CFR part 21**;
3. **49 U.S.C. 5332**, prohibiting discrimination on the basis of race, color, creed, national origin, sex, or age in employment or business opportunity;
