Dear Mr. Williams:

We have reviewed the FY 2025-2028 STIP, received on September 24, 2024, with the Texas Department of Transportation's (TxDOT) approval letter (dated September 23, 2024) and updated fiscal constraint documentation received on September 24, 2024, and September 26, 2024. Based upon the information provided, we find that the FY 2025-2028 STIP is fiscally constrained.

In accordance with 23 CFR 450.218, the FY 2025-2028 STIP includes the Transportation Improvement Programs (TIP) for Texas' Metropolitan Planning Organizations (MPO). We jointly find that the State of Texas and the MPOs have generally complied with the joint statewide and metropolitan planning regulations issued by FTA and FHWA pursuant to Title 23 United States Code (USC) Sections 134 and 135, and the Federal Transit Act under Title 49 USC, except as otherwise noted in the enclosed project specific comments.

Portions of the FY 2025-2028 STIP for the Dallas/Fort Worth, El Paso, Houston, and San Antonio non-attainment areas, and the Beaumont-Port Arthur orphan area have been reviewed for consistency with their currently conforming Metropolitan Transportation Plans (MTPs). Based upon this review, we hereby find that the TIPs for these areas conform, except as otherwise noted in the enclosed project specific comments.

To expedite the review and approval of the STIP/STIP revisions, TxDOT and FHWA have implemented a streamlined approach for Federal review of the STIP/STIP revisions. In accordance with this streamlined approach, if the total number of project entries for any MPO or District exceed 30 entries, then FHWA staff will review a statistically valid sample of the entries for the area. Entries that are not reviewed as part of the sample will be designated with a corresponding comment. This comment helps to flag entries for additional TxDOT Transportation Planning and Programming Division (TxDOT-TPP) review. It also supports TxDOT in their responsibility to ensure proper authorization of Federal-aid funds. For the FY 2025-2028 STIP this streamlined approach was applied to the Dallas/Fort Worth, Houston, Rio Grande Valley, and San Antonio MPO areas.

Based upon our review the STIP documentation and the attached Federal Planning Finding, the FY 2025-2028 STIP is hereby approved subject to the enclosed comments. Please note STIP approval of projects that are not federally funded is not intended to provide federal endorsement or action. We thank TxDOT-TPP staff for their efforts in completing the review and approval of the FY 2025-2028 STIP.

Additionally, in accordance with our October 21, 2015, letter, TxDOT has been utilizing estimated Develop Authority (DA) to demonstrate the availability of sufficient project funding for National Environmental Policy Act (NEPA) clearance actions for projects in rural portions of the State not consistent with the fiscally constrained STIP. This demonstration of funding availability has been provided to FHWA and FTA and is accepted subject to the enclosed comments. NEPA clearance actions for projects utilizing DA should not be completed unless the project is consistent with a fiscally constrained MPO TIP/MTP or the Rural DA Project list provided with the FY 2025-2028 STIP.

## **Federal Planning Finding**

### **Texas**

#### **Summary**

The purpose of the Federal Planning Finding is to enable the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) to make a joint determination that the statewide planning process meets or substantially meets the requirements of 23 USC 134 and 135 and 49 USC 5303 and 5304, and related regulations. This joint planning finding is done in conjunction with the review and approval of the Fiscal Year (FY) 2025-2028 Statewide Transportation Improvement Program (STIP). In Texas, the STIP is adopted every two years, and includes four years of Federal-aid projects, projects requiring Federal actions, and regionally significant projects, regardless of funding source.

The FHWA Texas Division and the FTA Region VI office have been involved in the statewide and metropolitan planning activities throughout the last year. Below is a summary of the activities and observations in each area. Following the summary of activities and observations, this report will list any commendations, recommendations for improvement or corrective actions concerning the planning process in Texas.

Based on the Federal involvement in the statewide and metropolitan planning processes, and review of required documents, the FHWA and the FTA have determined the statewide and metropolitan planning processes substantially meet the requirements of statute and regulation. In accordance with 23 CFR 450.218, the FHWA and the FTA hereby find that the projects in the FY 2025-2028 STIP are based on a transportation planning process that substantially meets the requirements of 23 CFR Part 450 Subpart A, B, and C; 49 U.S.C. Sections 5303-5305; and 23 U.S.C. Sections 134 and 135. This finding is based on the certifications of the statewide and metropolitan transportation planning processes for, and within, the State of Texas and the FHWA's and FTA's participation in those transportation planning processes.

#### **Planning Process**

##### **Long Range Transportation Plan**

The Texas Transportation Commission adopted Connecting Texas 2050 on July 30, 2024, to serve as TxDOT's statewide long-range transportation plan. Connecting Texas 2050 was developed through a collaborative process including local governments, metropolitan planning organizations, transit agencies, advisory committees and federal agencies. Connecting Texas 2050 guides planning and programming decisions for the development, management, and operation of the statewide, multimodal transportation system in Texas over the next 25 years. The statewide long-range transportation plan is developed using state planning and research (Subpart A) funding. It is updated every four years and includes a minimum of a 20-year planning horizon.

The MPO approved Metropolitan Transportation Plan (MTPs) are provided to the Division Office and Region VI Office. MTPs are reviewed for compliance with 23 CFR 450.

The Texas Freight Mobility Plan was adopted on January 26, 2023. The new Texas Freight Mobility Plan, called Texas Delivers 2050, will serve as a keystone document for future investment in freight-supportive infrastructure across Texas. Texas Division staff routinely worked with TxDOT to ensure compliance with Federal requirements. The document was reviewed and found satisfactory (May 2023) by the Texas Division Office.

### **Statewide Transportation Improvement Program (STIP) & Transportation Improvement Program (TIP)**

The STIP includes highway and transit projects funded under Title 23 USC and Title 49 USC, Chapter 53, and modal projects with phases or components funded under those titles or with state or local funds. Regionally significant projects to be funded with non-federal funds (e.g., state or local) are included in the STIP for planning, coordination, and public disclosure purposes. The State and MPOs have a coordinated process for developing the STIP and MPO TIPs. When submitting the STIP for approval TxDOT includes the MPO TIPs without modification. MPO TIPs in the STIP are reviewed for compliance with 23 CFR 450 by the Texas Division Office and Federal Transit Administration Region VI Office. FHWA and FTA utilize a joint Record of Review (ROR) to document review of the TIP and associated metropolitan planning process. In addition, the MPO self-certifications and State approval of the MPO TIPs are included in the STIP back up documentation.

The FY 2025-2028 STIP and subsequent revisions will be available through the eSTIP portal. TxDOT adopts a new STIP every two years that includes four years of transportation improvements. All tribal and Federal Lands projects are incorporated into the STIP without change. This occurs through coordination with the Central Federal Lands Division of the Federal Highway Administration. STIP coordination also occurs with local governments. TxDOT has a public involvement process for their STIP.

The financial information for the FY 2025-2028 STIP was reviewed. TxDOT and the MPOs have demonstrated funding is reasonably available to support the programmed projects while adequately maintaining the transportation system, except as otherwise noted in the project specific STIP comments.

TxDOT annually develops a Unified Transportation Program (UTP) that includes ten years of anticipated funding and projects. Projects identified in the UTP are progressing through the project development process and will ultimately be moved into the STIP. This process enhances the delivery of projects as they will only be allowed to progress into the STIP when at a stage that delivery is ready to be commenced within the four-year timeframe of the STIP.

### **Air Quality Conformity**

Portions of the FY 2025-2028 STIP for the Dallas-Fort Worth, El Paso, Houston-Galveston and San Antonio non-attainment/maintenance areas, and the Beaumont-Port Arthur orphan area have been reviewed for consistency with their currently conforming Transportation Plans. Based upon our review the Texas Division found that the TIPs for these areas conform, except as otherwise noted in the project specific STIP comments.

### **Statewide (SPR Part A / Part B) & Unified Planning Work Programs (UPWP)**

TxDOT has submitted both a Statewide Planning and Research (SPR) Subpart A (systems planning) and Subpart B (university research) Work Program, fulfilling the federal requirements of 23 CFR 420. TxDOT's SPR Work Programs are based on the state's fiscal year. Both the FY 2025 SPR Subpart A and Subpart B work programs have been reviewed and approved by the FHWA Texas Division. The SPR Subpart A Work Program was approved on April 3, 2024, and the SPR Subpart B Work Program was approved on May 20, 2024, by the FHWA Texas Division.

Texas is a Consolidated Planning Grant state for the administration of MPO planning funds, with the FHWA Texas Division serving as the lead agency. MPO Unified Planning Work Programs are approved jointly by FHWA and FTA Region VI in a timely manner.

### **Meetings and Public Involvement**

TxDOT has an excellent public involvement process. In Texas, MPOs develop and implement Public Participation Plans. The MPOs update the Public Participation Plans on an as needed basis. They are continually evaluating the process and results with a focus on improving the process. During the pandemic the State and the MPOs transitioned successfully to almost a completely virtual public participation process and TxDOT documented lessons learned. Public Participation Plans (PPPs) are reviewed as part of routine oversight and if identified as risk-based, are included as part of the Federal Certification Review Process organized by the Division and FTA Region VI office.

### **Coordination with Statewide Planning and Metropolitan Planning Organizations (MPOs)**

The TxDOT continues to maintain a positive relationship with the MPOs. The State attends MPO meetings and is involved in oversight of the studies conducted by the MPOs. The MPO TIPs and the STIP are developed in a cooperative process and MPO approved TIPs are included with the STIP submission.

As part of regular oversight of the Transportation Management Areas (TMAs) and the Metropolitan Planning Organizations, FHWA staff routinely participate in MPO Policy and Technical Committee meetings. At a minimum, Division Planning staff are required to visit TMAs twice a year and non-TMAs annually. The Division Office, Planning Program and Development (PPD) section routinely interacts with TxDOT's Planning and Programming Division (TxDOT-TPP) and holds joint monthly

meetings with staff. This involvement provides an on-going opportunity to identify and correct issues as they arise.

### **Transportation Performance Measures**

TxDOT leads the development for Transportation Performance Measures (TPMs). MPOs designated non-attainment or maintenance for air quality have an active working group to coordinate on the System Performance Measures (PM3). TPMs are reviewed as part of the oversight for the STIP, TIP, and MTP. As required by regulation, the MPOs are given the opportunity to adopt the State's Performance Measures or adopt their own. The State and MPO TPMs have been found acceptable by the Texas Division and Federal Transit Region VI, except as otherwise noted in the project specific STIP comments.

### **Commendations, Recommendations, Corrective Actions:**

#### **Definitions**

*Corrective Actions:* These are activities that are required by statute or regulation and are not being done by the State and may potentially prevent the STIP from being approved without correction or without an action in place to correct the current processes.

*Recommendations:* These are activities that would be good for the State DOT to incorporate into their planning processes. These activities are not required; however, some of the items that are noted could become a Corrective Action in a future Federal Planning Finding if not appropriately addressed.

*Commendations:* These are items that the FHWA and FTA deem worthy of recognition for their innovation and improvement to the process.

#### **Corrective Actions:**

None

#### **Recommendations:**

There have been several staff changes to TxDOT-TPP in recent years. This has left a gap in experience and knowledge concerning the planning processes in Texas, which has resulted in the need for more frequent communication with Division and Region VI staff. It is recommended that TxDOT continue to review and develop Standard Operating Procedures for coordination of the planning process.

#### **Commendations:**

TxDOT has a well-organized electronic application (eSTIP) in place for management of the STIP in Texas. This application makes reviewing and approving the STIP transparent and straightforward. The level of effort put forth by the TxDOT staff to address issues concerning the STIP including: the addition of staff working on the STIP, development of a STIP manual, and review of STIP procedures is also commendable.

**Conclusion**

The FHWA and FTA have reviewed the statewide planning processes, the metropolitan planning processes, and public involvement processes. Based on Federal agency involvement in the planning processes and communications with planning partners, the FHWA/FTA find that TxDOT substantially meets the requirements of 23 USC 134 and 135, 49 USC 5303 and 5304, 23 CFR 450, and 49 CFR 613.
