We have reviewed the May 2024 revisions to the FY 2023-2026 STIP, received on June 5, 2024, with the Texas Department of Transportation's (TxDOT) approval letter (dated June 4, 2024). Based upon our review and the updated fiscal constraint documentation (received May 31, 2024), the May 2024 revisions to the FY 2023-2026 STIP are hereby approved subject to the enclosed comments. Please note STIP approval of projects that are not federally funded is not intended to provide federal endorsement or action.

Revisions to the FY 2023-2026 STIP for the El Paso, Dallas/Fort Worth, Houston, and San Antonio non-attainment areas have been reviewed for consistency with their currently conforming Metropolitan Transportation Plans (MTPs). Based upon this review, we hereby find that the Transportation Improvement Programs (TIPs) for these areas conform, except as otherwise noted in the enclosed project specific comments.

To expedite the review and approval of the STIP/STIP revisions, TxDOT and FHWA have implemented a streamlined approach for Federal review of the STIP/STIP revisions. In accordance with this streamlined approach, if the total number of project entries for any MPO or District exceed 30 entries, then FHWA staff will review a statistically valid sample of the entries for the area. Entries that are not reviewed as part of the sample will be designated with a corresponding comment. This comment helps to flag entries for additional TxDOT Transportation Planning and Programming Division (TPP) review. It also supports TxDOT in their responsibility to ensure proper authorization of Federal-aid funds. For the May 2024 revision this streamlined approach was applied to the Dallas/Fort Worth MPO area revisions.
