The Texas Department of Transportation (TxDOT) has made design modifications for the above referenced project. This notice advises the public that TxDOT will be conducting an on-line virtual stakeholders meeting on the proposed project. The virtual stakeholders meeting presentation will be available beginning May 1, 2020. The virtual meeting will consist of a video presentation containing both audio and video components explaining the proposed project, as well as other exhibits and materials for your review. The virtual meeting materials will be posted beginning May 1, 2020 on www.635east.com, under the "View" tab, on the "Upcoming Events" subpage. The presentation will remain available online through the comment period deadline of May 15, 2020. If you do not have internet access, you may call the TxDOT project manager, Grace Lo, P.E. at (469) 670-0950 or the project public information officer, Dianne Tordillo at (214) 724-5904 to ask questions about the project and request project materials at any time during the project development process. Formal comments may be provided by U.S. mail, email, or voicemail as explained below.

The purpose of this stakeholders meeting is to update property owners within the project vicinity of the design modifications at Garland Avenue being performed by TxDOT, and offer the opportunity for comment. This notice and opportunity to comment is also provided to affected local government and public officials.

The design modifications for this section of I-635/LBJ would include the following:

- The westbound and eastbound continuous frontage roads will be elevated and crossing over Garland Avenue and KCS railroad track at the same elevation as the proposed I-635 mainlanes, which would eliminate the two new railroad underpass structures from the previously approved schematic.
- Garland Avenue would be maintained at the approximate existing elevation instead of a depressed roadway as identified in the approved schematic.
- Access between frontage roads and Garland Avenue would be provided via proposed loop ramps
 instead of a conventional at-grade signalized intersection as shown in the approved schematic. The
 east to west U-turn at Garland Avenue would be moved approximately 1000 feet west of its original
 location. The west to east U-turn free movement at Garland Avenue would now be provided via the
 proposed loop ramps.

- Shiloh Road would be maintained at the same existing alignment and grade. The jug-handle like connection shown in the approved schematic between Shiloh Road and the westbound frontage roads would be replaced with an at-grade signalized intersection at the westbound frontage road. The eastbound frontage road would continue to be elevated above Shiloh Road as shown in the approved schematic.
- The mainlanes entrance and exit ramp to and from Garland Avenue would be maintained. The exit ramp from eastbound I-635 mainlanes to Northwest Highway would be shifted approximately 300 feet to the west, and the eastbound frontage road entrance ramp from Garland Avenue to I-635 mainlanes would be shifted approximately 1000 feet to the east. The proposed westbound exit to frontage road for Garland Avenue and Shiloh Road would remain at the same location shown in the approved schematic.

No additional right-of-way is required to implement these proposed design changes.

TxDOT makes every reasonable effort to accommodate the needs of the public. The virtual stakeholders meeting will be in English. 



Proposed Design Modifications at the Garland Avenue Intersection






