Community Workshops Overview EL PASO DISTRICT

DOWNTOWN (10)

On August 23 and 24, 2024, TxDOT hosted Community Workshops for the Downtown 10 project at the El Paso Convention Center. Directly adjacent property owners and residents were invited to attend, and attendees were able to learn about the improvements being considered, share ideas and feedback, and ask questions on the project's progress. While these workshops were not a typical public meeting, they were offered as an additional touchpoint with directly adjacent property and business owners to ensure they were informed and updated on the project status, as our last official public meeting was two years ago. Attendees were able to submit their comments and surveys from August 23, through September 9, 2024.

These workshops were designed as come-and-go events and were offered outside of a traditional public meeting time – all day on Friday and Saturday – to ensure the public could attend whenever it worked best for their schedule. The workshops were supported by Spanish-and English-speaking staff. An overview of the workshops and outreach methods utilized is captured below.

St. Clements has expressly told Ciudad Nueva that if the field is torn down, Ciudad Nueva's buildings will be torn down to rebuild the field. Ciudad Nueva is a vital resource for the community for 20 years, providing youth development programs, nutrition assistance, resource connecting, senior neighbor support, small business support, & so much more. Disrupting the work of Ciudad Nueva through the demolishing of their buildings will have significant & detrimental impact to the lives of hundreds of community members. 39	9/8/2024	Veronica Carrillo	Dear TxDOT, I support necessary repairs to I-10 between Copia and Executive but strongly oppose any expansions that increase capacity for cars and semi-truck traffic. My neighborhood, which lies adjacent to this freeway section, suffers significantly from noise pollution and exhaust fumes. Notably, this area, one of the lowest in car ownership according to the US Census, disproportionately suffers from diseases linked to traffic pollution - such as diabetes, asthma, and heart disease - as identified by the American Lung Association. Adding more lanes to I-10 will only exacerbate pollution issues, irrespective of traffic flow improvements or reductions in idle time. Instead, I urge you to consider integrating infrastructure that supports commuting by foot, bicycle, or bus, without expanding car or semi truck capacity. The initial concepts from the Reimagine project included in-line transit, and I strongly advocate for this to be implemented starting with segment two, between Copia and Executive, with stops at Copia, Piedras, Cotton, and downtown. Regarding the Deck Plaza, it is crucial that taxpayer money not be used to subsidize what is essentially a private project that caters more to specific business interests rather than the broader community needs. As a member of the Deck Foundation's Community Advisory Committee, the project's focus on narrow interests rather than inclusive community benefits is particularly concerning. Additionally, please ensure that noise barriers are included along this entire segment of I-10. Residents of the El Paso High, Houston Park, and Golden Hills areas, often overlooked due to being predominantly renters or part of minoritized groups, deserve consideration and protection from the adverse effects of freeway proximity. I hope TxDOT follows up very soon on the request made by the Rio Grande Neighborhood Association included in their comment form the last public comment period to be made a consulting party. Finally, the Downtown 10 project jeopardizes a nonprofit that is deeply ro
