In no case will the original application be returned to the applicant. A re-submittal of an application will require new notary seals and signatures.

You cannot transfer a permit that meets any of the following conditions:

- The license of the current or proposed owner is not active.
- The permit is not active.
- The permit is pending cancellation or has an outstanding violation.

The department's approval of a transfer DOES NOT certify the sign complies with current regulations. If the department approves a transfer, it becomes the responsibility of the new permit holder to maintain the sign in accordance with all applicable rules in accordance with the original permit.

With few exceptions, you are entitled on request to be informed about the information that we collect about you. Under §552.021 and §552.023 of the Government Code, you are entitled to receive and review this information. Under §559.004 of the Government Code, you are also entitled to have us correct information about you that is incorrect.
