WIND LOAD CERTIFICATION

Under Transportation Code Chapters 391 & 394

Part 1 – Instructions

Complete this form in its entirety. If the application is incomplete or has incorrect information, it will be rejected. This form serves as certification by you, the applicant, that your structure meets or exceeds the wind load pressure requirements in 43 TAC §21.188 (Interstate and Primary Highways) or 43 TAC §21.431 (Rural Roads).

- ◆ **For new signs or permit amendments**, you must include a signed copy of this form with your initial application. Failure to include this form will result in your application being rejected.
- ◆ **For existing signs newly subject to regulation**, you must include a schematic showing the sign as it exists currently. You may provide an unsealed schematic or sketch showing relevant dimensions if the original engineered drawings are unavailable.
- ◆ **Before the 1st year inspection**, you must provide this form and as-built schematics of your sign produced either by the actual professional engineer who oversaw the erection of your sign, or if you did not utilize a professional engineer, the person responsible for the sign's construction. **You will not be able to renew your permit until you submit this form with as-built schematics. You may lose your permit to expiration.**
