TxDOT Construction Project Wins Award for Contractors

A TxDOT construction project on US 96 in San Augustine County recently won the contracting companies national award. Madden Contracting LLC and Longview Asphalt Inc., of Minden, LA, were honored with the National Asphalt Pavement Association (NAPA) award for Quality in Asphalt Paving. The contractors were recognized at the recent 68th Annual NAPA conference in Miami Beach, FL.

The US 96 construction project consisted of contractors placing a leveling course of asphalt on the roadway, followed by a 2-inch surface course. Using a mix that included reclaimed asphalt pavement (RAP), a sustainable paving technique that conserves virgin aggregates, earned them a green designation. The result was a pavement with a very smooth ride and an excellent appearance that earned awards from Texas Asphalt Pavement Association and The Texas Department of Transportation.

"The asphalt pavement industry is committed to building high-quality projects that deliver superior performance to the traveling public. A Quality in Construction award is measured against best practices designed to live up to that commitment," said James A. Mitchell, 2022 NAPA Chairman. "Earning the Quality in Construction Award demonstrates that Madden Contracting LLC and Longview Asphalt Inc. have met or exceeded these rigorous standards."

NAPA is the only trade association that exclusively represents the interests of the asphalt producer/contractor on the national level with government agencies and other national trade and business organizations. The company was founded in 1955 and has more than 1,100 members nationwide

Nov. 7th marks the 23rd anniversary of the last deathless day on Texas roadways. It is an unwelcome anniversary that is marked by at least one person dying on Texas roadways every day since Nov. 7, 2000. More than 79,000 people – loved ones, children, and friends, have died in a crash.

TxDOT created End The Streak in an effort to raise awareness and how this issue impacts every Texan. We need to end the streak of daily deaths. We know it is a big goal, but it is possible to reach, and it will take us all to do our parts behind the wheel. When you drive remember:

- Drive at a safe speed and to roadway and weather conditions
- Do not drive under the influence of alcohol or drugs
- Put the phone away and do not let anything distract your attention from driving

I-69 DEVELOPMENT IN THE LUFKIN DISTRICT


There are currently ten projects that the Lufkin District is actively developing to meet interstate standards. These projects are in varying stages of development from schematic to construction. Below is a brief status on each. For more information on I-69 projects development in the district, please visit our webpage at <u>www.txdot.gov</u> and search "<u>I-69 Projects Overview</u>".

- <u>US 59/SL 224 South Interchange</u> project involves upgrading existing US 59 by constructing new US 59 direct connectors at SL 224(S) and frontage roads along SL 224 between SH 7 and US 59. Construction began in September 2019 and is anticipated to be complete summer 2024, weather permitting.
- <u>US 59 Diboll Relief Route</u> project involves constructing a new location controlled-access roadway east of Diboll. Construction began in Spring 2020 and is anticipated to be summer 2025, weather permitting.
- <u>US 59 Upgrade Moffett Rd to SH 103</u> this project in Lufkin involves upgrading existing US 59 to a controlled access roadway by adding frontage roads. Construction began in 2021 and scheduled for completion in winter 2024, weather permitting.
- <u>US 59 Upgrade Redland</u> project involves upgrading existing US 59 to a controlled access roadway by adding frontage roads between SL 287 and FM 2021. Construction began in late 2022 and is anticipated to be completed in fall 2025, weather permitting.
- <u>US 59 Corrigan Relief Route</u> project involves the construction of a new location controlled-access roadway, west of Corrigan. Construction began in fall 2022 and is anticipated to be completed in summer 2026, weather permitting.
- <u>US 59 Upgrade Shepherd to Cleveland (future I-69)</u> project involves upgrading existing US 59 to a controlled-access roadway by adding frontage roads between FM 2914 and SL 573. Construction was awarded to begin in fall 2023 and is anticipated to be completed in fall 2029.
- <u>US 59/US 259 North Nacogdoches Interchange</u> this project involves upgrading US 59 to a controlled-access roadway from Stallings Drive/SL 224 to 1.3 miles north of US 259 by reconstructing the US 59/US 259 interchange and adding new frontage roads. A public meeting was held on Aug. 3, 2023. Construction is currently scheduled to begin in 2029.
- <u>US 59 Upgrade Shepherd to Trinity River</u> project involves upgrading existing US 59 to a controlledaccess roadway by adding frontage roads between FM 223 (Church Street) to just north of the Trinity River. TxDOT held a public meeting on April 27, 2023. Construction is currently scheduled to begin in 2029.
- <u>US 59 Upgrade North Livingston</u> project involves upgrading US 59 to a controlled-access roadway by reconstructing the US 59/US 190 interchange, reconstructing US 59 main lanes and frontage roads from just south of US 190 to SL 116. TxDOT is currently working with a consultant on the development of the schematic. A public meeting is tentatively scheduled in early 2024. Construction is currently scheduled to begin in 2032.
- <u>US 59 Upgrade South Livingston</u> project involves upgrading US 59 to a controlled-access roadway by reconstructing the US 59/FM 1988 interchange, reconstructing US 59 main lanes and adding frontage roads from just south of US 190 to 0.39 miles south of FM 1988. TxDOT is currently working with a consultant on the development of the schematic. A public meeting is tentatively scheduled in early 2024. This project currently does not have construction funding identified.


